New Delhi, Aug. 7 Prime Minister, Shri Narendra Modi today said that Vocal for Local has become a mass movement which has given a new impetus to the textile sector in the country. Addressing the 9th National Handloom Day celebration today at Bharat Mandapam in Pragati Maidan, Delhi, Shri Modi said that the schemes that have been initiated in the textile sector bring justice to weavers and artisans.

The Prime Minister also urged the people to reaffirm their commitment to



popularise local products on National Handloom Day. Prime Minister, Shri Modi said that India's vibrant handlooms exemplify the country's diversity. He said that

the government's endeavour is to give wings to the aspirations of children of those associated with handlooms and handicrafts. Shri Modi said that to

promote the handloom industry, the government is giving loans without guarantee and providing raw material for the handloom weavers at discount rates.

Talking about the GEM portal, he said that now every small enterprise can sell their project on GEM directly. He added that at present, 1.75 lakh MSMEs are associated with GEM portal. He mentioned that the government is working to set up 'Ekta Mall' across the country to increase the sale of handcraft products of all other states.

Port Blair, Aug 7 Ministry of Health & Family Welfare is committed towards providing 100% full immunization and reduce the Vaccine Preventable Disease across the Country. In view of this, Intensified Mission Indradhanush 5.0 (IMI) was launched in these Islands with the rest of the country aiming to enhance immunization coverage for all vaccines specified under the National Immunization schedule for children below 5 years and pregnant mothers, especially Measles & Rubella vaccine for children up to 5 years of age. The ultimate objective is to eliminate Measles & Rubella by the year 2023.



The IMI 5.0 will be conducted in three rounds: Round 1 will be held from Aug 7 - 12, Round 2 will be held from Sept 11 - 16, and Round 3 will be held from Oct 9 - 14, 2023.

Each round will be conducted for

6 working days i.e. including Routine Immunization days. It will cover the dropped out and left out children up to the age of 5 years and pregnant women with missed doses of vaccine. It will give special focus on

improving coverage of Measles & Rubella (MR) vaccine Pneumococcal Conjugate Vaccine (PCV) and 3rd doses of fractional Inactivated Polio Vaccine (fIPV). Henceforth, all the physical cards for vaccination will go online at par with COVID - 19 vaccination certificate through the U-WIN Portal of GoI. An inaugural function was conducted in this regard at PHC Garacharama today,

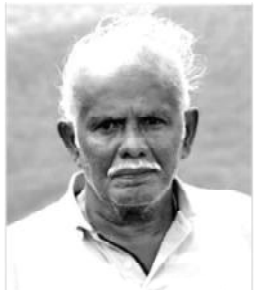
