## Concerted efforts of A&N Administration pay dividends

## Sindhu & Nalanda granted permission to carry copra products

## Initiative will open up business opportunities for farmers/tribals of Southern Group of Islands

Port Blair, Aug. 8

The passenger shipping services provided by A&N Administration predominantly play pivotal role in passenger transshipment as well as towards transshipment of essential commodities/produces to the far flung Inhabited Islands in the archipelago of A&N Islands.

The cargo enabled passenger vessels of A&N Administration, although, carry various agricultural and fisheries products from the local farmers/traders to Port Blair, these vessels were completely barred from transshipment of Copra as the product falls under the category of dangerous cargo. The tribal and other habitant community of Nancowry and Great Nicobar Islands are almost entirely dependent on exports of Copra as this cash crop is reported to be the main source of their income. Due to non availability of suitable mode for transshipment, the farmers/ tribal community are compelled to bear heavy

loss for not being able to sell their Copra product suitably in Port Blair/ Mainland markets.

In view of these difficulties being faced by the farmers and tribal communities towards transportation of their Copra products from their respective Islands to Port Blair/Mainland, the Directorate of Shipping Services, under the guidance of the Chief Secretary, A&N Administration has taken up a case with DG Shipping for grant of necessary permission to carry Copra Products through their passenger vessels. Since 'Copra' falls under the category of IMDG Cargo, the required modifications and arrangements were made onboard Sindhu & Nalanda so that the safety aspect should not be compromised.

The Directorate of Shipping Services, with its unwavering dedication to the highest standards of safety and compliances, has diligently worked towards securing the necessary license

all children and adolescents from 1-19 years of age are given de-worming tablets through the platform of Schools and Anganwadi Centres.

National De-worming Day 2023 (Second Round) will be implemented in A&N Islands on Aug. 10 followed by Mop up on Aug. 17, 2023. During this Round Albendazole Tablet will be administered through schools and Anganwadi Centres. All parents are requested to ensure that their children are administered Tab Albendazole in Schools and Anganwadi Centres. The worms consume nutrients meant for the human body and cause blood loss, poor nutrition and stunted growth. Due to heavy infection, children are often too sick or tired to concentrate at school or attend school/anganwadi. Worm infestations negatively affect children's physical and cognitive development which could have long term negative impact on them. Studies show that absenteeism in schools decreases with regular deworming

Parliament approves Bill to simplify birth and death registration and making it digital

New Delhi, Aug. 8 Parliament has approved the Registration of Births and Deaths (Amendment) Bill, 2023. Rajya Sabha passed the bill yesterday while Lok Sabha had cleared it on 1st of this month. Replying to discussion on the bill, Minister of State for Home Shri Nityanand Rai said, the bill has been brought to simplify the birth and death registration and it will be completely digital. He said the data received will help in making social schemes for the benefit of the people. Shri Rai said it will be a very important document for different works like getting driving licence and admission into educational institutions. The Minister said, according to the bill, the Birth and Death certificates can be received within seven days. The Bill seeks to amend the Registration of Births and Deaths Act, of 1969 which provides for the regulation and registration of births and deaths. The Act provides for the appointment of a Registrar-General, India who may issue directions for registration of births and deaths. The Bill adds that the Registrar General will maintain a national database of registered births and deaths.

World Breastfeeding Week observed under ICDS Project Rangat
