3 foreign poachers apprehended, 1 surrenders before a civilian of Kishori Nagar

Mayabunder, Aug. 17

As the anti-poaching team consisting of ASI B.S Halder, HC V. Saji, and PCs Subrata Biswas & Jaspal Singh was on its way to search for foreign poachers in the mangroves and creek area of Loha Tikrey, Khari Nallah where they were suspected to be hiding, on Aug 16, 2023, the team noticed some movement of the poachers and the team was alerted by ASI B.S Halder. On seeing the Police team the poachers tried to escape into the dense jungle. The team courageously followed and rounded them, resulting in apprehension of 3 poachers successfully. Meanwhile, in an incident, on Aug 15, 2023 one person namely Rupeshwar, S/o Shri Bimal Soreng, R/o Pailoon came to OP Kishorinagar with one Myanmar National who surrendered himself at his home at Pailoon. The surrendered Myanmar National was immediately detained at OP Kishorinagar and was later shifted to PS Kalighat.



interrogation through sign-language, the surrendered Myanmar National replied that he was alone and hungry since last 20 days and he couldn't find his group members. On the reply of the surrendered Myanmar National, it was understood that he might have been left by his group as 5 members of his group were already apprehended by Police team few days back. He hid himself in the jungle of Loha Tikrey all these days. The surrendered Myanmar National had entered in the territorial water of A&N Islands with vested interest of collecting sea cucumber illegally.

All the 4 apprehended poachers were brought to PS Kalighat and later handed over to PS CCS for further investigation. The

entire operation was carried out under the direct supervision of Ms. Geetanjali Khandelwal, IPS, SP (D) N&MA.

The exemplary bravery shown by the anti-poaching team has been lauded and they will be suitably rewarded. Also, the civilian person is being rewarded for his bravery and an appreciation certificate is also being given.

experiments on the lunar surface. India's ambitious Moon Mission Chandrayaan-3 successfully completed its fifth and final lunar-bound orbit maneuver yesterday.

Chandrayaan-3, launched on July 14, consists of a lander module, a propulsion module (PM), and a rover. The spacecraft successfully entered lunar orbit on August 5, following which a series of orbit reduction maneuvers were carried out to position it over the lunar poles. The Propulsion Module, on the other hand, will continue its journey, studying the spectral and polarimetric measurements of Earth from lunar orbit. It carries a Spectro-polarimetry of Habitable Planetary Earth (SHAPE) payload, aimed at aiding future discoveries of smaller planets in reflected light, which would qualify for habitability or presence of life. 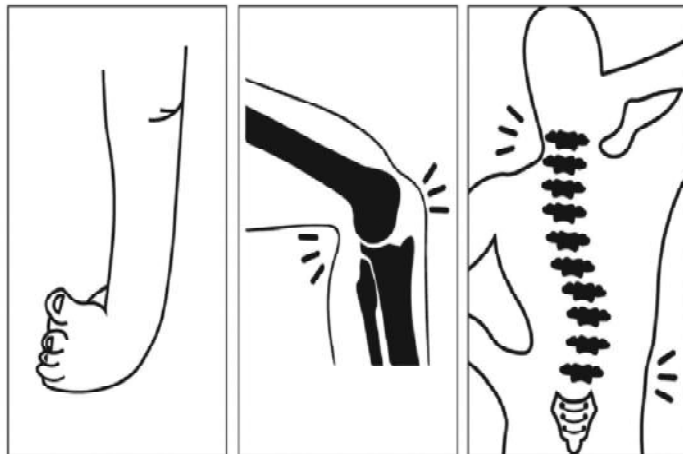

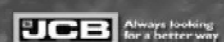
