The fraudsters later make use of this material to harass, embarrass, threaten, exploit and blackmail the victims. Catphishing occurs when a fraudster threatens to circulate your private and sensitive material online, if you do not provide images of a sexual nature, sexual favors, or money. The perpetrator may also threaten to harm your friends or relatives by using information they have obtained from electronic devices unless you comply with their demands.



In this regard, Andaman and Nicobar Police has issued the following advisory to safeguard the citizens against online Catphishing: ♦ Never share any compromising images, posts, videos of yourself to anyone, no matter who they are. ♦ Never pick up any calls/video calls from anonymous number. ♦ Turn off your electronic devices and web cameras when you are not using them. ♦ Use two factor authentication with strong passwords and different passwords for different social media accounts. ♦ Enable privacy and security features in all

your social media accounts. ♦ Do not suffer in silence, know that you are not alone, reach out and seek help from trusted family and friends. ♦ Avoid browsing the suspicious websites and websites fully which are not aware. ♦ On social media or dating platforms, be cautious of unknown users who try to move the conversation to another interactive platform very quickly. 

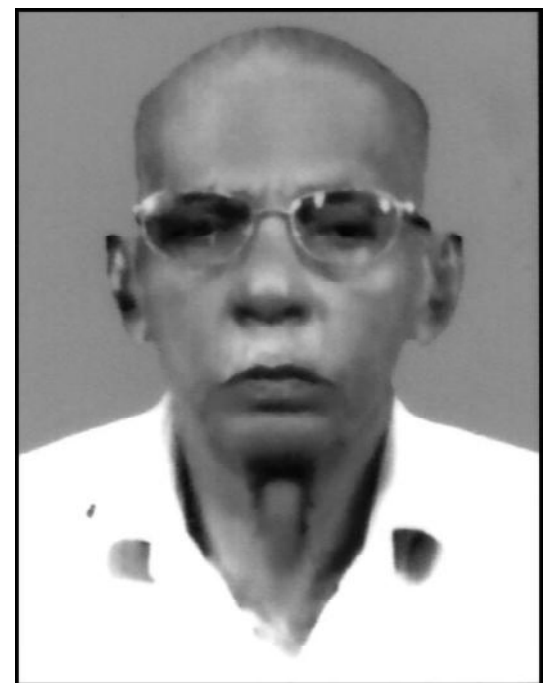
