PMEGP Scheme -a platform for setting up self employment ventures

ANIKVIB & DIC forwarded 436 loan proposals to financing banks; Bank sanctions loans to 259 cases/proposals during FY 2023-24 so far

Port Blair, Dec.25

The aim of the Prime Minister's Employment Generation Programme (PMEGP) aimed to create employment opportunities for youth by assisting them in setting up of micro enterprises in non-farm sectors has become a boon for the youth of these Island. Launched on 15th August, 2008 to give power to the first generation entrepreneurs to create micro enterprises, PMEGP is a credit-linked subsidy programme offered by the Ministry of Micro, Small and Medium Enterprises, Government of India. Khadi and Village Industries Commission (KVIC), is the nodal agency at national level for implementation of the scheme in A&N Islands. At state level the scheme is put into practice through KVIC, KVIB and

District Industries centre.

By availing PMEGP scheme, many unemployed/ under employed youth has been benefited through setting up self-employment ventures at their respective places throughout the A&N Islands. With an objective to generate continuous and sustainable employment opportunities in Rural and Urban areas, the Prime Minister's Employment Generation Programme (PMEGP) has served as an important tool for employment generation in the Islands. A lot of people from A&N Islands have embraced the scheme, making it the most viable option for earning livelihood. They have also established themselves as proud employers thus paving way for

employment generation.

In order to simplify the process under the scheme, the Ministry of MSME, GoI has discontinued the system of selection of beneficiaries and recommendations of proposals / applications by the DLTF to streamline the process of selection and expedite the flow of applications under PMEGP scheme. Accordingly, the Programme Implementing Agencies viz. ANIKVIB & DIC are forwarding applications directly to the financing banks for credit decision after preliminary scrutiny and examining the personal and factual details mentioned in the application including project report etc.

Apart from this, to mobilize more and more youth to become Atmanirbhar, the

Industries Department under the

guidance of Secretary (Industries) is taking various steps including disseminating information on PMEGP and ventures available under the programme at PRI level. Awareness campaigns and People's Education programmes on PMEGP scheme are organized at different Islands through which the first generation entrepreneurs were appraised about the benefits available under PMEGP scheme. Interested beneficiaries were guided for preparation of project report and online submission of loan proposals under the captioned scheme.

During the current financial year 2023-24, the Programme Implementing Agencies viz. ANIKVIB & DIC have forwarded 436 loan

proposals directly to the financing banks, out of which, 259 cases/proposals have been sanctioned by Banks so far. Under this scheme, 231 beneficiaries have been provided EDP training through 'Udyami Portal'.

Health Care Facilities in Isles urged to strictly comply with Bio-Medical Waste Management Rules

Port Blair, Dec. 25

The Health Care Facilities in Andaman & Nicobar Islands have been urged to ensure strict compliance of Biomedical Waste Management Rule, 2016. Under schedule-II of Biomedical Waste Management (BMWM) Rules, 2016 as amended thereof, all the Government and Private Healthcare facilities need to ensure the implementation of Rules as well as the strict compliance with respect to the following points:

> Installation of Online Continuous Emission Monitoring System (OCEMS) by Health Care facilities having captive treatment facilities-incinerators and transmission of real time data to CPCB server.
> Existing deep burials pits should be authorized as per BMWM Rules, 2016 and designed in line with standards prescribed under Sr. No. 5 Schedule-II of BMWM

Rules, 2016.

> The standards for liquid waste prescribed under Biomedical Waste Management Rules 2016 and its amendments to be compiled by Health Care Facilities:
a) The limits mentioned under Schedule II of Biomedical Waste Management Rules, 2016 are applicable to the occupiers of Health Care Facilities (bedded) which are either connected with sewerage network without terminal sewage treatment plant or not connected to public sewers: HCFs required to comply with limits under Schedule II at S.No.08 (CPCB guidelines for Management of Healthcare Waste as per BMWM Rules, 2016 may be referred).
b) For discharge into public sewers with terminal facilities, the general standards as notified under the Environment (Protection) Act, 1986 (29

of 1986) shall be applicable: HCFs required to comply with general discharge standards for public sewers.

c) HCFs having less than ten beds shall comply with the output discharge standards for liquid waste as mentioned under Schedule II at S.No.8.
d) Non-bedded occupiers shall dispose infectious liquid wastes only after treatment by disinfection as per Schedule-II (6) of the principal rules: CPCB guidelines may be referred.

All the Health Care Facilities in Andaman and Nicobar Islands have therefore been requested to ensure strict compliance of the stipulated conditions under BMWM Rules, 2016. The guidelines are available in the link: https://cpcb.nic.in/uploads/Projects/Bio-Medical-Waste/Guidelines_healthcare_June_2018.pdf, a press release from ANPCC said.
