# Bharat believes in respecting the boundaries and fostering a rule based maritime order: VP

India's maritime strength will be critical to our aim of Viksit Bharat@2047

Visakhapatnam, Feb. 22 (PIB)

The Vice-President, Shri Jagdeep Dhankhar today cautioned that unilateral actions and disregard for international law at sea can have farreaching consequences, jeopardizing the stability and security of the entire region. He further remarked that, "if not well contained in time, it can go beyond regional disputes." Addressing the **Indian Maritime Seminar** (MILAN 2024) organised by Indian Navy in Visakhapatnam today, Shri Dhankhar highlighted that challenge to the rule based order is at peak at the moment and described

potential to endanger peace, not and to speak of unsettling supply chains," VP said while mentioning the cascading impact of such supply chain disruptions on the lives of ordinary people.

Emphasising global dependence on the seas for trade and commerce, VP underlined the need for observance of maritime order terming it quintessential to peace and menacing harmony of the region as also for international law, including the having maintenance of supply chains UNCLOS, is imperative,

economic Protection of global supply chains, avoiding deeper regional tensions and exploitation of the blue economy are global concerns that can no longer be ignored, he added.

Stating that Bharat recognizes the significance of respecting the boundaries and fostering a rule based maritime order, VP said, "We believe that unscrupulous adherence to

essential and the only way for the peaceful coexistence sustainable maritime resources." In the present times, the Vice President observed that this aspect is severely strained and compromised.

# Major milestone achieved in Instrument Landing System operationalization at VSI Airport

IFR will enable flight operations at night and in bad weather condition

Port Blair, Feb. 22

The Civil Aviation in Andaman & Nicobar Islands today has achieved a major milestone in making veer Savarkai International Airport Instrument Landing System (ILS) ready. The draft ILS procedures have been successfully validated by Vistara flight UK 747 from



Kolkata to Port Blair under the leadership of Captain Ishar Singh and First Officer Mohammad Saifullah which landed at 11.27 am today. The Instrument Landing System (ILS) is a precision radio navigation system that provides short-range guidance to aircraft to allow them to approach a runway at night or in bad weather. Now, VSI is one step away from operationalization of ILS. These procedures are to be published in AIP (Aeronautical Information Publication). After the publication of procedures in AIP, the flight rules of VSI Airport will be switched from VFR (Visual Flight Rule) to IFR (Instrument Flight Rule). IFR will enable the flight operations at night and in bad weather condition.

The Airport Director, Shri Devender Yadav stated that the work is progressing on mission mode to operationalize ILS and switch to IFR as soon as possible. This switch will be a game changer for Civil Aviation in




