enhancement of infrastructure to support community functions for the wellbeing of nearby residents. Further, Secretary directed to install lights to facilitate nighttime sports activities, thereby raising youth engagement. This initiative aims to create a safer environment, discouraging illegal activities and providing constructive alternatives for the youth in the community.

The Secretary also visited Garacharama school ground. Plans are advancing for the implementation of an open-air gym and recreational areas through the ongoing AMRUT project. The Ward Councillor put forth the idea of developing a fish vending platform and the Secretary expressed the desire in examining its feasibility through consultation with the Fisheries Department. Pending a positive feasibility assessment, the proposed project will be initiated. Meanwhile, during the inspection of the Burning Ghat, Secretary highlighted the critical importance of quickly completing the fencing work, emphasizing its urgency for the overall wellbeing of the community. In the Attam Pahar area, citizens expressed their desire for installation of a statue of Birsa Munda. Secretary assured a thorough examination of the feasibility of installing the statue in the available space.

The Department of Posts will affix a special cancellation stamp (bearing voter education messages) on the postal articles.

Despite successfully managing and conducting elections by the Election Commission over the years in fair and peaceful way along with a significant increase in participation of the electors, there is also a concern that around 30 crore electors (out of 91 crore), did not cast their votes in General Election to Lok Sabha 2019. The voting percentage was 67.4%, which the Commission has taken as a challenge to improve upon.

This collaboration with IBA and Department of Posts, signifies a significant step towards strengthening democracy by empowering citizens with knowledge and awareness about their electoral rights and responsibilities. Through concerted efforts, both organizations are committed to fostering a culture of informed and active participation in the electoral process, a press note issued by ECI said.




