Centre proposes self-regulatory mechanism, mandatory players verification for online gaming companies

New Delhi, Jan. 2

Centre has proposed a self-regulatory mechanism, mandatory verification of players, and physical Indian address for online gaming companies.

It has released the draft of online gaming rules. Online gaming

companies will be covered under the new IT rules 2021 for social media platforms.

Online gaming platforms are expected to comply with the laws of the land, including any such law that relates to gambling. The draft rules envisage that an

online gaming intermediary will observe the due diligence required under the rules.

It includes reasonable efforts to cause its users not to host, display, upload, publish and share an online game not in

Pradhan Mantri Suraksha Bima Yojana

1,01,231 persons insured under the scheme in A&N Islands; 12 claims settled so far

Port Blair, Jan. 2

Pradhan Mantri Suraksha Bima Yojana (PMSBY) is one of the three social security schemes that the Government of India introduced in the 2015 budget speech. Launched in May 2015, it is an accident insurance scheme that covers people aged between 18 years and 70 years against death, total disability, and partial disability. The scheme is available for the people in the age group of 18 to 70 years with a bank account who give their consent to join / enable auto-debit on or before 31st May for the coverage period from 1st June to 31st

May on an annual renewal basis. Aadhaar would be the primary KYC for the bank account.

Pradhan Mantri Suraksha Bima Yojana covers the policy holders against the health care expenses i.e. a benefit of Rs. 2 lakh given to the nominee in case of an accident leading to the death of the policy holder, a benefit of Rs. 2 lakh is provided in case of permanent total disability and benefit of Rs. 1 lakh is provided in case of permanent partial

disability. In A&N Islands, 101231 persons have availed this accident insurance scheme as on Dec.7, last year. So far, 12 claims have been settled and a sum of Rs. 24 lakh has been disbursed while two claims are in process, under this scheme.

As per the scheme, a premium of Rs. 20 per annum is to be deducted from the account holder's bank account through 'auto-debit' facility in one installment. The scheme is being

offered by Public Sector General Insurance Companies or any other General Insurance Company who are willing to offer the product on similar terms with necessary approvals and tie up with banks for this purpose.

The PMSBY policy is ideally a financial aid for economically backward families. It provides adequate health insurance coverage to the insured in case of their death or disability due to accident(s).

One can avail the policy by paying a nominal amount of Rs.20 and the policy's beneficiaries will

Pradhan Mantri Kisan Samman Nidhi Scheme effectively being implemented in A & N Islands

Farmers urged to use only official website of PM-KISAN portal for e-KYC authentication

Port Blair, Jan 2

The Department of Agriculture is implementing Pradhan Mantri Kisan Samman Nidhi Scheme in A & N Islands. The Department in coordination with the PRIs are working in tandem in all the Zones of A&N Islands continuously from the day of launch of the scheme for its better reach to the farmers.

To make the integrated platform available in the country to assist in benefit transfer, a platform named PM-KISAN Portal was launched for uploading the farmers'

details at a single web portal in a uniform structure. Accordingly, a facility is provided in PM-KISAN portal in which any grievances related to PM-KISAN scheme can be submitted. The Department of Agriculture has requested the farmers to submit their grievances in PM-KISAN Portal/Mobile App and they can also contact the respective Agriculture Extension staff/Agriculture Office.

It is to mention that there are various factors owing to which, a farmer does not receive the benefit of PM-KISAN. The

main reason being mismatch in the spelling of the name in the bank account and the name entered on the Aadhaar Card due to which farmers fail to get the money. To facilitate farmers, the Govt. of India has decided to undertake e-KYC verification of all the eligible registered farmer-beneficiaries of PM-KISAN Scheme for smooth transfer of benefits.

The e-KYC authentication of the beneficiaries can be done by both e-KYC OTP mode as well as e-KYC biometric mode. The e-KYC authentication of the beneficiaries through

OTP mode can be done on PM-KISAN portal, free of cost by the beneficiaries or State functionaries. For e-KYC biometric authentication facility, the beneficiary may visit the nearest CSC. The CSC will charge for bio-metric authentication from each beneficiary. For any query/doubt related to e-KYC, the beneficiaries can also contact the concerned Zonal Agriculture Office/ Field functionaries of Agriculture Department.

receive the death benefit after the insured's unfortunate demise in an accident. The health insurance premium amount is auto-debited from the linked savings bank account and applicants can choose between a long-term policy or an annually renewable plan as per convenience.

This health insurance policy offers accidental insurance cover without spending huge money. Apart from this, the policy provides financial aid to the dependents, if the insured dies in an accident. With the auto-debit option, the insured no longer has to worry about missing the premium due dates. The policy offers secure processing and continuous coverage and the insured gets the flexibility to either continue or discontinue the plan as per their wish. The premiums paid towards the plan can be claimed for tax deductions under Section 80C of the old income tax regime. Sum of upto to Rs.1 lakh received by the beneficiaries is non-taxable under Section 10(10D) of the Income Tax Act, 1961.

PM-KISAN portal and not to download any other App for e-KYC authentication.

As per the guidelines of the scheme, the following categories of beneficiaries of higher economic status are not eligible for benefit under the scheme:

(a) All Institutional Land holders.

(b) Farmer families in which one or more of its members belong to following categories :

➤ Former and present holders of constitutional posts.

➤ Former and present Ministers/ State Ministers and former/present Members of Lok Sabha/ Rajya Sabha/ State Legislative Assemblies/ State Legislative Councils, former and present Mayors of Municipal Corporations, former and present Chairpersons of District Panchayats.

➤ All serving or retired officers and employees of Central/ State Government Ministries /Offices/Departments and its field units Central or State PSEs and Attached Offices /Autonomous Institutions under Government as well as regular employees of the Local Bodies (Excluding Multi Tasking Staff / Class IV/Group D employees).

➤ All superannuated/retired pensioners whose monthly pension is Rs.10,000/-or more(Excluding Multi Tasking Staff / Class IV/Group D employees) of above category b (3)).

➤ All Persons who paid Income Tax in last assessment year.

➤ Professionals like Doctors, Engineers, Lawyers, Chartered Accountants, and Architects registered with Professional bodies and carrying out profession by undertaking practices, a press release from Agriculture Deptt. said.

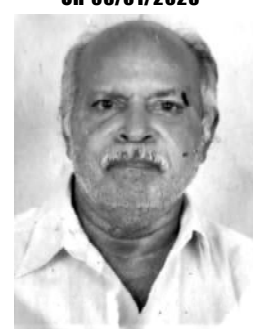
