

organization extracting water above 10 KLD has to obtain No Objection Certificate from exempt category status from CGWA. Every Commercial and Industrial organization extracting water must install the Tamper Proof Digital Water Meter.

It was decided that all hotels and other such organizations must get the NOCs or exemption status before 31st January, 2024.

It was also reiterated that all bulk water suppliers must adhere to CGWA guidelines, otherwise strict penalties would be imposed as per law, a press release from SDM (SA) said.


