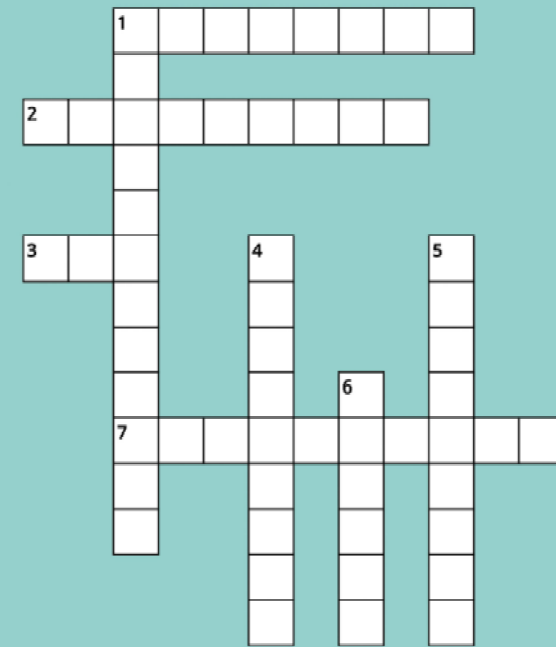
The PMJAY eligible beneficiaries can also create the PMJAY Card by registering themselves in the web portal and the procedure of self registration is as follows:

- ◆ Go to the official PMJAY website: <https://pmjay.gov.in>
- ◆ Click on the Am I Eligible tab.
- ◆ Enter your mobile number, CAPTCHA code, and click Generate OTP.
- ◆ Enter your state and your name, Ration Card number, household number, or mobile number.
- ◆ Eligible beneficiaries can fill out the registration form, upload the necessary documents, and complete the process.

All PMJAY beneficiaries are entitled for cashless treatment worth Rs. 5 lakh per family per year at empanelled hospitals across the country in case of secondary and tertiary care hospitalization.
