Indemnity to all beneficiaries of sterilization, doctors & health facilities through Family Planning Indemnity Scheme

Port Blair, Jan. 19 is a continuing concern about the number of adverse events following sterilization as well as litigations faced by the facilities/doctors against such cases. To mitigate this, the Government of India introduced the National Family Planning Insurance

Scheme which was later modified as Family Planning Indemnity Scheme (FPIS), now operational through State NHM Program Implementation Plan instead of private sector insurance company. The objective of the Family Planning Indemnity Scheme is to indemnify all

beneficiaries of sterilization, doctors and health facilities (public and accredited private/NGO) conducting sterilization operation in the unlikely event of death/failure/complication following sterilization operation.

views about road safety in the UT in past & present, Shri Sebastin, Retd. DySP urged everyone to follow traffic rules & regulations. He said, timely servicing of the vehicles, avoiding walking in groups on roads and not allowing children below 18 years to drive vehicles have to be followed, among other things, to avoid road accidents.

Speaking on the topic road safety from children's perspective, the Resource Person, NCPDR, Ms. Rubina Siddiqui enlightened the gathering about school transport especially school buses and the safety norms attached to it. While highlighting the importance of First Aid Boxes, she said, every school transport & public transport should be equipped with first aid boxes, which are very essential and helps in providing First Aid on the spot during accidents.

In his address on the occasion, Representative of Federation of Automobile Dealers Association, Shri Sagar Khurana informed about the technology advancements in vehicles and regular addition of safety features in vehicles for the safety of travelers. He urged to follow road safety protocols while driving for our safety as well as the safety of others.

In his address, CMO, NFSG, Dr. Amitabh De while enlightening the gathering in detail about first respondent/ first aid & Trauma Care, said a person who comes to help a road accident sufferer and takes him to hospital is the first responder. He informed about the golden hour in which the life of accident sufferers can be saved if, they are brought to hospital within one hour after the occurrence of the accident.


An on the spot slogan writing competition was organized in which more than 70 persons participated. The slogan written by Afra Khatoon was adjudged first and she got a cash prize of Rs. 2000. Lata Das who stood second received a cash prize of Rs. 1500 while Afreen Shafi who secured third position was awarded a cash prize of Rs.1000.
