Interview of Secretary (CS&CA) broadcast through Akashvani

Secretary outlines the steps taken to strengthen Public Distribution System in ensuring food security to Islanders

Port Blair, July 7

The Chief Secretary, A&N Administration, Shri Keshav Chandra, IAS has directed all Secretaries of the Departments concerned to give interviews in Akashvani Port Blair and Doordarshan (DD) and highlight the initiatives taken by the Departments involved in public delivery services to improve public delivery system, social infrastructure and social benefit schemes. The interview of Secretary (CS&CA), Ms Ranjana Deswal, IAS was broadcast through Akashvani Port Blair and the same is being reproduced in Q&A format for the wider reach of the people of A&N Islands.

Interviewer: Kindly brief about the functions and objectives of the Department of Civil Supplies & Consumer Affairs.

Secretary (CS&CA): The Directorate of Civil Supplies & Consumer Affairs earlier called Supply Office was functioning under the Deputy Commissioner, South Andaman. The Department has been in existence in this UT prior to independence of India. In those days, foodgrains were imported from mainland to these Islands by the British Administration. Since inception, the Department has been catering to the food requirement of the natives covering the remotest part of the UT. Interviewer: What is Universal Public Distribution System?

Secretary (CS&CA): The UT of Andaman & Nicobar Islands is a food deficit area in terms of production of foodgrains. As such, to ensure food security to all the islanders, A&N Administration has introduced Universal Public Distribution System in the UT and every Islander is covered under the ambit of Public Distribution System, making them eligible for obtaining foodgrains through rationing system at a highly subsidized rate. Interviewer: What are the challenges met by your Department in implementation of PDS in this UT:

Secretary (CS&CA): Although this UT is small in terms of size and population, its peculiar location about 1200 KM away from mainland, scattered from North to South for more than 750 KM, volatile climatic conditions and difficult accessibility, the implementation of PDS is most challenging. Despite the challenges, the Department has been able to ensure food security to all the islanders throughout the year by maintaining three months buffer stock of PDS items in every nook and corner of A&N Islands. Till date, no case of death due to hunger has been reported/noticed in this UT, even in adverse situation

Interviewer: What is National Food Security Act, 2013, when was it implemented in this UT and how many beneficiaries are covered under the Act?

Secretary (CS&CA): National Food Security Act, 2013 was implemented in the UT from 1st March, 2016. The main objective of this Act is to provide nutritional security to every economically backward households by providing rice and wheat absolutely free of cost to about 61,000 identified eligible beneficiaries throughout A&N Islands. Along with this, the NFSA beneficiaries are also provided with one kg sugar per family per month @ Rs. 15/- per kg to every AAY card holders and @ Rs. 30/- per kg to every PHH card holders. Apart from this, considering the Islands being a minimal food producing area and is totally dependent on mainland to cater to its need, Universal Public Distribution System is in place covering almost the entire population under APL category as approved by the Govt. of India.

Interviewer: What is the scale of distribution of foodgrains and sugar under NFSA in the UT?

Secretary (CS&CA): There are three types of ration card holders in A&N Islands. The first is Antyodaya Anna Yojana (AAY) card holders under which, 31 kg rice and 4 kg wheat per household per month are provided. However, in the tribal belt of Car Nicobar and Nancowrie, 35 kg rice per household is given to the members of the AAY households. The number of ration card holders under AAY is 3562 and the number of beneficiaries is 12,362. The second is Priority Household (PHH) card holders under which, 4 kg rice and 1 kg wheat per person per month are given to the beneficiaries. However, in the tribal belt of Car Nicobar and Nancowrie, 5 kg rice is given to the members of the Priority Households. The number of ration card holders under PHH is 12.745 and the number of beneficiaries covered under PHH are 46,484. Every AAY & PHH households are entitled for 1 kg sugar per month @ Rs. 15/- per kg and Rs. 30/per kg respectively. The third is Above Poverty Line (APL) card holders, under which, 4.5 kg rice is provided to adults & 2.5 kg rice is provided to child per person per month. Apart from this, 8 kg of wheat per household up to three members & 12 kg per household per month are also provided. The number of card holders under APL is 92,840 and the total number of beneficiaries is 3,07,865.

Interviewer: What are the steps taken to monitor pilferage/ diversion of PDS foodgrains?

Secretary (CS&CA): Foodgrain is distributed in the entire UT through a network of 415 Fair Price Shops to the ration card holders through automated PoS device. Out of these, 404 FPS are having internet connectivity which facilitate in distributing PDS foodgrains through Aadhaar Authentication with real time data while 11 FPS are functioning at very remote locations without net connectivity. The foodgrains are issued through PIN based ePOS machine. However, the Department is continuously making persistent efforts to make these 11 FPS

Interviewer: What facilities are being provided to those ration card holders who are unable to approach the FPS?

Secretary (CS&CA): For those ration card holders who are unable to reach the Fair Price Shops for collecting their entitlement of foodgrains due to old age, bed ridden, chronically ill, specially challenged etc. they are given special dispensation to authorize either any of the two relatives or friends to receive their entitled foodgrains after mapping of their Aadhaar Card with Ration Card who comes under the special category household.

Interviewer: What is the benefit of One Nation One Ration Card (ONORC)?

The Hon'ble Lt. Governor (Administrator), A&N Islands in exercise of powers conferred under Section 5 of the Minimum Wages Act, 1948 read with Notification No.LP24 (1) dated the 16th March, 1949 of the Govt. of India, Ministry of Labour has revised the Minimum Rates of Wages w.e.f. 01.07.2023 across Six Schedules of Employments in A&N Islands. The revision has been done taking into account the Average All India Consumer Price Index from the period October, 2022 to March, 2023. Accordingly, the new rate of wages will be as follows:

Interview of Secretary (CS&CA) broadcast through Akashvani... (Contd. from page 1)

Secretary (CS&CA): It is a milestone achievement of the Govt. of India to implement ONORC throughout the entire country with the facility of drawing highly subsidized PDS foodgrains by NFSA beneficiaries as per the entitlement from anywhere in the country. This scheme has been launched in A&N Islands from the year 2021. Under this scheme, labourers and workers who migrate from one place to another can avail PDS items from Fair Price Shops of any State or UT. At present, there are 21,661 beneficiaries in A&N Islands under this scheme. This ONORC scheme has become a boon to migrant labourers ensuring their food security.

Interviewer: How many LPG consumers are there in this UT and what mechanism has been adopted for supplying LPG cylinders in this UT?

Secretary (CS&CA): A&N Islands was declared kerosene free from 1st September, 2019. At present, there are more than 1,21,000 LPG consumers. IOCL is the only oil marketing company for distribution of LPG in this UT through their authorized LPG distributors. The Department of CS&CA is the monitoring agency on behalf of the Administration to ensure regular and adequate supply of LPG to safeguard the interest of the consumers. Presently, in South Andaman, there are four LPG distributors and one more distributor has started distributing LPG in Bambooflat area. In North & Middle Andaman, presently there are two distributors and one more distributor will be added for distributing LPG at Mayabunder. In Nicobar district, one distributor is operating in Nancowry group of Islands. Apart from this, in Campbell Bay, Car Nicobar, Little Andaman, Swaraj Dweep, Shaheed Dweep and Mayabunder presently extension counters of LPG are being operated by CCS Limited to cover all the population under LPG network.

Interviewer: What are the steps taken to facilitate consumers for booking LPG?

Secretary (CS&CA): The Administration has asked IOCL to onboard all the LPG consumers under online booking mode of LPG cylinders. Accordingly, the LPG consumers of Municipal area can avail the booking by making a Missed Call to 8454955555 from their registered mobile number. Apart from this, the LPG consumers can book the LPG through Indian Oil Portal (Indian Oil One) and also avail online booking facility through other easily available online portal (e.g. Paytm, Phonepay, Google Pay and Amazon Pay etc.). The Department has also asked distributors to keep weighing machine in all delivery vehicles to facilitate LPG consumer to check the prescribed weight of the LPG as denoted in the cylinder.

Interviewer: Kindly explain about Pradhan Mantri Ujiwala Yojana (PMUY). Secretary (CS&CA): PMUY is a flagship program implemented by the Govt. of India. Under this scheme, the elderly women of those families identified under socially & economically backward community are provided subsidy to obtain new LPG connection, which is a clean, healthy and environment friendly cooking fuel. As on date, in A&N Islands, 12,940 households have been benefitted under this scheme. The beneficiaries are issued one LPG cylinder, one hose pipe and cooking stove on loan basis with adjustment from the subsidy provided to the LPG consumers till recovery of the exact amount of the stove.

Interviewer: Where can one make Aadhaar Card?

Secretary (CS&CA): The Department of Civil Supplies & Consumer Affairs has been declared as the Nodal Agency/State Registrar for the UT pertaining to Aadhaar enrollment. This Department has setup permanent Enrollment Centres at the Directorate of Civil Supplies and Consumer Affairs, Supply Line and its Offices at Rangat, Mayabunder, Diglipur and Car Nicobar. The Department is also in the process of establishing Permanent Enrollment Centres at Campbell Bay and Little Andaman for ease to the aspirants for Aadhaar enrollment or updation. Apart from this, the stakeholder Departments are also engaged i.e. Registrar of Births and Deaths for Aadhaar enrollment of infants, Education Department to facilitate school going children ranging in the age of 5 to 15, Social Welfare Department for enrolling at Anganwadi Centres & old age individuals. Further, the Department along with Post Office, BSNL and certain nationalized banks also provides the facility of Aadhaar services. As a gesture in accordance with 'Sarkar Aapke Dwar', these Departments organize regular Aadhaar camps to provide services at the doorsteps.

Interviewer: What is fortified rice and its benefit?

ecretary (CS&CA): The rice is being enriched with essential micronutrients in the form of fortified granules premixed with the normal rice in the ratio of 1:100 to ensure nutritional security amongst the PDS beneficiaries, especially pregnant ladies, lactating mothers, children etc. as per FSSAI norms framed by the Govt. of India.

In this regard, the Department has received few complaints regarding blending of plastic rice with PDS rice. Since this being a serious matter, the Department collected random samples from different areas and got it tested from NABL laboratories through Food Safety Department which revealed that it does not contain any plastic rice. This myth has been created in the mind of the beneficiaries due to its slight discolouration in appearance and floating of fortified rice granules in water which occurs due to density variation. The fortified rice is totally safe and free from any adulteration. Interviewer: What are the duties and responsibilities of the Legal Metrology

Secretary (CS&CA): The Legal Metrology Department implements all the rules such as the Legal Metrology (Package Commodities) Rule, 2011, the A&N Islands enforce rule 2011 etc. framed under the Legal Metrology Act 2009. The main objective is to verify and calibrate all the weighing and measuring instruments used for commercial purpose for its correctness to safeguard the interest of public. The Department also enforced the relevant rules in the Union Territory to avoid any unfair trade practices.

Interviewer: What is the role of Consumer Commission? How many Consumer Commissions are functioning in these Islands?

Secretary (CS&CA): For redressal, the aggrieved consumers can approach the Consumer Commission in person or through eDakhil from any location and can also avail the services from Common Service Centres (CSCs). Apart from this, for redressal of grievances, one District Commission is functioning in the High Court Complex and State Consumer Commission in Deptt. of CS&CA complex.

Screening, Dental Check up and Ayurveda treatment was also provided to the beneficiaries / villagers. A total of 84 villagers, including 22 school students attended the health camp. During the camp, 4 Cataract cases and 11 cases of refractive error were detected under eye screening. 66 cases were screened by Dental Surgeon for oral hygiene. 24 cases were treated for their ailments by MO Ayurveda, 40 Cases of hypertension and 4 cases of diabetes were also examined and provided treatment by the SMO, IAF.

Shri Hari Kallikkat, IAS, Deputy Commissioner (Nicobar District) also paid a visit to the camp and expressed happiness on the conduct of such activities benefitting the needy local villagers. "1. Short Title and Commencement: -

(i) These Rules may be called as Andaman and Nicobar Islands Consumer Protection (Amendment) Rules, 2023.

(ii) They shall come into force from the date of its publication in the Official Gazette. 2. Sub-rule (4) of Rule 12 of the Andaman and Nicobar Islands Consumer Protection Rules 2021 (hereinafter called Principal Rules) published vide notification No.77/2021/F.No.1-6/SC/

ANI/Rule/2021/1097 dated 25.08.2021 shall be substituted and reads as under :-"(4) Pending creation or sanction of regular posts, the President of District Commission shall receive a consolidated remuneration of Rupees Two lakhs per month subject to deductions of the amount of gross monthly pension so received by him/her from the gross amount of monthly pay and allowances payable to him/her.

Each of the Members of District Commission shall receive consolidated remuneration of rupees forty thousand as a stopgap arrangement.

In the event of selection of a Pensioner as member of the District Commission the salary of that member shall be fixed as Rs. 1,00,000/- subject to deduction of the amount of gross monthly pension so received by him/her from the gross amount of monthly pay and allowances payable to him/her. The maximum payable amount after deduction of gross monthly pension shall not be above 40000/-

In the event of the creation of regular posts of the President and Members of the District Commission in accordance with new Rules, the President and Members so appointed under the new Rules shall get their respective salary in terms of sub-rules (1), (2) and (3) of rule 12 subject to reduction as contemplated under sub-rule (5). The aforesaid amount of salary of the President and Members of District Commission on regular pay structure shall only be released in case of appointment on regular basis against sanctioned posts under due process of selection and appointment.

Provided that the Registrar of the High Court, Calcutta, Circuit Bench at Port Blair shall continue to function as President, District Commission in addition to his own substantive function till the appointment of the post of President on a regular basis as per extant Rules or appointment of an appropriate incumbent on contract basis. 
