Chairman, Rajya Sabha brings gender parity, nominates fifty percent women members to the panel of Vice-Chairpersons

All four women in the panel are first time members of Rajya Sabha

New Delhi, July 20 (PIB)

In a historic move, Chairman, Rajya Sabha, Shri Jagdeep Dhankhar has nominated four women Parliamentarians to the panel of Vice-Chairpersons. The women Members nominated to the panel of Vice-Chairpersons are Smt. P.T. Usha, Smt. S. Phangnon Konyak, Dr. Fauzia Khan and

Smt. Sulata Deo.

It is also noteworthy that all women members nominated to the panel are first term Parliamentarians and Smt. S. Phangnon Konyak is the first ever woman from Nagaland to be elected as a member of the Rajya Sabha.

The panel reconstituted before the Monsoon Session contains a total of eight names, out of

which half are women. This is the first time in the history of the Upper House that equal representation has been given to women members in the panel of Vice-Chairpersons. Apart from the aforementioned women members, Shri V Vijayasai Reddy, Shri Ghanshyam Tiwari, Dr. L. Hanumanthaiah and Shri Sukhendu Sekhar Ray have also

been nominated to the panel of Vice-Chairpersons.

In another notable development, the Rajya Sabha Chair has become fully digital. The Rajya Sabha Chair will be using electronic tablets for matters related to the conduct of business in the House, attendance in the House, details of Members speaking and other relevant information.

Department of Animal Husbandry & Dairying, Ministry of Fisheries, Animal Husbandry and Dairying is implementing the Credit Guarantee Scheme under Animal Husbandry Infrastructure Development Fund (AHIDF) to

strengthen credit delivery system and facilitate smooth flow of credit to the Micro, Small & Medium Enterprise (MSMEs) engaged in Livestock sector without hassles of collateral security. For operationalizing the scheme, DAHD has established a Credit Guarantee fund Trust of Rs.

750.00 crores, which will provide credit guarantee coverage up to 25% of the credit facilities extended to the MSMEs by the eligible lending institutions.

The credit guarantee scheme facilitates access to finance for un-served and under-served livestock sector,

making availability of financial assistance from lenders to mainly first-generation entrepreneurs and

The Health Minister said that food and health are connected to each other and therefore quality and nutrient-based food is essential for human health. He added that food safety is essential for ensuring good

health and the food regulators should have a wider approach towards the subject of food safety and food standard.

During the event, Dr Mandaviya also launched three Digital Platforms namely Food - O- Copoeia which is a

collection of food category-wise monographs, a Common Digital Dashboard, and SaNGRAH.

The general public, business entities and stakeholders of A&N Islands have been informed that due to construction of alternate land cable path, Segment-1 (Chennai - Port Blair link) of CANI Submarine Cable will be affected due to ongoing construction work of an underground Metro Station at the Chennai, Mandaveli junction by

CMRL (Chennai Metro Rail Limited).

Accordingly, the CANI Submarine of Cable Segment-1, (Chennai to Port Blair) will be temporary shutdown during the night hours of 29.07.2023 from 2000 hours (8 pm) to 30.07.2023 1000 hours (10 am), approximate downtime of 14 hours. All efforts will be made to minimize the downtime window to the least extent possible.

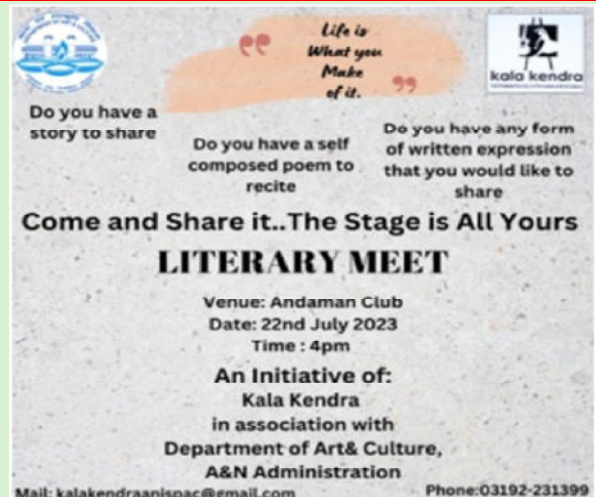

First ever 'Credit Guarantee Scheme' for Livestock Sector launched...

under privileged section of society, who lack collateral security for supporting their ventures.

The main objective of the Credit Guarantee Scheme is that the lender should give importance to project viability and secure the credit facility purely on the basis primary security of the assets financed. The establishment of credit guarantee fund trust was approved under the Prime Minister's AtmaNirbhar Bharat Abhiyan stimulus package of Rs.15000 crores "Animal Husbandry Infrastructure Development Fund" (AHIDF) for incentivizing investments by individual entrepreneurs, private companies, MSMEs, Farmers Producers Organizations (FPOs) and Section 8 companies to establish (i) the dairy processing and value addition infrastructure, (ii) meat processing and value addition infrastructure, (iii) Animal Feed Plant, (iv) Breed Improvement technology and Breed Multiplication Farm (v) Animal Waste to Wealth Management (Agri Waste Management) and (vi) Setting up of Veterinary Vaccine and Drugs Manufacturing facilities.

One of the key features of the AHIDF scheme is the establishment of a Credit Guarantee Fund Trust of Rs. 750.00 Crores. DAHD has formed a trust with NABSanrakshan Trustee Company Private Limited, a wholly owned subsidiary of NABARD for the establishment of a Credit Guarantee Fund Trust for extending the credit guarantee to Micro, Small & Medium Enterprises under AHIDF scheme. This fund trust established in March 2021 is the Nation's first ever fund trust under Credit guarantee scheme of AHIDF in the agriculture and Animal Husbandry sector and is a path-breaking initiative taken by DAHD which would exponentially increase the number of MSME units getting benefits of AHIDF scheme and strengthen the ecosystem for the collateral-free credit from the banks.

The credit guarantee portal has been developed as a rule based B2B portal and implemented the enrollment of eligible lending institutions under Credit Guarantee Scheme, issuance/renewal of Credit Guarantee Cover and Settlement of Claims.

Notably, the initiative of credit guarantee scheme taken by DAHD is expected to greatly increase the participation of MSMEs engaged in livestock sector leading to increased flow of credit to the sector and strengthen the MSMEs to boost the overall rural economy through strengthening the Livestock sector which is of one of the most potential sector seeking development.

* Loan up to 90% of the total project cost from any Scheduled Bank, National Cooperative Development Corporation (NCDC).

One more foreign poacher apprehended by N&M Andaman Police

Mayabunder, July 20

While on their way to search for foreign poachers in the mangroves and creek, where they were suspected to be hiding, on July 15, 2023, the anti-poaching team consisting of SI Dheeraj Kishen, HCs Khokan Ch. Das, Alaxander, Cts Rakesh Chander Rathore, Raj Kamal and PCs Elazier & P.K Mohd. Zunaid suddenly noticed some movement in the mangroves and the team got an alert from SI Dheeraj Kishen. The team then split into two and slowly moved towards them. One of the team reached very near to 1 poacher who was found hidden in a bush. As the team tried to capture him, the poacher reacting quickly, ran away but the team swiftly chased and apprehended him successfully.

Further, the team continued its search for more poachers and even after an extensive search in the dense

mangroves and in the creeks, no clue of more poachers were found.

One team along with 1 apprehended Myanmarese poacher reached OP Kishorinagar on July 17, 2023 from where he was transited to PS Kalighat for initial enquiry. The other team is still in jungle and continuing with its search operations to look for more of his accomplice. After conducting enquiry, the Myanmar Poacher was handed over to PS CCS for further investigation. The entire operation was carried out under supervision of Ms. G e e t a n j a l i Khandelwal, SP (D)

N&MA.

The exemplary bravery shown by the anti-poaching team has been lauded and they will be suitably rewarded.


