

efforts are on to create international level fishing eco system which will include development of big fishing harbor, deep sea going fishing vessels with professional workforce, fish processing units with advanced technology etc. Once the complete fishing ecosystem is ready, we shall be able to export fish to South East Asia as well as International markets and the islanders will also get best price for it.



The Chief Secretary further informed about the good market potential of spices of A&N Islands which have great demand among visitors/tourists. He said A&N Isles' produces best quality of cinnamon and there is need for proper packaging and branding of cinnamon and other spices for its sale not only in mainland but also in International markets. He further stated that the coconut produced in Carnicobar is of high quality. There is need for proper branding of virgin coconut oil for fetching better price.
