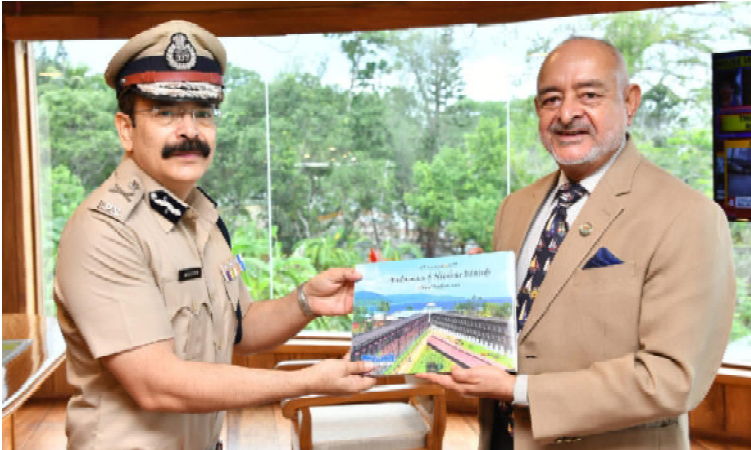

Intensified Diarrhoea Control Fortnight to commence in Isles from June 19

Port Blair, June 16

Reduction of childhood mortality to 23 per 1,000 live births by 2025 is one of the prime goals of National Health Policy 2019. Childhood diarrhoeal diseases continue to be a major killer among under-five children in many States. Diarrhoea is considered when the stools have changed from usual pattern with increase in frequency and change in consistency (more water than faecal matter). Almost all the deaths due to diarrhoea can be averted by preventing and treating dehydration by the use of ORS (Oral Rehydration Solution) and administration of Zinc tablets along with adequate nutritional intake by the child during diarrhoea. Diarrhoea can be prevented by exclusive and continued breastfeeding, timely introduction of appropriate



and safe complementary feeding, use of safe drinking water, hand-washing, sanitation and immunization.

Intensified Diarrhoea Control Fortnight (IDCF) will be observed from 19th June to 1st July, 2023 in this UT with the ultimate aim of 'Zero Child Deaths due to childhood diarrhoea. Intensified Diarrhoea Control Fortnight (IDCF) consists of a set of activities to be implemented in an intensified manner during IDCF 2023 for prevention and control of deaths due to dehydration from diarrhoea. These activities mainly include- intensification of advocacy & awareness generation activities for diarrhoea management,

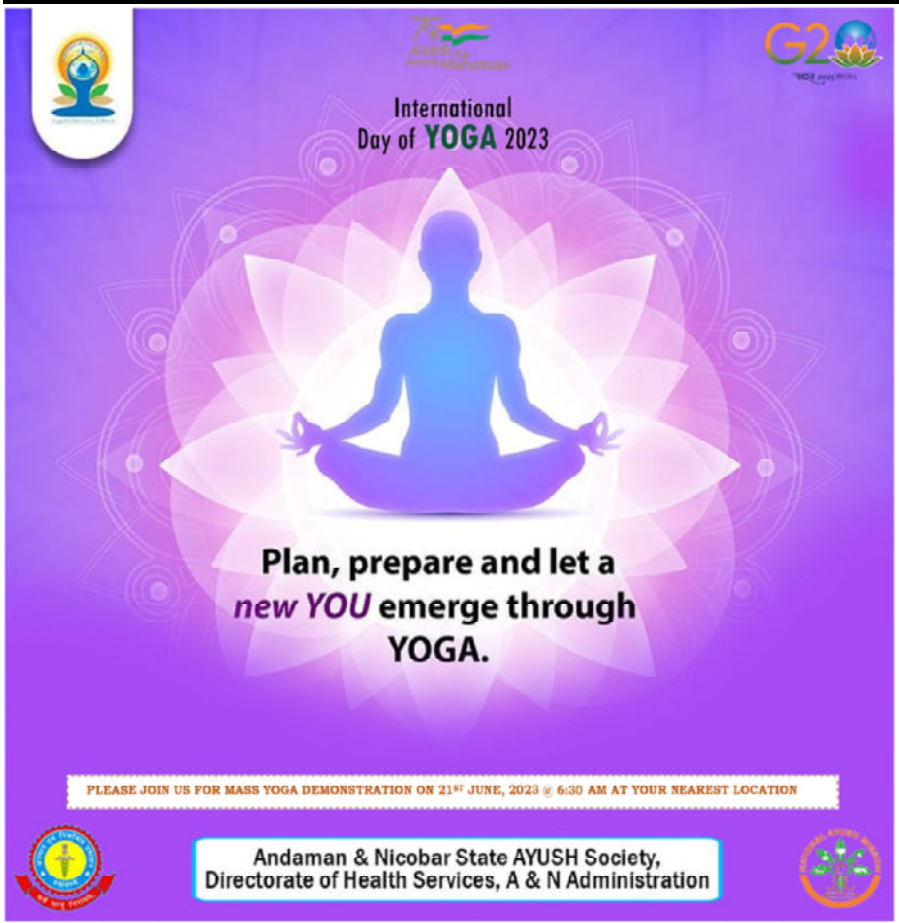

Sports Ministry increases upper ceiling norms of boarding & lodging for athletes and team officials by 66%

New Delhi, June 16 (PIB) The Ministry of Youth Affairs and Sports (MYAS) has revised the upper ceiling amount of boarding and lodging for Indian Athletes and team officials by 66%. This is for the athletes and officials participating only in international competitions, under the Ministry's Scheme of Assistance to National Sports Federations (NSFs). Under the newly revised norm, athletes and support staff travelling for approved competitions abroad (foreign exposures) will now be entitled to USD 250 per day, which is an increase of 66% from an earlier norm of USD 150 per day. The revision has been made taking into consideration the requests from NSFs, wherein they have mentioned that rates for boarding & lodging fixed by the Local Organizing Committee (LOC) of the competitions are higher than the existing ceiling of USD 150 per day. These norms for boarding & lodging were fixed way back in November 2015 and it has been eight years since the revision of the same had taken place. With the increase in the ceiling for boarding and lodging, the NSFs will be able to arrange reasonably better accommodations for athletes when competing and representing the country at various International Competitions. Further, as per recent trends, the Local Organizing Committees (LOC) of International Competitions are offering a complete hospitality package to the participating teams rather than merely boarding and lodging as was the case earlier. The package includes boarding, lodging, local transportation, and on some occasions entry fees as well. The total cost of the package is much above USD 150 per person per day. These considerations have necessitated review of boarding and lodging norms fixed in 2015.

The Physical Measurement & Endurance Test will not carry any marks but will be of qualifying nature. Those candidates who are declared not qualified in Physical Standards, i.e., height and chest may prefer an appeal, if they so desire, to the Appellate Authority. The decision of the Appellate Authority will be final and no further appeal or representation in this regard will be entertained. Candidates are essentially required to qualify in the Physical Measurement and Endurance test to be considered for further course of examination. Candidates are also advised to familiarize themselves regarding their Centre of Physical Measurement and Endurance Test, Application Number allotted, and other details given in Admit Card, well in advance. Candidates facing difficulties in downloading Admit Card due to slow internet speed or any other technical snags beyond the control of A&N Police, are advised to collect their Admit Card personally from Recruitment Cell, A&N Police Headquarters, Atlanta Point, Port Blair.
