India were all out for 571 in their first innings against Australia on day four of the final test of the Border-Gavaskar trophy in Ahmedabad. Virat Kohli hit a Test century in more than three years and narrowly missed the double ton, as he got out at the individual score of 186. Kohli had good support from Axar Patel, who scored 79 runs. They had the highest 162-



run partnership for hosts. Axar was also the third-highest scorer for India.

Earlier, Shubman Gill's sparkling century gave India a solid standing in the game. India resumed their first innings at the overnight score of 289 for 3 this morning.

Australia were 3 for no loss in their second innings, at stumps on day four. They scored 480 in their first innings.

intelligence. Shri Shah said that the Union Home Ministry will make all provisions to equip CISF with all the latest technologies to meet the future challenges by adopting state-of-the-art technologies for the security of ports, airports and industrial units. He said that the Home Ministry has already prepared an action plan in this regard.

Shri Amit Shah said that currently CISF is providing security to 66 sensitive and major airports, 14 major seaports, nuclear and space institutions, Delhi Metro, Statue of Unity and many industrial units and mines. He said that among CAPFs, CISF is the only force, which has an effective fire fighting force, and it has achieved accolades in the field of fire protection. Shri Shah said that while dealing with about 50 lakh commuters on Delhi Metro and Airport every day, CISF remains committed to the security of the nation's assets with righteous but firm conduct.

Shri Amit Shah said that today India has become a fast growing economy and it is our responsibility to keep the country's industrial institutions, mines, ports, airports safe. He said the protection and security has to be increased in the days to come. Shri Shah said that under the Ayushman CAPF scheme, the Union Government under the leadership of Prime Minister, Shri Narendra Modi has distributed more than 35 lakh Ayushman CAPF cards and has also made arrangements for cashless medical treatment for jawans and their families in about 24,000 hospitals across the country. He said that under the housing scheme also, we have set a target to increase the housing satisfaction ratio. The Union Home Minister said that a country, whose airports and ports are not secure, can never be secure. He said that there are many challenges before us today, such as counterfeit currency trade, infiltration and narcotics, and with a bright history, CISF has secured the country.

Whereas as per the section 25(RESTRICTIONS ON NEW OUTLETS AND NEW DISCHARGES) of Water (Prevention and Control of Pollution)Act, 1974, No person shall, without the previous consent of the State Board, establish or take any steps to establish any industry, operation or process, or any treatment and disposal system or an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land.

Whereas as per the section 21(RESTRICTIONS ON USE OF CERTAIN INDUSTRIAL PLANTS) of Air (Prevention and Control of Pollution) Act, 1981, subject to the provisions of this section, no person shall, without the previous consent of the State Board, establish or operate any industrial plant in an air pollution control area.

Whereas, it is the responsibility of the industrial unit to obtain Consent To Establish(CTE) from Andaman Nicobar Pollution Control Committee(ANPCC) before establishment of industry and also obtain Consent to Operate(CTO) after establishment of unit. Non compliance of this is the violation of the provisions made under Water (Prevention and Control of Pollution)Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986.

Whereas, it has come to the notice of ANPCC that the many of Industrial Units have been established without obtaining CTE and also started operating without CTO under the Water (Prevention and Control of Pollution)Act, 1974 and Air (Prevention and Control of Pollution)Act, 1981, which is a violation of the aforesaid rules.

Whereas, ANPCC has given an opportunity to such units by giving one time window to all such industrial establishment who have not obtained CTE before establishment by giving 60 days window from 07-10-2020 to 05-12-2020 for getting CTO from ANPCC. Even after the lapse of such period, ANPCC is still receiving applications for issue of CTO without having prior CTE.

Now, therefore the ANPCC in its XXVII meeting held on 18-01-2023 has decided to regulate all such industrial establishment who have not obtained CTE before establishment by giving 60 days window from 10-03-2023 to 10-05-2023 apply for getting CTO from ANPCC. However the CTO will be issued subject to fulfillment of environmental norms applicable to the industry.

Therefore, it is informed to all the stakeholders and general public that it is the statutory responsibility of all the industries to obtain CTE prior to establishment of any industry & CTO after establishment in Andaman and Nicobar Islands. The industrial unit/entrepreneur shall apply for CTE & CTO using the URL: www.anocmms.nic.in for the fulfillment of requirement made under Water (Prevention and Control of Pollution)Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986. Any industrial unit which fails to obtain CTO from ANPCC within the stipulated time shall be liable for action as the provisions of Environment (Protection) Act, 1986.

No Consent to Operate will be issued to any industry after lapse of 60 days(i.e30-04-2023)who have not obtained CTE before its establishment.


