India creates history by winning two Oscars

Song 'Naatu Naatu' from film RRR wins Best Original Song award; 'The Elephant Whisperers' bags Best Documentary Short Film award

Los Angeles, March 13
In 95th Academy Awards ceremony, India's 'Naatu Naatu' song from Shri SS Rajamouli's film RRR today made history by becoming the first Indian film to win an Oscar for best original song. Prime Minister, Shri Narendra Modi has expressed his delight at the country's achievements at the Oscars in Los Angeles today. Congratulating the entire team of the movie RRR for winning in the best original song category, Shri Modi said that the popularity of the song 'Naatu Naatu' is global. In a tweet, he remarked that the song will be remembered for years to come.

The Government has asked Charity hospitals in the country to open medical colleges to provide quality and affordable medical education.

Union Health Minister, Shri Mansukh Mandaviya said, he held a meeting with 62 Charity Hospitals in

this regard. These hospitals include Breach Candy Hospital Trust, Sathya Sai Hospital, Kokilaben Dhirubhai Ambani Hospital, Amrita Hospitals and Anandamayi Hospital. Shri Mandaviya said, twelve Charity hospitals have already applied for the opening of medical colleges. The Minister said, the motive behind this is to provide medical education to more Indian students so that they should not venture abroad for medical studies. 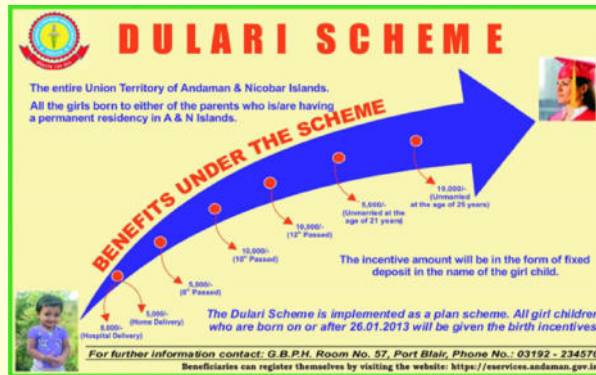

Providing social & financial security to girl child under 'Dulari Scheme'

Girl children born on or after 26.01.2013 eligible to get benefit under the scheme

Port Blair, March 13
Dulari Scheme, a Govt. of India scheme, which envisions encouraging birth of girl child, is being implemented as a plan scheme effectively in A&N Islands. Launched on Jan. 26, 2013 in A&N Islands, the scheme is aimed at reducing the gap in sex ratio to the replacement level of Net Reproduction Rate (NRR) i.e. 1 by ten years after implementation of the scheme whichever is earlier. Implementation of Direct Benefit Transfer (DBT) of Dulari Scheme has been successfully completed on



online mode in the Isles.

The objective of the scheme is to reduce the gap in sex ratio to a replacement level of NRR, to encourage birth of girl child in A&N Islands, to provide social security to the newly born girl child, for her education and marriage, to adopt delayed marriage practices in respect of girl child and

to encourage adoption of hospital delivery practices.

As per the present scheme, the girl child born on or after 26.01.2013 can avail their benefit under the scheme and the girl child who have passed 8th Standard for the academic session of 2012-2013 onwards will also be eligible from the category of education incentives of this scheme.

All the girls born to either of the parents who is/are permanent resident of A&N Islands are eligible for availing benefit provided under Dulari scheme viz. (Contd. on last page)

documentary short film 'The Elephant Whisperers' for its story of baby elephant Raghu and his care-takers Bomman and Belli which he said depicts love and co-existence in harmony with nature.

Composer of the song, Shri M. M. Keeravani along with Lyricist, Shri Chandrabose collected the award. Playback singers of the 'Naatu Naatu' song, Shri Rahul Sipligunj and Shri Kaala Bhairava performed the song at the Academy Awards ceremony at the Dolby Theatre in Los Angeles in USA. The performance got them a standing ovation. The live performance at the ceremony was introduced by Ms Deepika Padukone. RRR is the first Indian film in over two decades to be nominated for the Academy Awards while 'Naatu Naatu' was the first Indian song to be nominated at the Oscars.

The film inspired from the lives of freedom fighters Komaram Bheem and Alluri Sitarama Raju, narrates a fictional tale set in the 1920s. The song, choreographed by Shri Prem Rakshith was competing against Applause from the film Tell It Like A Woman, Hold My Hand from the movie Top Gun: Maverick, Lift me Up from Black Panther: Wakanda Forever, and This Is Life, from Everything, Everywhere All At Once. Another Indian entry in the Academy Awards 'The Elephant Whisperers' also won an Oscar in the Best Documentary Short Film category. This 41 minutes short documentary movie of filmmaker Ms Kartiki Gonsalves and producer Ms Guneet Monga, explores the bond between Raghu, an orphaned baby elephant, and his caretakers. H.D., Assistant Plant Protection Officer of CIPMC along with Shri S.P. Prasad, Asst. Director (Soil), Smt. Pitchammal, AO, Shri Sitaram, JAA, Ms. Naazneen, SCFA visited the farmers' fields at Govind Nagar, Joginder Nagar, Vijay Nagar, Laxmi Nagar, Gandhi Nagar and Shastri Nagar. They observed that the Arecanut Palms were infected by leaf spot, bacterial leaf blight, yellow leaf disease in trace to low intensity and the coconut orchards on the other hand, were sporadically infested with rhinoceros beetle in trace level.

The experts advocated Integrated Pest Management (IPM) through balanced nutrition along with MOP, Borax and Zinc Sulphate. They also suggested the application of Farm Yard Manure (FYM), Trichoderma, Neem Cake, spraying of Neem Oil and use of light traps as well as bucket traps for Rhinoceros Beetle infestation. They stressed on the need to provide good drainage to overcome the disease. The team urged the farmers to adopt IPM technology to minimize the pest and disease incidence in Coconut and Arecanut.

Dr. Shiva Kumar visited Tsunami Shelter in Shastri Nagar and interacted with a Woman Farmer, Smt. Kusum Mishra in her Coconut and Arecanut orchard. He advised Smt. Kusum to adopt IPM technologies to minimize crop losses caused by pest and diseases and for the betterment of environment and human health, a press release from CIPMC said.

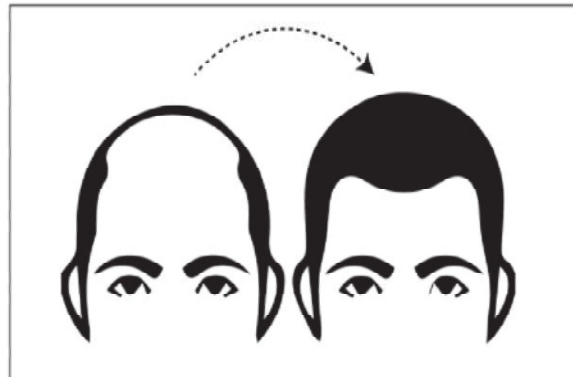
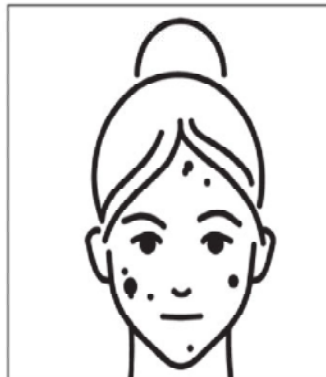
