# Secretary highlights on 'Schemes implemented by RD/Panchayats' for transforming the lives of rural populace

Port Blair. May 14

The Chief Secretary, A&N Administration, Shri Keshav Chandra, IAS has directed all Secretaries of the Departments concerned to give interviews in Akashvani Port Blair and Doordarshan (DD) and highlight the initiatives taken by the Departments involved in public delivery services to improve public delivery system, social infrastructure and social benefit schemes. As per the roster, the interview of Secretary (RD/Panch,/PRI), Ms Veditha Reddy, IAS was broadcast today through Akashvani Port Blair and the same is being reproduced in Q&A format for the wider lacksquarereach of the people of A&N Islands.

Interviewer: Kindly elaborate on the role of Zilla Parishad, 50 sqmtr. prescribed in the scheme. In addition, Panchayat Samiti and Gram Panchayats in transforming the

Secretary (RD/Panch.): Directorate of Rural Development was established in the year 1983. Before that local level Panchayats were in existence but in the year 1992, 73rd Amendment came into being and to strengthen the Local Self Govt., Article 243 was pronounced. Under this, the activities which were earmarked can be looked after by a Local Self Government viz. Minor Irrigation, Agriculture, Animal Husbandry, Education, Fisheries, Libraries, Cultural activities and other sectors. The standing point and the most crucial part of the Rural Development sector is the Gram Panchayats which is the fulcrum of the development. With this, the Three-Tier Govt. was formed. Under the Three-Tier Panchayati Raj System, Gram Panchavats comes first, the elected representative for which is the Pradhan. In Andaman & Nicobar Islands, there are 70 Gram Panchayats, 7 Panchayat Samitis & 2 Zilla Parishads. Gram Panchayats core role is to prepare Gram Development Plan and they discuss the priorities in their villages during Gram Sabhas. A resolution is passed after the Gram Sabha and Development Plan is devised. The next level in the three tier Panchayati Raj Institution is the Panchayat Samiti, which is headed by a Pramukh and the Panchayat Samiti is responsible for preparation of Block Panchayat Development Plan after preparation of GPDP which is catering to the needs of the people.

The Apex Body of the PRI, the Zilla Parishad is responsible for the preparation of the District Panchayat Development Plan (DPDP) which is passed by the District Planning Committee. In A&N Islands, there are two Zilla Parishads having 35 members including Adhyaksh and Up-Adhyaksh. As soon as the fund is received from the GoI, all three tiers provide their Development Plan to the RD Department. Fund is allocated in the ratio of 70:15:15 i.e. 70 percent goes to the Gram Panchayats, 15 percent goes to the Panchayat Samitis and the other 15 percent goes to the Zilla Parishads. Keeping in mind the functionality of the PRIs, the Administration is having BDOs, Extension Officers, Village Level Workers, Panchayat Secretaries to monitor, supervise and help the PRIs. However, the most important work is to prepare Gram Panchayat Development Plan, Block Level Plans and Zilla Parishad Level Plans. As per the 73rd Amendment, 29 sectors were defined for rural development and also to strengthen local self-government in the country. There exists immense scope for the 3-tier PRIs for taking up development activities in varied sectors including capacity building. Accordingly, the GoI has also devised various schemes to harness the potential of the PRIs.

Interviewer: Can you elaborate on the schemes being implemented by your Department?

Secretary (RD/Panch.): Apart from the 29 Sectors, the RD Department has various schemes. The first scheme is Pradhan Mantri Awas Yojana (Grameen). The scheme aims at providing pucca house with basic amenities to all houseless householders living in kutcha and dilapidated houses. Unit assistance of Rs. 1.20 lakh in plains and Rs.1.30 lakh in hilly UTs. Unit assistance of Rs. 1.20 lakh is given in three installments and the beneficiaries construct their houses. As of now, 1300 plus houses have been sanctioned, out of which, 1220 houses have been constructed so far. In Kodiaghat village area, good number of people have been covered under the Pradhan Mantri Awas Yojana (Grameen). This area has become a model of PM Awas Yojana Colony wherein 69 beneficiaries have constructed their houses beautifully covering an area of

the beneficiary will get Rs.12,000/- as assistance for the construction of toilet under 'Swachh Bharat Mission'. This scheme focuses more on the 'Rural Poverty Alleviation' to ensure that no person is left without a house, which is the sole identity of a person. PM Awas Yojana is very popular in the A&N Islands and the first phase is under implementation currently. Apart from this, a new survey has been conducted under the Social Economic Caste Census (SECC) by which the Department has identified 2500 plus beneficiaries in phase -II to be brought under this scheme. Many people are interested to construct their own scheme and they willingly come forward to construct their homes by availing financial assistance earmarked in the scheme. The criteria of the scheme is that the beneficiary should not have any landholding with them and do not possess any pucca house. Persons who are houseless or have Katcha House are eligible for financial benefits under

The second scheme is the 'Swachh Bharat Mission (Grameen). The Swachh Bharat Mission (Grameen) is the world's largest behavioral change program, achieving the seemingly impossible task by generating a people's movement at the grassroots in our Country. Earlier, nobody wants to talk about Swachh as they feel odd to discuss about garbage. A&N Islands has become number one in the 'Swachh Bharat Mission' and our Island was declared 'Swachh Sujal State' amongst States and UTs and received an award from the Hon'ble Minister, Shri Gajendra Singh Shekhawat. Under this Mission, there are three components and the first is 'Access to Toilet' for every individual. Under this, the Department constructed individual toilets and community toilets. The basic aim of this scheme was to make these Islands open defecation free and Isles achieved this goal after 2019-20. Apart from this, Isles also received the award for ODF plus. The Second component under 'Swachh Bharat Mission (Grameen)' is the segregation and collection of waste. In rural areas, people are segregating the waste at their own at the household level. This was possible due to the efforts made by the PRI Members at grass root level bringing this behavioral change in their respective Panchayats and the general public voluntarily participated in this Mission of segregation of waste. The entire credit goes to the people of rural areas for the projects executed by the Rural Development, as rural people only decides their goals during Gram Sabhas. Two types of wastes are segregated that is 'dry waste' and 'wet waste'. Dry wastes are collected in 25 Clusters, where it is segregated and collected while people are asked to compose the 'wet waste' at their backyard itself. After compositing, they can also use it as manure and in turn, it becomes feed. The rural populace are motivated by Panchayat Officials as well as PRI Members through timely training.

The third component under Swachh Bharat Grameen is Grey Water Management i.e. the water generated from the kitchen and bathing by individuals, which can be reused. The Department has started working on it. This water can be used for kitchen garden by recycling it for which the RD Department impact on their livelihood have been formed in Car about the benefits of the motivates, creates awareness, and provide training. As these Islands have achieved the distinction of being the first 'Swachh Sujal Pradesh' in the entire country, the Islanders have to maintain this status by working consistently on 'Swacch Bharat Mission'. The funds for constructing individual toilets and community toilets are provided by the Govt. but other components are executed by the Department as per convergence of schemes. MPLAD funds. Apart from this, the UT of A&N Islands has received 'Har Ghar Jal' certification. In March 2022, every rural household has been covered by providing one functional tap connection.

The third scheme is MGNREGA Scheme: The Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) is a powerful instrument for ensuring inclusive growth in rural India through its impact on social protection, livelihood security, and democratic empowerment which also showcases the three-tier Panchayati Raj Institution. It ensures providing job to individuals within 5 km vicinity of their place of stay. Any individual can apply for job and as per the criteria; only 100 days of job can be provided. This scheme is successful in A&N Islands and many development works are executed through MGNREGA. The rural people help each other by taking up work in their villages or neighborhood, under MGNREGA and they also get wages for the execution of the project. This also generates employment opportunities for individuals. Those who want to earn a livelihood by staying in their own villages, for them, MGNREGA is a helpful tool which benefits them immensely.

The fourth scheme is Deendayal Antyodaya Yojana National Rural Livelihood Mission (DAY-NRLM): This scheme is especially for women. Isles Self Help Group (SHGs) formed under this Mission are tied up with NABARD or other sectors and are provided two types of funds i.e. Revolving Fund and CIF Composite Fund. Amount ranging from Rs.15000 to 1.5 lakh is provided to SHGs immediately as soon as the group is formed. Thereafter, they are extended marketing support and training for empowering them. This is an SHG empowering scheme, under which, women are being motivated to form their own SHGs and select an activity for their livelihood. In these Islands, there are 1100 SHGs with more than 11000 SHG members. They are tied up with RD Department and are fully functional. Some SHGs are fully active while others are being motivated for which SHG Melas are conducted by the RD Department. This Mela is different from other Melas as SHGs prepare products in a hygienic way at home and the handicraft items prepared by them are showcased in a unique way. The Rural Department gives immense importance to DAY-NRLM scheme, as it has tie up with various sectors like Banks, Industries Department for providing training in Agriculture, fisheries etc.

The fifth scheme is the Rashtriya Gram Swaraj Abhiyaan (RGSA): It was launched in the year 2018 which is a unique scheme proposed to develop and strengthening the Panchayati Raj System across India in the rural areas. The main objective is capacity building & training, providing orientation training to the Elected Representatives (ERs) of Panchayats, within 6 months of their election and refresher trainings within 2 years. Accordingly, the RD Department organized training for the newly elected public representative as soon as the Municipal and Panchayats elections were completed last year, so that they are enlightened about their roles and responsibilities as elected members. An interaction was also organized with the officials of various Departments during the training, in which, they were apprised about the schemes available that can be implemented for the benefit of the general public. It was a learning experience for the Department as well.

The sixth scheme is the Shyama Prasad Mukherji Rurban Mission (SPMRM): This scheme is a mix of rural and urban.This scheme envisages to deliver catalytic interventions to rural areas on the threshold of growth. Rurban clusters are identified across the country based on increase in population density, high levels of non-farm employment, presence of growing economic activities and other socio-economic parameters. To make this Mission as growth catalyst, the RD Department has taken up various projects totaling to 75 in numbers and projects amounting to  $Rs\,20$  to 25 crores have been undertaken under this Mission. The projects include construction of Fish Market, Development of Parking Lots etc. which is continuing.

The seventh scheme is Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY): This scheme is a nationwide placement-linked skill training program. The objectives are to add diversity to the incomes of rural poor families and cater to the career aspirations of rural youth by transforming them into an economically independent and globally relevant workforce. In A&N Islands, this scheme is of immense importance, as it help in skilling the rural youth in sectors like Hospitality, Hospital Management, Tourism, Mason training for which RD Department arranges training. The target beneficiaries for the training is 1500 and it is organized in PPP mode. The Department selects 5 Agencies for the conduct of the training and the onus of placement also lies with the Agency. Accordingly, the Department has selected 5 Agencies (PIAs) and they have been given the target. It's heartening to inform that 492 members have already been trained and their placement is underway. Recently, the Department organized an event at Chouldari under Ferrargunj Tehsil, in which 7-8 Companies participated like Hoteliers, Tata Motors, Hyundai Motors etc. and they also ensured placement of the trainees. The trainees who are selected will get to earn their livelihood with an initial earning of Rs.15000/-. If the company is satisfied with the work after providing training, they then retain the trainees as employees.

The eighth scheme is Saansad Adarsh Gram Yojana (SAGY): Saansad Adarsh Gram Yojana (SAGY) is a village development project launched by Government of India under which each Member of Parliament takes the responsibility of developing physical and institutional infrastructure by providing fund. Under this scheme, projects are undertaken by preparing Village Development Plan and the Member of Parliament executes the project, if it is found beneficial to the rural populace.

The ninth Scheme is Amrit Sarovar: Under this project, 75 Amrit Sarovars have to be created in each District of A&N Islands totaling to 225 which will be in the form of digging ponds by the people in their respective place of stay or in Govt. sites. Development of these 75 sarovars can also be taken through CSR activities or through MGNREGA which will raise employment as well as help in rejuvenating water also. Accordingly, Amrit Sarovars are being created in all the 3 Districts which will hold water and will be of great help to mitigate water scarcity. Our target was of 225 and so far, the Department has constructed 220 Amrit Sarovars and by August 2023, the entire project will be completed. Amrit Sarovar is an overall composite plan which will help the villagers to take up allied activities such as fisheries, catering the water needs for the livestock and beautification of the surroundings of the Sarovars, where people can come and spend time at the Sarovar.

nterviewer: How important is people's participation for the success of such Mission?

Secretary (RD/Panch.): 'Jan Bhagidari' is vital as far as the Rural Development is concerned. The BDOs, the Panchayat Secretaries and PRI Members used to conduct timely awareness programmes. It is seen that all the Rural Development Schemes are taken by the people themselves as they earn their livelihood through these schemes. These schemes have the potential to generate employment and it directly affects their lives in a positive manner be it development of houses, availability of water or for that matter Swachhta in their own Panchayat. Rural Development Department involves rural people to carry out almost all the schemes Beach cleaning activities are also conducted by involving rural people and PRIs so that they themselves clean their own area/ beach. The concept of Swachh Bharat is 'Waste to Wealth' or how to make wealth out of waste. People are motivated to sell the waste after segregation so that they can earn themselves and at the same time recycling of the waste can also be done. Awareness camps by the RD Department is continuing to educate people regarding this. People also suggest the Department to work on particular subject/activities, which the Department immediately responds and the same activities are taken up without fail. Interviewer: How is the Co-ordination between the RD Department and the PRIs?

Secretary (RD/Panch.): During interactions, it was ascertained that the PRIs are very active in A&N Islands and they bring forth the issues of the general public of their respective Panchayats. PRIs are like a medium of information to us and they also supervise our work too. They also turn up with varied suggestions for further improvement in the schemes which helps in uplifting their living condition thus contributing towards the socio-economic development of  $\mathbf{A}$ &N Islands.

Interviewer: What about Grameen Paryatan (Rural Tourism), how it is being propagated?

Secretary (RD/Panch.): A new scheme has been devised named 'Rural Haat' and it will be developed in every Panchayat, so that the products and handicrafts prepared by the rural people can be marketed. There are tourist attraction places Swaraj Dweep, Shaheed Dweep, Port Blair, Diglipur and other rural areas in different Islands which is frequented by the Tourists in good number. Establishment of these eco-friendly 'Rural Haat' will help the SHGs and other people to market their product thereby uplifting their economic status. Local people will be allowed to sell their products through these Haat. This will not only help the rural people to increase their earning but it will contribute towards boosting tourism. One of the key features of A&N Islands is its pristine beaches. Beach 'Management Committees have been formed, in which PRI members play a vital role. They also suggest various activities such as beach cleaning activities etc. Eco-friendly 'Rural Haat' can by developed in beaches. Rural Tourism is the way forward. Urban tourism is in saturation point and tourists prefer to visit rural areas where pollution is less and they want to know more about the rural life, culture and the history of that place. The Rural Development Deptt. has devised Mayabunder, May 15 a scheme to enable the SHGs to purchase machineries. The SHGs can take works such as copra making, bamboo based products and other coconut products and eco-friendly plates using arecanut for which appropriate machineries are required. The RD Department is planning to procure machines, so that it can be handed over to SHGs in different clusters or at village level. It will be the responsibility of the SHGs or the village for the maintenance of the machines and anyone can use this machine for the branding and marketing of their product. Our progress is possible only when our rural entrepreneurs, SHGs, local community people are able to prepare their own brand. In A&N Islands, virgin coconut oil is available which is not available anywhere, we have to think how to market this virgin coconut oil especially produced from rural areas. In Nicobar Islands, traditional organic fruits and vegetables are grown and there is a need to think for its organic labelling. There is need to bring SHGs on the platform of GeM and Amazon. There are 40 SHGs who have already been registered with online platform as well as GeM. Any Department or individual, who wish to procure products, can directly purchase it from SHGs. These all are an empowering plan for the women community. Apart from this, women fishers have also asked for providing them training on fish preservation, cutting methods and how to increase its shelf life. We are focusing on providing such trainings through convergence plan and few training have already been conducted for them.

Interviewer: What is being done to improve service delivery system?

Secretary (RD/Panch.): The Rural Development Department is functioning in different locations in A&N Islands. Our Department

MV Bambooka will sail for Swaraj Dweep on 16.05.2023 (Tue) at 1400 Hrs from Phoenix Bay Jetty Wharf and in co-ordination with the other Departments conduct awareness programmes and also receives applications from the general public for different schemes. Our effort is to run these activities in a de-centralized manner. The main aim of the rural Development Department is to start all the development activities from the Gram level.

wer: What shortcomings are noticed while implementing the schemes and the steps taken to overcome them?

Secretary (RD/Panch.): There is an imperative need to create 'Rural Haat' and the Department is working on it, so that we are able to prepare our own sustainable market. Efforts are also on to provide machineries so that the rural women or SHGs starts doubling their income by preparing quality products and at later stage they are able to procure machineries on their own. The most important thing is to look into the aspect of marketing and branding and the RD Department is putting its best effort in this area. Swachchta and Amrit Sarovars are the areas, where Rural Development Department is concentrating more at Village level and Panchayat level for their self sustainability. Efforts are also on to create job opportunities for rural educated unemployed youth. In A&N Islands, youth are focusing more on getting a Govt. job, which is not a sustainable mode. Sustainability will come

only when, youth starts his own venture, be it small or big. By starting own business, the owner is able to provide employment to other people also. The RD Department is focusing more on imparting skill development training. The youth should come forward for getting training, placement and for suggesting new ideas and new business ventures, where the RD Department extends support. Maximum awards announced by the GoI has been bagged by the Gram Panchayats of A&N Islands. Recently, Laxminagar Panchayat received an award for Self-Sustainability. Good works are being carried out by the Panchayats and there is also the need to learn from each other's good

Interviewer: Lastly, what would you like to tell our rural listeners and elected

Secretary (RD/Panch.): The most important message I would like to share among rural people and PRI members is they must introspect on how to become self-sufficient. There is also the need to check what are the projects to be initiated for self sustainability. A plan has to be prepared by the people and the PRI members regarding what facilities are required in their respective Panchayats be it water, electricity etc. People should also think about generating electricity for their uses. There is also the need to think about using the wastes generated in each household from the Panchayat level. We have to move forward in a self-sustainable manner, for which, we have to work hard. Secondly, we have to concentrate more on skilling the rural youth and people as well as PRIs have to come forward, so that the Department can give them the opportunity to do so. If one person sets up a business, it should bring happiness in the lives of 10 other family members. Third is the behavioural change. Self sufficiency is possible only when we bring about a behavioural change in ourselves. We should also think of converting wastes produced in our respective Panchayats into wealth. Fourth is the people's participation which is of paramount importance. Without people's participation, the implementation of schemes of different Department cannot be successful. The Rural Development Department is committed towards the welfare of the rural populace, for which, it leaves no stone unturned and is also ready to listen to the suggestions of the rural people/PRIs for its meaningful implementation. All the Rural Development Schemes viz. 




