Rs.3.5 Lakh per annum from all sources are eligible to appear in NMMSS Examination. The students of Kendriya Vidyalayas, Jawahar Navodaya Vidyalayas and Residential Schools run by State Government and Private unaided Schools are not eligible for scholarship under the National Means-cum-Merit Scholarship Scheme (NMMSS).

NMMSS examinations students have to produce Mark Statements of the qualifying examinations (i.e. Mark Statement of Class -VII for NMMSS examination). To appear in the NMMSS Examination, students should produce parental Income Certificates issued from Revenue Authority not below the rank of Tehsildar concerned with their application forms. Category Certificate are also to be produced by the candidates who come under reserved categories.

Application forms can be obtained from the Office of the Principal, State Institute of Education, Port Blair/Zonal Education Officers of Education Department.




