## PBMC committed to enhancing quality of life for citizens of Port Blair

# Work of 'Marine Esplanade' from Marina Park to Entry Gate of JNRM completed; JNRM to Flag Point in progress

Port Blair, Oct. 20

The Port Blair Municipal Council (PBMC) is the lone Council in A&N Islands with the objectives to provide basic urban services like sanitation and conservancy, distribution of drinking water, shelter and lodging facilities, developing civic amenities such as parks and gardens, community assets such as footpaths, drains, retaining walls, roads besides community halls, auditorium and public grounds. The Secretary (PBMC) outlined the initiatives of the Council in maintaining the city's upkeep while striving to provide and meet the expectations of the citizens. The excerpts of the interview are as below.

**Interviewer: How many citizen centric services are provided by PBMC?**

**Secretary (PBMC):** PBMC offers various citizen-centric services comprising of sanitation, drinking water, road infrastructure, and community spaces. These services prioritize the welfare and contentment of citizens, creating healthier, more livable, and engaged communities. They prioritize convenience, accessibility, and responsiveness to residents' needs. Sanitation services,

adhering to standard guidelines, play a pivotal role in public safety. They include practices like regular garbage collection through door-to-door services, ensuring cleanliness and hygiene. The daily collection routine contributes to a healthier living environment, preventing the spread of diseases and maintaining a visually appealing urban landscape.

Another vital service is the provision of drinking water. Ensuring a reliable supply of potable water is essential for citizens' health and daily life. Additionally, roads enhance accessibility and safety for residents, facilitating smoother transportation. Community halls for functions and events serve as communal spaces, fostering social cohesion and enabling citizens to celebrate important occasions. These amenities contribute to an enriched community life, strengthening the overall well-being of residents.

The Port Blair Municipal Council (PBMC) operates a 24x7 Control Room to swiftly address emergent situations and serve citizens' needs. Residents can file complaints related to sanitation, water, street lights, and various municipal works through this facility. Section in-charges are readily available to handle concerns and provide assistance. Citizens' feedback is encouraged, fostering a responsive system. The Control Room can be reached at numbers 231179, 231141, 231142, and 245798, ensuring continuous support for the community, day or night.

**Interviewer: Kindly explain about the online portals available for the citizens?**

**Secretary (PBMC):** In 2017, the Port Blair

Municipal Council (PBMC) introduced the eNagarSewa application with the aim of simplifying the delivery of citizen-centric services to the general public within the municipal limits of Port Blair. A total of 27 services, including both major and miscellaneous ones, were converted into an online format. Some of the key services included property tax payment, water tax for domestic and commercial properties, conservancy fee, property tax assessment, market rent payments, issuance of No Dues Certificates, and various other miscellaneous services.

Citizens have the convenience of registering on the portal and accessing services such as tax payments and market rent payments from anywhere at any time. The portal offers multiple payment options, including internet banking, UPI, and QR code facilities.

Additionally, dedicated eCorner facilities are available at PBMC-HQ and Bathubasthi Municipal Complex (located next to the Bathubasthi Petrol Pump), where citizens can also access these online services. Upon logging in, registered users are directed to their personalized dashboard menu, from where they can select the specific online services they require, such as property tax payment, shop rent, or water tax. Each citizen is assigned a unique Citizen ID, and their respective property and water connections are given distinct IDs. These IDs are automatically generated by the application when the Department uploads citizen data. Citizens can easily find their Citizen ID through a provided link in the dashboard menu, titled 'know your citizen

ID'. To access any services on the portal, users must enter their Citizen ID.

Recently, PBMC introduced a new module that enables citizens to apply for new water connections, both commercial and domestic, directly from their registered ID. Once the new connection request is approved, citizens can make online payments for the estimated charges through their account and download the sanction order as well. Furthermore, a mobile app for these online services is currently in development and will soon be made available to citizens.

**Interviewer: Elaborate on different schemes implemented by PBMC and its current status.**

**Secretary (PBMC):** Under DAY-NULM: Port Blair Municipal Council is actively implementing the Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY-NULM), a centrally sponsored scheme aimed at promoting sustainable livelihoods in urban areas. The program encompasses various components, each addressing specific aspects of urban livelihood development.

One significant component is EST&P (Employment through Skilled Training and Placement), which focuses on providing skill training to individuals to enhance their employability. In Andaman, two training partners, namely Sri Angalamman Trust (offering training in tailoring and beauty therapy) and M/s Swadin Pvt. ITI (providing electrician training), offer skill development programs. Upon successful completion of these training programs, beneficiaries are awarded certificates and assisted

in securing job placements in collaboration with the training partners. This initiative covers a range of skills, including tailoring, assistant beauty therapy, and masonry, thereby catering to diverse employment opportunities.

Another crucial facet of the program is SM&ID (Social Mobilization and Institutional Development). Under SM&ID, Self Help Groups (SHGs) are formed primarily to cater to urban poor families with income below 2 lakhs. While women SHGs are common, there's also room for male SHGs, especially for handicapped individuals. Vulnerable occupation-based SHGs for men, like rag pickers, rickshaw pullers, fishermen and sanitation workers, are encouraged. Activity-based SHGs for males are also permitted. These groups receive essential financial support, with a revolving fund of 10K, ALF of 50K, and CLF of 1 Lakh. These SHGs were provided with handholding support and enhancing the livelihoods of their members, thereby contributing to the economic empowerment of the urban poor.

### Police adopts zero tolerance against drugs

#### South Andaman Police arrests three drug peddlers for supplying drugs

Rigorous effort is being made by the A&N Police to weed out menace of drugs from A&N Islands. Continuing its zero tolerance against drugs, the Police Station Aberdeen team working professionally has succeeded in registering two cases under NDPS Act within a week and arrested three persons who were supplying drugs, said the DIGP, Law & Order, A&N Police, Ms. Monika Bhardwaj, IPS while interacting with the scribes here today.

Giving details of the arrest and seizure of drug, the DIGP disclosed that acting on a tip off received on Oct. 16 and 18 from reliable sources, a raiding team led by Inspector Girish Kumar, SHO PS



Aberdeen conducted two consecutive raids at Dean Street and near JNRM, Port Blair respectively. In the first raid which took place on Oct.16 at Dean Street, Junglighat, a total of 6.93 grams Methamphetamine and more than 3 lakh rupees cash was recovered from an Auto Driver who was a resident of Dean Street, Junglighat. The accused was arrested and a case was registered under relevant sections of NDPS Act. The raiding

team consisted of HC Vinod Kumar, HC Nakul Halder, PC SN Rao, PC Jayraj, PC Naw Elieen, PC Jagdish Babu, PC S.S Yadav and PC B. Kumar Swamy.

The DIGP further stated that subsequently, one more accused person from Little Andaman has also been arrested. The second raid was conducted on Oct. 18 near JNRM, on receipt of credible information about a college going girl arriving with huge

### Global Iodine Deficiency Disorders Prevention Day to be observed in Isles today

National Iodine Deficiency Disorders Control Programme (NIDDCP) will be held tomorrow (Oct. 21) by the Directorate of Health Services in association with Union Territory Health Mission with the aim to zero mental and physical retardation, deaf & mutism, cretinism, still births, abortion etc., due to lack of Iodine.

Iodine is an essential micronutrient required daily at 100-150 micrograms for normal human growth and development. To achieve the last mile of iodized salt coverage, concerted efforts need to be made by developing contextual and targeted strategies at the sub-national level. A deep dive into



the India Iodine Survey 2018-19 by Nutrition International reveals that the progress in household coverage of adequately iodized salt has plateaued to 76%.

It is an excellent example of 'Made-in-India and Made-for-India' National Health Program model, acclaimed as a global public health success story. Indian Scientific Institutions, Government and Industry collaborated and complemented in shaping the program and ensuring its success. Iodine Nutrition is essential to protect the population from

Saitankhadi and Mannarghat. The trainees interacted with the farmers about the possibilities of initiating brackish water ventures, culture practices and challenges faced during culture period.

During the valedictory programme, an online session and interaction was also conducted with a successful crab fattening entrepreneur, Shri Kiran from Kerala, Dr. CP. Balasubramanian, HoD and Scientist team from Crustacean Division, ICAR-CIBA, Chennai and Private Distributors of Crab fattening inputs. During the interaction, the Crab Farmer from Kerala explained his success story in Crab fattening. The Scientists from ICAR-CIBA, Chennai assured all support in supply of Crablets and technical assistance to the farmers for promoting the Crab culture activity in A&N Islands. They also suggested for undertaking crab grow out in polyculture with other brackishwater fishes. The private distributor from mainland explained the availability and market price for different types of boxes and their willingness to supply inputs in the Islands.



Shri Vikram Singh, Director of Fisheries distributed certificates to the participants during the event. Speaking on the occasion, he informed that the Department has opened all the avenues for initiating brackish water aquaculture like trainings and ensuring of seed and feed. He requested the trainees to come forward and initiate the activity by utilizing the schemes under PMMSY.

The Self Employment Programme (SEP) is a critical component of DAY-NULM, which extends bank loans to SHGs at a nominal 7% annual interest rate. Those who repay on time receive a 3% interest subvention. In the previous year, 14 individual loans and 2 group loans were disbursed. The program sent 257 loan applications to banks, with endorsement by the Task Force Committee, led by the Secretary (PBMC). Committee members include the Lead Bank Manager, Project Officer, Assistant Director (Tech), and representatives from SBI, Canara Bank, and 2 ALF members.

The Scheme for Support of Urban Street Vendors (SUSV) is yet another crucial aspect, aiming to regulate street vendors in accordance with the Street Vendor Act. The issuance of 676 Certificates of Vending (CoV) and ID Cards by the Provisional Town Vending Committee ensures that vendors operate within defined zones. Vending is restricted in certain areas, including various road stretches, Government Offices, and Educational Institutions, promoting organized street vending and social security for vendors. Through these various components, DAY-NULM in Port Blair Municipal Council seeks to uplift urban livelihoods, empower individuals with skills, and promote economic sustainability in the city.

**PM SVANidhi:** The Pradhan Mantri Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) scheme is a transformative endeavour aimed at empowering a vital segment of India's informal economy - street vendors. These entrepreneurs play a pivotal role in the nation's economic fabric, but they faced severe repercussions from the COVID-19 pandemic and the associated lockdowns.

PM SVANidhi addresses the challenges faced by street vendors by providing comprehensive support. Its primary goal is to not only provide a source of livelihood but also promote self-reliance. To achieve this, the scheme offers working capital loans, which come in three categories - Rs. 10,000, Rs. 20,000 and Rs. 50,000. These loans enable street vendors to either restart their businesses or manage their day-to-day operations effectively.

A standout feature of PM SVANidhi is the 7% interest subsidy, which significantly eases the financial burden on beneficiaries. This interest subvention makes the loans more affordable, thereby encouraging more street vendors to access the financial assistance provided by the scheme.

Furthermore, PM SVANidhi goes beyond monetary support. It ensures that beneficiaries are linked to various social security schemes, creating a holistic safety net for them and their families. This comprehensive approach aims to uplift street vendors from their precarious economic situation, improve their livelihoods, and bolster their resilience against future challenges.

**PMAY(U):** The ‘Housing for All’ flagship scheme, PMAY (Pradhan Mantri Awas Yojana), stands as a transformative initiative in India, with the aim of providing secure and dignified living spaces to eligible families. Recently, the program reached a crucial phase of implementation, where meticulous planning and strategic actions are shaping the future for numerous households.

A significant milestone was achieved when 329 Economically Weaker Section deserving beneficiaries were identified. To engage and inform them, a programme was held at the PBMC auditorium. During this event, a three-dimensional model of the upcoming housing project was unveiled, offering a tangible vision of future homes. This not only empowered beneficiaries with knowledge but also instilled anticipation and ownership.

Two distinct sites, Prothrapur and Brookshabad were chosen for housing construction. The ambitious plan includes 213 housing units in Prothrapur and 116 units in Brookshabad. With a projected cost of 14.8 lakhs per unit, the initiative receives crucial central assistance of 1.5 lakhs per unit.

Collaboration with financial institutions, notably Canara Bank, played a vital role. They offered loans of up to 8 lakhs to each beneficiary, introducing a margin money of 1 lakh from the beneficiary's side. This not only enabled beneficiaries to secure their future homes but also fostered financial literacy. The remaining amount of Rs. 4.30 lakhs per unit will be contributed by the executing agency.

Transparency and fairness were paramount in execution. The allocation of housing units was done through a lottery system, ensuring unbiased and equitable distribution among beneficiaries.

*Interviewer: Kindly elaborate on the current status and future plans to tackle water crisis in Port Blair?*

**Secretary (PBMC):** During the recent crisis period, PBMC has deployed the tankers to extract the water from various resources such as from Joda Nallah & Bore Wells. As on date, PBMC has identified 11 Ponds, 10 Bore wells, 05 Wells & 3 Weirs to mitigate the future problems. The population is continuously increasing and with this, the city's expansion is also taking place. As per the current water supply schedule, our daily requirement is 35 MLD and we are supplying 29.5 MLD. The main source of drinking water distribution in Port Blair is from Dhanikhari Dam and Rutland. The water level at Dhanikhari dam is at its lowest in the last 6 to 10 years and to draw water from this level motor has to be used to pump water from it, similarly, the water Rutland project has also reduced and 4 MLD water is received from Rutland project because of this, there was of shortage of water and the A & N administration is taking every possible step to mitigate the water crisis.

*Interviewer: Has any solution being worked out to tide over the situation in the coming summer?*

**Secretary (PBMC):** Yes, PBMC has prepared the DPRs. The work for digging of 09 Ponds are completed, 10 Bore wells & 5 wells are expected to be completed by this month. This will enhance the additional supply of 4 ML water for 90 Days in Urban areas. Whereas, the tender for connecting line from these sources to various Water Treatment Plants is floated & the DPR for Joda Nallah & Attam Pahad weir is under pipeline for execution. This will enhance additional 1.5 MLD for 120 days additionally.

*Interviewer: Is it true that 'Rain Water Harvesting' is mandatory for getting approval of building plan? What action is being taken against violators?*

**Secretary (PBMC):** Yes, 'Rain Water Harvesting' is mandatory for getting approval of building plan. As per 4.8(a) of Port Blair Municipal Building By Laws, 1999, action will be initiated against the violators by issuing Stay Order, Notices, Provisional Order, Demolition Order & prior approval obtained from the Chairperson, PBMC Clause 32.14 for executing the Demolition Order.

*Interviewer: What is being done to rejuvenate ponds, wells, reservoirs across the city?*

**Secretary (PBMC):** PBMC has recently developed 9 new ponds which have a capacity of 14.6 Million Liters as well as the rejuvenation & cleaning of 280 Wells across PBMC limit is being

executed at regular intervals which are majorly used by the public for non-drinking purpose.

*Interviewer: Currently purified water is being used for bathing, washing clothes and utensils, gardening etc. Is there any proposal to provide raw water for normal household chores?*

**Secretary (PBMC):** The 280 Wells are being utilized majorly by the residents of nearby areas as a substitute. General public are also requested to utilize these wells for non- drinking purposes.

*Interviewer: Is there any plan to install desalination plants in the near future?*

**Secretary (PBMC):** Generally, desalination plants discharges the back wash which destroys the aqua culture & marine life & will lead health & environmental hazard in future. Since our Islands receive ample rainfall the enhancements of water bodies resources are enough to cater the crisis.

*Interviewer: What would you like to say about uninhibited bore-well drilling during peak summer?*

**Secretary (PBMC):** PBMC has already identified & executed the drilling of Bore Wells at different locations identified by Central Ground Water Board Authority, Kolkata to address the shortage.

*Interviewer: Can Water Meter prove to be a problem solver?*

**Secretary (PBMC):** Presently, water is being charged on Monthly flat rate basis of Rs. 50/- per month per connection, which encourages Public to use water carelessly. Installing Water Meters on water connections will certainly improve the water problem owing to fact that once the water meter is installed the payment will be charged on tariff basis which will implicate the capital cost & will automatically restrict the usage.

*Interviewer: Elaborate on Smart City project. How much is the grant allocated and how much has been spent on different projects?*

**Secretary (PBMC):** The Smart city is a Centrally Sponsored Scheme (CSS), the Central Government proposes to give grant to the cities and an equal amount of grant will be contributed by State/UTs. Currently, Port Blair City received an amount of Rs. 445 Cr (Rs. 245 Cr GoI + Rs. 200 Cr UT) and Rs. 87.55 Cr has been spent on different projects till date.

*Interviewer: What is the current status of 'Marine Esplanade'?*

**Secretary (PBMC):** The stretch leading from Marina Park to Entry Gate of JNRM has been already completed whereas the work from JNRM College to Flag Point is in progress. In addition to these, the work leading from the stretch Chatham to Water Sports Complex is in pipeline for award. The whole projects timeline for completion is expected by May, 2024.

*Interviewer: Comment on the current status of installation of CCTV Cameras across the city?*

**Secretary (PBMC):** The installation of CCTV Cameras under ICCC project is expected to be installed by end of this year which will enhance the surveillance of the city in various modes.

*Interviewer: What is the status of Solid Waste Management including e-waste and medical waste?*

**Secretary (PBMC):** PBMC has identified 681 routes, the Swachhta Awareness teams are continuously encouraging general public not to throw the waste in public areas such as drains, footpaths, roadside berms etc. Instead, they shall hand over the segregated waste at their door steps, non- compliance /non-participation as per the notified Solid Waste By Laws 2017, will attract penalties and the Sanitary Inspectors have been delegated the powers to impose penalties as per the violations. At present, the Safai Mitras are collecting the waste from the doorsteps of households whereas the Self Help Groups have been engaged to collect the commercial waste being generated across the city during morning & evening hours, twice in a day. General public are requested to support PBMC for implementing the Solid Waste Management System by abiding by SWM Rules.

Regarding hazardous waste & Municipal waste generated from various Clinics/ Hospitals, PBMC has authorized vendors. They collect these waste & further sent hazardous waste for recycling at mainland whereas the Municipal waste is being processed at PBMC's DRCs & landfill sites.

*Interviewer: What is being done to overcome the problem of clogging of major drains in the city during heavy downpour leading to water logging?*

**Secretary (PBMC):** PBMC has identified the major & critical mouths of drains, where schedule cleaning has been enforced, the work for installation of garbage arresters is in progress. The nearby residents of these drains are also asked not to throw Municipal Waste as well as the garden Tree trunks & other heavy structure waste into the drain which chokes the mouth of drains, which results into flooding. Apart from this, the de-silting of drains are also scheduled to keep the drains utility area intact.

*Interviewer: After the recent downpour, what is the status of link roads across Port Blair city?*

**Secretary (PBMC):** The recent downpour which continued for more than a month has brittle the top surface of Bituminous Road which has to repair in most of the wards. The estimates are already in pipeline, as soon as the favorable condition is aroused such as the drying of base course in sunny days will help to execute the repair work of roads in an efficient manner.

*Interviewer: Can you elaborate on 'Green Connect' initiative of PBMC?*

**Secretary (PBMC):** The ‘Green Connect’ project stands as a pivotal initiative aimed at creating an integrated one-day destination by seamlessly connecting Gandhi Park, City Forest, and Jogger's Park

in Port Blair. This project holds the potential to act as a catalyst for both boosting tourism in Port Blair and providing a central open space for its residents.

Currently, Gandhi Park and Jogger's Park are two widely popular open spaces in Port Blair. Gandhi Park, generously spread across acres, offers an expansive open area surrounding a picturesque lake. In contrast, Jogger’s Park provides visitors with breathtaking 360-degree panoramic views of the Airport and NSCB Dweep, making it a unique and attractive spot.

To provide a clearer understanding of the project's scope, the interventions have been categorized into three distinct sub-components corresponding to the respective sites. First, there are development works planned for Gandhi Park, covering approximately 20 acres. Second, development initiatives for Jogger's Park, spanning around 4 acres, aim to enhance its appeal and facilities. Finally, the project includes development works within the Forest area, encompassing a substantial 62 acres, ensuring that the natural beauty of the City Forest is preserved and accessible to the public.

Through the ‘Green Connect’ project, Port Blair aims to create an enriched urban environment that harmoniously blends nature, recreation, and tourism, ultimately benefiting both its residents and visitors.

The ‘Green Connect’ project is guided by a set of strategic objectives aimed at enhancing the urban green space in Port Blair. These objectives encompass creating a distinct city identity, integrating existing green assets to establish a comprehensive vision for urban green spaces and preserving the area's ecology and biodiversity while promoting awareness about these valuable natural resources.

Additionally, the project seeks to improve the well-being and health of the city's residents, foster social interaction within communities, and provide a variety of outdoor activities that balance ecological, educational, and recreational aspects.

To achieve these objectives, the project is meticulously planned, focusing on specific components within the key sites of Gandhi Park, Jogger's Park, and the Forest Area. In Gandhi Park, enhancements include the entrance area, art gallery, seating spaces, green amphitheatre, children's play area, and more, all designed to create a vibrant and engaging urban green space. Jogger's Park is set to undergo renovations such as parking extension, yoga deck relocation, and the addition of amenities like toilet blocks.

Meanwhile, the Forest Area will see improvements like trails, flowering along paths, information centres, and watchtowers.

The project, with a total award amount of Rs. 29,45,00,000, has commenced the survey work, scheduled for completion by May 2024. ‘Green Connect’ promises to transform Port Blair into a city with a unique identity and a sustainable, vibrant urban green space that benefits both residents and tourists while preserving the environment.

*Interviewer: What is being done to solve the problem of parking of vehicles?*

**Secretary(PBMC):** PBMC has identified 36 parking places. In order to digitize the collection systems, the POS machines have been made available to Tax Collectors for making the parking places operational as per the Notified parking charges. General public are requested to co-operate to avoid traffic congestions as well as to keep the city's road side aesthetics intact.

*Interviewer:Is flyovers and underpass part of Smart City Project?*

**Secretary (PBMC):**No.

*Interviewer: What is being done to ensure safety and security of sanitary workers?*

**Secretary (PBMC):** The PBMC has been providing time to time protective gears like Hand gloves, Gum Boot, Reflected Jackets, Rain Coat, face Mask, Soap, Sanitizer etc. to all sanitary workers in 24 Wards. Medical health check-up is also being done at regular intervals for all the sanitary workers. Besides, the Sr. Sanitary Inspectors from time to time also educate them about the health hazards and precautions to be taken.

*Interviewer: What are the other initiatives taken to make the city Green and Clean?*

**Secretary (PBMC):**PBMC has created a 3R team with the aim to convert the GVP areas into a Green patches, Selfie Points & showcasing of recycle innovative & decorative products which not only reduces the generation of waste whereas also encourages to use the waste products. Recently, a new concept of Used Book Library has also been introduced which has not only reduced the production of waste but also helped the families of Economically Weaker Sections for getting the books for their school going children.

Apart from the above, PBMC along with various entrepreneurs (ACCI, Hotel & Grain Dealers Associations, Vegetable Market Associations, various Marriage Halls Associations, AATO) initiated Go- Green concept by avoiding Single Use Plastic at Hotels, Puja Pandals, Public functions, Marriage Halls & Community Halls by introducing Green Leaves, Coconut Bowls & Bartan Bank Concept. Door to door collection of segregated waste transportation to SLRM Center for further processing is in practice. Daily cleaning of road side footpath is being done, drain cleaning, bushes cutting, beach cleaning, cattle menace, cleaning of public toilets, night sweeping at various markets. 72 GVP (Garbage Vulnerable Points) were converted into Green Patches. 3 Selfie Point have been made by PBMC for citizens and tourist in the said spot. Fines are being imposed on violators as per Solid Waste Management (SWM) By-Laws.

*Interviewer: What would you like to say to the residents of Port Blair city?*

**Secretary (PBMC):** The Port Blair Municipal Council (PBMC) continuously strives to provide citizens with essential services and amenities, ensuring their safety, comfort, and satisfaction. We encourage open communication and engagement. The 24x7 Control Room with dedicated numbers (231179, 231141, 231142, and 245798), is at your service. Whether you have concerns about sanitation, water, street lights, or any municipal matters, our section in-charges are there to assist you promptly. Your feedback is invaluable, helping us improve our services to better meet your needs.

PBMC is committed to enhancing the quality of life in Port Blair. 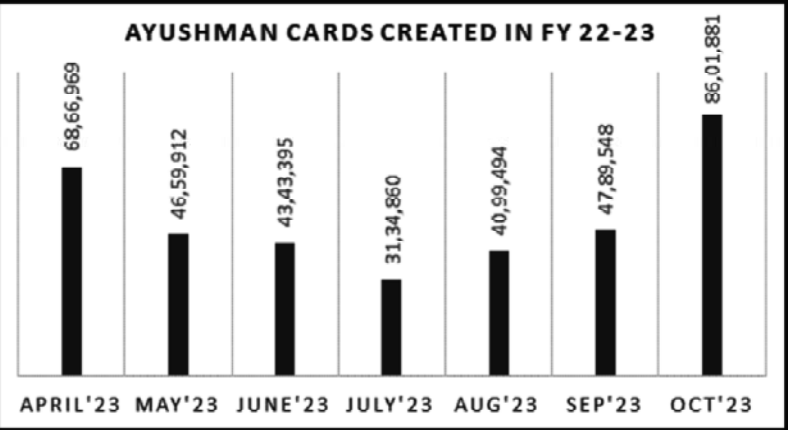

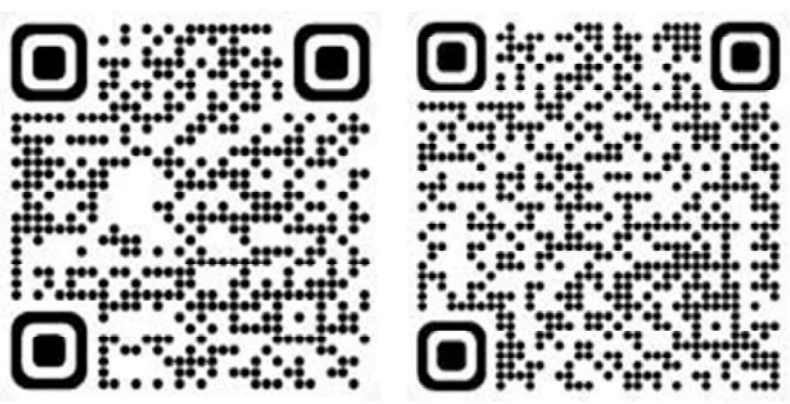

## MeitY Secretary launches 'Made-In-India' 2KW DC Portable Charger to help Boost Electric Vehicle Adoption

New Delhi, Oct. 20 (PIB)

Secretary, Ministry of Electronics & Information Technology (MeitY), Shri S Krishnan has witnessed the launch of indigenous Technology of 2KW DC Portable Charger developed by Centre of Excellence at IIT Madras Research Park to help Boost Electric Vehicle Adoption, here today at IIT Madras. The official from MeitY, Smt. Sunita Verma GC (R&DE), MeitY, Prof. Ashok Jhunjunwala, IIT Madras and other dignitaries from MeitY and IIT Madras were present on the occasion.

Addressing the gathering, Shri S Krishnan said, "The Prime Minister, Shri Narendra Modi's vision of 'Make in India Make for the World' can be achieved with developing more and more indigenisation of technology and taking it forward by the industry. Now, India has moved from importing Nation to exporting Nation, this type of innovation and synergy will make India an 'Aatma Nirbhar Bharat'.



Ministry of Electronics and Information Technology's (MeitY) mission of accelerating Electric Vehicle adoption in India, reducing the current dependence on imported charging solutions. Currently, a substantial portion of portable chargers utilized by OEMs are imported and arrive pre-programmed. Hence, they are not customizable in terms of voltage and current settings. Thermal and mechanical design play a major role in

ensuring the proper functionality of the chargers. This further underlines the importance of developing Make-In-India chargers to aid in the proliferation of EVs in India.

To address this challenge and increase local manufacturing, the 2KW charger has been designed and developed by CEET, IIT Madras and industrial partner Flowtrik Technologies with funding by the Ministry of Electronics and Information Technology (MeitY), Govt of India. These chargers sporting an efficiency of >95% and functioning at a maximum operating ambient of 50 Degree Celsius are built with over-load, over-voltage, reverse polarity and in-built EMI/EMC filter. The chargers are designed to meet safety Standard IEC 60950-11. Charger design also includes optional provision to communicate with battery for adaptive charging based on battery requirements and hooks for IoT to enable live tracking of charging related parameters. Power output settings can be customized based on the volume of the manufacturing to suit the requirement of individual OEMs. Successful large-scale manufacturing of this technology can significantly make difference in the portable charger market.

## International Olympic Committee includes T20 cricket, four other sports as part of Los Angeles Olympic Games 2028

New Delhi, Oct. 20

The International Olympic Committee has announced the inclusion of Twenty-20 cricket and four other sports as part of Olympic Games Los Angeles 2028. The other new entries are flag football, lacrosse, squash and baseball-softball.

The IOC's executive board last week accepted a proposal by Los Angeles organisers for Twenty20 cricket, along with the four other new events. Adding cricket to the Olympic programme would tap into the lucrative South Asian market, attracting fans



in countries such as India and Pakistan. Cricket last featured at the 1900 Paris Olympics, when Britain stumped France to win the Gold Medal. It remains as the only cricket match played in the Olympics so far.

## Partial Eclipse of the Moon on October 28-29

New Delhi, Oct.20 (PIB)

A partial lunar eclipse will occur on 28-29 October, 2023 (6-7 Kartika, 1945 Saka Era). Though Moon will enter penumbra at midnight of 28<sup>th</sup> October, the umbral phase will start in the early hour of 29<sup>th</sup> October. The Eclipse will be visible from all places of India around mid-night.

Eclipse will be visible in the region covering Western Pacific Ocean, Australia, Asia, Europe, Africa, eastern South America, north-eastern North America, the Atlantic Ocean, the Indian Ocean and the South Pacific Ocean.

The umbral phase of this eclipse will begin at 01 hr. 05 min IST on 29<sup>th</sup> October and will end at 02h 24m IST. The duration of the Eclipse will be 1 hour 19 minutes with very small magnitude 0.126. The next lunar eclipse which will be visible from India on 7<sup>th</sup> September, 2025 and the same will be a total Lunar eclipse.

Last lunar eclipse which was visible from India was on 8<sup>th</sup> November, 2022 and it was a total eclipse. Lunar Eclipse occurs on a full moon day when the earth comes in between the Sun and the Moon and when all the three objects are aligned. A total lunar eclipse will occur when the whole moon comes under the umbral shadow of the Earth and the partial lunar eclipse occurs only when a part of the moon comes under shadow of the Earth.

## CBSE develops Vidya Samiksha Software- Saagar se Saraansh

New Delhi, Oct. 20

The Central Board of Secondary Education (CBSE) has developed Vidya Samiksha Software- Saagar se Saraansh as part of the Vidya Samiksha Kendra for amplifying data-based decision-making. Vidya Samiksha Software of CBSE aims to leverage data and technology to bring a big leap in decision-making and governance. This software covers data from more than 28 thousand CBSE schools, over 13 lakh teachers and approximately three crore students.

Talking about the features of the software Director of Information Technology and Projects, CBSE, Dr. Antriksh Johri said that the data will be used for effective analysis of academic enrichment projects in schools in order to enhance the overall monitoring of the CBSE education system. It has over 12 billion data points. He said that this software is compliant with the National Digital Education Architecture that was launched by Prime Minister, Shri Narendra Modi in 2021. He further added that the software provides real-time updates and data processing.

Dr. Johri said that the software aims to create a single source platform, fostering detailed analysis and visualization to generate actionable insights. He said that the software primarily includes three datasets that consist of comprehensive school data, academic skill training and sports data and examination results data.

The existing data resources collected by CBSE have been utilized to bring forth insights and generate reports to provide guidance and direction for the Board, Departments, Regional Offices, Schools, Teachers and Students. (Source:india.gov.in)

## Indian Navy gets its third stealth destroyer 'IMPHAL'

New Delhi, Oct. 20

The third stealth destroyer of Project 15B Class Guided Missile Destroyer 'IMPHAL' was handed over to the Indian Navy by The Mazagon Dock Shipbuilders Limited in Mumbai today.

It is constructed using Indigenous Steel DMR 249A with an overall length of 164 meters and a displacement of over 7,500 Tons. The Destroyer is amongst the largest Destroyers constructed in the country.

The ship is a potent platform capable of undertaking a variety of tasks and missions, spanning the full spectrum of maritime warfare. It can accommodate a crew of 312 persons, has an endurance of 4,000 Nautical Miles and can carry out a typical 42-day mission with extended mission time in out-of-area operations.

The IMPHAL has been delivered to the Indian Navy more than four months ahead of the contractual time. (Source: india.gov.in)

With this significant triumph, he joined the ranks of other leading players such as SL Narayan, Javokhir Sindarov, David Navayan, Arjun Erigaisi, and Nodirbek Yakubboev, all of whom held a remarkable score of 5.5 out of 7.
