

Craftsmen Training Scheme (CTS):

The A&N Administration through Industrial Training Institute (ITI) imparts institutionalised vocational training under Craftsman Training Scheme (CTS). As on date, a total of 3 Government ITIs are functioning, one in each district. Under Craftsman Training Scheme, 13 conventional trades are offered in 41 Training Units with a total intake capacity of 928 seats. The duration of the trades are full time 02 years & 01 year.

Apprenticeship Training Scheme (ATS) / National Apprenticeship Promotion Scheme (NAPS): Ministry of Skill Development and Entrepreneurship is the Administrative Ministry responsible for implementation of the Act for skill based trade apprenticeship with assistance of State/UT Governments.

In this regard, all the concerned stakeholders/employers including Government/PSUs/ MSMEs/Private etc. have been requested to register their establishment on the designated portals of Government of India i.e. http://www.apprenticeship.gov.in and https:// apprenticeshipindia.org for engagement of Apprentices. At present, a total of 58 Govt./Private establishments have been registered in the NAPS portal under A & N Administration to offer Apprenticeship training in these Islands.

Pradhan Mantri Kaushal Vikas Yojana (PMKVY): PMKVY is implemented by National Skills Development Corporation (NSDC) under the guidance of the Ministry of Skill Development and Entrepreneurship (MSDE). The objective of the said scheme is to enable Indian youth to take-up Industry-Relevant Skill training that will help them in securing a better livelihood. The target group of this scheme is the unemployed youth or school/college passed outs/ dropouts who have a minimum age of 18 years.

The A&N Administration is implementing the PMKVY in these Islands through the Govt. ITI Dollygunj as a Nodal Agency. The Govt. ITI Dollygunj along with its 8 Training Centers have been accredited in more than 54 Job roles under Short Term Training (STT).
