## Social Welfare Deptt. implementing National Family Benefit Scheme

Eligible beneficiaries may obtain form from Directorate of Social Welfare or Offices of CDPOs

Port Blair, Sept. 14

The Directorate of Social Welfare is implementing the National Family Benefit Scheme (NFBS) which is administered by the Ministry of Rural Development under the National Social Assistance Program (NSAP). As per the scheme, an amount of Rs. 20000/- will be given as a lump sum assistance to the bereaved household in the event of the death of the breadwinner.

It is clarified that any event of death (natural

or otherwise) would make the family eligible for assistance. A woman in the family, who is a homemaker, is also considered a 'breadwinner' for this purpose. The family benefit will be paid to such surviving member of the household of the deceased poor, who after local inquiry, is found to be the head of the household. For the purpose of the scheme, the term 'household' would include spouses, minor children, unmarried daughters, and dependent parents.

In case of the death of an unmarried adult, the term household would include minor brothers/sisters and dependent parents.

The death of such a breadwinner should have occurred while/she is more than 18 years of age and less than 59 years of age. The assistance would be given in every case of the death of a breadwinner in a family.

The eligibility criteria for availing the Scheme is that the family should

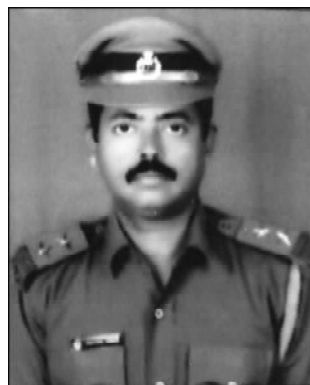
