And whereas, according to the information received from the Andaman and Nicobar Administration, 98% voters have been issued Electoral Photo Identity Cards (EPICs). However, there may be electors who have lost their Identity cards and a few newly enrolled electors may not be having the EPICs, and such electors will find it difficult to cast their vote:




