

Tokyo Olympics gold medallist Neeraj Chopra nominated for Laureus World Breakthrough of the Year Award

New Delhi, Feb. 4

Tokyo Olympics gold medallist Neeraj Chopra has been nominated for the prestigious Laureus World Sports Awards. India's first-ever winner of an Olympic athletics gold medal, Neeraj has been selected as one of the six nominees for the 2022 Laureus World Breakthrough of the Year Award. The other five sportspersons who have been nominated for the award are Australian Open runner-up Daniil Medvedev, British tennis star Emma Raducanu, Barcelona and Spain footballer Pedri, Venezuelan athlete Yulimar



Rojas and Australian swimmer Ariarne Titmus. 24-year-old javelin thrower is only the third Indian to be nominated for the award after wrestler Vinesh Phogat in 2019 and cricket star Sachin Tendulkar, who won the Laureus Sporting Moment Award 2000-2020. A panel of over 1,300 sports journalists and broadcasters globally selected the

nominees in seven categories. The winners will be revealed in April following a vote by the Laureus World Sports Academy, made up of 71 sporting greats. In a statement, Chopra said, he is delighted to be nominated for this Laureus Award. It's a great honour for him to be recognized in the wider sporting world for what he achieved in Tokyo, he added.

India administers over 168.47 crore vaccine doses under Nationwide Vaccination Drive

New Delhi, Feb. 4

Over 168 crore 47 lakh vaccine doses have been administered so far under Nationwide Vaccination Drive. Health Ministry said, over 55 lakh 58 thousand doses were administered yesterday. The Recovery Rate is currently at 95.39 percent. Over 2 lakh 46 thousand recoveries in the last 24 hours increase total Recoveries to over 4 crore. India's Active caseload currently stands at 14 lakh 35 thousand 569. Active cases stand at 3.42 percent. Over one lakh 49 thousand new

cases were recorded in the last 24 hours. The daily positivity rate is at 9.27 percent and Weekly Positivity Rate is at 12.03 percent. One thousand 72 deaths have been reported in the last 24 hours. Over 73 crore 58 lakh tests have been conducted so far. Over 16 lakh 11 thousand tests were conducted in the last 24 hours. Health Minister, Dr Mansukh Mandaviya has said that Young India's historic effort continues and in just one month, 65 percent of children aged 15 to 18 received the first dose of the COVID-19 vaccine. 
