

#### TN Guv's 'guest' recorded Assembly proceedings, matter referred to Committee of Privileges

It is the Governor's duty to read out govt prepared address: Speaker

ruling DMK legislator T R B Rajaa on Wednesday raised a question involving breach of privilege as a 'guest' of Governor R N Ravi recorded Assembly proceedings using his mobile phone in contravention of

Speaker M Appavu referred the matter to the Committee of Privileges for its consideration. Following the question hour, Rajaa said on January 9 a 'guest' of Governor Ravi recorded from the visitor's gallery, House proceedings using his mobile phone. That day, Ravi was in the Assembly to make his customary address of the year to the House. Rajaa said mobile phones are not allowed inside the House and recording proceedings went against rules. After noticing it, the ruling party MLA said he took up the matter with Assembly authorities. The legislator said he has provided a notice on the matter as it involved breach of privilege of the House. Rajaa urged Speaker Appavu to refer the matter to the Committee of Privileges. Accepting it, Appavu said he was referring it to the Privileges panel for its consideration

The Assembly Speaker on Wednesday said that the onus of responsibility in respect of the content of Governor's address is on the chief minister and his council of ministers and the duty of the Governor is only to read out the prepared text. Giving his ruling on MLAs-belonging to parties including the Congress, Viduthalai Chiruthaigal Katchi and the Left-raising slogans during Governor R N Ravi's customary address to the House on January 9, Appavu said the microphone on

CHENNAI, JAN 11 /--/ In the Assembly, such occasions is provided only to the Governor and no one else. The Governor has a right to address the House and no hindrance shall be caused. Citing relevant rules, he said members shall comply with it. On that day, the Legislators aired their views and there was no 'dharna' or any untoward incidents.

The Speaker said slogan shouting should have been, however, avoided and in future they must steer clear of it. Appavu recalled past instances (1998 and 2011) witnessed in the House when Governors of the day were present. During the previous AIADMK regime (1991-96), rules were relaxed and critical remarks were made against the then Governor M Channa Reddy. However, when (late DMK patriarch) M Karunanidhi returned as Chief Minister (1996-2001) rules were amended to ensure that there was no discussion or remarks visa-vis the Governor, President and Judges.

On Governor Ravi's customary address, the Speaker said there were irregularities in respect of the text he read out as there were exclusions from the government prepared address. Also, Ravi made inclusions on his own.

Though this led to an abnormal situation, chief minister Stalin deftly handled it and piloted a resolution which shone light on the rights and role of a Governor and upheld the dignity of the House. Appavu lauded Stalin for bringing the resolution and getting it passed. As regards the content of Governor's address. the onus of responsibility, is on the chief minister and his council of ministers and the duty of the Governor is only to read out the text, he said, (PTI)

## Naqvi hails Bhagwat's remarks on Muslims, says spirit of partnership leads to path of growth

Union minority affairs minister and senior BJP leader Mukhtar Abbas Naqvi on Wednesday hailed RSS chief Mohan Bhagwat's remarks on Muslims and said the spirit of partnership and not the battle to dominate leads to the path of development.

Naqvi's assertion came after Bhagwat said Muslims have nothing to fear in India, but they must abandon their "boisterous rhetoric of supremacy". In an interview to Organiser and Panchjanya, Bhagwat said: "The simple truth is this, Hindusthan should remain Hindusthan. There is no harm to the Muslims living today in Bharat... Islam has nothing to fear. But at the same time, Muslims must abandon their boisterous rhetoric of supremacy.' "We are of an exalted race; we once ruled over this land, and shall rule it again; only our path is right, rest everyone is wrong; we are different, therefore we will

continue to be so; we cannot live together; they (Muslims) must abandon this narrative. In fact, all those who live here whether a Hindu or a communist must give up this logic," the RSS chief said.

Speaking with journalists here on Bhagwat's remarks, Naqvi said: "The spirit of participation and not the battle to dominate leads to the path of development and trust. The result of this is that out of every 10 Muslims in the world, one is living in India. His social, economic and educational rights are completely secure and strong." "But the problem is not of common Muslims, it is of the 'contractors' vying for

want Muslims to be a part of inclusive development and society," he said in an apparent swipe at the Opposition. But today the environment has changed and because of this there has been a "lockout" on the shops of contractors vying for Muslim votes,

In his remarks, Bhagwat had said the new-found aggression among Hindus the world over was due to an awakening in the society that has been at war for over 1,000 years. "You see, Hindu society has been at war for over 1,000 years this fight has been going on against foreign aggressions, influences and foreign conspiracies. Sangh has offered its support to this cause, so have others. There are many who have spoken about it. And it is because of all these that the Hindu society has awakened. It is but natural for those at war to be aggressive," Bhagwat

#### PM to flag off 'world's longest river cruise' on Friday

Narendra Modi will flag off the world's longest river cruise, MV Ganga Vilas, and inaugurate a 'Tent City' on the banks of the Ganga river in Varanasi on January 13 via video conferencing.

His office said in a statement that he will also inaugurate and lay the foundation stones for several other inland waterways projects worth more than Rs 1,000 crore

during the event. MV Ganga Vilas will begin its journey from Varanasi and sail around 3,200 km in 51 days to reach Dibrugarh in Assam via Bangladesh. traversing across 27 river systems in the two countries, it said. Modi said the 51-day river cruise is a unique opportunity to connect with the country's cultural roots and discover beautiful aspects of its diversity. The cruiser has three decks 18 suites on board with a capacity of carrying 36 tourists and having all luxury amenities. The maiden voyage has 32 tourists from Switzerland signing up for the entire length of the journey, it noted.

The PMO said the cruise has been curated to bring out the best of the country to be showcased to the world. The cruise is planned with visits to 50 tourist spots including world heritage sites, national parks, river 'ghats' and major cities like Patna in Bihar, Sahibganj in Jharkhand, Kolkata in West Bengal, Dhaka in Bangladesh and Guwahati in Assam. The journey will give the tourists an opportunity to embark upon an experiential voyage and indulge in the art, culture, history, and spirituality of India and Bangladesh. In line with the Prime Minister's endeavour to boost river cruise tourism, the service will help unlock the huge untapped potential of the sector and herald a new age of tourism for India, it

The 'Tent City' at Varanasi has been conceptualised on the banks of the River Ganga to tap the potential of tourism in the region, the PMO said. The project has been provide accommodation facilities and PMO said. (PTI)

FATEHGARH SAHIB, JAN 11 /--/ Congress leader Rahul Gandhi on Wednesday accused the BJP of spreading fear and hatred in the country, even as he asserted that India stood for "brotherhood, unity and respect" and that is why his 'Bharat Jodo Yatra' was "successful".

Rahul was addressing people at Sirhind here before beginning Punjab leg of the Yatra. "An atmosphere of hatred has been spread in the country. The BJP and RSS people are dividing the country, putting one religion against

## Lakhimpur Kheri violence: May take at least 5 years to conclude trial in normal course, sessions judge tells SC

NEW DELHI, JAN 11 /--/ It might take at least five years in the normal course to conclude the trial in the Lakhimpur Kheri violence case, a sessions judge conducting the trial in the case in which Union minister Ajay Kumar Mishra's son is one of the accused, informed the Supreme Court on Wednesday.

In a report submitted to the apex court, the additional sessions judge said there are 208 witnesses, 171 documents and 27 forensic science laboratory (FSL) reports in the case. The apex court had last month asked the sessions court how much time in normal course was it likely to take to conclude the trial, without compromising with the schedule of other pending or prioritised matters. "The report says it will take at least five years. It says there are 208 witnesses, 171

documents and 27 FSL reports," said a bench of Justices Surya Kant and V Ramasubramanian while referring to the report received from the trial court judge. "He (sessions judge) says in normal course, it may take five years," observed the bench, which is hearing a plea by Ashish Mishra seeking bail in the case of mowing down of protesting farmers in October 2021 in Lakhimpur Kheri.

During the hearing, the bench asked the counsel appearing for the Uttar Pradesh government to confirm whether the four accused in a separate case lodged over the killing of three occupants of the SUV, which allegedly mowed down four farmers in the incident, are still in custody. At the outset, advocate Prashant Bhushan, appearing for the complainant in the case of the killing of farmers,

hearing for some other day, saying senior advocate Dushyant Dave who is leading him in the matter is unwell. The bench inquired from the state's counsel about the status of the separate case lodged over the killing of three occupants of the SUV, which allegedly mowed down farmers.

The counsel said charges have been framed against the accused in that matter. "We just want to know if there are accused in that case who have been arrested?" the bench asked. The state's counsel said four accused were arrested in the case. Senior advocate Mukul Rohatgi, appearing for Ashish Mishra, told the bench that the trial judge has sent a report to the apex court. When the bench said as per the report of the additional sessions judge, it may take at least five

conclude the trial, Bhushan said material witnesses can be examined first. "The problem is the report says when the case was fixed for examination of prosecution witnesses, one of the material witnesses was to be examined but he got fever and was unwell on that day...These practical difficulties may arise," the bench pointed out.

It said if the trial in the case is asked to be speeded up, it will have to be done at the cost of all other cases pending in that court. Bhushan said day-to-day trial is needed in this case being probed by a special investigation team. When he alleged that some witnesses were attacked and beaten up, Rohatgi shot back, saying: "This is completely false." The bench observed that ultimately, the larger interest and

requested the bench to post the years in the normal course to larger issue will have to be kept in mind and fixation of time sometimes can create serious prejudice to the prosecution's case. Bhushan, while arguing that the accused in the case of mowing down of farmers are influential, suggested the apex court can ask the trial court to hold day-to-day trial and examine material witnesses first.

The bench posted the matter for further hearing on January 19. On October 3, 2021, eight people were killed in Tikunia in Lakhimpur Kheri district during violence that erupted when farmers were protesting against the then Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya's visit to the area. Four farmers were mowed down by an SUV in which Ashish Mishra was seated, according to the Uttar Pradesh Police FIR. (PTI)

## New therapies, not tobacco ban, key to combating lung cancer: Nobel laureate

of novel immunotherapies and diagnostic techniques and not a complete ban on tobacco that is impossible to enforce, says American Nobel Jaureate Harold Varmus.

Varmus won the 1989 Nobel Prize in Medicine - along with American immunologist Michael Bishop -- for the discovery of gene mutations that can lead to the transformation of a normal cell into a tumour cell and result in cancer. Dwelling at length on lung cancer, the leading cause of death due to cancer globally as well as in India, Varmus said, "Trying to prohibit tobacco or to ban tobacco entirely is a mistake because we know that you can't enforce complete prohibition. That is the kind of thing that leads to various forms of crime and it doesn't work.'

"I don't think bans work very well. But I do think that not just in India and every country, including the US, where we still have 18 per cent of our population smoking, we have people using nicotine vapes instead of cigarettes. All these are risk factors for cancer," the scientist told PTI in an interview at Ashoka University in Sonepat, Haryana. The Parliamentary Standing Committee on Health and Family Welfare in India has recommended in its latest report that the government ban the sale of loose cigarettes. "The focus should be on novel therapies and diagnostic techniques and not on complete prohibition," the 83-year-old said when asked if tobacco ban is the answer to combat the deadly disease.

Noting that there were limited therapies available for lung cancer 20 years ago, Varmus said he is "optimistic" about developments in the field of cancer research. "Broadly speaking, in addition to the preventive advice, which is mainly about smoking, that's the biggest with respect to lung cancer. But the second thing is early diagnosis and there are new ways to make diagnoses of lung cancer earlier. Third thing is the development of new kinds of therapies.'

Varmus, who is currently the Lewis Thomas University Professor of Medicine at Weill Cornell Medicine and a senior associate at the New York Genome Center. said there are two major types when it comes to diagnostics. "The first one I'm particularly knowledgeable about because it involves work that I and my colleagues

"And we now have drugs that work in a very precise fashion to reverse the effects of those mutations. These so-called targeted drugs have had a very measurable benefit on the lifespan of somebody who's diagnosed with cancer. These are not curative but they're highly beneficial."

The scientist also highlighted the role of genetics in cancer diagnosis, saying the chances of different cancers arising vary if a person comes from a certain ancestry. "We can use modern genetics, genome tools to try to understand the amount of risk that's conferred by your ancestry and make people more alert to certain kinds of cancers and seek attention if they have symptoms of those cancers," Varmus said. "Early diagnostic procedures, when they're available, reduce the risk factors which may be exposure to certain environmental factors," the scientist said. Varmus is in India at the invitation of the Indian Academy of Sciences to give a series of lectures that were scheduled to be held in 2020 but could not due to the pandemic. He will be travelling over the next two weeks to Pune, Odisha and Bangalore to deliver lectures about the nature of science and about the kinds of work that he has done over the course of his career.

Varmus, who has previously been the director of the US National Cancer Institute, also emphasised the role of new immunotherapies -- that are based on changes in the immune system -- in lung cancer research.

"We now know that a certain percentage of patients with certain kinds of lung cancer -- this is not for everybody -- but for many people the use of agents that affect the immune system can prolong life to a degree we don't really fully understand," he added. Every patient, he said, will not respond to these drugs, but some have a temporary reduction in their cancer.

According to the World Health Organization, cancer accounted for nearly 10 million deaths in the world in 2020, with lung cancer accounting for 2.21 million cases. The Indian Council of Medical Research (ICMR) notes that the number of lung cancer cases in India is expected to rise more than sevenfold by 2025. (PTI)


## SA Police confiscates 158 pieces of Padauk worth Rs 3 Lakhs

#### Stop distressing scenes, **Govt tells TV channels**

The I & B Ministry's latest advisory to TV channels against telecast of distressing and disturbing footages has not come a day too soon. In the recent months, there have been umpteen instances of telecast of such sickening scenes -- the television news coverage of cricketer Rishabh Pant's road accident in Uttarakhand being among the latest. The detailed advisory was issued after several instances of lack of discretion by television channels were noticed by the Ministry while reporting incidents of accidents, deaths, and violence including that against women, children and elderly in manners which grossly compromises on "good taste and decency". The Ministry said that television channels have shown dead bodies of individuals and images/ videos of injured persons with blood splattered around, people, including women, children and elderly being beaten mercilessly in close shots, continuous cries and shrieks of a child being beaten by a teacher shown repeatedly over several minutes, including encircling the actions thereby making it even more ghastly, without taking the precaution of blurring the images or showing them from long shots. It has further highlighted that the manner of reporting such incidents is distasteful and distressing for the audience. The advisory highlighted the impact such reporting has on various audience. It stated that such reports can also have an adverse psychological impact on the children. There is also a crucial issue of invasion of privacy which could be potentially maligning and defamatory, the advisory underlined.

Television, being a platform usually watched by families in households with people from all cohorts - old aged, middle aged, small children, etc., and with various socio-economic backgrounds, there should be a certain sense of responsibility and discipline among the broadcasters, as enshrined in the Programme Code and the Advertising Code. The Ministry observed that in most cases, the videos are taken from social media and broadcast without editorial discretion and modifications to ensure compliance and consistency with the Programme Code. Citing a dozen examples of such broadcast content in the past few months, the Ministry said distressing images and videos of a cricketer injured in an accident, were shown without blurring, a reference to cricketer Pant, who suffered injuries on the head, along with a ligament injury on his right ankle when the Mercedes Coupe he was himself driving crashed into a road divider near Roorkee and caught fire on December 30. Pant, police said, lost control after he apparently dozed off at the wheel. The disturbing footage of a man dragging the dead body of a victim and also focusing on the face of the victim with blood splattered around, was another example.

Raising concern over such telecast and in view of larger public interest involved and having regard to the nature of audience of television channels including elderly, women and children, the Ministry strongly advised all private television channels to attune their systems and practices of reporting incidents of crime, accidents and violence, including death in conformity

# Legitimacy based on technicality leaves important issues unanswered

The Supreme Court has by a 4-1 majority ruled that the demonetisation decision by the Modi government was technically valid, but apart from the concerns raised in the dissenting voice recorded by Justice Nagarathna, the verdict has failed to acknowledge the huge human cost of the draconian decision.

After declaring during the hearing of the case that the court will not be a 'silent spectator and sit quietly with folded hands only because it was an economic policy decision', it has refused to consider whether the heavy cost the nation had to pay in terms of both human suffering as well as economic losses was worth the results. In fact, the apex court has disappointed by stating it was not relevant whether the objectives were achieved. This is particularly so as the court has found that the reasonable nexus with the objectives of eradicating black money, terror funding etc. If it does not matter whether the objectives were achieved or not, what is the big deal in proclaiming that the objectives were all fine?

The economy is estimated to have lost 1.5 per cent of GDP in terms of growth, which has been computed as loss of Rs 2.25 lakh crore a year. Some 15 crore daily wage earners lost livelihood as thousands of SMEs were shut. Over a hundred people died while waiting in queues to exchange their hard-earned money, while thousands had to pay with their lives in the aftermath of the crisis brought about by shortage of cash caused by the 'orphaned' decision. An in terms of fighting black money, demonetisation drew a complete blank. In fact, the window provided by demonetisation offered an opportunity to regularise tonnes of black money. There was no success in reigning in counterfeiting as well. Compared with predemonetisation days, there was an increase of 35 per

cent in counterfeit notes detected in the denomination of Rs 100, while there was a noticeable increase of 154.3 per cent in counterfeit notes detected in the denomination of Rs 50 in one year alone.

The big question that remains unanswered is who takes the responsibility for the huge human as well as economic cost, which is real as opposed to the academic interest of whether the Modi government had acted with due consideration of the consequences. If status quo cannot be restored, as reasoned by the court for not raising any challenge to the decision. Prime Minister Modi, who stunned the nation with his bolt from the blue announcement has not claimed any responsibility. In fact, he has never referred to demonetisation ever since it became clear that it was a blunder of Himalayan proportions.

The bench has taken cover under 'restraint' on the part of the court in dealing with administrative actions. "There has to be great restraint in matters of economic policy. Court cannot supplant the wisdom of executive with its wisdom," the bench pointed out while stating that the decision-making process cannot be faulted merely because the proposal emanated from the central government. This is a potentially dangerous position to take and runs counter to the stand taken by court in the past in effective interventions in forcing the government to act in dealing with the human tragedy in the long march back home by migrant labourers and the covid

vaccination programme. These interventions were based on the court's conviction that its wisdom must prevail when the government shows a lack of it.

But in the course of the hearing, the bench had made many references to the social and economic hardships and distress faced by the common people as a result of the controversial policy decision. The Centre has justified these hardships as part of the nation-building activity, but nation-building cannot be through trial and error, especially when there are safeguards against such impulsive administrative decisions. It is these safeguards that were sidestepped by Modi's dramatic announcement.

Justice Nagarathna in her dissent held that demonetisation of currency notes was a serious matter and it could not be done by the Centre by merely issuing a gazette notification. She even declared it unlawful on legal grounds and was not quite impressed by the objectives, which any way remained unrealised. She pointed out that the RBI merely approved the government's decision without applying its independent mind and cited the desire by the Centre as justification for the approval.

While the judgment refers to parliament and the supremacy of people in terms of the rights of the executive to issue administrative decisions, the court's stand of a strict no-go into the domain of economic policies is not in conformity with the Supreme Court's recent assertion of its authority for judicial review of executive decisions, although the context was different. With regards to the controversy about Collegium and the appointment of judges, the court had clearly stated that while the legislature had the power to make laws, the judiciary's power for review was not at all contestable. # Turkey walks a fine line to challenge China

An official visit to Xinjiang to assess the fate of Turkic Muslims in the troubled north-western Chinese Province is a risky proposition by any definition. Even so, it would be worth the risk if China and Turkey could agree on the terms of a visit. The problem is that the terms constitute a zero-sum game.

China wins if it controls the programme of a visiting Turkish delegation as it does with whoever else is granted access to a region where in recent years, more than one million Turkic Muslims were reportedly incarcerated in re-education camps dubbed vocational schools.

"Why would we be a tool of Chinese propaganda?" Turkish Foreign Minister Mevlut Cavusoglu snapped at a recent news conference when asked about a visit to Xinjiang by Turkey's ambassador in Beijing, Abdulkadir EminOnen."It's been five years since (Chinese President) Xi (Jinping) proposed this. Why have you been preventing this delegation from visiting for five years? Why don't you cooperate?" Cavusoglu said.

The foreign minister conceded that "Turkish-Chinese ties have suffered over Beijing being disturbed by our attitude on the Turkic Uyghurs issue," including a Turkish refusal to extradite to China Uighurs resident in the country. China and Turkey started discussing a Turkish visit in 2019. However, the talks were put on ice when China effectively closed to shield the nation from the Covid-19 pandemic. In an indication of the importance, both countries attribute to a possible visit, discussion of the terms restarted within weeks of China's recent lifting of Covid-19 restrictions. By controlling Onen's program, China is seeking to ensure that he walks away from his visit praising the Chinese administration of Xinjiang. Coming from Turkey, endorsement of China's effort to Sinicise Islam and turn Uyghur identity into a folk tale would have particular

significance.

Turkey has long fashioned itself as the hub of a Turkic world that stretches from the Turkish Diaspora in Western Europe through the Balkans across the Caucasus and Central Asia into Xinjiang and a defender of threatened Muslim communities. Moreover, Turkey is home to the largest Uighur exile community. The blue flag of East Turkistan, as Uighurs describe Xinjiang, is banned in China but flies in shop windows and restaurants in Istanbul neighbourhoods heavily populated by the ethnic group. Cavusoglu's rare public challenge of China could prove a first test for China's newly appointed foreign minister, Qin Gang. China has yet to respond to Cavusloglu. A former ministry spokesperson, a deputy director-general of its information department, and most recently, ambassador to the United States, Qin made his name as a pioneer of China's wolf warrior diplomacy involving confrontational and coercive responses to criticism of the People's

Positioning Turkey as unwilling to walk on a Chinese leash, Cavusloglu is brandishing the nationalist credentials of his ruling Justice and Development or AK Party (AKP) and President Recep Tayyip Erdogan in advance of a critical


election later this year. With Uighurs on their minds, more than half of Turks polled in multiple surveys over the past two decades express critical and/or negative attitudes towards China. In one of the latest polls, a survey conducted by the Center for Turkish Studies at Istanbul's Kadir Has University concluded that only 27 percent view China positively.

Meral Aksener, the leader of the nationalist Iyi or Good Party, one of the opposition parties aligned against the AKP, and Ankara's mayor Mansur Yavas, viewed as one of Erdogan's potentially most serious challengers, got significant traction on social media for commemorating the 1990 Baren Township Massacre during an armed clash between Uighur militants and Chinese security forces. Twenty-three people are believed to have died in the fighting. Erdogan is seeking a third term as president in an election scheduled for June 18, the centennial of the founding of the Turkish republic on the ruins of the Ottoman empire. Concerned that he could face the most serious challenge to date to his power, Erdogan uses every trick in the book to ensure that the election goes his way. Recent polls suggest that the AKP could win less than 30 per cent of the vote. Challenging China on the Uighurs follows sabre rattling in Syria, where Mr. Erdogan again wants to intervene to subdue Syrian Kurds. At the same time, Turkey is engaging under Russian Bashar al-Assad in a bid to open a relations. (IPA)

pathway for the return of up to four million Syrian refugees in Turkey. Antimigrant sentiment is a major topic in the

election campaign. Cavusoglu's refusal to "be a tool of Chinese propaganda" jars with the past acceptance by Turkey's state-owned news agency, Anadolu Agency, and iournalists working for other progovernment media, of Chinese paid and tightly controlled tours of Xinjiang designed to counter allegations of abuse against Turkic Muslims. Even so, a recent report by the Carnegie **Endowment for International Peace** noted that in the absence of much Turkish-language content in Chinese media that target foreign audiences, China "is now assertively developing new strategies to engage with local actors in Turkey."

The strategy emphasises China's economic and commercial ties to Turkey at a time when the country is struggling with an inflation rate that peaked at about 80 per cent in 2022 but dropped last month to 64.7 per cent. It's a strategy that may work. Chinese telecommunications giant Huawei, slated to build Turkey's 5G network, has four times more Turkish followers on Twitter than the Chinese embassy in Ankara. Now and then, Turkey reasserts itself as a rare Muslim nation willing to tackle China publicly on the Uighurs. But, by and large, Turkey shines by mainly remaining silent. In the final analysis, domestic politics, rather than principled concern, determines if and when Turkey takes on China. This year, elections are the driver. As a result, Uighur exiles fear that their utility is temporary and that they ultimately could be sacrificed on the auspices with the regime of President altar of Turkish-Chinese economic

## ED conducts searches in money laundering caseagainst Maharashtra NCP legislator Mushrif

**Enforcement Directorate** (ED) on Wednesday conducted searches at multiple premises in Maharashtra as part of a money laundering investigation against NCP MLA Hasan Mushrifand others, officials said

The raids are understood to be linked to a probe related to alleged irregularities in the operations of some sugar mills based in the state that are linked to Mushrif. located in Mumbai, Pune and Kolhapur are being covered by the ED officials since around 6:30 am, they said. Mushrif, 68, is a Nationalist Congress Party (NCP) MLA from Kagal constituency in Kolhapur.

He is also the vice president of the political party, headed by former chief minister and Union minister Sharad Pawar, Maharashtra. Mushrif posted an Instagram video message asking his supporters not to obstruct the action that he said are being carried out at the premises of his relatives, daughter and some co operative sugar mills. He said he was not aware about the case for which the ED action was being undertaken.

He later spoke to report ers saying the Income Tax department had carried out raids against him in 2019 that led to two allegations against him -- one about the owner ship and links to some companies and the other related to benami assets. He claimed that in both the cases the courts have "stayed" the proceedings. The Supreme Courthadlastyearruledthat the anti-benamitransactions law cannot be applied retrospectively. The Union government has recently recently filed a review petition against this order.

#### Biju Patnaik's Dakota aircraft to reach Odisha soon

BHUBANESWAR, JAN been assigned to dismantle 11/--/The Dakota aircraft the Dakota (DC-3) VT-AUI used by Biju Patnaik, which aircraft, which is about 64 had been lying in a dilapidated condition for decades at the airport in Kolkata, is likely to reach here on January 16, officials said.

The former chief minister had used this plane to rescue the then prime minister of Indonesia Sutan Sjahrir in 1947, historian Anil Dhir said. A technical team will start dismantling the aircraft at the Netaji Subhas Chandra Bose International (NSCBI) Airport in Kolkata on Wednesday and it will be transported to Odisha by road.

The plane will be positioned at a designated place at the international airport here named after Biju Patnaik, the father of Odisha Chief Minister Naveen Patnaik.

The Airports Authority of India (AAI) has already allotted 1.1 acres of land where the Dakota plane will be displayed for public viewing. Officials at Odisha's commerce and transport department said that a four-member team has feet 8 inches long with its wings stretching to 95 feet.

The team will restore, reassemble and do the renovation work at the airport here, the officials said.

Efforts to transport the aircraft to Odisha were made in the last two years, and tender was also floated for the initiative, but the COVID-19 pandemic had stalled the plan, a senior official said. Besides being a social reformer and politician, Biju Patnaik was a skilled pilot who undertook high-risk missions.

He clandestinely flew Indian freedom fighters from one location to another. the historian said. A grateful Indonesia had twice decorated Biju Patnaik with its highest civilian honour 'Bhumiputra' for rescuing Sutan Sjahrir. Before joining active politics, Biju Patnaik had set up Kalinga Airlines which operated from Calcutta. He was also a member of the Royal Indian Air Force under British

His accomplice fled fromthe spot taking advantage of the dense fog. The gangster was identified as Vinay Shrotiya, a resident of Firozabad district," said Mayank Tiwari, Assistant Commissioner of Police (ACP), Hari Parwat. Shrotiya was taken to the SN Medical

"The body has been sent for a postmortem and the family members have been informed about his death," he

Tiwari said Shrotiya fled from the police custody from the court premises on July 13 last year. "He was booked under the gangsters act and various other cases in Agra, Firozabad and other districts," he said. Shrotiya was waiting on the Agra District Court premises for his appearance when he and his accomplice hit the head constable in his head with a brick and fled from the police cus-

## Gujarat: Bootleggers and police exchange fire; None hurt

DAHOD, JAN 11 /--/A gang of bootleggers and a police team chasing them fired shots in the air in Dahod district of Gujarat, an official said on Wednesday.

Nobody was injured in the incident. The gang also tried to run over the police personnel using a vehicle on Tuesday night near Sagtala village in Devgadh Baria taluka near the Gujarat-Madhya Pradesh border, he said. "While the gang fled from the spot following an exchange of 4 to 5 rounds in the air from both sides, a State Monitoring Cell (SMC) team managed to stop one of the vehicles used by bootleggers to run over the policemen,"said Assistant Superintendent of Police, Dahod district, Jagdish Bangarva. He said the SMC team was keeping a watch at a village under the Sagtala police station on Tuesday night to nab bootleggers. "When the team asked a suspected vehicle to stop, its occupants opened fire on police. They fired nearly two-three rounds in the air. SMC officials retaliated by firing some rounds in the air. No one was injured in the firing," said Bangarva.

According to sources, the liquor mafia was involved in smuggling alcohol into 'dry' Gujarat from Madhya Pradesh. #### Joshimath: Renewed efforts by admin to persuade locals to allow demolition; clamour for compensation grows

JOSHIMATH/DEHRADUN, JAN 11 /--/ Renewed efforts were made by the administration on Wednesday to persuade hoteliers and locals refusing to allow the demolition of two precariously standing hotels in subsidence-hit Joshimath in Uttarakhand. A fresh round of talks was held between secretary to the chief minister, Meenakshi Sundaram and the protesters who have been demanding compensation on the lines of Badrinath before the demolition exercise is undertaken. Hotels 'Malari Inn' and 'Mount View' are leaning towards each other dangerously, posing a threat to the human settlements around the structures. The Uttarakhand government had directed the razing of unstable structures on Monday, starting with these two buildings. Talking to reporters, the senior official clarified that only two hotels in Joshimath have to be dismantled and not the houses demarcated as unfit for living. "I want to clarify one thing. Only two hotels are to be dismantled. Demolition, though being used widely, is not the precise word in this context. Houses in the danger zone are not going to be demolished.



The red cross marks put on them is only to have them vacated," Sundaram, who is also the nodal officer for the land subsidence-hit town, said. He, however, did not give a definite timeline on the beginning of the demolition exercise, but said his interaction with the protesting locals was positive and the matter will be resolved soon. The chief secretary also announced that Rs 1.5 lakh is being given as interim assistance to the affected families. Out of this amount, Rs 50,000 is being provided in advance for house shifting and Rs 1 lakh for disaster relief which will be adjusted later, he said. Those who want to shift to a rented accommodation will be given Rs 4,000 per month for six months, the bureaucrat said. Earlier, Sundaram held a meeting with the stakeholders and the locals and assured them that adequate compensation according to market rates will be given. "The market rate will be decided after taking suggestions of the stakeholders in the public interest. The interests of the local people will be taken care of," he said. Meanwhile, the clamour for compensation grew as agitated locals continued to sit on dharnas and refused to allow the authorities to go ahead with the demolition. (PTI)

# Vice-Prez slams 'one-upmanship' from judicial platforms, says cannot have 'Ostrich-like' stance

JAIPUR, JAN 11 /--/ Virtually censuring the judiciary, Vice-President Jagdeep Dhankhar on Wednesday said "one-upmanship and public posturing" from judicial platforms is not good and these institutions must know how to conduct themselves, while pointing to the apex court's remarks on the issue of the collegium system.


Dhankar, who is the Rajya Sabha chairman, again criticised the NJAC Act scrapping in 2015 and also questioned the landmark 1973 Kesavananda Bharati case verdict, saying it set a wrong precedent and that he disagrees with the Supreme Court ruling that Parliament can amend the Constitution but not its basic structure. As presiding officers of Legislatures, "we cannot have an Ostrich-like stance" on judiciary-legislature relations. Parliamentary sovereignty cannot be permitted to be diluted or compromised by the executive or the judiciary, he said in his strongest remarks yet against alleged judicial interference in the working of Parliament. "If any

organisation strikes down a law by Parliament. then it is not good for the democracy. And it would be difficult to say we are a democratic nation," he said addressing the 83rd All India Presiding Officers Conference here. Speaking in the same vein, Lok Sabha Speaker Om Birla said the judiciary is expected to follow the principle of separation of powers as defined in the Constitution. "Legislatures in our country have always respected the powers of the judiciary. The judiciary is also expected to follow the principle of separation and balance of powers conferred by the Constitution," Birla said. The Vice-President, who has criticised in the House and outside the striking down of the National Judicial Appointments Commission (NJAC) Act by the apex court, said it was "a scenario perhaps

In the Kesavananda Bharati case, the Supreme Court gave the idea of basic structure saying that Parliament can amend the Constitution

but not its basic structure. "With due respect to the judiciary. I cannot subscribe to this. Dhankhar, who has been a Supreme Court lawyer, said describing himself as a soldier of the judiciary and a student of law. Dhankhar further asked: "Can parliament be allowed that its verdict will be subject to any authority." The executive has to follow laws and the judiciary cannot intervene in lawmaking, Dhankhar added. "If any institution on any basis strikes down the law passed by parliament, then it will not be good for democracy and it will be difficult to say we are a democratic nation," the Rajya Sabha Chairman said. Dhankhar said no institution can wield power or authority to neutralise the mandate of people. #### Govt decides to do away with VIP Haj quota

NEW DELHI, JAN 11 /--/ The Union government has decided to do away with the discretionary Haj quota that was available with people in top constitutional posts and the minority affairs ministry, Union minister Smriti Irani said on Wednesday while asserting that the step has been taken as part of Prime Minister Narendra Modi's resolve to end 'VIP culture'.

Minority affairs minister Irani hit out at the Congress-led UPA government, saying the discretionary quota was introduced during its period. "A decision has been taken (to end discretionary quota in Haj). Prime Minister Modi had put forward his resolve to end VIP culture on the very first day of his term. VIP culture was put in place with respect to Haj during the UPA rule under which there was a special quota allocated to the Ministry of Minority Affairs, Haj Committee and all those in top

## Biden 'surprised' govt records found at old office

Joe Biden said Tuesday he was surprised when informed that government records were found by his attorneys at his former office space in Washington. He was asked about the issue after the top Republican on the House Intelligence Committee requested that the US intelligence conduct a "damage assessment" of potentially classified documents.

Speaking to reporters in Mexico City, Biden said his attorneys "did what they should have done" when they immediately called the National Archives about the discovery at the offices of the Penn Biden Center. He kept an office there after he left the vice presidency in 2017 until shortly before he launched his presidential campaign in 2019. The White House confirmed that the Department of Justice was reviewing "a small number of documents with classified markings" found at the office. "I was briefed about this discovery and surprised to learn that there are any government records that were taken there to that office," Biden said in his first comments since news of the November 2. 2022, document discovery emerged Monday. He added that "I don't know what's in the documents" and that his lawyers had suggested he not ask.

Earlier Tuesday, Rep. Mike Turner sent the request to Director of National Intelligence Avril Haines, saying that Biden's retention of the documents put him in "potential violation of laws protecting national security, including the Espionage Act and Presidential Records Act." Irrespective of a federal review, the revelation that Biden potentially mishandled classified or presidential records could prove to be a political headache for the president, who called former President Donald Trump's decision to keep hundreds of such records at his private club in Florida "irresponsible." "Those entrusted with access to classified information have a duty and an obligation to protect it," said Turner in a letter to Haines. "This issue demands a full and thorough review.

On Tuesday, Rep. James Comer, the new GOP chairman of the House Oversight Committee, sent the White House Counsel's office a letter requesting copies of the documents found at the Biden office, communications about the discovery, and a list of those who may have had access to the

WASHINGTON, JAN 11 /--/ President House didn't immediately respond to the request. Haines agreed in September to conduct a "risk assessment" rather than a "damage assessment" of the Trump case. There are significant differences between the Trump and Biden situations, including the gravity of an ongoing grand jury investigation into the Mar-a-Lago matter. The intelligence risk assessment into the Trump documents is to examine the seized records for classification as well as "the notential risk to national security that would result from the disclosure of the relevant documents." Sen. Mark Warner, the Democratic chairman of the Senate Intelligence Committee, called for a briefing on the documents.

"Our system of classification exists in order to protect our most important national security secrets, and we expect to be briefed on what happened both at Mar-a-Lago and at Biden office as part of our constitutional oversight obligations," he said. "From what we know so far, the latter is about finding documents with markings, and turning them over, which is certainly different from a months-long effort to retain material actively being sought by the government. But again, that's why we need to be briefed."

Special counsel to the president Richard Sauber said Monday that after Biden's attorneys found the records, they notified the National Archives and Records Administration which took custody of the documents the next day. "Since that discovery, the President's personal attorneys have cooperated with the Archives and the Department of Justice in a process to ensure that any Obama-Biden Administration records are appropriately in the possession of the Archives," Sauber said. A person who is familiar with the matter but not authorized to discuss it publicly said Attorney General Merrick Garland asked U.S. Attorney for the Northern District of Illinois John Lausch to review the matter after the Archives referred the issue to the department. Lausch is one of the few U.S. attorneys to be held over from Trump's administration.

## Report says UK, US supplied arms, killed civilians, in Yemen

Weapons supplied by the United Kingdom and the United States and used by a Saudi-led coalition fighting in war-torn Yemen killed at least 87 civilians and wounded 136 others in just over a year, a new report said

The report by the Oxfam charity found that the Saudiled coalition used weapons supplied solely by the UK and the US in hundreds of attacks on civilians in Yemen between January 2021 to the end of February 2022. Britain is the secondbiggest supplier of weapons to Saudi Arabia, after the US. Yemen's war began when the Iranian-backed Houthis seized the country's capital in September 2014 and forced the internationally recognised government into exile. A Saudi-led coalition armed with US weaponry and intelligence entered the war on the side of Yemen's exiled government in March 2015. Oxfam's report comes ahead of a legal challenge by the Campaign Against Arms Trade, or CAAT, against the UK government on supplying weapons used in Yemen's war. The charity

says it provides witness in support of CAAT's

Responding to an inquiry by The Associated Press, a spokesperson for UK's Department for International Trade said they operate "one of the most robust and transparent export control regimes in the world." "We consider all our export applications

thoroughly against a strict risk assessment framework and keep all licenses under careful and continual review as standard," the spokesperson said. The court battle is years old. The Court of Appeal in London ruled in 2019 that the UK government acted unlawfully in selling weapons to Saudi Arabia that were used in the Yemen war. The court however didn't order a halt to the exports to the Gulf monarchy. Oxfam's report portrayed a grim picture. Martin Butcher, Oxfam's Policy Advisor on Arms and Conflict and author of the report, said they analysed 700 attacks on civilians in Yemen's war during the 14month period, with the

Saudi-led coalition, using

weapons supplied by the UK and the US, was responsible for a quarter of all attacks. "It's just so relentless," Butcher told The Associated Press in an interview. "People just find it so hard to escape the violence and the

report airstrikes by the Saudi-led coalition during the 14month period killed at least 87 civilians and wounded 136 others. The charity counted at least 19 attacks by the coalition on health facilities and ambulances. It said 293 airstrikes forced people to flee their homes. Overall, the conflict has killed more than 150,000 people have been killed, including over 14,500 civilians, according to The Armed Conflict Location & Event Data Project, and created one of the world's worst humanitarian crises. Butcher called the UK government to "immediately stop selling arms to Saudi Arabia for use in Yemen," and promote a permanent cease-fire and negotiations for a long-term settlement through its position as a member of the UN Security Council. # Cardinal Pell, whose convictions were overturned, dies at 81

onetime financial adviser to Pope Francis who spent 404 days in solitary confinement in his native Australia on child sex abuse charges before his convictions were unanimously overturned, died Tuesday in Rome.


He was 81. Pell suffered fatal heart complications following hip surgery, said Archbishop Peter Comensoli, Pell's successor as archbishop of Melbourne. Pell had been in Rome to attend the funeral last week of Pope Benedict XVI. "This news comes as a great shock to all of us," Sydney Catholic Archbishop Anthony Fisher said in a statement on Facebook. "Please pray for the repose of the soul of Cardinal Pell, for comfort and consolation for his family and for all of those who loved him and are grieving him at this time." Australian Prime Minister Anthony

Albanese said plans were underway to hold a service at the Vatican and to bring Pell's body back to Australia. "For many people, particularly of the Catholic faith, this will be a difficult day and I express my condolences to all those who are mourning today," Albanese said. Journalist Lucie Morris-Marr, who wrote the book "Fallen" about Pell's trial, said on Twitter that Pell's death "will be terribly triggering for many Australians impacted by Catholic child sexual abuse and not just those involved in his

Pell, the former archbishop of Melbourne and Sydney, became the third-highest ranked official in the Vatican after Pope Francis tapped him in 2014 to reform the Vatican's notoriously opaque finances as the Holy See's first-ever finance czar. He spent three years as prefect of the newly created Secretariat for the Economy, where he tried to impose international budgeting, accounting and transparency standards. But Pell returned to Australia in 2017 in an attempt to clear his name of child sex charges dating from his time as archbishop.

A Victoria state County Court jury initially convicted him of molesting two 13-year-old choirboys at St. Patrick's Cathedral in the latest

1990s shortly after he had become archbishop of Melbourne. Pell served 404 days in solitary confinement before the full-bench of the High Court unanimously overturned his convictions in 2020. During his time in prison, Pell kept a diary



documenting everything from his prayers and Scripture readings to his conversations with visiting chaplains and the prison guards. The journal turned into a triptych, "Prison Journal," the proceeds of which went to pay his substantial legal bills. In the diary, Pell reflected on the nature of suffering, Pope Francis' papacy and the humiliations of solitary confinement as he battled to clear his name for a crime he insists he

Pell and his supporters believe he was scapegoated for all the crimes of the Australian Catholic Church's botched response to clergy sexual abuse. Victims and critics say he epitomized everything wrong with how the church has dealt with the problem. "Looking back, I was probably excessively optimistic that I'd get bail," Pell said in a 2021 interview at his home in Rome, crediting his "glass half-full" attitude to his Christian faith. Even after he was acquitted, Pell's reputation remained tarnished by the scandal. Australia's Royal Commission into Institutional Responses to Child Sexual Abuse found that he knew of clergy molesting children in the 1970s and did not take adequate action to address it.

Pell later said in a statement he was

"He acknowledged what I was trying to do," Pell said of the pope during a 2020 interview. "And, you know, I think it's been sadly vindicated by revelations and developments." Francis said as much in a recent interview with Italy's Mediaset broadcaster,

crediting Pell with having set the Vatican on the path of financial transparency and lamenting that he was forced to abandon the effort to face the "calumny" of the abuse charges back home. "It was Pell who laid out how we could go forward. He's a great man and we owe him so much," Francis said last month.

Pell was born on June 8, 1941, the eldest of three children to a heavyweight champion boxer and publican also named George Pell, an Anglican. His mother Margaret Lillian (nee Burke) was from an Irish Catholic family. He grew up in the Victorian regional town of Ballarat. At 193 centimeters (6 foot, 4 inches) tall, he was a talented Australian Rules Footballer. He was offered a professional football contract to play for Richmond but opted for a seminary instead. After his convictions were overturned, Pell divided his time between Sydney and Rome, where he took part in the typical life of a retired cardinal, attending Vatican events and liturgical feasts and otherwise keeping up with news of the church. "I've become very Italian," Pell told a visitor during a lull of the coronavirus pandemic, which he spent in Rome. A requiem Mass would be celebrated in Rome, but Pell was expected to be buried in Sydney. (AP)

#### Lanka summons Canadian diplomat over sanctions on Rajapaksa brothers

COLOMBO, JAN 11 /--/ Sri Lanka's Foreign Ministry on Wednesday summoned Canada's top diplomat here and expressed its displeasure over his country's decision to impose "unilateral sanctions" on its four citizens, including two former presidents.

Canada on Tuesday imposed sanctions on four Sri Lankans, including former presidents Gotabaya Rajapaksa and Mahinda Rajapaksa, for committing what it called "gross and systematic violations of human rights" during the country's civil war. Sanctions were also imposed on Staff Sergeant Sunil Ratnayake and Lt Commander Chandana P Hettiarachchithe. Reacting to the sanctions, the foreign ministry summoned Canada's Acting High Commissioner in Colombo and expressed the government's displeasure over the move. "Foreign Minister Ali Sabry summoned the Canadian Acting High Commissioner Daniel Bood to the Ministry of Foreign Affairs..., and expressed the deep regret of the Government on the announcement of unilateral sanctions brought against four individuals including two former Presidents of Sri Lanka by the Government of Canada based on unsubstantiated allegations," the foreign ministry said in a tweet.

Earlier, State Minister of Foreign Affairs Tharaka Balasuriya said that the sanctioning of former presidents was "untimely" and was intended to pacify domestic elements in Canada. He said Canada's decision to impose sanctions on the Rajapaksa brothers came at a time when Sri Lanka was attempting to take forward the post-war reconciliation process. "This shows who our friends really are and who are not," he was quoted as saying by the Colombo Gazette newspaper. The sanctions target former president Gotabaya, who resigned in July last after a massive protest against his government, and his elder brother Mahinda, who has held the titles of president and prime minister. Gotabaya temporarily fled his country last summer after mass protests over the country's economic crisis, while Mahinda resigned from his post as prime minister last spring. Sri Lanka's majority Sinhalese population had praised the brothers for defeating Tamil separatists after a 26-year civil war, which took place from 1983 to 2009.

The LTTE ran a military campaign for a separate Tamil homeland in the northern and eastern provinces of the island nation before its collapse in 2009 after the Sri Lankan Army killed its supreme leader V Prabhakaran. (PTI)

## Greece's former king to be buried as a private citizen

former and last king of Greece, will be buried as a private citizen in Tatoi, the former summer residence of Greece's royals and where his parents and ancestors are buried, the government said on Wednesday. A controversial figure in Greek history, Constantine died in hospital late on Tuesday night at the age of 82. Greece's monarchy was definitively abolished in a referendum in 1974, and Constantine spent decades in exile before settling in his home country once more in his waning years. Decisions on his funeral were announced by the office of Prime Minister Kyriakos Mitsotakis, who chaired a Wednesday details. The date and location of the funeral service were not immediately determined and will be decided on in collaboration with the former king's family, the prime minister's office said. The government will be represented at the funeral by the culture minister, while "all protocol procedures will be followed for dignitaries from abroad who will attend the funeral", the announcement said.

Few people in Greece have any nostalgia for the former royal family, but other European royals, many of whom are related to Constantine, are likely to attend his funeral. His older sister is Sophia, wife of former King Juan Carlos I of Spain, while the Greek-born Prince Philip, the late husband of Britain's late Queen Elizabeth II, was an uncle. Constantine was one of the godparents of Prince William, the heir to the British throne. The family, which had ruled Greece from 1863 apart from a 12-year republican interlude during 1922-1935, was descended from Prince Christian, later Christian IX of Denmark, of the House of Schleswig-Holstein-Sonderburg-Glucksburg branch of the Danish ruling family. Constantine's wife, Anne-Marie, is the younger sister of Denmark's Queen Margrethe. In a statement, the royal palace in Copenhagen said it was "with great sadness" that the queen had learned of Constantine's death. "The royal family's thoughts are currently with H.M. Queen Anne-Marie and the entire Greek family,"

ATHENS, JAN 11 /--/ Constantine, the the Danish palace said. An Olympic sailing gold medalist, Constantine was hugely popular when he acceded to the throne in 1964 at the age of 23, but much of that support rapidly waned with his active involvement in the machinations that brought down the elected government of Prime Minister George Papandreou. The episode involving the defection from the ruling party of several lawmakers destabilized the constitutional order and led to a military coup in 1967. Constantine eventually clashed with the military rulers and was forced into exile.

When the dictatorship collapsed in July 1974, Constantine was eager to return to veteran politician Constantine Karamanlis, who returned from exile to head a civilian government. After his triumphal win in November elections, Karamanlis called for a plebiscite on the monarchy. Constantine was not allowed in the country to campaign, but the result was unambiguous and widely accepted: 69.2 per cent voted in favour of a republic. To his final days, Constantine, while accepting that Greece was now a republic, continued to style himself King of Greece and his children as princes and princesses even though Greece no longer recognized titles of nobility. For most of his years in exile he lived in London and was said to be especially close to his second cousin, Charles, now King Charles III. "The eventful course of former King Constantine marked and was marked by turbulent times in the country's modern history," Mitsotakis said in a statement. "By wounds that were however healed by the choices, the free conscience and the maturity of our people. But also by his own discreet, it is true, stance throughout the post-dictatorship years." Constantine's death marked the "formal epilogue of a chapter that had definitively closed with the 1974 referendum", Mitsotakis said, extending his condolences to the former king's family. History, he said, "will judge the Constantine of public life fairly and strictly. Because the person Constantine is already accompanied by sadness and respect in the face of the loss of life itself." ## UK's Princess Anne visits British peacekeepers on Cyprus

NICOSIA, JAN 11 /--/ Britain's Princess Anne cast aside the controversy surrounding her nephew Prince Harry and carried on with her royal duties on Wednesday by visiting British soldiers serving with a United Nations peacekeeping force on ethnically divided Cyprus. The princess, who is King Charles

III's sister and the only daughter of the late Queen Elizabeth II, plans to meet with members of the Royal Logistic Corps, the army unit of which she serves as colonel-in-chief, to recognise their service to one of UN's longest-serving peacekeeping forces. peacekeepers invited Anne to visit and planned to lead her on a tour of a section of the UN-controlled buffer zone that separates the island nation's breakaway Turkish Cypriot north from the internationally recognised Greek Cypriot south. The princess will also lay a wreath at a cemetery in



the buffer zone where many Commonwealth soldiers who died in conflicts including both world wars are buried. The visit came the day after Prince Harry's ghostwritten memoir "Spare" went on sale around the world. The book exposes bitter divides inside the House of Windsor.

Harry, who spent a decade in the British army, claims his relatives were unwelcoming to his wife, Meghan, and accuses members of the royal family, including his stepmother Camilla, of leaking stories to the media to burnish their own reputations.

Buckingham Palace has not commented on any of the allegations, though royal allies have pushed back, largely anonymously. Earlier on Wednesday, Anne met with Cypriot President Nicos Anastasiades. They discussed climate change-related issues, the energy crisis spurred by Russia's war in Ukraine and efforts to

restart stalled talks to reunify Cyprus, a government statement said. Anastasiades gifted the princess a silver copy of cup from the 4th century BC and a photo album of Cypriots who volunteered to fight with British forces during World War II. Anne reciprocated with a portrait of herself.

The princess also was scheduled to meet with soldiers and their families at Dhekelia Garrison, one of two military bases that the UK retained after Cyprus gained independence from British rule in

Media access during her visit was limited to Anne's brief meeting with Anastasiades. She did not make any public remarks. British High Commissioner to Cyprus Irfan Siddiq said in a statement that the visit was "an important opportunity to showcase the strength of the enduring links between our two countries". (AP)

### **Hundreds of flights across US** grounded after technical failure at FAA

WASHINGTON, JAN 11 / --/ Hundreds of flights across the US were grounded on Wednesday morning following a technical failure in the system of the Federal Aviation Administration (FAA). The extent of the delays was not immediately known. But the FAA said it is working to restore it as soon as possible. "The FAA is working to restore its Notice to Air Missions System. We

performing final validation checks and reloading the system now. Operations across the National Airspace System are affected," FAA said. The outage comes as a result of the failure of the Notice to Air Missions system, which alerts pilots and other personnel about airborne issues and other delays at airports across the country. "The FAA is still working to fully restore the Notice to

Air Missions system following an outage. While some functions are beginning to come back on line, National Airspace System operations remain limited," the FAA said in another update of the evolving situation.

While the FAA has not enforced a grounding of aircraft due to the technical failure, most airlines have chosen to ground their own aircraft. (PTI)

# India eyeing another big win with Rohit, Virat in full flow

KOLKATA, JAN 11 /--/ Buoyed by the form of its top three batters, a clinical India will look to take an unassailable 2-0 lead when they face Sri Lanka in the second ODI here on Thursday. Having ended his century drought for nearly three years in a T20I against Afghanistan in the Asia Cup in September, Virat Kohli has not looked back since then especially in the white ball format and brought up his 73rd International century in their 67-run win in Guwahati on Tuesday.

He looked in supreme control in the first ODI in Guwahati on Tuesday and made Sri Lanka pay the price for two dropped chances to slam a back-to-back ODI hundreds that formed the backbone of India's massive 373 for seven. It was like the Kohli of the old as he looked uncluttered and no Sri Lankan bowler troubled him. Returning from an injury, Indian skipper Rohit Sharma too allayed any concerns whatsoever of being short on match-fitness as he took on the Lankan attack in a 67-ball 83 to set the foundation for a mammoth total. He seemed to be in his zone before coming to his favourite venue Eden Gardens. The last time the two teams met in an ODI here, Rohit struck that world record 264 eight years back. Now here in his favourite venue as the Indian skipper, Rohit would be definitely keen to get to a big score. That an ODI century is also eluding him since a long time -- his last ODI hundred came against Australia in January 2020 would also be an added motivation. Add young opener Shubman Gill's splendid ODI run to Indian top three and Indian top-order looks sorted and would once again look to dominate the pedestrian Lankan attack. Having got unflinching support from his skipper, Gill was back as opener in the ODI format at the expense of left-handed



keeper-batter Ishan Kishan, a selection that copped a lot of criticism in Guwahati. But Gill silenced all that debate with yet another aesthetic knock of 70 off just 60 balls as he continued his fine form from last year during which he has averaged 70-plus from 12 innings. With Shreyas Iyer also coming back from a dream ODI run last year and occupying the no 4 spot with his flair for tackling spin and rotating strike in the middle overs, the only spot that may open up in the batting order is that of KL Rahul.

Rahul, who also doubles up as a wicketkeeper, has been in wretched form of late but may get a longer run especially in the series to prolong Kishan's wait.



GUWAHATI, JAN 11 /--/ Sri Lanka skipper Dasun Shanaka's unbeaten 88-ball 108 will put him in the "IPL marketplace" again, feels their head coach Chris Silverwood. Chasing a mammoth 374, Sri Lanka were staring at a big loss after being reduced to 179 for 7 but Shanaka, batting at No 6, gave them a faint hope with his counter-attacking knock as they managed 306 for 8 to settle for a 67-run loss here on Tuesday. "I think he (Shanaka) has done himself a world of good," Silverwood said at the postmatch media interaction here. Shanaka, who had a base price of Rs 50 lakh, went unsold at the IPL 2023 auction held in Kochi last month. "He has put himself in the marketplace now. I am sure the (IPL) franchises will be looking at him and seeing how dynamic a cricketer he is. He is a great striker of the ball, so hopefully, he will get an opportunity." This was Shanaka's second ODI century as he carried on his form from the T20I series where he was their top run-getter with 124 runs at a strike rate of 187.87. (PTI)

"Having been a former ACC chairman, Najam will be giving out assurances to all members that Pakistan is completely safe and secure to host the regional event and all teams including India must send their teams," he said. #### FIFA boss Gianni Infantino questioned by Swiss special prosecutors

GENEVA, JAN 11 /--/ FIFA President Gianni Infantino met with special prosecutors in Switzerland on Tuesday as part of their criminal investigation into his undisclosed meetings with the country's attorney general during a wider probe of soccer officials. Criminal proceedings against Infantino were recommended in 2020 by a previous special prosecutor — who was later removed from the case by a Swiss federal court – for possible incitements to commit abuse of public office and breach of official secrecy. The case potentially implicating Infantino is now moving forward in his home country, weeks after he oversaw the World Cup in Qatar and about two months before he is due to be re-elected unopposed by FIFA member federations. Special prosecutor Hans Maurer confirmed in an email to The Associated Press that "a

confrontation hearing was held in the proceedings. conducted by himself and a second prosecutor, Ulrich Weder. "However, I do not comment on the time, scope and purpose of this hearing," Maurer wrote. prosecutors were elected at the Swiss parliament in December 2021 to continue an investigation relating to three undocumented meetings held in 2016 and 2017 involving Infantino and thenattorney Michael Lauber. The

meetings started soon after Infantino was elected FIFA president in the fallout from American and Swiss investigations of suspected corruption in international soccer that forced his predecessor Sepp Blatter out of office. After the meetings were revealed by media reports starting in 2018, both Lauber and Infantino said the meetings were routine but claimed not to recall details or to have taken notes. Lauber was ousted from his job after being found to have misled and obstructed a federal office overseeing prosecutors, which had sought more information about the meetings. FIFA declined to comment Tuesday on the questioning of its president. Soccer's world body has previously said "both FIFA and the FIFA president are fully available to cooperate with the authorities, whether that concerns meetings that the FIFA president had with the former Attorney General of Switzerland, or anything else." ## I was in denial about my vulnerability, frustration was creeping in: In-form Kohli recalls prolonged lean patch

GUWAHATI, JAN 11 /--/ A remarkably eloquent Virat Kohli admitted being in complete denial about his "vulnerabilities" and "frustrations" during his poor run of form, which in turn also made him "cranky" and "snappy" with his family and friends.

Kohli smashed his 45th ODI hundred, a 87-ball 113, to guide India to a 67-run win over Sri Lanka in the opening game here on Tuesday.

The 34-year-old batter had scored an identical 113 against Bangladesh in his final ODI of 2022 and has now 73 international hundreds with the last three coming in a space of four months after a near three year lull. "In my case, in denial, frustration was creeping in. I was very cranky, very snappy in my space. It was not fair on (wife) Anushka (Sharma), my closed ones, its not fair on the people who support you. So I had to take responsibility and kind of put things in perspective," Kohli told teammate Suryakumar Yadav in an interview for bcci.tv. Kohli reiterated the need to be away from his primary passion in order to rekindle it and feel hungry once again. "I was far off from my cricket. My attachments, my desire, had totally taken over. That's when I realised that I can't be away from who I am. I have to be true to myself. Even when I am vulnerable, I am not playing well, I am the worst player around, I have to accept it. I can't be in denial," Kohli admitted his frailties. In fact, he had a word of advice for Surva, who is in the form of his life as far as T20Is are concerned. "Sometimes what happens, you (Surya) will also experience it as you play more and more now, people look at you differently. When Surya goes out to play, people will say that Surya will do it. To keep up with it is an intense process," he told his junior colleague about the weight of expectations that he has carried for more than a decade now. One only realises the downside when

form deserts a player, said Kohli. "When

your cricket is going well, all these things flow well but whenever there is a slight dip, in my case, frustration started creeping in because I wanted to play in a certain way but my cricket was not allowing me to play like before." Kohli said that he would like to build on his good form having started the new year with a hundred. "I am just happy... in the last two years I didn't have such a start,' Kohli said. "It was the first match of the year and I got a century, so hopefully, I can build on this because it is also a World Cup year and there is a big Test series coming against Australia. "When you score runs in any match, it gives you confidence. I am
