We are focusing on food as well as nutrition security

New Delhi, Feb. 5 (PIB)

The Prime Minister, Shri Narendra Modi visited the International Crops Research Institute for the Semi-Arid Tropics (ICRISAT) campus in Patancheru, Hyderabad and kickstarted the 50th Anniversary celebrations of ICRISAT. The Prime Minister also inaugurated ICRISAT's Climate Change Research Facility on Plant Protection and ICRISAT's Rapid Generation Advancement Facility. These two facilities are dedicated to the smallholder farmers of Asia and sub-Saharan Africa. Prime Minister also unveiled a specially designed logo of ICRISAT



and launched a commemorative stamp issued on the occasion.

The Prime Minister noted the auspicious occasion of Basant Panchami and congratulated ICRISAT for 50 years. Underlining the importance of next 25 years for both the country and also for ICRISAT, the Prime Minister stressed the need for new goals and working for them. The Prime Minister lauded ICRISAT for their contribution in helping agriculture in large part of the world including India. He appreciated their

contribution in water and soil management, improvement in crop variety, on-farm diversity and livestock integration. He also praised their holistic approach in integrating farmers with their markets and promoting pulses and chick pea production in Andhra Pradesh and Telangana. "Your research and technology have helped making agriculture easy and sustainable", Shri Modi said.

The Prime Minister said that the worst affected by climate change are the people on the last rung of development with little resources. That is why, the Prime Minister reiterated India's request to the world to pay special attention to the climate changes. He talked of LIFE-Lifestyle for Environment; P3 -

RBI warns against forex trading on unauthorized Platforms

New Delhi, Feb. 5

Requesting investors to remain vigilant, RBI has said that it has noticed a few misleading advertisements of unauthorized Electronic Trading Platforms (ETPs) offering forex trading facilities to Indian

residents. RBI said that these ads are being run on social media platforms, search engines, Over The Top (OTT) platforms, gaming apps, and the like. It added that such entities are also personally contacting people and luring

them with promises of disproportionate returns. Reserve Bank said there have been reports of frauds committed by such unauthorized ETPs where many residents have lost money. Stating that forex transactions must be

DPME takes stock of preparedness for ensuing Panchayat & Municipal Elections

Stresses on need for ensuring conducive environment for free and fair elections

Port Blair, Feb. 5

Shri. Suneel Anchipaka, Director (Panchayat and Municipal Elections) reviewed and took stock of the preparedness for the ensuing Panchayat and Municipal Elections with all Assistant Commissioner(s), Tehsildar(s), Nodal Officer(s) of Forest Department, Nodal Officer(s) designated with various works related to Elections as well as the Returning Officers/Assistant Returning Officers through Video Conferencing.

During the interactions, all aspects related to the preparatory arrangements regarding contingency plans for transportation of men & materials, assured minimum facilities available at all Polling Stations, communication plans, Distribution Centre, Collection Centre, Strong Rooms, Counting Centre of each constituencies etc. were discussed in brief.



The DPME reviewed in detail the strategy to be implemented during the enforcement of Model Code of Conduct to curb misuse of money/drugs/liquor & freebies distribution during the election. He urged all the Nodal Officer to attach maximum importance for ensuring conducive environment for free and fair elections in the UTs. Effective monitoring and vigilance should be ensured. Concerns at each level should be addressed. All Nodal Officers and Returning Officers have been asked to make comprehensive action plans so as to instill absolute confidence in all stakeholders.

The Director (Panchayat and Municipal Elections) further briefed that Election Commission (UTs) has directed the electoral machinery of the Islands to gear up with

In pursuance of Press Note by Election Commissioner (UTs), dated 28/01/2022 to hold General Election to Gram Panchayats, Panchayat Samities, Zilla Parishads and PBMC, the District Administration has constituted Enforcement Team Police Station wise for maintaining Model Code of Conduct and defacement of Public Property vide Nodal Officer (PME) Order no. 76, dated 03rd Feb, 2022. Altogether, 9 Flying Surveillance team, 9 Video Surveillance team and 9 Check Point teams have been

BSI Scientist discovers new genus of Mistletoe in Islands

Port Blair, Feb. 5

Scientist, Dr. Lal Ji Singh from Botanical Survey of India has discovered a genus of Mistletoe found in the Nicobar Island.

The new genus name, Septemeranthus is derived from a Latin word 'Septem' meaning 'seven' for the 7-merous nature of flower. It was discovered with only single species and recognized as a monotypic genus. Its type species, named as Septemeranthus nicobaricus

COVID-19 status in A&N Islands

Port Blair, Feb. 5

During the RT-PCR test conducted on 208 passengers who arrived here yesterday, one positive case has been detected. Today, 8 flights with 919 passengers arrived, out of which, 752 passengers were vaccinated with both doses while RT-PCR test was conducted on 148 passengers (6 foreign travellers) and the reports are awaited.

During RAT conducted on 44 passengers bound for

North & Middle Andaman at Ferrargunj, no positive case has been detected. At Mohanpura Bus Terminus, test was conducted on 38 passengers and no positive case has been detected. At Phoenix Bay Jetty, 48 passengers were tested with RAT, no positive case has been detected. At Helipad, 1 passenger was tested with RAT and was found negative, a press release from Directorate of IP&T said.

Vaccination drive in A&N Islands

6,05,113 doses of vaccines administered to beneficiaries in the age group of 18 and above so far

Port Blair, Feb. 5

The vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 6,05,113 doses of vaccines have been administered to beneficiaries in the age group of 18 and above so far in A&N Islands. Similarly, 22,718 beneficiaries have been vaccinated in the age group of 15 to 18 years against the target beneficiaries of



23,000. The number of beneficiaries administered precautionary dose of vaccine so far stood at 6654.

A total of 1691 eligible beneficiaries were vaccinated today. A&N Islands today, 1158 beneficiaries

BSI Scientist discovers new genus...

published in Journal of Botanical Taxonomy and Geobotany, Feddes Repertorium 132:193-203, 2021.

Botanical Scientist Dr. Lal Ji Singh in a press release stated that taxonomically the new genus belongs to Lorantheaceae under the sandalwood order Santalales, is of widespread importance. The family Lorantheaceae is currently represented by 9 genera including this new genus, Septemeranthus in India.

The new genus, Septemeranthus is distinguishable from previously known genera of loranths in having the heart-shaped leaves with extended drip tip, camptodromous venation and 3-7 pairs of lateral nerves, racemose inflorescence with unpaired flowers (3-7 flowered) sometimes a solitary flower, 7-merous flowers with 5 persistent bracts having conspicuous margins, urceolate ovary, fruits and seeds. The 7-merous corolla with 5 bracts of new genus has not been recorded in any of the previously known genera of Lorantheaceae family.

Mistletoe is relevant to several aspects and play important role in various ways such as ecologically important as keystone species, food for frugivorous birds, medicines. Discoverer of this new genus, Dr. Singh during the field studies found the birds consume viscous seeds of this new genus and seeds have potential of pseudoviviparous germination that deposit on the leaves and branches of their mother and host plants both where starts the life cycle all over again said, discoverer of this genus.

Besides Septemeranthus, genus, Dr. Singh has also discovered two endemic species Macrosolen andamanensis and Scurrula paramjitii under family Lorantheaceae. More recently a new species in hemiparasitic family Lorantheaceae have also discovered from Nicobar Group of Islands and named as Dendrophthoe laljii in the name of discoverer (Dr. Lal Ji Singh, an eminent Botanist) of genus Septemeranthu, a press release from BSI said.

Pro Planet People movements and India's net zero target by 2070. "Pro Planet People is a movement that connects every community, every individual with climate responsibility to tackle the climate challenge. This is not limited to just words, but is also reflected in the actions of the Government of India", he added.

Referring to 15 Agro-Climatic Zones and 6 seasons of the country, the Prime Minister highlighted the depth of ancient experience of Indian agriculture. He pointed out that India's focus is on the fusion of 'back to basic' and 'march to future' to protect its farmers from climate challenge. "Our focus is on our more than 80 per cent farmers who are small and needs us the most", the Prime Minister said.

He mentioned another dimension of changing India i.e. digital agriculture which he termed as India's future and stressed that talented Indian youth can contribute a great deal in this. He listed areas like crop assessment, land records digitization, spraying insecticides and nutrients by drones which are witnessing increased use of technology and artificial intelligence. "India's efforts are increasing relentlessly for empowering farmers through digital technology", he said.

The Prime Minister emphasized that in the Amrit Kaal, India is focussing on inclusive growth along with higher agriculture growth. Women in agri-sector, are being supported through self-help groups. "Agriculture has the potential to take a large chunk of population out of poverty and take them towards better life-style. This Amrit Kaal will also provide new means to the farmers of geographically difficult areas", he said.

The Prime Minister said that India is working on a dual strategy. On the one hand, a large part of the land is being brought under irrigation through water conservation and connecting of rivers. Water use efficiency through micro irrigation is being encouraged in areas with limited irrigation, on the other.

The Prime Minister said that National Mission for self-reliance in edible oils indicates India's new approach. The Mission aims to increase palm oil area by 6 lakh hectare. "This will help Indian farmers at every level and will prove very beneficial for the famers of Andhra Pradesh and Telangana", the Prime Minister pointed out. He also dwelled on the steps taken to strengthen post-harvest infrastructure like creating cold chain storage capacity of 35 million tonnes and creation of 1 lakh crore rupees Agriculture Infrastructure Fund.

India is also focusing on establishing FPOs and Agriculture value chain. "We wish to create an alert and potent market force out of small farmer by organizing them into thousands of FPOs", he said.

The Prime Minister said that India's goal is not just increasing food grain production. India has enough surplus food grain to run one of the world's big food security programme. "We are focusing on food security as well as nutrition security. With this vision, we have developed many bio-fortified varieties in the last 7 years".

ICRISAT is an international organisation that conducts agricultural research for development in Asia & sub-Saharan Africa. It helps farmers by providing improved crop varieties and hybrids and also helps smallholder farmers in the drylands fight climate change.
