Lok Sabha passes Election Laws (Amendment) Bill 2021

Bill provides linking of Aadhaar number with electoral rolls besides giving four opportunities to enroll in a calendar year

New Delhi, Dec. 20 (PIB)

The Lok Sabha has passed the Election Laws (Amendment) Bill 2021 today. The bill provides linking of Aadhaar number with electoral rolls besides giving four opportunities to enroll in a calendar year as voter upon attaining 18 years of age. Apart from this, the Bill has provisions of gender neutrality in regard with service voters and to enable the requisition of any premises for election purposes.

Replying to the discussion, Union Law and Justice



Minister, Shri Kiren Rijiju said that the Amendments in the Bill would bring clean and fair elections. He said, linking of Aadhaar number with electoral rolls is not compulsory or

mandatory but voluntary. He said, the amendments are based on the recommendations made by Election Commission of India and the Parliamentary Standing

Committee as well. He also said the Government has thoroughly discussed the recommendations with ECI and the States as well.

While moving the Bill for passage, Shri Rijiju said unlike earlier, now a person could get an opportunity to enroll as a voter four times in a year on the 1st Day of January, April, July and October. Later talking to the Media outside the Parliament, Minister, Shri Kiren Rijiju said, the Bill will pave the way for greater electoral reforms in the country.

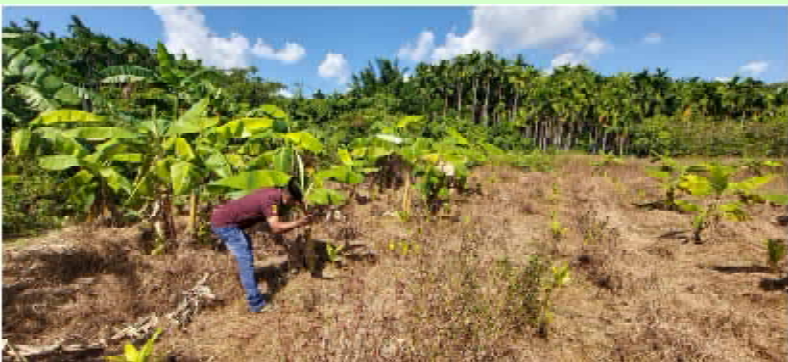
Zero tolerance towards encroachment on Govt. land

Encroachment Eviction Drive conducted in N&M Andaman District

Diglipur, Dec. 20

Continuing with the policy of zero tolerance towards encroachment on Govt. land, as directed by Ms. Anjali Sehrawat, Deputy Commissioner (N&MA), a team of Revenue Department officials attached to Diglipur Tehsil carried out an Encroachment Eviction Drive at Paschimsagar on Dec. 16 under the supervision of Shri Ankit Yadav, Assistant Commissioner, Diglipur.

As per revenue records, the land bearing Survey No.54 measuring an area 0.11 ha is classified as Road and Sy.No.27 measuring an area 5.14 ha is classified



as Nallah. Out of which, an area of 0.009 ha (approx) was encroached from both part of the land in the shape of

banana plantation, arecanut plantation and fencing blocking the footpath access to the villagers. During eviction, all plantation were removed and an area of 0.009 ha (approx.) was restored into Govt. account.

Such eviction drive will continue and will be conducted in other villages of North and Middle Andaman also. General public have been requested to share information regarding such encroachment to Revenue Department, a press release from Assistant Commissioner (Diglipur) said.

General public have been advised to earmark common central places in every locality/area where people could gather and burst fire crackers within the prescribed limits of time i.e. from 11.55 PM to 12.30 AM and permitted noise levels. Any violation in this matter will be dealt promptly as per the law.
