Let's stop campaigning and distributing money... not a single survey predicts our victory! Mumbai, Oct. 31: The first pilot in the Digital Rupee, Wholesale segment (e¹-W) will commence on November 1, 2022, the Reserve Bank of India (RBI) said in a circular.

"The use case for this pilot is settlement of secondary market transactions in government securities. Use of e¹-W is expected to make the inter-bank market more efficient. Settlement in central bank money would reduce transaction costs by preempting the need for settlement guarantee infrastructure or for collateral to mitigate settlement risk," the circular said.

"Going forward, other wholesale transactions, and cross-border payments will be the focus of future pilots,



based on the learnings from this pilot," it added.

Nine banks namely State Bank of India, Bank of Baroda, Union Bank of India, HDFC Bank, ICICI Bank, Kotak Mahindra Bank, Yes Bank, IDFC First Bank and HSBC have been identified for participation in the pilot.

The first pilot in Digital Rupee — Retail segment (e¹ -

R) is planned for roll out within a month in select locations in closed user groups comprising customers and merchants. The details regarding operationalisation of e¹ -R pilot will be communicated in due course.

The RBI on Monday also released a Concept Note on Central Bank Digital Currency (CBDC) for India. The purpose behind the issue of this Concept Note is to create awareness about CBDCs in general and the planned features of the Digital Rupee (e¹), in particular.

It explains the objectives, choices, benefits, and risks of issuing a CBDC in India. The Note also seeks to explain Reserve Bank's approach

Success is not an activity but a process ...

United Against Terror

India's decision to host the United Nations Security Council's Counter-Terrorism Committee (CTC) is an important marker of the Government's ongoing effort to highlight terrorism issues at a time the global body has been more focused on the Ukraine war. Held in Mumbai and Delhi, it brought UN officials, and ministers and diplomats from all members of the Security Council (UNSC), to discuss challenges to the global counter-terrorism architecture. In Mumbai, the spotlight was on the 26/11 attacks. Despite the global nature of the terror targets, India has had an uphill battle since 2008 in international cooperation to pursue the case, and in bringing the lone surviving attacker, Ajmal Kasab, through a full trial and execution. After a brief period of information sharing, Pakistan has dragged its feet on prosecuting even LeT commanders Hafiz Saeed, Zaki-ur-Rahman Lakhvi and others that its Federal Investigative Agency held responsible for the attacks. During the UNSC conference, the attendees heard not only from victims of the attacks but also voice samples of LeT recruiter Sajid Mir directing terrorists during the attacks; even so Mir, now in a Pakistani prison on terror financing charges, after Pakistan's greylisting at the Financial Action Task Force mandated action, has not been tried. The U.S., which has cooperated in many other ways with India on terrorism, convicted conspirators David Headley and Tahawwur Rana for the attacks, but has refused to extradite them. Meanwhile, China continues to block designating LeT leaders on the UNSC 1267 terror list, a problem External Affairs Minister S. Jaishankar and U.S. Secretary of State Antony Blinken specifically mentioned at the conference.

In Delhi, the CTC focus was on online radicalisation and terror recruitment, terror financing through crypto-currency and virtual assets, and unmanned aerial system use including drones for terror strikes, transporting drugs and arms. The deliberations led to the "Delhi Declaration on countering the use of new and emerging technologies for terrorist purposes". While India has only two months left in its current elected tenure at the UNSC, the Government appears to be making efforts to keep up the momentum from the CTC meet; it will host an international "No Money For Terror" conference (November 18-19), and a UNSC special briefing on challenges to global counter-terrorism efforts (December 15-16). As the Indian experience with 26/11 has shown, the global community has often been long on statements but short on cooperative action, and New Delhi will have to keep pressing the point that terrorism remains, in Mr. Jaishankar's words, amongst the "gravest threats to humanity".

Kantara Plagiarism Row: Makers Asked to Refrain from Using Varaha Roopam Song in Film

October 31: The Keralamusic based Thaikkudam Bridge, which had alleged that the Varaha Roopam song in the acclaimed film Kantara was a plagiarism of their 2017 track Navarasam, has welcomed the interim injunction issued by a Kozhikode Sessions Court restraining the producer, director and music composer of Kantara and online platforms from playing the song in theatres and on the streaming platforms.

The band had approached the Court for relief, and the injunction order was issued on Friday. The hard copy of the injunction order will be issued on Monday.

"Our fight is only for acknowledgement and recognition of our hard work by the filmmakers. After submitting all the documentary and video evidence, the Court gave the injunction order, which I feel is a validation of our integrity and hard work," said Sujith Unnithan, the band's manager.Advocate Satish Murthi, representing Thaikkudam Bridge, said "The Court found prima facie, there is 'substantial similarity' between the original song (Navarasam) and the Varaaha Roopam song. It also took notice of the admission of the film's music composer that he was inspired by the original song. Hence the injunction, which says the song cannot be played without taking the permission of Thaikkudam Bridge."

Murthi, who practices in the Supreme Court, said this would develop into a landmark case in the field of music copyright.



directed the Kantara film distributor in Kerala to remove the song from the atre distributors in other states on the issue. The injunction order has been sent to major streaming platforms including (YouTube), Amazon Music, Spotify, Wynk Music, JioSaavn, etc. These are big players and corporates, so I don't think they will mess with Court orders. I am sure as soon as they receive the injunction order they will remove the song from their platforms," Sujith said, adding that their legal team would monitor the platforms from time to time. "Once the distributor in Kerala gets the hard copy of the order on Monday, they will have to remove the song from the theatre shows. Distributors in other states will also get toknow about it through the media. I believe they will all have to remove the song from the shows until further Court orders," he says, adding that the onus is on the filmmakers to get the song removed from theatres in all the states.

Meanwhile, there were reports that the band was in talks with the Kantara

While the Court has makers on this issue. We asked Sujith Thaikkudam Bridge took recourse to legal action at this screenings, Sujith said the juncture. "Because the band is also alerting filmmakers are still denying our plagiarism claims, Sujith replied.

The Kantara team which was in Kerala tocelebrate the Google film's success, did not comment on the plagiarism issue except to say that their legal team was looking into the matter," the band manager added. He pointed out that plagiarism charges had earlier been levelled against the film's composer B Ajaneesh Loknath for the film, Kirrak Party. On another front, Mathurbhumi Music has the exclusive streaming rights of the song Navarasam and there were reports that it was negotiating for compensation with the filmmakers. "We don't know about Mathurbhumi Music, butour fight is only for due credits," Sujith said, when asked to comment.

> "Either the filmmakers will give us the credit for the song and accept our claims or they will appeal against the injunction in a higher Court," said Sujith.

RGV Retorts to TD Leader's Criticism of His Ensuing Film

Hyderabad Residents Enthused by Launch of 5G Services



October 31: Hyderabad: City residents are enthused by the launch of 5G services, despite it being available only on a handful of phones and in select pockets. However, with the coverage expected to rise in the next few weeks, netizens are refusing to let the excitement die down, as many clocked speeds of 300-600 MBPS.

The fifth-generation technology standard for cellular networks, i.e. 5G, was launched on October 6 in the city. This technology is only for mobile networks as Wi-Fi networks run on broadband technology.

Srinivas Reddy, who has used 5G service, said that there is a big difference in the internet speed and that people were unlikely to stick with 4G for long.

A representative for telecom company Airtel said that the 5G service is being rolled out in a phased manner and that it is expected to cover the entire city by the year-end.

Airtel 5G services are available only on Xiaomi, Redmi and Oppo handsets at present, while other handset manufacturers, including Apple, have announced that they will release updates soon, after which users can use 5G.

A representative for telecom Jio said the firm would launch 5G services by the end of October, and most key areas of the city will be covered, with coverage gradually expanding to the whole city.

It is to be noted that Jio previously carried out 5G tests across the country, with speeds over 800 MBPS being clocked, while in Delhi, a speed of 1 GBPS was logged. In comparison, the fastest 4G speed is 200

Netizens said that this would help them deploy heavier applications, especially games, on their phones. They have also been taking to Twitter to post the speed test results of the 5G network.

In some instances, netizens complained that 5G was not available despite their phones meeting the compatibility criteria and that speed was much lower than the average.

The Hon' ble Lieutenant Governor, UT And aman and Nicobar Islands is pleased to grant the relaxations as a **ONE TIME MEASURE** vide A & N Admn's Order No.2770 dated 25/10/2022, for the direct recruitment conducted by Andaman Public Works Department for the posts published on 16/08/2022 in the Notice of vacancy for recruitment.

As per the relaxations given vide the aforesaid order, the following categories of candidates are also eligible to apply for the notified posts:

- 1. Upper age limit by two years extended to the Group-B (NG) posts notified in the notice of vacancy for recruitment published on 16/08/2022 for the posts of Architectural Assistant, Assistant (Arch Dept), Junior Engineer (Civil), Junior Engineer (E&M) and Planning Assistant. Accordingly, the upper age limit for both male and female shall be 32 years. The age relaxation available to various categories shall also be applicable over and above the relaxation now given. The crucial date for determining the age limit shall be the first closing date for receipt of application i.e.16/09/2022.
- 2. Candidates who have appeared/appearing the final semester of the qualifying examination in the academic year 2021-2022, the passing of which would render themeducationally qualified for the recruitment examination will also be eligible for admission to the recruitment examination. However, those candidates who are declared qualified in the recruitment examination will be required to produce proof of passing the requisite qualifying examination, failing which their candidature for the post will not be considered. Such proof of passing the requisite qualifying examination should be produced at the time of verification of certificates after the publication of merit list. This shall be applicable for the posts of Architectural Assistant, Assistant (Arch Dept), Junior Engineer (Civil), Junior Engineer (E&M), Draughtsman Grade-III(Civil), Draughtsman Grade-III (E&M) & Surveyor.

Such candidates, while applying online are required to upload a certificate issued from the respective University/Institution stating that "He/she is a bonafide student and appeared/appearing in the final semester examination for the academic year 2021-22".

Candidates who had undergone course duration of 01 year in the Surveyor trade training as per the directions issued by Directorate General of Training, Ministry of Skill Development & Entrepreneurship, Gol, New Delhi vide letter No.DGET-19/06/2014-CD dated 06/06/2014 during the academic year 2014-15, 2015-2016, 2016-2017 and 2017-2018 and restored to 02 years vide their letter No. MSDME (DGT)-19/02/2018-CD dated 05/04/2018, shall be given equal weightage at par with others who had completed course duration of 02 years in the Surveyor trade in the ongoing recruitment. 



Surya Keeps Raising Bar, Perth Knock is His New T20 High

October 31: It's Suryakumar Yadav's eyes that tell the story. They don't lightup when he sees a bad ball as the commentators are prone to say. There's no frantic scanning and surveying of the field. They remain calm, and they alone should hold off a tempest, like the one at Perth on Sunday. The captain had perished, the hero had drowned. His 40- ball 68 against South Africa was on a fast and bouncy track against a frightening quartet of hard-length perpetrators.

Surya is just 35 international T20 innings old. Yet, in this briefest of periods, he has remade T20 batting in his own image. Every time he makes the world believe that he has compiled his greatest knock, he makes them rethink. Within days, he raises the bar, comes up with a new greatest knock.

This was a night when all there was to do was gawp at the player who can bend the game according to his own laws. He met fire with ice. The most devilishly speeding bouncer would scream onto his bat. Then fly off it, defused of all its devilishness. He unfurled some outrageous strokes—a downthe-line forehand off Kagiso Rabada that would have some tennis players drooling for its power and precision.

Like a textbook forehand, he made sure that he moved into the ball, a mini leap enabling him to get on top of the ball, and kept the shoulder on the same line all the way through the stroke. He



did not turn the shoulder until he was through with the shot. The hands, the eyes, the muscles, and the mind in perfect synchronisation; there are no links that rebel.

He plays a lot of strokes, but each of them sticks in the mind. He grants even the humdrum every day stroke with a shade of grandeur. Like the flick. His first six was a flick, a searing 89 mpher from Anrich Nortje that he twirled over fine leg. No extravagance, no flourish, just touches, glides and deflection, hitting the ball with just enough fade to glide through the narrow target areas. Nortje looked baffled, just as shocked Lungi Ngidi was when he cuffed a short of length ball outside off-stump over fine leg.

The speed-gun flickered that the ball clocked 143 kph. But it looked slower. It's the gift to create the illusion of time, that he has more time than the rest to do the most outrageous things.But none of these was his most

memorable stroke of the night. It was a simple off-drive off Ngidi that the mid-off fielder dashed to abort, the high front-elbow winking at the inky skies, the ball purring along the ground, perhaps dusting up grainy memories of Sachin Tendulkar at the WACA three decades ago. In quality as well as context, Yadav's knock was the T20 equivalent of Tendulkar's 116. And both ended in tears.

Time, thus, is knocking on to put him as the contemporary benchmark of T20 batting. Chris Gayle is a spent force; Babar Azam, however graceful he is, does not scorehis runs as fastas Yadavdoes. Azam picks his runs at 128; Yadav at 178. The power-hitters of the world are nowhere as consistent as him in delivering match-bending knocks in high-pressure situations. T20 cricket, truly, is living in the era of Suryakumar Yadav. The Perth knock was the greatest, grandest example. How will he now raise the bar? Even for him, it won't be easy but then he has proved us wrong, before, hasn't he?


