

flare and flare activities, dynamics of weather and the study of the propagation of particles and fields in the interplanetary medium. Soon after India's successful mission to the Moon on the 23rd of August, Indian Space Industry witnessed another journey to the Sun which has been undertaken by four other Space Centres in the World. ISRO's service includes not only orbiting India's own satellites but also hundreds of foreign satellites and in the process earn foreign exchange for the country. India has till date launched 431 foreign satellites belonging to 36 countries since 1999 with its rockets and bulk of the numbers were by the PSLV rocket. The rocket has also been used to put into orbit 104 satellites in a single flight.(Source:india.gov.in)
