

Ministry of New and Renewable Energy issues simplified procedure to install rooftop solar plant for the residential consumers

To develop National Portal for the consumers to avail subsidy, apply for net metering

New Delhi, Feb. 2 (PIB)

The Ministry of New and Renewable Energy has issued simplified procedure for the residential consumers to get the rooftop solar plant installed by themselves or through any vendor of their choice under the Rooftop Solar Programme. As per the new simplified procedure, a national portal for registering applications from the beneficiary, approval thereof and tracking progress will be developed. There will be a portal in the similar format at the level of the DISCOMs and both the portal will be linked.



The beneficiary, who wishes to install Rooftop Solar (RTS) under the new mechanism will apply on the national portal. The beneficiary will be required to submit necessary information including details of bank account where the subsidy

amount will be transferred. At the time of application, the beneficiary will be informed about the complete process and subsidy amount that can be availed for installation of the RTS plant.

The application will be

forwarded online to the concerned DISCOM for issuance of technical feasibility approval within next 15 working days. After the application is transferred to the DISCOM it will also be displayed on the DISCOM portal.

After obtaining technical feasibility, the beneficiary will install the RTS plant from any vendor of his choice by selecting solar modules fulfilling the conditions of DCR and enlistment under ALMM and inverters which are certified by J3IS. The list of empanelled vendors will be

Aadhaar of Husband is not mandatory under Matru Vandana Yojana to facilitate inclusion of single mother: Govt

New Delhi, Feb. 2

Government has clarified that Aadhaar of Husband is not mandatory under the Pradhan Mantri Matru Vandana Yojana, PMMVY, to facilitate the inclusion of single mother and abandoned mother. Under the scheme, maternity benefits of five thousand rupees

is being provided in three installments to the Pregnant Women and the Lactating Mothers for the first living child of the family upon fulfilment of certain conditionalities. Earlier, the beneficiary was required to provide Aadhaar cards of the women and their

husbands. This information was given by the Women and Child Development Minister, Smti Smriti Irani in a written reply to a question in the Rajya Sabha today.

The Minister said, Pradhan Mantri Matru Vandana Yojana is

GoI issued guidelines for Ex-Gratia Assistance to next of kin of the deceased by COVID-19

All applications for ex-gratia have to be submitted to Deputy Commissioners of respective Districts

Port Blair, Feb. 2

In pursuance of Hon'ble Supreme Court judgment in W.P. (C) No. 539 & 554 of 2021, the National Disaster Management Authority (NDMA), Government of India has issued guidelines for Ex-Gratia Assistance to next of kin of the deceased by COVID-19 and recommended an amount of Rs. 50,000/- per deceased person including those involved in relief operations or associated in preparedness activities of COVID-19 subject to cause of death certified as COVID-19 and the said ex-gratia assistance shall be paid from the State

Disaster Response Fund (SDRF).

Accordingly, in compliance with the above guidelines and with the approval of the State Disaster Management Authority, the A & N Administration has ordered that the Deputy Commissioners of South Andaman, North & Middle Andaman and Nicobar District shall act as Disbursement Authority in their respective jurisdiction to disburse the ex-gratia assistance to the next of kin of deceased by COVID-19, in accordance with the guidelines issued by the Ministry of Home Affairs.

All application

for ex-gratia will have to be submitted to the Deputy Commissioner of the respective Districts in the prescribed format (published in the leading newspapers and broadcasted in the All India Radio, Port Blair on October 28, 2021) along with specified documents including death certificate that certifies the cause of death due to COVID-19. All claims must be settled within 30 days of submission of the application and disbursed through Aadhaar linked Direct Benefit Transfer procedure.

The Chief Registrar/Registrar of Birth & Death/ CMO authorised by Chief Registrar, shall issue

Official Document relating to COVID death to the family member of the deceased, who died due to COVID-19, strictly in accordance with the Ministry of Health & Family Welfare and Indian Council of Medical Research Guidelines communicated by MoHFW, GoI.

In case of any grievances with regard to certification of death, the applicant may submit representation to the District Grievance Redressal Committee, which is constituted and notified for the 3 Districts.

The District Grievance Redressal Committee shall be responsible to address any

grievances with regard to certification of death as prescribed in the MoHFW and ICMR Guidelines and to propose necessary remedial measure, including issuance of amended official document of COVID-19 death after verifying facts in accordance with the guidelines and in the letter and spirit of Hon'ble Supreme Court's Order dated 04/10/2021 in Misc. Application No. 1120/2021 in W.P.(C) No. 539 /2021. (Details of Order and MHA guidelines are published in the leading newspapers on October 28, 2021), a press release from Directorate of Disaster Management said.

COVID-19 vaccination continuing smoothly

22,330 beneficiaries in the age group 15-18 years of age vaccinated with first dose so far

Port Blair, Feb. 2

The vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 6,04,599 beneficiaries in the age group of 18 and above have been vaccinated so far in A&N Islands. Similarly, 22,330 beneficiaries have been vaccinated in the age group of 15 to 18

years against the target beneficiaries of 23,000. The number of beneficiaries administered precautionary dose of vaccine so far stood at 5999.

A total of 2842 eligible beneficiaries were vaccinated in A&N Islands today. 1750 beneficiaries were vaccinated in South Andaman

District, out of which, 100 beneficiaries were in the age group of 15-18 years, 26 beneficiaries were in the age group of 18-44 years and the number of beneficiaries administered precautionary dose of vaccine stood at 91.

Similarly, 962 beneficiaries were vaccinated in North &

During the RT-PCR test conducted on 50 passengers who arrived here yesterday, one positive case has been detected. Today, 7 passengers bound for flights with 578 passengers arrived, out of which, 445 passengers were vaccinated with both doses while RT-PCR

test was conducted on 125 passengers (1 foreign traveller) and the reports are awaited.

During RAT conducted on 40 passengers bound for North & Middle Andaman at Ferrargunj, no positive case has been detected. At Mohanpura Bus

Terminus, test was conducted on 34 passengers and no positive case has been detected. At Helipad, 9 passengers were tested with RAT, no positive case has been detected. Today, till 3 pm, 233 eligible persons were vaccinated, a press release from Directorate of IP&T said.

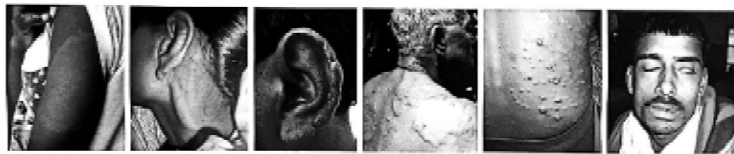
