Port Blair city has been conferred with the 'Award for Excellence in Urban Transport' under the category 'City with Best Green Transport Initiative' for the entry submitted by Transport Department, A&N Administration by Ministry of Housing and Urban Affairs (MoHUA), Govt. of India during the valedictory session of the 14th edition of Urban Mobility India (UMI) Conference 2021 held yesterday at Sushma Swaraj Bhawan, New Delhi. Shri Jitendra Narain, Chief Secretary, A&N Administration received the award from Shri Hardeep Singh Puri, Hon'ble Minister, MoHUA, GoI. It is to mention that the Port Blair city has competed with different cities of the country to be adjudged a winner for the award, which were considered and recommended by an Award Selection Committee constituted by MoHUA.

Addressing the gathering, Union Minister of Housing and Urban Affairs said that sustainable mobility and universal access is crucial for achieving the 2030 Agenda of Sustainable Development Goals

(SDGs). He said that the National Urban Transport Policy of 2006 highlights "Moving people rather than vehicles", following which most vision documents and policy statements related to urban transportation are formulated.

The main theme of this year's conference is 'Mobility for All' which focuses on providing equitable access and promote inclusive urban transportation. Urban centre's are engines of economic growth, with rising trend of urbanization, the biggest challenge is to have proper Urban Transport System. Rising usage of personal motorized vehicles which manifests into severe congestion, increased air pollution and high incidence of road accident deaths are the biggest challenges of urban agglomerations of present time. This is not only affecting the health and well-being of the people but also impacts global climate change.

The challenge of moving people from all segments of society, efficiently, safely and sustainably is being addressed through new and innovative solutions in our increasingly globalized urbanized and

digitized world. A&N Administration has proactively taken initiatives to make a shift to e-Mobility by encouraging Green Transport in the form of Electric Vehicles.

➤ **Electric Air conditioned Public Transport Buses has been introduced** -

To augment the fleet, reduce traffic congestion, pollution, conserve biodiversity and for faster mobility 40 Electric AC Buses have been hired by the Transport Department on dry lease from NTPC for Public Transport. The e-buses commenced commercial operation from 1.4.2021. To meet the charging requirements of these buses 15 Charger's were installed in record time i.e. seven in Bus Terminus, Six in Workshop & 2 in STS unit Ferrargunj. Dedicated Transformers were provided in Bus Terminus, Workshop & STS Unit Ferrargunj.

Farmers' Corner- A Knowledge Hub

Heliconia wagneriana commonly known as Easter Heliconia

Heliconia wagneriana is commonly known as Easter Heliconia. This is an evergreen, perennial, rhizomatous, erect, herbaceous species growing to a height of 1.5-3.0 m. The leaves are alternate, oblong with pointed apex, green in colour and the sheathing tubular foliar bases forming a 1-1.5 m long flattened pseudostem. The inflorescence is sessile, 45 cm long, erect spike, waxy, overlapped at the base and wholly wrapping the rachis. Bracts are of pinkish red colour with pale yellow edge and green margins. The bracts secrete a liquid that gathers in the cavity besides rainwater. This species is highly adapted to grow in humid tropical and subtropical climate and preferably in shaded condition. This species is a short-day plant and can be a suitable intercrop in plantation based cropping system with peak flowering during summer season. The shelf life of the spike is 10-15 days. The popular varieties in the species are H. Wagneriana Cv. Rainbow, H. wagneriana Cv. Turbo and H. wagneriana Cv. Big Red.



Benefit: *Heliconia wagneriana* has huge ornamental potential as cut flower and in landscape horticulture with prolonged flowering habit. It can also be grown in spacious pots for decoration of patios and balconies.

Union Minister launches Indian manned Ocean Mission 'Samudrayan'

New Delhi, Oct. 30

Union Minister of State for Science and Technology, Dr. Jitendra Singh launched the Indian manned Ocean Mission 'Samudrayan' in Chennai on Friday. The Minister said that India has joined the elite club of Nations such as USA, Russia, Japan, France and China to have such underwater vehicles for carrying out subsea activities. He informed that the

Sciences is carrying out deep ocean exploration of the non living resources such as polymetallic manganese nodules, gas hydrates, sulphides and cobalt crusts located at a depth between 1000 and 5500 metres. He said that sea trials of 500 metre rated shallow water version of the manned submersible are expected to take place in the last quarter of 2022 and the MATSYA 6000, the

deep water manned submersible will be ready for trials by the second quarter of 2024. The Minister said that NIOT is indigenously developing a manned submersible designed to carry three persons in 2.1 diameter Titanium Alloy Personal Sphere with an operational endurance of 12 hours and systems to support emergency endurance upto 96 hours. 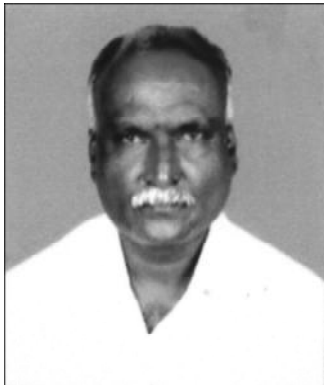

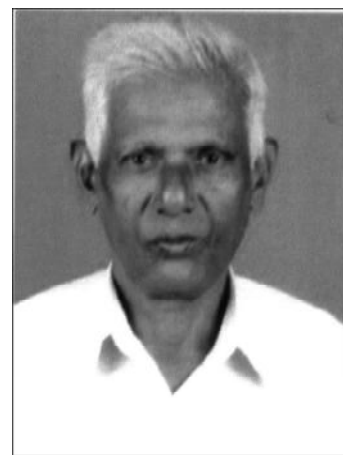
