Success is not an activity but a process ...

A Necessary Signal

The 27th session of the Conference of Parties (COP) is underway at Egypt's sea-side city of Sharm el-Sheikh where, over two weeks, heads of government, diplomats, business heads, activists, journalists, and lobbyists will converge. The attempt is to inch ahead on a global rehaul of energy consumption to improve earth's chances against catastrophic climate change. While every COP ends with a hard-bargain document, the essential principle remains constant: how to ensure that all countries contribute to paying for what it takes to avoid the consequences of global warming without compromising on economic development, while accounting for their historical responsibility in exacerbating the crisis. There are several countries, especially island nations, that stand to lose the most from global warming without having a role in causing it. Given that COP agreements are non-binding on the signatory member-states, and volte-faces not unusual — such as the United States unilaterally exiting the agreement only to join again — these meetings also serve as a forum for public posturing. Countries announce their commitment to lofty environmental goals but do little to execute the often-stringent measures that these entail because they potentially involve political blowback. However, COPs do serve as an effective nudge. Even a decade ago, the link between global warming and climate change had sizeable critics; now, no country challenges fundamental science. A fossil fuel-free future is the direction that the world is moving towards.

It is thus appropriate that COP27 is viewed as the so-called 'implementation CoP', to borrow a term from Sameh Shoukry, Egyptian Foreign Minister and President, COP27. Shifting from fossil fuels to renewable sources is expensive and the large developing countries (India, China, Brazil, South Africa) while committing to a carbon-free future also underline their right to rely on fossil fuels in the interim. While there is agreement that developed countries foot the bill, the bulk of the wrangling is over determining how the bill is paid. The 'implementation COP', India has said, must set out a transparent payment system and spell out how countries already reeling under climate disasters can be compensated. This will also mean greater transparency from recipient nations on how these investments measurably improve a transition away from polluting sources. Unlike Glasgow 2021, when 'net zero' or commitments to be carbon neutral were the flavour of the season, implementation COPs are unlikely to result in ambitious breakthroughs. Often, however, it is the unspoken and the subterranean that get the job done. COP27 must send the message, loud and clear, that be it war or peace, poverty or plenty, securing the world's future comes at a price that only gets costlier every passing day.

Ranbir Kapoor Calls Alia Bhatt 'Inspiring' for Promoting Brahmastra During Pregnancy, Says Any Criticism is 'Jealousy and Stupidity'

November 9: Actors Ranbir Kapoor and Alia Bhatt are basking in the glory of their film, Brahmastra, which, despite intense criticism, has continued to rake in big bucks at the box office. Nevertheless, the actors are not calling it a complete victory as yet, because it still has a bit of a journey to go before it can be declared as a blockbuster.

Alia Bhatt told NDTV that she isn't quite at ease yet, saying that every timethey've heaved a sigh of relief, they realise there is a next hurdle to cross. The sci-fi film is the first in Ayan Mukerji's 'Astraverse', and sees the unfolding of their love story, along with Ranbir's Shiva trying to understand his unique powers of fire.

Asked how it was to work with Ranbir as well as promote Brahmastra, Alia said it was 'easy'. She answered, "Ranbir and I are both strong individuals. We both respect each other's individual personality in our professional commitments and we don't get in the way.

We aren't do jismek jaan in our personal lives. We have a beautiful equation as companions, but we have a better working relationship because we are so passionate about movies...we like to soldier on and surrender to the process. Nothing screams out as a different equation as such..." Ranbir and Alia had famously fallen in love on the sets of Brahmastra and dated for several years before tying the knot in 2022. The couple are now expecting their first child.

Ranbir echoed the sentiments and said that he respects her a lot and added, "She can get daunting at times and boisterous and can bully you...she tries to get me to Instagram photoshoots," at which Alia cut in and explained that Ranbir hates photoshoots. Ranbir then hailed Alia as the 'best manager' and that she makes 'his life easier', and handles communication



promotions. When referring to the 'sexist reporting' about her pregnancy that Alia had earlier slammed, she said that it had indeed reduced. Intervening, Ranbir said, "Alia in the history of Indian cinema is one of the most important actors, owing to her value system, the work she has done on screen and how she carries herself. I haven't really seen that strength in men and women, and we should respect that. The way she carried herself through the entire marketing of this process, being pregnant and in this condition, we should just be inspired by her and any criticism of her is just jealousy and stupidity."

Brahmastra released in theatres on September 9, and continues to attract footfall. It has almost crossed Rs 200 crore milestone.

Sudhir Mishra Recalls Working with Om Puri: 'He was Tough, Generous Guy Who Would Lose it if I Shot After Midnight'

November 9: Some of filmmaker Sudhir Mishra's stories were set in the night but actor Om Puri never liked shooting post midnight. Naturally, when the duo worked in the acclaimed 1991 classic Dharavi, there were fireworks.Sudhir Mishra has opened up about his experience of working with OmPuri and recalled how the legend, who passed away in 2017, was an incredibly giving actor who would stop at nothing to give a good shoteven if it was at the expense of his discomfort.In an interview with Unfiltered By Samdish, the director said he first collaborated with Om Purion the 1983 cult Jaane Bhi Do Yaaron, where Sudhir Mishra was a writer and an assistant director.

"I worked with Om Puri when I made my third film, I was a young man. I had worked with him as an assistant in Jaane Bhi Do Yaaron and then in 1991 I worked with him (as a director). He was a big guy. He was so graceful, generous.

None of these guys were easy. When one says, 'he was graceful', it is almostas if they were boring people. Like everyone who talks about Irrfan these days sounds like he was a boring person. He was not. Those were wonderful, ambitious, complicated times. There was a need for money, good work. It was difficult."

Mishra said Puri's craft was so strong, he would incorporate last minute suggestion with a remarkable ease. His talent, Mishra recalled, went beyond his performance onscreen as he was also technically sound." You could tell anything to him, hewas graceful, technically perfect. You could provoke him the last moment and it would be there in the shot. If I'd say, 'Puri sahab, ek aisa khayal aaya hai', he would do that on screen. If there was no tripod and you'd request him to spread his legs and stand and then give close ups, he would do that. He was so technically



(sound)," Mishra said, who last helmed Nawazuddin Siddiqui-starrer Serious Men. The filmmaker, however, said if there was one thing that Puri was not okay with, were night shoots. "Puri sahab was a tough guy often. He would lose it if you shot after 12 in thenight. 'Kya hai yaar? Chal...leaveit,' he would say. He would be angry but would say, 'Chal ghar pe, I'll feed you bhindi.' My films are mostly set in night, so he would get angry!" Mishra said once Puri even joked that he would never work with himagain as the filmmaker goes to extreme lengths to get the shot that he requires. Dharavai, which won the National Film Award for Best Feature Film in Hindi, was the last collaboration of Puri and Mishra.

Covid Patients at Increased Risk of Psychiatric Conditions After Two Years: Lancet

November 9: LONDON: Increased risk of neurological and psychiatric conditions such as dementia and seizures is still higher two years after COVID-19 compared to other respiratory infections, suggests an observational study of over 1.25 million patient health records published in The Lancet Psychiatry journal.

The increased risk of depression and anxiety in adults lasts less than two months before returning to rates comparable to those after other respiratory infections. Since the COVID-19 pandemic began, there has been growing evidence that survivors might be at increased risk of neurological and psychiatric conditions. A previous observational studyby the same research group reported that COVID-19 survivors are at increased risk of several neurological and mental health conditions in the first six months after infection.

However, until now, there have been no large-scale data examining the risks of these diagnoses over a longertime period." In addition to confirming previous findings that COVID-19 can increase the risk for some neurological and psychiatric conditions in the first six months after infection, this study suggests that some of these increased risks can last for at least two years," said Professor Paul Harrison, from the University of Oxford, UK." The results have important implications for patients and health services as it suggests new cases of neurological conditions linked to COVID-19 infection are likely to occur for a considerable time after the pandemic has subsided," Harrison, lead author of the study, said.

The study also highlights the need for more research to understand why this happens after COVID-19, and what can be done to prevent or treat these conditions. The study analysed data on 14 neurological and psychiatric diagnoses gathered from electronic health records mostly from the US over a two-year period.

Of those with health records in the US-based TriNetX network, 1,284,437 people had a confirmed SARS-CoV-2 infection on or after January 20, 2020 and were included in the study:185,748 children, 856,588 adults between 18 and 64 years old, and 242,101 adults over 65. These individuals were matched to an equal number of patients with another respiratory infection to act as a control group. Records from COVID-19 patients infected during different pandemic waves were also compared to investigate differences in the impact of the Alpha, Delta, and Omicron variants on the risk of neurological and psychiatric diagnoses.

People who had a first diagnosis of COVID-19 within the period when a particular variant was dominant were compared with a control group of the same number of individuals who had a first diagnosis of COVID-19 in the period just before the emergence of that variant. The study found that, in adults, the risk of having a depression or anxiety diagnosis initially increased post SARS-CoV-2 infection but returned to the same as with other respiratory infections after a relatively short time.

PM Modi Insulting KCR, Telangana: TRS

HYDERABAD: Ahead of Prime Minister Narendra Modi's visit to Telangana on November 12, the TRS has launched a 'protocol war' on the BJP.

The PM will arriving in the state to dedicate to the nation the Ramagundam Fertilisers and Chemicals Ltd (RFCL) plant at Ramagundam. The TRS on Tuesday accused the BJP-led government at the Centre of not following protocol and insulting Telangana people by sending a communication asking Chief Minister K.Chandrashekar Rao to "participate" in the inaugural event rather than "inviting" him. The TRS took to Twitter to lash out at the BJP and Modi on this issue. The party claimed that despite the Telangana government having 11 per cent stake in RFCL and offering the Centre all assistance necessary to revive the plant, the Centre had failed to send a "proper invitation" to the CM.

Further, the party took serious objection to the CM's name appearing on the list behind the PM and Dr

9: Mansukh Mandavya, Union's minister of fertilisers. Party sources said the the Centre's communication to the CMO stated, "You are requested to participate in the event."

> The party questioned the need for the PM to inaugurate or dedicate the plant to the country since production had commenced in March last year and approximately 10 lakh tonnes of fertiliser had been produced, the majority of which had been used in Telangana.

The TRS further claimed that the BJP was attempting to use the RFCL event to deflect attention away from the recent Munugode bypoll fiasco as well as from the poachgate controversy in which the BJP allegedly attempted to buy four TRS MLAs before the Munugode bypoll.The Telangana government, according to the party leaders, purchased land, built roads, spent Rs 100 crore on Mission Bhagiratha to supply drinking water to the plant's new township, as well as providing Yellampalli project with a reliable power and water supply to support the revival of the plant and



production.An additional Rs 160 crore was spent to create infrastructure facilities at the plant, the party added.

Party sources claimed that the CM never broke protocol and that he did not receive Modi at the airport only when the Prime Minister arrived to take part in 'private programmes' such as inauguration of Statue of Equality, the event marking the Indian School of Business anniversary and the BJP's national executive meetings.

They said as per protocol there was no need for the CM to receive the PM on private visits. They recalled that when the CM tried to welcome and meet the PM when he arrived in Hyderabad in November 2020 to visit Bharat Biotech, the PMO refused the permission. As a result, the CM stayed away from the PM's private visits.

Parliamentary Committee on Industry to Arrive Today on a **Two Days Visit**

Port Blair, Nov. 9: The Department Related Parliamentary Committee on Industry is arriving on a two visit to A&N Islands tomorrow (Nov. 10). Soon after the arrival, the Committee will proceed to Swaraj Dweep. During their stay there, the Committee Members will hold meeting with the Chief Secretary, A&N Islands and M/o MSME on implementation of PMEGP scheme in A&N Islands at Taj Exotica on Nov. 11.

Thereafter, Committee Members will hold meeting with representatives of SBI, Central Bank of India, UCO Bank, PNB, A&N State Co-operative Bank, M/o MSME, M/o Finance (DFS) and KVIC and review the performance of PMEGP scheme in A&N Islands. The Committee Members are also scheduled to hold meeting with the representatives of Airports Authority of India, Buildings Construction Corporation Ltd, Engineers India Ltd., Indian Rare Earths Ltd., M/o MSME, M/o Civil Aviation, M/o Housing & Urban Affairs, M/ o P& NG and Department of Atomic Energy on the implementation of 25% prescribed procurement from MSEs by PSEs under the public Procurement Policy and Review of release of payments to MSEs at the same venue on Nov. 11, 2022.

On completion of visit, the Parliamentary Committee is scheduled to return to mainland on Nov. 12

CEO A&N Parliamentary Constituency **Conducts Meeting On Special Summary** Revision of Electoral Roll-2023

Port Blair, Nov. 9: The Chief Electoral Officer, A&N Islands Parliamentary Constituency, Shri Binay Bhushan held a meeting with representatives of recognized Political Parties of A&N Islands regarding the Special Summary Revision of Electoral Roll-2023 in the conference hall of Secretariat this evening. The Joint CEO, Shri Hari Kallikkat, Electoral Registration Officer, Shri Ankit Yadav, Dy. CEO, Shri Dilkhush Meena, Electoral related Officers were also present during the meeting while the AEROs of outer stations joined the meeting through video conference.

Addressing the meeting, the CEO remarked that the role of political representatives in Special Summary Revision of Electoral Roll-2023 is vital and sought their support and urged them to appoint Booth Level Agents (BLA) who would be associated with Block Level Officers (BLO) during the revision period. The BLA along with BLO will verify the data and urged family members and other electors of a locality to fill Form -7 for those who have migrated to mainland or expired but their name still existin the Electoral Roll. Such information is very crucial for purification of Electoral Roll in order to have the correct electoral roll, the CEO remarked. He said, every BLA can distribute forms to ten

persons and the claims and regarding the special objections received will be shared with the Political

The CEO also informed that in addition to the qualifying date of 01.01.2023, an eligible Citizen, who is going to attain the age of eighteen years on any of the subsequent qualifying dates in the year 2023, that is to say, the 1st April, 2023, the 1st July, 2023, or the 1st October, 2023, may also file his or her claim for inclusion of his or her name in the Electoral Roll, in Form-6, in advance, and the same shall be considered and decided in the respective quarter of the year with reference to the respective qualifying date. Similarly, data of any eligible PwDs voters in A&N Islands should also be shared with the Electoral Officers for inclusion. Any issues or grievance can be addressed to the Electoral Team, the CEO said.

CEO also uraed representatives of political parties to urge voters to check and verify the data provided and if any changes are to be made it can be intimated to the respective BLAs. BLOs have been directed to conduct awareness camps and nukkad nataks among general public summary revision for its wide publicity. As per the draft roll published, the A&N Islands has 3,04,413 voters, out of which 1,59,923 are male voters, 1,44,479 are female voters and 11 are transgenders. The gender ratio is 903.

The CEO while explaining the schedule of the Special Summary Revision-2023 informed that the publication of Integrated Draft Electoral Roll commenced today and the period for filing claims and objection is from Nov. 9 to Dec. 8, 2022 while the Special Camps will be held on Nov. 26 & 27 and Dec. 3 &4, 2022. Disposal of claims and objections will be held on Dec. 26, 2022 and final publication of electoral roll will be on Jan. 5, 2023. He said, to have a correct electoral roll, the Special Summary Revision -2023 is important. He said, all applications received on CEO's website on day to day basis shall be shared with recognized Political Parties in order to bring more transparency in the process of electoral registration.

The CEO also handed over copies of the draft electoral rolls to the representative of recognized political parties who were present during the meeting.

Six Dead After 6.3-Magnitude Earthquake Shakes Nepal, Strong Tremors in Delhi

A powerful 6.6-magnitude earthquake in the remote mountains of west Nepal rocked the Himalayan nation in the early hours of Wednesday, killing at least six persons, including two minors, damaging buildings and sparking panic among the residents. According to the National Seismological Centre, the earthquake occurred at 2:12 am with its epicentre at Khaptad National Park in the Doti district.

Six persons have been killed in the earthquake, Home Ministry spokesperson Phanindra Pokharel said.

Five persons who sustained serious injuries have been rushed to the district hospital in Doti,

Pokharel told PTI over the phone. A police post and eight houses collapsed due to the earthquake.

According to Nepal Army spokesperson Narayan Silwal three persons were missing and are believed to have been trapped in the housing collapse in Purvichauki. The Nepal Army has started searching for the missing persons, he said.

Deputy Superintendent of Police Bhola Bhatta, the acting chief at the District Police Office in Doti, said that all the victims were killed by the debris of the houses damaged during the earthquake.

The earthquake sent people in the mountain villages panicking out of their houses and many spent the entire night out in the open, officials said

The identities of the deceased have been established of which two are women, two men, and two minors, Deputy Superintendent of Police Bhola Kumar Bhatta was quoted as saying by the Himalayan Times newspaper.

Close to ten houses collapsed in the quake and cracks had developed in most of the houses in the aftermath of the geological event, police added.

Nepal Army and Nepal Police personnel have been mobilised to carry out rescue operations. Nepal's Prime Minister Sher Bahadur Deuba was also in Western Nepal for an election campaign when the earthquakes hit the region. He was attending election rallies and meeting people at Dhangadhi district, 160 km South of the epicentre.


