Unannounced power cuts leave the general public sultry; shortage of technical staff is alleged to be the reason

Power cuts have assumed unexpected proportions this year: General public

Port Blair, April.24: General public of South Andaman District has been undergoing a harrowing experience for about a fortnight now thanks to the unannounced power cuts regardless of day or night. The frequency of power cuts have reached such a peak that, general public are left to suffer since there are no specific schedule or timing for power cuts. Many allege that, they have not come across such a worst current situation is something difference and uncalled for. According to them, earlier, the electricity department used to notify the general public of any power cuts through news paper in advance, now the department has scant regard about notifying the public of such power cuts.

Irked over the unannounced and frequent power cuts and also infuriated by lack of response over telephone from the Officials, a group situation in the past as the of general public had, last

week, stormed into the Electricity Site Office of Shadipur had an altercation with the staff present there. It was alleged by them that, the staffs at the Section Office were rude and were not cordial in responding to the general public present. Similar incidents of lack of response from staff were reported from other Section offices of electricity department.

Tourism stakeholders were briefed about the EOIs during a meeting held by the Deputy Commissio ner, South Andaman, Shri Suneel Anchipaka and Special Secretary (IP&T), Shri Hari Kallikkat today with the representatives of ACCI, Hotel Association,

Shipping Association and other stakeholders.

During the interact ion, the representatives of Associations provided valuable suggestions for boosting tourism in Isles. In the meeting, it was also decided that all ships and big hotels shall promote music, especially live music for the entertainment of the tourists as well as promotion of tourism. The EOIs intend to attract new ideas into the Tourism Industry, investment etc. besides finding out market interests for new activities and events as well as locations to conduct them in the Islands.

ment for the Islanders and this EoI is expected to attract private investment in tourism sector and create new job opportunit ies for the Islanders. The Fol for Tourism related events & activities will be a game changer in the development of tourism facilities as it would open up new venues for tourism like sky dinning, submer sible scooters, bungee jumping etc. and new events to enhance tourism engage ment and night life in the Islands. The transparent bidding process would allow new activities at fair prices, propelling Andamans among the most prominent Island destinat ions across the globe.

led to malfunction of electronic appliances such as television & refrigerator in many households. As the students are barely into reopening of their schools, complain of severe suffering due to lack of power supply as they are unable to site inside homes amidst scorching sun outside.

Enquiry with the electricity department claims that, due to lack of technical staff in the department, the department is unable to attend repair works and troubles hooting in time. There are large exodus of staff on superannuation and also due to death and these vacancies remain unfilled ever since the proposal to

privatise the department came to the fore, it is alleged. Due to this, there has been drastic fall in the number of technical staffs attending the repair works on daily basis.

Now, the rotational load shedding of 45 minutes as announced by the electricity department is a big shocker for general public and consumers. While the untimely power cuts leave the citizens furned, the rotational load shedding has left them sultry, it is claimed.

Such precarious situation arises when the Government of India is vying to take the country on a progressive path through schemes like Digital India. Since the electronic

gadgets constitutes the core of Digital India. uninterrupted power supply assumes equal importan ce in reaching the true potential of the said scheme. When it comes to the population of South Andaman, it is hardly 3 lakh and the electricity department is finding it difficult to fulfil the power demand of this meagre population. Unless the Administration takes fruitful steps such as filling the vacancies in electricity department & augmenting the power infrastructure, uninterrupted power supply for general public would be a distant dream. Lets hope that the administrators accord top priority for power supply in the coming days.

bearing on the execution of developmental works as the Municipal Council is looking after a vast urban area, especially after the last delimitation of wards which scaled up the number of wards to 24. Regardless of an increase in the jurisdiction, there has not been any substantial increase in workforce, but only it has waned over time due to retirement or death of staffs, an employee of PBMC alleges. Now, after a long gap, the PBMC has got a new Council and the efficiency and delivery of the Council would depend on the workforce alone.

While the steps initiated by the Chief Secretary, Andaman and Nicobar Administration for filling up the vacant posts in all departments is a welcome and laudable one, it will be in the public interest if the PBMC is also accorded priority in filing up the vacant posts. Now, the onus is on the Administration to revamp the waning workforce in the Port Blair Municipal Council.

vacant posts. Starting from sanitary mazdoors to Superintending Engineer at the top of the engineering hierarchy, the PBMC is deprived of adequate vacancies which silently hamper the efficiency of this vast civic body. While the staff crunch at the grassroot level leads to sanitary officers running from pillar to post to cope up with the work pressures related to maintaining sanitation, staff crunch of officials has led to additional charges being saddled upon each. Starting with Draughtsman under an Executive Engineer of PBMC, there is a shortage of Head Draughtsman or Draughts man Gr-II in various Divisions Due to lack of promotion to existing Draughtsman Gr-III, they are saddled upon the duty of looking after the Head Draughtsman as well. Since the post of Head Draughtsman is not available for long time, the duties of a Draughtsman Gr-III seems to have been subsumed with that of

Draughtsman Gr-II with no

palpable difference of duty,

sources allege.

Apart from routine

duties related to tenders and bills, Draughtsman are given additional duty of "Building Inspectors" which constrains them to go on field duty by leaving their routine desk works behind. This also leads to huge backlog of desk works resulting in delay of processing tenders, bills and other tender related works, a Draughtsman on condition of anonymity says. According to him, the post of Building Inspector seems more like a exofficio posts of Draughts man rather than being a separate post with difference nature of duty, he further says.

When it comes to Assistant Engineers and Executive Engineers, every officer is saddled with more than one additional duty in addition to their own duties. At the peak of it, an Executive Engineer who is already looking after more than one Division is saddled with the post of Superintending Engineer, PBMC apart from his additional charge of SWM Management. Saddling the officers with additional

charges only leads to inefficiency & mismanage ment as every officer is already entrusted with multiple charges, an Ex-Councillor alleges.

In the sanitation front, there are huge vacancies of posts like Sanitary Inspector, Senior Sanitary Inspector besides the Sanitary Mazdoors. All these vacancies had reportedly cropped up due to retirement or death of existing staff, it is claimed. Drivers serving in the Municipal Council claim that, there are severe shortage of Drivers in the Municipal Council which leads to one or two drivers being saddles with excessive duties, it is alleged.

Earlier, a couple of posts of Executive Engineers besides the Superintending Engineer posts were being held by a competent officer from the Andaman Public Works Department on deputation. Now, it seems that, Assistant Engineers of PBMC are given charge of Executive Engineers in addition to their own charges as Assistant Engineer.

Such a precarious situation is likely to have its
