

Budget Session of Parliament to be held from Jan. 31 to April 8

New Delhi, Jan. 18

The Budget Session of Parliament will commence on January 31. The first half of the budget session will run from January 31 to February 11. It will reassemble on March 14 to sit until 8th of April subject to exigencies of government business. The Government will present the Budget for fiscal year 2022-23 on 1st of February. President, Shri Ram Nath Kovind will address both the Houses of Parliament assembled together at 11 am on 31st of



January, the first day of Budget Session of Parliament. Lok Sabha Secretariat in a communique said that the eighth session of the 17th Lok Sabha will commence on 31st of January and subject to exigencies of government business, the session is likely to conclude

on 8th April, 2022. Rajya Sabha Secretariat in a press communique said that the President has summoned the Rajya Sabha to meet on 31st January 2022. It said, subject to exigencies of business, the Session is scheduled to conclude on 8th April, 2022. (Source: india.gov.in)

Exclusive 'Fever Clinic' opened in GB Pant Hospital

Port Blair, Jan. 18

In the wake of increase in number of COVID-19 positive cases, admission of new non-COVID cases at GB Pant Hospital has been restricted. In order to de-congest GB Pant Hospital, 3 Specialists, one each from General

Medicine, General Surgery and Orthopaedics will be available for OPD consultation at PHC Garacharama with effect from Jan. 19. Patients pertaining to the concerned discipline, who are seriously ill can avail this facility from PHC Garacharama instead

of visiting GB Pant Hospital.

Meanwhile, an exclusive 'Fever Clinic' has also been opened in GB Pant Hospital away from OPD complex to cater to patients having symptoms suggestive of COVID infection, a press release from GB Pant Hospital said.

COVID-19 status in A&N Islands

Port Blair, Jan. 18

During the RT-PCR test conducted on 95 passengers who arrived here yesterday, 25 positive cases have been detected. Today, 10 flights with 488 passengers arrived, out of which, 354 passengers were vaccinated with both doses while RT-PCR test was conducted on 124 passengers (4 foreign travellers) and the reports are

awaited.

During RAT conducted on 34 passengers bound for North & Middle Andaman at Ferrargunj, three positive cases have been detected. At Mohanpura Bus Terminus, test was conducted on 31 passengers and two positive cases have been detected. At Phoenix Bay Jetty, 16 passengers were tested with RAT and

no positive case has been detected. RTPCR test was conducted on 48 crew members of MV Bharat Seema, 46 crew members of MV Kalighat and 9 crew members of MV Sindhu, the reports of which are awaited.

Till 3 pm, 163 eligible persons were vaccinated, out of which, 21 were in the age group of 15-18 years, a press release from Directorate of IP&T said.

Vaccination drive in A&N Islands

80.61% of target beneficiaries in the age group 15-18 years of age vaccinated with first dose so far

6,01,917 doses of vaccines administered to beneficiaries in the age group of 18 and above

The vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 6,01,917 beneficiaries in the age group of 18 and above have been vaccinated so far in A&N Islands. Similarly, 18,541 beneficiaries have been vaccinated in the age group of 15 to 18 years against the target beneficiaries of



23,000. The number of beneficiaries administered precautionary dose of vaccine so far stood at 3260.

A total of 858 eligible beneficiaries

were vaccinated in A&N Islands today. 650 beneficiaries were vaccinated in South Andaman District, out of which, 165 beneficiaries were in

Big boost for A&N Islands

Near Coastal Voyage (NCV) gets in-principle approval; Draft policy and negotiation likely to start

Port Blair, Jan. 18

In what can be termed as a major boost for Andaman and Nicobar Islands, the proposal of the Administration to allow seafarers holding Near Coastal Voyage (NCV) Certificate of Competency to travel to Southeast Asian countries such as Thailand, Malaysia and Indonesia received in-principle approval and the drafting of the multilateral agreement to be executed with these countries through the Ministry of External Affairs along with negotiations for the same is likely to start shortly.

The matter was hanging fire for many years and after the 1997 agreement of BIMMS, where similar agreement with regards to NCV seafarers was reached between India, Bangladesh, Myanmar, Maldives and Sri Lanka, there had been no progress forward. In this regard, a virtual meeting on A&N Administration's proposal for notification of Ports of Ranong & Phuket of Thailand, Ports of Lankavi, Lumut and Klang of Malaysia, Northern Ports of Indonesia under Near Coastal Voyage (NCV) was held today under the Chairmanship of the Union Home Secretary. The Chief Secretary, A&N Administration,



Shri Jitendra Narain & Senior Officers attended the meeting.

Although the Administration has been trying to resolve the issue for many years, the proposal has finally been agreed to by the Ministry of Shipping, the DG Shipping, the Ministry of External Affairs and the Ministry of Home Affairs who have shown a positive and favourable response. In the next few months, through a multilateral agreement, it is likely that this will come through. The matter was important as it will allow our seafarers to go to these countries, thus enabling easier movement of ships thereby encouraging growth of tourism, trade, movement of raw materials and construction materials and for opening up of Andamans, not only to particular Ports, but to the entire country and these countries.

National Immunization Day for Polio to be observed in Isles on Feb. 27 instead of Jan. 23

On the National Immunization Day for Polio, polio drops will be given to all the children in the age group of 0-5 years, a press release from DHS said.

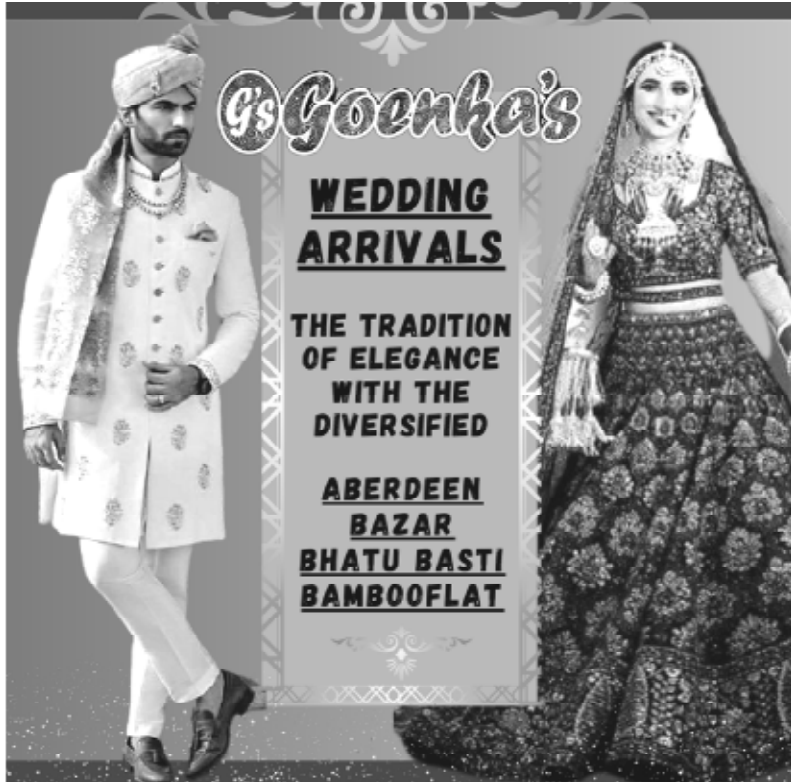

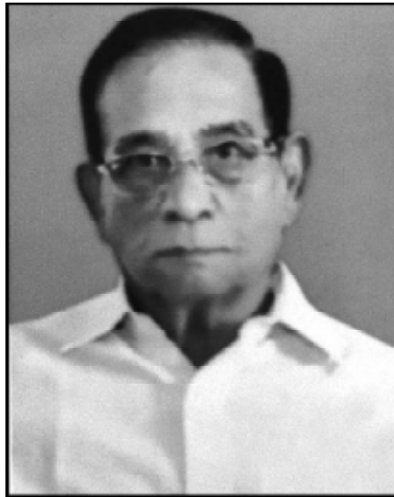

worker can get registered on e-SHRAM Portal by Self Registration or visiting nearest CSC. Labour Department has set up facilitation centre in the Office of Labour Commissioner, Supply Line, Port Blair so as to facilitate the Unorganized Workers to get themselves registered on e-SHRAM Portal.

As on 18th January, 2022 in A & N Islands, the total registration has crossed 23,106.

Meanwhile, the Office of the Labour Commissioner has appealed to all unorganized workers (those who are aged between 16-59 years, not a member in EPF/ESI and not an Income Tax Payee) to get registered themselves at e-SHRAM Portal. They can utilize Self Registration or service of any CSCs or the Facilitation Centre functioning at Office of the Labour Commissioner, Department of Labour, Supply Line, Port Blair along with a copy of Aadhaar Card, nominee's details, Bank A/c number, IFSC Code and Aadhaar Linked mobile number.

The Labour Department has also appealed to all NGOs, Trade Unions, Social Work Organizations and committed social leaders to conduct e-SHRAM Registration Camps in their respective areas for which the Department will extend all support, a press release from Labour Commissioner (I/c) said.
