# Navy to open all branches for women from next year: Navy Chief

The Indian Navy is looking at opening all its branches for women from next year, Chief of Naval Staff Admiral R Hari Kumar said on Saturday.

Addressing a press conference a day ahead of the Navy Day, Admiral Kumar also said that the first batch of around 3.000 'Agniveers' has been inducted and it included 341 women. In December last year, Navy officials said 28 women officers were deployed on board around 15 frontline warships, including aircraft carrier INS Vikramaditya, and the number is set to go up. "The first batch of Agniveers have already reported.

#### **Indianever favours** war, violence: **Defence** minister

BENGALURU, DEC 3 /--/ Defence Minister Rajnath Singh on Saturday said India neither troubles others nor does it spare those who trouble the country.

India never favoured war and violence but it cannot remain neutral to injustice and oppression, Singh said. "We all believe that India is a country which had always been peace loving. War and violence were never our nature. India neither attacked any other country, nor it occupied even an inch of any other



country's land.

This is India's character.' the Defence Minister said. Singh was speaking at the Gita Dana Yajna organised by the International Society for Krishna Consciousness (ISKCON) at its magnificent Govinda temple in Vasantapura in Bengaluru.

"The world should also know that India doesn't like staying neutral to the injustice and oppression is also not part of our character," he said without elaborating.

The Union Minister explained circumstances that led to the Battle of Mahabharata. It was on the battlefield of Kurukshetra where Lord Sri Krishna delivered his epic lecture which came to be known as Srimad Bhagwad Gita, he said.

The defence minister told the gathering that the Pandavas, the central character of the Hindu epic Mahabharata were ready to settle for five villages after spending years in exile but the Kauravas were not ready to part with land measuring the cusp of a needle

This denial had led to the battle, which ended by establishing the victory of virtues. "That's why I often say that India never troubles others but if someone troubles us, India will not spare them.

This is the message of Bhagwad Gita," Singh said. He also told the audience that the content of Gita makes it eternal and universal. Bhagwad Gita and imbibing it in life makes a person fearless, he added. The ISKCON Bengaluru has decided to donate one lakh copies of Bhagwad Gita through-out this month, apart from organising cultural and religious events.

## Gehlot vs Pilot: As Cong gears up for Bharat Jodo Yatra, 2 groups fight for dominance in hoardings

KOTA.DEC3/--/Rajasthan chief minister Ashok Gehlot and his former deputy Sachin Pilot may have put up a united front before AICC general secretary (organisation) Venugopal, but their supporters are reportedly showing one-upmanship on the ground ahead of the Bharat Jodo Yatra.

leaders are competing in Hadoti to highlight their dominance, which is visible from the hoardings in the region. This has also led to blame games between leaders of the two factions. Pramod Sharma, who contested the 2019 Lok Sabha elections from the Congress in Jhalawar. alleged that the Pilot camp has been attempting to weaken Gehlot's influence Sharma targeted Jhalawar district in-charge minister Pramod Jain Bhaya alleging that he was weakening the party's roots by leading a separate group of local people, and thereby sidelining efforts of the party's other workers. "The particular group (Bhaya's group) is going ahead everywhere only with Sachin Pilot. In many posters and hoardings that have out up, pictures of Pilot, Rahul Gandhiand Priyanka Gandhi Vadra are occupying the maximum space, while those having Ashok Gehlot's picture prominently are lesser," Sharma said. He also claimed that pictures of the party's national president Mallikariun Kharge and former president Sonia

Gandhi were confined to small circles in the hoardings.

Another local leader involved in the arrangements said the conflict between Gehlot and Pilot does not seem to end soon and this is clearly reflected in the hoardings. However, both the factions are believed to maintain calm during the yatra because of Venugopal's the two leaders, a Congress Seva Dal worker in Jhalawar's Chanwali said. Jhalawar district Congress president Virendra Singh Guriar, who is working under Pramod Bhaya for the yatra, however, said there was no infighting as far the event was concerned. Gurjar, who is considered as a seen as a Pilot lovalist.toldPTIonSaturday that party workers prepare the banners with photos of leaders of their choice. He said only three things were dominent in all the advertisements -- pictures of Rahul Gandhi, the party's name and its symbol.

He said all party leaders and workers were eager to Gandhi welcome Rajasthan. PCC member Suresh Gurjar, who contested the last assembly election from Khanpur and is believed to be a Pilot loyalist, also denied groupism and dominance of a particular faction. He said both Gehlot and Pilot were their leaders and their pictures were displayed prominently in all the advertisements brought out in connection with the yatra. The yatra will enter Jhalawar from Madhya Pradesh on Sunday evening. On Monday morning, Gandhi will start the Rajasthan leg of the vatra from Kali Talai area, which comes under BJF leader Vasundhara Raje's constituency Jhalrapatan. Raie has been representing Jhalarapatan since 2003 while her son Dushvant Singh is serving as the MP from Jhalwar constituency for the third time. The vatra will enter Kota on Tuesday.

Kota-Bundi is the parliamentary constituency of Lok Sabha Speaker Om Birla. Parliamentary Affairs Minister in governmentShantiDhariwal also hails from Kota. Dhariwal was among three Congress leaders who had been issued notices for indiscipline after they refused to attend the Congress Legislature Party meeting on September 25 and held a parallel meeting instead.

Meanwhile, preparations for the vatra are in final stages in Jhalrapatan's Chanwli village. Three grounds covering around 45 bighas of land have been prepared for night stay of the leaders on Sunday Of these. the middle ground is meant for Rahul Gandhi's convoy. consisting of approximately 20 vehicles, while the first ground is for the state-level Congress workers and the third one for local party workers. Around six to eight state ministers and several senior party workers have reached Jhalawar to review the preparations. Gehlot, too, took stock of the preparations on Friday. (PTI)

## AAP introduced 'Lalu model' in Delhi, bungled crores in name of workers' welfare: BJP

NEW DELHI, DEC 3 /--/ The BJP on Saturday alleged the AAP government introduced the "Lalu model" in a new avatar in Delhi and bungled crores of rupees by enlisting fake names as beneficiaries under the construction workers'

It is "Delhi's Lalu model," alleged Union minister Anurag Thakur at a press conference here, a day before the Municipal Corporation of Delhi polls. An immediate reaction was not available from the Aam Aadmi Party on the issue. Rashtriya Janta Dal supremo Lalu Prasad Yadav was convicted in the fodder scam of Bihar and was in jail in cases related to it.

"There (Bihar), cattle feed was gobbled up, here (Delhi) labourers' right were denied," Thakur claimed and alleged that Kejriwal and "his friends" bungled crores in the name of welfare of construction workers in Delhi. The Antifound that "ghost" workers were disbursed funds to the tune of Rs 900 crore by the AAP government's Labour department, official sources had said earlier.

In 2018, the ACB had registered a case after they found bogus registration of employees under the Delhi Building and Other Construction Workers Welfare Board. "Kejriwal has presented Lalu's model in a new form. It has been found that there were fake names, addresses and mobile numbers. of persons registered as construction workers. Even 'kachori' sellers and taxi drivers were enlisted as employers," Thakur said, showing a bundle of papers. Official sources had earlier said a preliminary inquiry by the ACB found "fraudulent disbursal" of funds to the tune of Rs 900 crore to "bogus and ghost" workers by the Labour department of the Delhi government.

"There are names of people in the lists from UP and Haryana. Who is responsible for bungling the funds of the construction workers in Delhi," the minister said, reading out names and their addresses. "There were liquor scam, classroom construction scam, bus scam and now this one. I wonder how Arvind Kejriwal is able to sleep at night," Thakur said giving a slogan "Bhrashtachariyon ka yaar hai, Kejriwal gunahgar hai" (Friends with the corrupt, Kejriwal

Sources had earlier said a random survey of registration papers by the ACB showed that 424 out of 800 were fake. Over 17 lakh persons have been registered with Delhi Building and Other Construction Workers Welfare Board (DBOCWWB) as construction workers. The Kejriwal government had provided financial assistance of Rs 5,000 each to registered construction workers to help them during lockdown imposed due to Covid. Even last month, the Delhi government had announced a relief of Ra 5,000 each to registered construction workers as relief due to pollutionrelated ban on construction activities in the city. (PTI)

**Amid Karnataka** CM's remarks on border row, NCP slams Maharashtra govt, BJP and Centre for 'eerie silence

MUMBAI, DEC 3 /--/ The NationalistCongressPartyon Saturday questioned the 'eerie silence" of the Maharashtra government, the Bharatiya Janata Party and the Centre on the "uncalled for" statements made by Karnataka Chief Minister Basavaraj Bommai on the border dispute between the two states, which it claimed brought the differences to the fore again.

Bommai had recently soughtamerger of "Kannadaspeaking" areas Maharashtra's Akkalkotand Solapur and had also said some villages in Jattaluka in Sangli district wanted to join the southern state.

A day earlier, he said the visit of Maharashtra ministers Chandrakant Patil and Shambhuraj Desai to Belgaum was not good in the given situation. Maharashtra and Karnataka have been involved in a long-standing border dispute, with the former seeking administrative control of Marathi-speaking Belgaum and some other villages of theneighbouring state.

"Why is an eerie silence being maintained by the Centralgovernment, BJP and CM of Maharashtra on the uncalled for statements made and issues raised on the border row by Karnataka CM Basavaraj Bommai," NCP national spokesperson Clyde Crasto asked in a statement. "Firstly, he (Bommai) made statements on the sub-judice border issue, which led to disturbance of peace in both the states. (PTI)

A new initiative is on under the auspices of the Tamil Nadu Development Corporation to upskill them and provide employment opportunities and the scheme coversprovidinglaptops with loaded relevants of twares. The initiative is covered under the 'Naan Mudhalvan' (I am the first) State scheme. He said that it is the goal of the government to see that the differently-abled people should not face any difficulty. Not even a single person with disability should have any grievance and even if an initiative is going to benefit a single differently-abled person, it should be done, he said. Stalin said the pension

given by the revenue department would be raised to Rs 1,500 from Rs 1,000, effective January 1 for 4,39,315 differently-abled pensioners including the visually impaired. The move would entail an annual additional expenditure of Rs 263.58 crore. He referred to the exclusive pathway set up by the Greater Chennai Corporation to provide easy access to the Marina beach here to the differently-abled persons. It is their right and it is the government's pathway of love, he said.

The differently-abled people should be given due respect and providing barrier free access to them begins at home (Accessible Home). The disability is in respect of only the human body and is not about their intelligence or skills. He cited the inspiring hardwork of several differently-abled persons including noted the Paralympic champion Mariyappan Thangavelu. He said the state government is dedicated to the welfare of all sections of people, in particular the marginalised

Perhaps along with the territorial sovereignty and the symbolism of the national flag itself, it represents the most sacred manifestation and expression of the land and its people. The fact that not a single member of the Iranian team sang the National Anthem (a wholly voluntary decision, knowing consequences of their move), says something of palpable national mood beyond the officialspeak. That they played to the best of their abilities and even managed to defeat a much higher ranked team i.e., Wales, in the second match, is reflective of the Iranian efforts team's following the expected threats of consequences and conservative authorities, the Iranian team did half-heartedly sing their national anthem in the second game against Wales, however the message of

protest and support for the societal cause back home, had already been made. Had the Iranian players crossed a

line with their visible defiance and brought shame and indignity to their motherland and cherished symbols, or had they only brought shame onto a repressive and exclusivist dispensation that did not behoove the civilisational depth of the long-standing Like identity? authoritarian regimes, the current Iranian dispensation leans on 'manufactured nationalism' (not liberal patriotism) to invoke a toxic admixture of pride, fear and fury to suppress all forms of public dissent and protest. A vital part of this project is to denigrate and punish the 'others' (in this case, a women of ethnic minority) for ostensibly disrespecting symbols like the national anthem. It is a deliberate slam effected on minorities. intellectuals, free press, secularists etc., all of whom seek to posit an alternative

opposed to the religioinspired puritanism and national identity, especially in a vivid civilisational land like Iran. So, as the final line of the current Iranian national anthem expresses the hope that the Islamic Republic of Iran will survive forever, it is only in opposition to that specific construct of governance type that the Iranian protesters are up in arms against, and not to the timeless land called Persia or Iran. The notions of nationalism for the Iranian protestors are no longer as small-spirited, regressive and discriminative as their dispensation of the day would like it to be, to perpetuate their own regime. # Delhi breathes cleaner air this winter

This winter, Punjab and Haryana saw less farm fires. This is good news and credit goes to both policy framers and agriculture scientists. Farm fires are down by 30% and 48% over last year in Punjab and Haryana respectively (this may be Punjab's lowest farm fire count since 2012). Delhi's average Air Quality Index (AQI) for November was 321. While this still puts average AQI for November in the 'Very Poor' category - it is bad enough to affect most people with prolonged exposure -Delhi's air quality this November was the second-best since 2016. What explains this relative improvement in Delhi's air quality this year? October was also the second best. But, this could also be  $attributed \,to\,the\,weather\,in\,Punjab\,and\,Delhi\,rather\,than$ more effective pollution management by governments of the two regions. The key, therefore, is sustaining these gains next year and the years after – to ensure that the practice of paddy stubble burning, which is nothing less than social malpractice, is eradicated.

A concerted attempt is needed by Punjab and Harvana officials to deter farmers from setting fields on fire. This brings to the forefront a political dimension as well. AAP winning the Punjab assembly elections has ensured that the Punjab government cannot duck accountability for farm fires, which hurts Delhithe most Similarly, BJP helming Centre and Haryana have ensured both governments are on the same page. Every year from September to December, air pollution becomes a big issue due to stubble burning. During this time, the NCR areas of the four states including Delhi are the worst affected by this phenomenon. NASA satellites have observed in October-November large clouds of smoke and heightened fire activity in northwestern India from farmers burning crop stubble. That was because tens of thousands of farmers across north India set fire to their fields at the start of every winter to clear crop stubble from recently harvested rice paddies.

The practice is one of the key drivers of Delhi's annual smog problem and persists despite efforts to persuade farmers to use different clearing methods. A surge of smoke, caused by these fires, often contributes to a sharp deterioration of air quality across the region, including in Delhi-NCR. The anti-farm-reforms agitation and the Punjab elections had turned the fightback against stubble burning into a nonstarter, the last two years. Both in-situ straw management through super-seeders, which plough the straw back into the soil, and ex-situ baling of the straw for sale to biogas plants, industries with captive power plants, and fodder suppliers, were heavily promoted this year. Super-seeder machines gaining in popularity over the previous generation of happy-seeders is a promising development. Innovations that make these machines better and faster and more fuel-efficient can win over the holdout farmers too. ICAR's bio-decomposer appeared to not find much favour, given the short window between kharif harvest and rabi sowing this year, but it's just as promising.

Interventions to reduce stubble burning and the pollution it causes need to be focussed on just six districts of Punjab — Barnala, Sangrur, Patiala, Moga, Ludhiana and Fatehgarh Sahib — a new research by scientists from Harvard University and the Massachusetts Institute of Technology (MIT) in the United States has advised. These six districts should be focussed upon as they contribute 40 per cent of India-wide exposure to fire-related PM2.5, according to the research just published in the journal 'Nature Communications'. While figures from the Indian Agricultural Research Institute (IARI) indicate that the paddy stubble burning related fire count has been lower this year when compared to previous years in Punjab and Haryana, scientists say the fire count is yet to be corelated with the figure of the area that has been burnt this year.

# Bengal's new Governor may be different from Dhankar

The West Bengal BJP is at crossroads over its interaction with new governor CV Anand Bose after leader of the Opposition, Suvendu Adhikari and state unit chief, Sukanta Majumdar boycotted the swearing in ceremony of the governor on November 23 claiming they were not given seats of honour in keeping with their position. The saffron camp leaders are in doubt whether Bose had taken exception to the "boycott" or taken it in his stride.

For the governor's mindset is of significant import to the state BJP, the principal Opposition party in the state. After all, Raj Bhavan had been a frequent port of call for BJP delegations during the tenure of Bose's predecessor, Jagdeep Dhankhar who never failed to give a patient hearing. Over and above this, Dhankhar shot off caustic comments about the mode of governance of the state, incidents of breakdown of law and order and even sent for senior officials to learn their views on matters which had hit the headlines for the wrong reasons.

Things had come to such a pass that according to some Trinamool, leaders the previous governor's role became almost as a BJP cadre. Without admitting it, the state BJP leadership looked towards the principal occupant of Raj Bhavan almost as another spokesperson who though sans a political colour was of greater constitutional weightage. But the boycott has put a question mark on Bose's future interaction with it when a saffron delegation next calls on the

To make matters worse, the BJP was beaten to the draw by Congress. Though his party is unrepresented in the assembly, Bengal Pradesh Congress Committee chief Adhir Ranjan Chowdhury gave the governor the first complaint from the Opposition alleging that Trinamool Congress government was trying to appoint an administrator at Jhalda municipality in Purulia where Congress had just won a vote of confidence. as skeletons tumble out of its cupboard. Senior state saffron camp leaders have been rapped on their knuckles by senior party leader Satish Dhond after he came across that the outreach of his party men towards the masses falling short of the goal. The reprimand had come at a time when the protests and processions against Trinamool dispensation have been stepped up. Dhond had been on the lookout for the organisational lapses which made the saffron party stumble and fall in the state Assembly elections last year after having been tipped to sweep it.


Seeking to script a prescription for recovery, Dhond has stumbled on to unpleasant facts which include that several BJP MLAs are conspicuous by their absence in their constituencies. The surprise was laced by embarrassment when it came to light that these MLAs sought to bite more than they can chew. For some of these legislators of the saffron camp who are infrequent visitors in their own constituencies aspire to contest in 2024 parliamentary elections. Apart from these MLAs, the Lok Sabha aspirants seeking the party's nomination also include senior organisational leaders, who have been detected to be lacking people's support. It is not that the MLAs in question are sitting idle. They are more active outside their respective constituencies cultivating persons of influence for nomination to the 2024 parliamentary election, according to reports of district chiefs placed at the meeting.

The facts looking the state saffron camp leadership cannot be binned as Trinamool canards for they had come to light at a recent state unit meeting. Small wonder, Dhond had given vent to his ire which was

triggered by the finding that some of his party MLAs and leaders are sleeping on their job. It is a pointer to a question that asks whether most of the seats the saffron party lost last year was an outcome of the diminution of its organisational strength triggered by complacency following the impressive haulof bagging 18 seats in 2019 parliamentary polls. Not shy of calling a spade by any other name, Dhond lashed out at the MLAs and party leaders playing truant. At a top level meeting of the state unit at its Hastings party office, he pulled up the errant leaders and MLAs for not visiting their constituencies.

Dhond who is from BJP's national leadership had Howrah, Hooghly and Midnapur in his focus. Midnapur happens to be a stronghold of leader of the Opposition, Suvendu Adhikari. As Dhond who is BJP's joint general secretary (organisation) belled the cat, he found he was not crying in the wilderness. A senior leader pointed out that there exists little coordination between the party's MLAs and MPs. Party meetings are poorly attended, it was stated. The charge was underscored by former state chief and Kharagpur MP, Dilip Ghosh. Voicing his dissatisfaction, the veteran leader said that his meetings in the districts are drawing party activists in insufficient numbers. Since Ghosh is speaking of organisational meetings, it is pointer to the scanty number of activists at the level of mandals, an internal unit of BJP. Organisational weakness apart, internal dissension came to the fore at the meeting which Dhond attended. It was reported that five mandal committees cannot be formed at Haldia and Moyna assembly segments owing to disagreement between state party chief, Sukanta Majumdar and leader of the Opposition, Adhikari.

The situation has boiled down to saffron camp leaders finding internal dissension getting out of hand. The errant leaders are now apprehensive of facing the music when Dhond places his report before Union home minister, Amit Shah. (IPA)

# India-UAE economic relations set to reach new high

India and the United Arab Emirates (UAE) are all set to deepen their already warm relationship. The development is bound to have a beneficial bearing on India's relations with the other countries of West Asia.

Topping the list is a food security cooperation under the I2U2, a new West Asian quadrilateral initiative, including Israel and the US besides India and the UAE. The stage has been set for an agreement on food security cooperation in the wake of India's External Affairs Minister S. Jaishankar's talks with UAE Foreign Minister Sheikh Abdullah bin Zayed Ali Nahyan this month. It may be mentioned that a delegation led by the CEO of ADQ, an active investor and a sovereign wealth fund located in Abu Dhabi, visited India in October this year for detailed discussions with the stakeholders.

On its part, the I2U2 leaders' summit, held in July had decided to harness private capital among the member countries for projects on agriculture, infrastructure, water, energy, transportation and digital connectivity. It is gratifying to note that bilateral relations between India and the UAE had registered an "appreciable growth" ever since the conclusion of a landmark Comprehensive Economic Partnership Agreement (CEPA) in February 18 this year. Subsequently, Prime Minister Narendra Modi had

visited Abu Dhabi on June 28 on his way back home from Europe. He was welcomed by UAE Sheikh Mohammed bin Zayed Ali Nahyan. Incidentally, it was Modi's fourth visit to the UAE.

The headway made is visible in a 24 per cent increase in India's exports to UAE between April and September in 2022. While India's exports were in the region of USD 16 billion, imports recorded a 38 per cent rise to touch USD 28.4 billion in the same period. The bilateral talks also concluded that there was scope for further cooperation in the fields of energy, healthcare, defence, space, climate change, skills, fintech and start-ups.

The growing warmth in the ties between the two countries is evident in India's talks with UAE and Saudi Arabia to allow settlement of trade in Indian rupee. Reports have it that the Reserve Bank of India and the Finance Ministry are working on a mechanism to facilitate trade in the Indian currency.

If the talks fructify, it will be a major gain for Indian businessmen as UAE is a big market for India. There is a rub, however. Since India is a net importer from both UAE and Saudi Arabia, the excess rupee management could prove ticklish. Incidentally, India's exports to UAE and Saudi Arabia posted a decline in October 2022.

Bilateral ties received a big boost when UAE became the highest contributor to Foreign Direct Investment in India from Gulf countries. UAE invested, between 2017 and 2021, nearly \$6,488.35 million in India. Saudi Arabia is also a significant contributor to FDI in India. India and UAE have a special relationship as close to 35 lakh Indians live there. Not surprisingly, remittances from UAE have recorded a five per cent increase in recent months. The break-up of major investment in India from Gulf countries is as follows: \$6488.55 million from UAE; \$3058.25 million from Saudi Arabia, \$223.49 million from Qatar; \$181.45 million from Bahrain, \$109.25 million from Oman and \$37.91 million from Kuwait.

Also, the period between June 2020 and December 2021 saw the return of Indian migrant workers from the Gulf countries. These included 1,52,126 from UAE, 1,18,064 from Saudi Arabia, 51,206 from Kuwait, 46,003 from Oman and 32,361 from Qatar. Available figures say

that the number of people who left India to work in Bahrain, Kuwait, Qatar, Oman, Saudi Arabia and the UAE, between June 2020 and December 2021 is 1, 41,172. It may be mentioned that the RBI had, in July, announced a policy decision to allow trade settlements between India and other countries in rupee. The notification, issued on July 11. said that it had been decided to put in place an additional arrangement for invoicing, payments, and settlement of exports and imports in INR. This has been done to promote global trade with accent on exports from India and to support the rising interest of global

trading community in INR.
Significantly, two Russian banks,
Sber Bank and VTB, are the first foreign
lenders which have secured the RBI's
approval to open special Vostro
accounts to trade in rupee. The RBI is
learnt to have given approval to the
HDFC Bank and Canara Bank to open
special Vostro accounts for trade
settlement in Indian currency with
Russia.

Three other banks, Uco Bank, Union Bank and IndusInd Bank, have also managed to get approval for opening Vostro accounts Vostro account maintains holding of the foreign entity in Indian banks in rupee. The advantage is that traders, irrespective of whether they are exporters or importers, can receive or make payments through this account. (IPA)

The scheme was later extended to the entire country on 27th September 2021, and renamed as Ayushman Bharat Digital Mission (ABDM). ### **Kolkata Police books** Paresh Rawal on CPI(M) leader's complaint

KOLKATA. DEC 3/--/The Kolkata Police has booked actor Paresh Rawal under different sections of the IPC on a complaint filed by CPI(M) state secretary Md Salim, who alleged that he delivered "hate speech" against the Bengali community during an election rally of the BJP in Gujarat. A case has been registered against Rawal under IPC sections 153 (provocation with intent to cause riot), 153A (promoting enmity between different groups), 153B (propagates denial of rights to linguistic or racial groups), 504 (Intentional insult with intent to provoke breach of the peace) and 505 (statements intending public mischief), police said in a communication to Salim. Salim in his complaint to the Taltala police station on Thursday said he came across a video on various social media platforms featuring the actor giving a speech that could promote feelings of hatred against Bengalis. Sharing a copy of the communication by the Taltala police station officer-in-charge, Salim said he is "eagerly awaiting" the follow-up action by the Mamata Banerjee government. The police officer said in the communication that an investigation into the case was underway. Seeking the actor's prosecution, Salim claimed that Rawal had made an unsavoury reference to Bengalis linking gas cylinders with Bangladeshis, Rohingyas, Bengalis and fish. Rawal apologised on Friday following a huge backlash on the social media over his comments. "Of course, the fish is not the issue as Gujaratis do cook and eat fish. But let me clarify by Bengali I meant illegal Bangladeshi N Rohingya. But still if I have hurt your feelings and sentiments I do apologise," the 67-year-old actor and former BJP MP wrote on Twitter. Rawal had taken up the issue of gas cylinder prices, an emotive poll issue, at a BJP rally in Valsad district on Tuesday. "Gas cylinders are expensive, but their price will come down. People will get employment too. (PTI)

# Himanta announces additional Rs 5 crore for Assam Agitation Welfare Trust

GUWAHATI, DEC 3/--/Assam Chief Minister Himanta Biswa Sarma on Saturday announced an additional Rs five crore for the Assam Agitation Welfare Trust. The trust was formed with an initial corpus of Rs five crore and with the chief minister's announcement of additional Rs five crore, the total amount at its disposal will be Rs 10 crore. A decision to this effect was taken at a meeting, chaired by the chief minister, to discuss matters related to future tasks as well as measures required for strengthening the trust, an official release stated. Sarma said the amount would be utilised to provide various relief measures to family members of martyrs of Assam Agitation and those grievously injured during the agitation. The chief minister also directed the Assam Accord Implementation Department to make an online database of those who were hit by bullets or were seriously injured during their participation in Assam Agitation. The state had witnessed a sixyear agitation against illegal migrants from neighbouring Bangladesh which ended with the signing of the Assam Accord in 1985 between the Centre, state government and All Assam Students' Union (AASU) Minister of Assam Accord Implementation Department Atul Bora, Finance Minister Ajanta Neog, AASU chief advisor Samujjal Kumar Bhattacharjee, its president Dipanka Nath, Assam Chief Secretary Paban Kumar Borthakur attended the meeting. ## Police complaint lodged against Ajmal; parties link his comments to Guj polls

complaints were lodged in Assam on Saturday by Assam Jatiya Parishad (AJP) against AIUDF MP Badruddin Ajmal for his purported comments targeting women and the Hindu community. AJP vice-president Dulu Ahmed filed the complaint at Hatigaon police station here and in Hailakandi by the party's chief convenor there. The police confirmed receiving the complaint and said investigation has been started in the matter. Ahmed demanded immediate action against Ajmal, a Lok Sabha MP, for his comments as it has led to "widespread reactions in the society and could ignite communal violence". He sought an enquiry against Ajmal and demanded stringent measures against him as per law. Ajmal in an interview to a media house on Friday had commented on women and Hindu men as well as Assam Chief Minister Himanta Biswa Sarma, purportedly as a rejoinder to his remarks on love iihad'. The AIDUF chief, who is revered as a 'maulana', courted controversy by reportedly advising Hindus to marry young to produce more children like Muslims. His political detractors Assembly poll and alleged that the AIUDF supremo was toeing the BJP line to "rescue" the party, which is in power in the western state. The TMC even burnt his effigy here. The ruling

BJP roundly criticised the remarks attributed to the perfume baron. The saffron party spokesperson Ranjib Sarma said "Ajmal and his ilk view women as mere objects. The words he has used against our chief minister should be challenged by the entire civilized society." He also demanded that Ajmal be stripped of his maulana' title. Sarma also questioned the timing of the comments as it came on a day when a committee was formed by the Assam government to look into problems of Satras (Vaishnavite monasteries) submitted its interim report. The report pointed to largescale encroachment of Satra land mostly by migrant Muslims who form Ajmal's vote bank, the spokesperson claimed. BJP legislator Diganta Kalita urged the Muslim community to stand up against Ajmal and maintained that people making such comments should be "socially and politically ostracised". State Congress president Bhupen Bora was quick to sniff a conspiracy between Ajmal and the chief minister in creating the "controversy". "Ajmal and Himanta Biswa Sarma are conspiring together to divert attention from the core issues linked his remarks to the Gujarat — facing the people and to keep them engaged elsewhere," he maintained.

> Leader of the Opposition in state Assembly Debabrata Saikia (Cong) also maintained that there is need to look into whether there is any

connection between BJP and AIUDF leading to Ajmal's comments. The Assam police should take suo moto cognisance against Ajmal for not only the remarks against women and a community, but also for the specific comments against the chief minister, he said. "It is strange that the Hindu organisations have not approached the police yet," Saikia added. Raijor Dal general secretary Azizur Rahman questioned why Ajmal, who hails from a Bengali Muslim family, chose to speak in Hindi during the interview. "Gujarat assembly election is on and BJP's boat is sinking there. BJP needs religious polarization to save itself and it has enlisted Aimal for its rescue. That's why he spoke in Hindi,

Rahman said that as a religious preacher Aimal is aware of the high status women are accorded in Islam and yet he made the "disparaging remarks against them and equated them with child producing machines". The Trinamool Congress staged a demonstration in front of its office here and burnt an effigy of Ajmal. "We will not tolerate such comments against women and Hindus. Ajmal is saying these things at the dictates of BJP with an eye on the Gujarat polls. We demand his immediate arrest," the party's spokesperson Dilip Sharma said.

"The impact was so powerful that the mud house with a thatched roof was blown off in the incident," the senior officer Bhupatinagar Police Station said. The three deceased were identified as Rajkumar Manna, who is reportedly a TMC worker, Debkumar Manna and Biswajit Gaven, he said, A forensic team later reached the spot and collected samples and a huge police team was deployed there. BJP national vice president Dilip Ghosh held the TMC responsible for the incident and said that "only bomb-making industry is flourishing in the state". (PTI)

### <u>Plans on IAC II put on hold for now; examining option of repeat order of INS Vikrant: Navy Chief Admiral Kumar</u>

NEW DELHI, DEC 3/--/The Indian Navy is looking at having a second indigenous aircraft carrier (IAC) and is set to procure a raft of other platforms including Predator drones from the US to bolster its overall military capability, Navy Chief Admiral R Hari Kumar said on Saturday in the backdrop of evolving regional security matrix and China's growing naval prowess.

Addressing a press conference a day ahead of Navy Day, he said the plan to have a bigger indigenous aircraft carrier (IAC II) has been put on hold and the option of a repeat order of the recently commissioned IAC I (INS Vikrant) is being contemplated. The Chief of Naval Staff also said a timeline of 2047 has been set for making the force 'Atmanirbhar' (self-reliant) and highlighted various initiatives to meet the target including to indigenously produce a twinengine deck-based fighter aircraft. Admiral Kumar also said that an exercise is underway in the force to shed the colonial past as "we strongly support the view that we have to get away from this "Ghulami ki mansikta" (slave

mentality). The Navy Chief also said that the Indian Navy is set to open all its branches for women from next year. On possible challenges from China, he asserted that the Navy keeps a strong vigil over movements of various Chinese military research and fishing vessels in the Indian Ocean Region. Listing initiatives to bolster the Navy's operational prowess, he said a draft cabinet note is being prepared for the proposed indigenous twin-engine deck-based aircraft, adding the plan is to have a prototype of the jet by 2026 while its production would start

The Navy celebrates December 4 as Navy Day to commemorate its daring attack on Karachi harbour and its decisive victory in the 1971 Indo-Pak war. Admiral Kumar said the Navy is contemplating whether to go for indigenous aircraft carrier (IAC) II or prefer a repeat order for the IAC I. The Navy has been making a strong push for having the IAC-II having a displacement of 65,000 tonnes which was estimated to cost close to Rs 50,000 with the envisaged specifications.

"We are still working on what size it should be and what its capabilities should be. Right now we have put a hold on it because we have just commissioned INS Vikrant. We are quite happy with the ship. The way the ship performed in the trial," Admiral Kumar said when asked about the IAC II. India's first indigenously-built aircraft carrier INS Vikrant (IAC I) was commissioned in September. The aircraft carrier, with a displacement of 40,000 tonnes, was built at a cost of around Rs 23,000 crore. People familiar with the issue said the cost of building the IAC II was a major discussion point as there has been a view in the defence establishment that the Navy should focus on enhancing its fleet of submarines rather than spending close to Rs 50,000 crore on the aircraft carrier. "It (IAC I) was 'Atmanirbharta' (self-reliant) in full bloom. So We are also currently examining whether we should look at the repeat order of the IAC I instead of going for the IAC II to capitalize on the equities which are available to the country," he said. "It is right now at the discussion stage.



We have not yet firmed up our mind nor have we taken it up to the government," Admiral Kumar said. He said the recent global events have amply underscored that this vision cannot be met in letter and spirit if the force remains dependent on others for its security needs. "Maintaining credible deterrence, while remaining ready to go into harm's way to protect, preserve, and promote our national interests

will remain our principal priority," Admiral Kumar said. "Our vision of being a 'combat ready, credible, cohesive, and future-proof force' underpins this aspect," he said.

"To that end, the Government has clearly spelt out the need for AtmaNirbharta. The Indian Navy, on our part, has made an unequivocal commitment to be fully Aatmanirbhar by 2047," he said. (PTI)

## IMF says it fully supports India's G20 agenda

supports" the G20 agenda of India, which is planning to use the ongoing global crises as an opportunity to seek consensus on issues that require urgent attention, a senior official from the international financial body has said.

India formally assumed the G20 Presidency on Thursday. "They (India) are putting together a collective agenda for a much more prosperous future," Ceyla Pazarbasioglu, Director of the Strategy and Policy Review department at the International Monetary Fund (IMF), told a group of reporters ahead of her trip to China and India next week. "They (India) plan to use the ongoing (global) crises as an opportunity to seek consensus on issues that really require urgent attention," she said on Thursday. Pazarbasioglu was apparently referring to the food and energy crises due to the ongoing Russia-Ukraine war. The IMF "fully supports" the G20 agenda of India, she said.

The theme of India's G20 presidency is "One Earth, One Family, One Future." "This means that India is prioritising the need to set aside differences and work at the local level, the federal level, the international level," explained the IMF official. India, she said, played an important role in negotiating the G20 declaration in Bali, Indonesia. "As you know, we haven't been able to have a declaration or a communique in the past two ministerial meetings, they were chair summaries. I will not go into

The G20's Bali Declaration last month acknowledged differences among members on the Russia-Ukraine war but stressed that it was essential to adhere to international law, including the protection of civilians caught in conflicts.

The members of the grouping made it clear that they were against the use or threat of use of nuclear weapons and sought "peaceful resolution of conflicts." "Today's era must not be of war," the declaration said, echoing the remark made by Prime Minister Modi during his bilateral meeting with Russian President Vladimir Putin on the margins of the SCO summit in September. In addition to continuing with the G20 agenda, India has also announced its set of priorities which are important for the global community, Pazarbasioglu said. "There are continuing efforts, be it on the debt side, be it on the tax side and other priorities," Pazarbasioglu said. At the same time, India has also identified its own initiatives that they want to showcase. "That's mainly the digital public infrastructure where India has been leading the way. That is very important for good governance, and that's very important in the current circumstances where we have a lot of inequality and concerns about just or transparent public revenues and spending," she said. ## Washington condemns shooting at Pak embassy in Kabul

condemned Friday's attack on the Pakistani embassy in Afghanistan's capital in which a senior Pakistani diplomat escaped unhurt but one of his Pakistani guards was wounded.

The attack comes amid rising tensions between the South Asian neighbours over Islamabad's claims that anti-Pakistan government forces are organising terrorist attacks from hideouts in Afghanistan. Shots were fired at the embassy from a nearby building by an as-yet known assailant or assailants. Shortly after the shooting. Pakistan's Prime Minister Shahbaz Sharif took to Twitter, calling the attack an "assassination attempt" against Pakistan's head of mission in Afghanistan, Ubaid-ur-Rehman Nizamani. Pakistan repatriated the guard by helicopter and he was being treated at a hospital on Saturday. The embassy attack came days after Pakistan's deputy Foreign Minister Hina Rabbani Khar flew to Kabul to hold talks with Afghan Foreign Minister Amir Khan Muttaqi on a range of issues, including the latest threat from Pakistani Taliban who recently ended monthslong ceasefire with Pakistan and asked fighters to resume attacks across the country. In Washington, US

spokesman Ned Price on Friday said the United States condemned the Embassy attack, telling reporters "we offer our sympathies and wish a quick recovery to those affected by the violence". The United States is "deeply concerned by the attack on a foreign diplomat and we call for a full and transparent investigation,' Price said. The US charg d'affaires for Afghanistan, Decker condemned the attack on Nizamani in a tweet Saturday. "Outraged at attack on my diplomatic counterpart @PakinAfg, Ubaid Nizamani; I am grateful he is safe & wish a quick recovery to the brave security guard who was injured. I join the call for a thorough and transparent investigation,' Decker wrote. Muttaqi on Friday evening called Pakistan's Foreign Minister Bilawal Bhutto Zardari to condemn the "terrorist attack" targeting Nizamani, according to a Pakistani Foreign Ministry statement. Muttaqi assured Bhutto-Zardari that "the Afghan government will bring the perpetrators of this heinous attack to justice swiftly," the statement said.

Bhutto-Zardari thanked Muttaqi and said the "Taliban government must prevent the terrorists from undermining relations between Pakistan and

said. It said Pakistan on its reiterated unwavering commitment to fight terrorism, saying "Pakistan will be undeterred by such cowardly attacks". Friday's shooting comes a after Pakistan demanded Afghanistan's Taliban government prevent terrorist attacks being organized from their soil by Pakistani Taliban, who are hiding in Afghanistan. Pakistan made the request after a suicide bomber dispatched by the Tehrik-e-Taliban Pakistan (TTP) group blew himself up near a truck carrying police officers on their way to protect polio workers near Quetta, the capital of Baluchistan province. A police officer and three civilians were killed in Wednesday's attack. The Pakistani Taliban are a separate group but allied with the Afghan Taliban, who seized power in their country last year as the US and NATO troops were in the final stages of their pullout from Afghanistan. # US designates Pak, China, Myanmar and 9 others as 'countries of particular concern' for religious freedom violation

United States has designated 12 countries, including China, Pakistan and Myanmar, as "countries of particular concern' for the current status of religious freedom in these nations.

Announcing this on Friday, US Secretary of State Antony Blinken said around the governments and non-state actors harass, threaten, jail, and even kill individuals on account of their beliefs. In some instances, they stifle individuals' freedom of religion or belief to exploit opportunities for political gain. These actions sow division undermine economic security, and threaten political stability and peace. The US will not stand by in the face of these abuses. "Today, I am announcing designations

People's Republic of China, Cuba, Eritrea, Iran, Nicaragua, the DPRK, Pakistan, Russia, Saudi Arabia, Tajikistan, and Turkmenistan as Countries of Particular Concern under the International Religious Freedom Act of 1998 for having engaged in or tolerated particularly severe violations of religious freedom," he said. Simultaneously, Blinken also placed Algeria, the Central African Republic, Comoros and Vietnam on the Special Watch List for engaging in or tolerating severe violations of religious freedom.

The US also designated al-Shabab, Boko Haram, Hayat Tahrir al-Sham, the Houthis, ISIS-Greater Sahara, ISIS-West Africa, Jama'at Nusrat al-Islam wal-Muslimin, the Taliban, and the Wagner Group

"Our announcement these designations is in keeping with our values and interests to protect national security and to advance human rights around the globe. ## Strong quake shakes main Indonesia island, no major damage

JAKARTA, DEC 3 /--/A strong earthquake shook parts of Indonesia's main island of Java on Saturday, causing panic but only minor damage just two weeks after an equally powerful quake killed hundreds. The US Geological Survey said the magnitude 5.7 quake was centred about 18 kilometers (11 miles) southeast of Banjar, a city between West Java and Central Java provinces, at a depth of 112 kilometers (70 miles). One resident was injured in Selaawi village of West Java's Garut district, and at least four houses

Many in Garut are still haunted by the disaster that devastated Cianjur and set off landslides, the district chief, Rudi Gunawan, said in a television interview. "The earthquake has caused extremely panic among people amid monsoon downpour," he said, adding that his administration had alerted hospitals, health centers and ambulances to be ready to treat possible victims.

Apart from the one injured, by Saturday evening there were no other casualties reported from all 42 villages in Garut, one of the closest district to the epicenter, Gunawan said. Many houses suffered minor damage. Dwikorita Karnawati, head of Indonesia's Meteorology, Climatology, and Geophysical Agency, said there was no danger of a tsunami but warned of possible aftershocks. The agency put a preliminary magnitude at 6.4. Variations in early measurements are common. High-rises in Jakarta, the capital, swayed for more than 10 seconds and some ordered evacuations, sending streams of people into the streets. Even two-story homes shook in Central Java's cities of Kulon Progo, Bantul, Kebumen and Cilacap.

Earthquakes occur frequently across the sprawling archipelago nation, but it is uncommon for them to be felt in Jakarta. The country of more than 270 million people is frequently struck by earthquakes, volcanic eruptions and tsunamis because of its location on the arc of volcanoes and fault lines in the Pacific Basin known as the "Ring of Fire." In 2004, an extremely powerful Indian Ocean quake set off a tsunami that killed more than 230,000 people in a dozen countries, most of them in Indonesia's Aceh

## Up to 11 per cent of Covid cases that needed hospitalisations had lung scarring: US study

WASHINGTON, DEC 3 /--/Up to 11 per cent of Covid cases that needed hospitalisation had lung scarring which may be irreversible and could get worse over time, according to a study conducted in

the United States. The study, published in the American Journal of Respiratory and Critical Care Medicine, sought to determine the percentage of Covid-19 patients, with various degrees of severity, discharged from hospital who had a type of fibrotic lung damage, known as interstitial lung disease, that requires follow-up care. Interstitial lung disease refers to a broad group of diseases that are characterized by lung scarring, including idiopathic lung fibrosis. This scarring makes it difficult to breathe and get oxygen into the bloodstream. Lung damage caused by this may be irreversible and get worse over time. "We estimated that up to 11 per cent of hospitalised Covid patients had fibrotic patterning after recovery from the acute illness," said corresponding author Iain Stewart, an advanced research fellow (Rayne Foundation) at the Margaret Turner Warwick Centre for

Fibrosing Lung Disease, National

Heart and Lung Institute, Imperial

College, London. "Whilst many people experience prolonged breathlessness, the major implication of these findings is that a substantial number of people discharged from a Covid

may also have fibrotic abnormalities in their lungs. These results should help concentrate efforts to closely follow at-risk

patients. This follow-up should include repeat radiological imaging and lung function testing,"

said Stewart. For some people, these fibrotic patterns may be stable or get resolved. For others, they may lead to long-term lung fibrosis progression, worse quality of life and decreased life expectancy. Early detection of progression is essential to improve outcomes, he said. The study authors examined evidence of abnormal lung patterns on follow-up CT scans from Covid-19 patients discharged from the hospital which could be suggestive of interstitial lung disease. The characteristics of the 209 study participants who had CT scans were applied to a wider posthospitalization cohort of almost 3,500 people without a CT to stratify the risk of residual lung abnormalities. Interim study participants were discharged from the hospital by the end of March

> 2021. while interim data were collected until 2021, October restricting the analysis to 240 davs after discharge.

The Post-Hospitalisation Covid-19 Research Study (PHOSP-COVID) is a consortium of leading researchers and clinicians from across the UK working together to understand and improve long-term health outcomes for patients who have been in hospital with confirmed or suspected Covid-19. The primary outcome that the scientists sought to determine was the prevalence of residual lung abnormalities in Covid patients discharged from hospitals. Analyses were performed to determine participants' risk factors for residual lung abnormalities in those who did not

receive a CT scan. These risks were used to estimate prevalence in the overall population hospitalized by the end of March 2021. According to the authors, the study offered the largest assessment of the prevalence of residual lung abnormalities in hospitalized individuals to date and is consistent with findings from several smaller studies that demonstrate persistent radiological patterns and impaired gas transfer during the extended follow-up of patients with Covid-

At the time of this interim analysis, it is not possible to determine whether the observed residual lung abnormalities represent early interstitial lung disease with potential for progression, or whether they reflect pneumonitis that may be stable or resolve over time, the study said. Pneumonitis refers to inflammation in the lungs.

"The next phase of the study is a primary analysis, which will be performed at 12 months. At that time, we will also use linked electronic health records of hospital admissions and mortality data to support our analyses. We expect to have the final results in early 2023," it said. (PTI)

MIRPUR, DEC 3 /--/ A consistent Shikhar Dhawan and a supremely talented KL Rahul will battle it out for the opener's slot even as a top-heavy Indian batting line-up will aim for transformation and show more intent against a gutsy Bangladesh in the three-match ODI series, starting this Sunday. Throw a fabulously consistent young turk Shubman Gill (rested for this series) into the mix, and coach Rahul Dravid will struggle to fit in all the boxes of this jigsaw puzzle called Indian top-order. The focus for the next one year will primarily be on ODIs and just like the T20Is, India's approach in the 50-over format needs a sea change. Sometimes having a plethora of options isn't actually a good headache to have as it creates more confusion

among the rank and file of the team. When there are similar skill set options, the coach tries to give everyone equal opportunities but it results in not having a settled line-up and this is not an ideal situation when a marquee event is round the corner. Currently, the Indian white ball squad is now going through that particular phase. A few years back, Rohit Sharma and Shikhar Dhawan were automatic picks as India's preferred ODI opening pair with hardly any questions asked or their spots being debated. But Dhawan's slow approach in the Powerplay overs and the emergence of Gill as a potent 50-over opener is bound to throw up possibilities. KL Rahul, during the last phase of Ravi Shastri's coaching stint played a few games in the middle-order but he

loves to bat at the top and has had a fair amount of success too. Ironically, the numbers in the face of it will not give a clear indication as to who should be Rohit's opening partner for the series. In the 19 ODI innings that Dhawan has opened for India in 2022, he had a poor strike-rate of 75.11. While between 2016-18, it used to be 101 and between 2019-21, it dipped but was still a steady 91. Rahul, who has five hundred and 10 fifties in 45 ODIs with a healthy strike-rate 85 plus and an impressive average of 45, looks a better candidate. For the opening match though, in case the team management wants to give rest to a jetlagged Dhawan, who has flown all the way from Down Under to join the team in Mirpur, Rahul will certainly join Rohit at the top.
