HEALTH FACILITY REELING UNDER SHORTAGE OF NURSING STAFF

PORT BLAIR, JAN 12/--/ Even as the UT Administration boasts of improved health services in GB Pant Hospital, shortage of at least 50% Nursing staff is adversely affecting services and patients care, besides putting extra workload on the current staff. Staff shortage has emerged as a major concern for patients at the lone referral hospital of these islands. According to sources, 130 posts of Nurses are lying vacant at the Directorate of Health Services. Presently 150 nursing staff are engaged in the health department. Out of the 150 nursing staff providing their services in various health centres, including GB Pant Hospital, 63 nursing staff are from ANIIMS while 87 nurses are from

Directorate of Health Services. Extension of contract for nurses engaged on contractual basis has been stopped leading to the department facing a lot of difficulties in running health centres effectively, across the islands. One can easily imagine the situation in other important Units of the hospital. Expectations were high of improved services in the GB Pant Hospital after the establishment of the Medical College, but sadly drawbacks continue to plague the hospital. Acute shortage of Nursing and other staff is hampering the effective delivery of services to the patients. The top brass of the Health Department should address the matter on priority by filling up all vacant posts in a time bound manner.



Karnataka govt authorises CBI to attach excess properties of mining baron Janardhana Reddy

The Karnataka government on Thursday authorised the Bureau Central Investigation (CBI) to attach 'excess properties' belonging to former minister and mining baron G Janardhana Reddy, his wife and companies owned by him. The order came after the High Court of Karnataka granted the state government two days on January 10 to give information on the delay in granting permission to the CBI to attach Reddy's properties. The court had asked the state government why it had not given the goahead to attach the properties worth Rs 19 crore it had earlier sanctioned the attachment

of Rs 64 crore assets. The government order on Thursday referred to the request made by the superintendent of police of the CBI to issue authorisation to the Pairavi officer/Holding Investigation Officer' to file an application before the special court for CBI cases in Bengaluru for attachment of scheduled excess properties' of Reddy. "The Pairavi officer/holding investigation officer is hereby authorised to file an application before the special court for CBI cases, Bengaluru city for the attachment of scheduled excess properties of G Janardhana Reddy in his name as well as in the name of his wife and his

companies and also other properties as shown in the schedule of properties as shown in the schedule of the properties that is submitted along with the letter dated August 30, 2022," the order said. The CBI had sought direction from the court to the government to approve attachment proceedings against the main accused in the Ballari illegal mining case. The request of the CBI has been pending before the government since August 2022. The CBI had traced additional properties in the name of Reddy, his wife, and the company in Telangana and Andhra Pradesh. The agency seeks to attach those properties in the illegal mining case pending before a special

court since 2013. The Central agency claimed Reddy was trying to sell the properties he had obtained from the money from illegal mining activities through his companies Obulapuram Mining Company and Associated Mining Company Ltd. On December 25 last year. Reddy had announced the launch of a Paksha'. An accused in the illegal mining case, he has severed his two-decades-old association with the BJP. GOPESHWAR, JAN 12 /--/ The crisis in Joshimath has brought into focus the issue of land subsidence which has for years been threatening several places of Uttarakhand, including the pilgrim town of Karnaprayag and Landour.

Around 80 km from

Joshimath, at least 50 houses at Bahuguna Nagar in Karnaprayag have been developing cracks since 2015. Locals hold gradual land subsidence responsible for the fissures and attribute it to the widening of the national highway, violation of norms in construction works related to mandi parishad, erosion caused by the Pindar river unsystematic flushing out of rainwater. Debris brought down by a landslide from above Bahuguna Nagar first inflicted damage to houses in 2015, former chairman of Karnaprayag municipal council Subhash Gairola said. The municipal council intervened immediately and the damage was restricted. It, however, started aggravating with the widening of the national highway in recent years and the unsystematic flushing out of rainwater in absence

Asked about the houses in Karnaprayag developing crack, chief minister Pushkar Singh Dhami, who is in Joshimath, said: "It has been there for some time. But it will be discussed in

Parts of Chamoli district headquarters in Gopeshwar and Semi village near Guptkashi on the Kedarnath national highway face a similar situation, Gairola said, and demanded immediate assistance for the affected people as well as developing long-term plans to ensure the safety of locals.

Chamoli district magistrate Himanshu Khurana said: "Families living in at-risk houses in Karnaprayag have been shifted to safety. We are taking the help of experts from IIT-Roorkee to solve Karnaprayag. They are studying the problem and preparing a detailed project report based on which remedial measures will be taken." Land subsidence has also been reported from Landour in Mussoorie and Atali village Rishikesh.

A 100-metre stretch of the road from Landour Chowk to Kohinoor building in Mussoorie has been sinking slowly for the past years. representatives from the area said and attributed it to heavy construction activities in the hill town and a poor drainage system which causes waterlogging. Mussoorie SDM Shailendra Singh Negi, who recently visited Landour to inspect the cracks, said land subsidence in the area is currently minor in nature. But in the larger public interest, the factors that have led to the situation are being studied so that corrective steps could be taken, he said.

In Atali village near Rishikesh, fissures have developed in the ground. Villagers claim that a railway tunnel being built in the area has caused the crack with Neighbouring Singtali, Lodsi, Kaudiyala and Bavani villages also affected. SDM Devendra Negi said a team of experts has been constituted which will do an on-the-spot inspection of the affected villages on January 15.

Ludhiana can compete with China if small, medium businesses get support: Rahul

Centre cracks down on 6 YouTube channels for 'spreading fake news'

NEW DELHI, JAN 12 /--/ The Union government has cracked down on six YouTube channels that were found to be spreading fake news to its nearly 20 lakh subscribers, an official statement said on Thursday.

The Fact Check Unit of the Press Information Bureau (PIB) of the ministry of information & broadcasting said these six channels were working in a coordinated manner and spreading false information and their videos had over 51 crore views. The YouTube channels were found to be spreading fake news about the elections, proceedings in the Supreme Court and Parliament, and the functioning of the government, the statement said. The channels are -Nation TV with over 5.57 lakh subscribers, Samvaad TV with 10.9 lakh subscribers, Sarokar Bharat (21,100), Nation24 (25,400), Swarnim Bharat (6,070) and Samvaad Samachaar (3.48

lakh), the statement said. A senior official said that the channels Samvaad Samachar, Samvaad TV and Nation TV changed their names to Inside India, Inside Bharat and Nation Weekly respectively, after being "busted" by the Fact Check Unit of PIB. The videos on the channels in question included false claims regarding ban on electronic voting machines, and false statements attributed to senior constitutional functionaries

including the President and the Chief Justice of India. "The channels are part of a fake news economy that thrives on monetization of fake news," the statement

It said that the channels use fake, clickbait and sensational thumbnails and images of television news anchors of TV channels to mislead the viewers to believe that the news was authentic and drive traffic to their channels to monetize the videos published by them. This is the second such action by the Fact Check Unit of the PIB. Last month, the unit had exposed three channels peddling fake news and written to YouTube to take them down. (PTi)





Uphaar fire tragedy: HC declines to stay web series 'Trial by Fire', to be released today

NEW DELHI, JAN 12 /--/ The Delhi High Court Thursday declined a plea by Sushil Ansal, convicted in the 1997 Uphaar cinema fire case, to stay

the release of web series 'Trial by Fire' said to be based on the incident and scheduled for release on Netflix on January 13.

Justice Yashwant Varma denied the interim relief to Ansal and said a detailed order will be uploaded on the court's website later. A massive fire had broken

out at the Uphaar cinema during the screening of the Hindi film 'Border' on June 13, 1997, claiming 59 lives. Ansal, who alleged defamation, had urged the court to grant an injunction against the release of the web series, saving even its teaser got 1.5 million views in four days which shows the immediate impact it has. The lawsuit by the 83year-old Ansal also sought to restrain the circulation and publication of a book titled 'Trial by Fire- The tragic tale of the Uphaar Tragedy' which was launched in 2016. Ansal claimed the web series directly attacks his personality. Ansal's plea was



vehemently opposed by the counsel for the producers of the web series, Netflix and authors of the book --Neelam and Shekhar Krishnamoorthy -- who lost their two

children in the fire tragedy. In his plea, Ansal said he has been "punished both legally and socially" and the release of the series, based on

the book written by a couple who lost their two children to the fire, will cause irreparable harm to his reputation and breach his right to

privacy. "The events are causing and will cause loss of reputation of the plaintiff, public trial, humiliation, stigmatisation and irreparable injury along with causing grave prejudice to the revision petitions pending before this court arising out of the (evidence) tampering case," the suit said. In 2017, the Supreme Court had finally decided the Uphaar cinema blaze case and directed the now 83-year-old

Sushil Ansal and his brother Gopal Ansal (74) to pay a fine of Rs 30 crore each. The apex court had then released Sushil Ansal taking into account the period he had already spent in jail. The Ansal brothers and two others were later held guilty of tampering with the evidence related to the trial. (PTI)

Spl focus on NE under PM Modi's leadership

The Government has accorded a cardinal priority to the development of North East, if the massive jump in budgetary allocations and Prime Minister Narendra Modi's visit to the region more than 50 times in the last 8 years are any indication. The North East was previously known for unrest bandhs and insurgency, but in the last eight years, peace has been established under the leadership of PM Modi. There has been a 74% reduction in insurgency incidents, 60% drop in incidents of attacks on security forces and 89% fall in civilian deaths. About 8,000 misguided youth have surrendered and joined the mainstream, selecting a better future for themselves and their families. Agreements were concluded with the National Liberation Front of Tripura in 2019, The Bru and Bodo in 2020, while the Karbi Agreement was inked in 2021. Besides, the Assam-Meghalaya and Assam-Arunachal border disputes have almost ended, and with the restoration of peace, the north-east region has moved on the path of development. Since 2014, a massive increase in the budgetary allocations to the region has been witnessed. Since 2014, more than 4 lakh crores under 10% Gross Budgetary Support (GBS) have been allocated for the region.

At its recent meeting chaired by the prime minister, the Union Cabinet approved schemes of Ministry Of Development Of North Eastern Region, with an outlay of Rs 12,882.2 crore, for the balance period of the 15th Finance Commission (2022-23 to 2025-26). The actual expenditure in last four years under MDoNER schemes was Rs 7,534.46 crore, whereas the fund available for expenditure in next four years till 2025-26 is Rs 19,482.20 crore (2.60 times more approximately). Massive efforts have been undertaken for infrastructure development in the region and improving connectivity has been the prime focus. For improving Railway connectivity, Rs. 51,019 crore have been spent since 2014. As many as 19 new projects worth Rs. 77,930 crore have been sanctioned. For railways, in comparison to average annual budget allocation of Rs. 2,122 crore during 2009-14, in the past 8 years, there has been a 370% increase in average annual budget allocation totalling Rs. 9,970 crore. For improving road connectivity, 375 projects worth Rs. 1.05 lakh crore are under way. In the next three years, the government 9,476 km roads will be laid under 209 projects. For this the central government is spending Rs. 1,06,004 crore. Air connectivity has also improved massively. In 68 years north east had only nine airports, but it jumped to 17 in a short span of eight years. Air traffic movement in north east has increased 113% since 2014 (weekly basis). To give a boost to air connectivity, Rs. 2,000 crore will be invested in civil aviation in North East region. For improving telecom connectivity, from 2014, Rs.3,466 crore have been spent under 10% GBS. Cabinet has also approved 4G connectivity in 4,525 villages in NE region. The Central government has set a target of 500 days to provide complete telecom connectivity in the region by end of 2023. Waterways are integral to life and culture of North East. The government is undertaking all efforts to develop this important sector in the NE region. Before 2014 there was only 1 national waterway in NE region. Now 20 waterways are declared as national waterways in the region. Recently around Rs. 600 crore have been sanctioned for the development of national waterway 2 and national waterway 16. Improving health infrstructure has remained a key focus over the last eight years. The Government has spent Rs. 31,793.86 crore since 2014-15 in the health sector.

Centre is making use of LG to get control of MCD

Gold appears to be in its march towards a historical high

2023 may well be a year of gold. This is because despite several negatives the vellow metal has outperformed everything else. And with the New Year expected to unravel all that traditionally has worked in favour of gold, this asset class appears to be nonstoppable right now.

IMF has warned that a third of the global economy is likely to fall into recession this year. Eurozone and Britain have already shown signs of such a crisis. And this is very much the likely scenario in the United States. Stock markets have already seen a blood bath and further falls are indicated in the days to come. Central banks persisting with their tightening plans and more uncertainties are staring at the world as it descends deeper into recession. These are conditions that gold feasts on.

There were a series of negatives for gold, specifically, in 2022. Fed raised rates at the second most aggressive pace last year; the US dollar index surged 30 percent in 17 months. Most significantly, the rise in the US dollar and real interest rates was much greater than that recorded for 2013 and even larger than in 2008, the year when global financial crisis struck hard. But last year gold declined only 19 percent compared to 30 percent and 34 percent in 2008 and 2013 respectively. Gold enthusiasts revel at the performance of gold despite strong bearish

fundamentals and aver that the yellow metal is only roughly 10 percent away from its historical high despite heavy headwinds of the past nine months and nothing seems to be capable of stopping it from breaking out to a new all-time high. That would be the most remarkable breakout in half a century's time.

The World Gold Council notes in its outlook for 2023 that the global economy is at an inflection point after being hit by various shocks over the past year and going forward, this interplay between inflation and centralbank intervention will be key in determining the outlook for gold's performance

The council cites economic consensus that calls for weaker global growth akin to a short, possibly localisedrecession; falling-yetelevated - inflation; and the end of rate hikes in most developed markets. The environment carries both headwinds and tailwinds for gold. It notes that a mild recession, coupled with weaker earnings, has historically been goldpositive while further weakening of the dollar as inflation recedes could also provide support for gold. Additionally, geopolitical flare-ups should continue to make gold a valuable tail risk hedge. Also, a likely improvement in Chinese economic growth should boost consumer gold demand.

Elaborating on the bumpy economic ride ahead, the council warns about many signs of weakening output due to the speed and aggressiveness of hiking moves by central banks, with consensus forecasts putting global GDP to rise by just 2.1 percent this year. Excluding the global financial crisis and Covid, this would mark the slowest pace of global growth in four decades and meet the IMF's previous definition of a global recession - i.e. growth below 2.5 percent. The council lists four key factors which will have a bearing on gold's performance, at least two of which are positive for the metal. These include economic expansion, which is positive form the point of view of consumption and risk and uncertainty, both of which are positive for investment in gold. The other factors are opportunity cost, which is negative for investment and momentum, which is contingent on price and positioning. It has been found that gold typically does well during times of recession.

Delivering positive returns during five of the seven recessions in the past. A sharp retrenchment in growth is sufficient for gold to do well, particularly if inflation is also high or rising. A dollar peak has historically been good for gold, yielding positive gold returns 80 percent of the time.

The council's latest Gold Demand Trends report reveals that gold demand in the third quarter of 2022 hit 1,181 tonnes, up 28 percent year-on-year. Strong demand pushed the year-to-date total to its pre-Covid levels. Gold demand was bolstered by consumers and central banks, although there was a notable contraction in investment demand.

Jewellery consumption continued to rebound and is now back to prepandemic levels, reaching 523 tonnes, 10 percent higher compared to the third quarter of 2021. Much of this growth was spearheaded by India's urban consumers who drove up demand 17 percent to 146 tonnes. Similarly impressive growth was also seen in much of the Middle East, with Saudi Arabian jewellery consumption up 20 percent since the third quarter of 2021, and United Arab Emirates up 30 percent for the same period. Chinese jewellery demand also saw a modest 5 percent increase, driven by improved consumer confidence and a dip in the local gold price, prompting the release of some pent-up demand. (IPA)

So, especially, youth should be alert," he said.

Bird flu outbreak in state-run poultry farm in Kerala, 1800 birds dead

KOZHIKODE, JAN 12 /--/ A bird flu outbreak has been reported in a state-run poultry farm in Kozhikode district of Kerala as around 1,800 chickens have died of the infection, official sources said. The presence of H5N1 variant, which has an additional proliferative capacity, was confirmed among the poultry in the local farm managed by



the district panchayat here on Wednesday, the sources said. J Chinchu Rani, kerala minister for animal husbandry, gave instructions to take urgent preventive measures as per the Centre's guidelines and protocol in this regard, they said.

As initial tests indicated the outbreak of bird flu, the samples were sent to the high security lab in Bhopal (Madhya Pradesh) for accurate diagnosis which confirmed the avian influenza, a government statement said. There were over 5,000 chickens in the farm and of them 1,800 died so far due to the infection. The culling and other further procedures would be done with the coordination of various government departments under the aegis of the district authorities, it added. (PTI)

The Assembly poll is three years away, there is Lok Sabha polls in 2024 and the party and the people will decide what to do, he said.

"As a political representative, we have to be ready for everything," the Lok Sabha member explained. Boy breaks security cordon at PM roadshow, being questioned

HUBBALLI, JAN 12 /--/ A young boy, not even in his teens, who cut through the security cordon and tried to hand over a garland to Prime Minister Modi during a roadshow here on Thursday, was taken away from the scene and is being questioned by the local police. According to police officials and grabs from the live video streaming of the event, the boy, who was seen rushing towards Prime Minister Modi's motorcade with a garland in hand, managed to reach very close to Prime Minister Modi. The Prime Minister extended his hand to accept the garland from above the car door but could not reach the boy. The Special Protection Group (SPG) personnel got hold of the garland before local police secured the boy and removed him from the scene. SPG passed on the boy's garland to the Prime Minister who then put it inside his vehicle. The incident happened during a road show by the Prime Minister as he was reaching the venue for inaugurating the 26th National Youth Festival here. PM Modi was standing on the 'running board' of his moving car and waving at an enthusiastic crowd that lined up the route in large numbers as he headed to Railway Sports Ground from the airport, when the incident occurred. Senior police officials told PTI that the boy who was whisked away from the spot was being questioned. Hubballi-Dharwad Commissioner Raman Gupta said the incident cannot be called a security breach as everyone (allowed to wave at the PM and greet him from both sides of the road) had been frisked and checked. "We cannot call it a security breach because we had frisked and checked everybody who stood on both sides of the road. Even the garlands were thoroughly inspected," Raman Gupta told PTI. Gupta added that over 3,000 policemen were deployed as part of the security arrangements and the entire road was barricaded.

Joshimath: Market rate of compensation will be decided keeping stakeholders' ineterst in mind, says Uttarakhand CM

Demolition of 2 'unsafe' hotels begins -

DEHRADUN, JAN 12 /--/ Uttarakhand chief minister Pushkar Singh Dhami on Thursday said a committee would decide the market rate for compensation to be paid to the families affected in Joshimath by keeping in mind the interests of stakeholders. A 19-member committee headed by Chamoli district magistrate Himanshu Khurana was set up on Wednesday to distribute an interim assistance of Rs 1.50 lakh among each affected family and decide the rate at which compensation is to be paid. "People will get the best compensation possible. The state government will do all it can to properly rehabilitate them. Protecting their life and property is our top priority," Dhami said at a meeting with the committee. On the Rs 1.50 lakh being paid immediately to each affected

already been released, the chief minister said: "It is only an interim relief. Details of the final compensation and rehabilitation are being worked out." Dhami said a wrong impression was being created about Joshimath that could hit the livelihoods of the local people. "The winter games in Auli are beginning in February and the Char Dham Yatra in a few months. Sending a message outside Joshimath that the entire town is sinking is wrong. It will adversely impact the local economy," the CM said. He also said only 20-25 per cent houses in Joshimath were affected by land subsidence and not the whole town -- an impression being wrongly created by some. "The disaster has hit 600-700 houses, which is only 20-25 per cent of the town's entire area. But an atmosphere is built around Joshimath that the whole town is family for which Rs 45 crore has sinking, which is not true," the

chief minister added. According to him, creating an impression like this could harm the local people's livelihoods, which are based on tourism and pilgrimage. Dhami said the interim assistance would reach the bank accounts of the families affected by this evening or Friday. He also called for a collective effort to strengthen the morale of people to overcome this phase. The chief minister also held a meeting with Indo-Tibetan Border Police and National Disaster Response Force personnel deployed on the ground and scientists from different organisations studying the land subsidence problem in Joshimath. Dhami began his day in Joshimath by offering prayers at the Narsingh temple. "I performed a puja at the Narsingh temple this (Thursday) morning and prayed to the lord, seeking His blessings for the safety and

security of this town and its residents," Dhami, who has been in Joshimath since Wednesday, said. Several meetings are lined up for the day in which all matters related to Joshimath will be discussed, he added. When told of reports about cracks appearing in houses in Karnaprayag, he said these had been there for some time but still they would also be discussed. Meanwhile, the process of demolishing two "unsafe" hotels in subsidence-hit Joshimath began on Thursday evening with an agreement between administration and the property owners who had stalled the exercise for the last two days demanding compensation. Hotels Malari Inn and Mount View had developed cracks and were precariously leaning towards each other posing a threat to the settlements around them, officials said. The exercise has begun under

the technical supervision of Roorkee-based Central Building Research Institute with Hotel Malari Inn, disaster secretary Ranjit Sinha told reporters here. The demolition of the hotels was scheduled to be undertaken on Tuesday and all preparations had been done. However, the process could not start as their owners staged a dharna demanding compensation along the lines of what was offered to those displaced by the Badrinath renovation masterplan. "First, the iron sheets shading the hotel's roof will be removed. JCBs will also be used wherever needed. But everything will be done under the technical supervision of CBRI," an official engaged in the operation said. "It will be dismantled in such a manner that no harm is caused to the structures nearby," he said, adding that the process will take time. (PTI)

I-T dept recovers Rs 11 cr after raids at state 'beedi' firms linked to politician

Extraordinary attack on judiciary: Cong on Vice-Prez's Kesavananda Bharati case verdict remarks

NEW DELHI, JAN 12 /--/ The Congress on Thursday described Rajya Sabha Chairman Jagdeep Dhankhar's remarks questioning the landmark 1973 Kesavananda Bharati case verdict as an "extraordinary attack on the judiciary", and said that a "no-holds-barred assault" on one constitutional institution by another

was quite unprecedented. Vice-President Dhankhar had on Wednesday criticised the scrapping of the NJAC Act in 2015 and also questioned the Kesavananda Bharati case verdict, saying it set a wrong precedent and that he disagrees with the Supreme Court ruling that Parliament can amend the Constitution but not its basic structure. "In my 18 years as an MP, I've never heard anyone criticise the 1973 Kesavananda Bharati judgment of the Supreme Court," Congress general secretary in-charge Jairam Ramesh said in a tweet. "In fact, legal luminaries of BJP like Arun Jaitley hailed it as a milestone. Now, the Chairman of Rajya Sabha says it was wrong. Extraordinary attack on the judiciary!" he tweeted. It also bears mention that a "no-holds-barred assault" on one Constitutional institution by another is quite unprecedented, Ramesh said in another tweet.

"Having different views is one

thing, but the Vice President has taken the confrontation with the Supreme Court to an altogether different level!" he said. Earlier, senior Congress leader P Chidambaram said Dhankhar is "wrong" in stating that Parliament is supreme and his views should warn every Constitution-loving citizen to be alert to the dangers ahead. Reacting Dhankhar's remarks,

Chidambaram, a lawyer, said on Twitter, "The Hon'ble Chairman of the Rajya Sabha is wrong when he says that Parliament is supreme. It is the Constitution that is supreme." The "basic structure" doctrine was evolved to prevent a majoritarian-driven assault on the foundational principles of the Constitution, the former Union minister said. "Suppose Parliament, by a majority, voted to convert the parliamentary system into a

Presidential system. Or repeal the State List in Schedule VII and take away the exclusive legislative powers of the States. Would such amendments be valid," former Union minister said in a series of tweets.

After the NJAC Act was struck down, nothing prevented the government from introducing a new Bill, the senior Congress leader said. "The striking down of one Act does not mean that the 'basic structure' doctrine is wrong," he added. "In fact, the Hon'ble Chairman's views should warn every Constitution-loving citizen to be alert to the dangers ahead," Chidambaram said. At a press conference here, Congress' media department head Pawan Khera also hit out at Dhankhar's remarks. "With due respect to the office of the vice president and the gentlemen who occupy that office, I think he needs to go back to his textbooks. The Constitution of India is supreme, not the legislature. The Constitution is bigger than all of us. That is the supreme guiding principle we need to follow and we follow," he said. (PTI)



NEW DELHI, JAN 12 /--/ Army Chief Gen Manoj Pande on Thursday chose not to respond to recent comments by his predecessor Gen MM Naravane that framing a national security strategy was a prerequisite to take forward the ambitious theaterisation plan. Gen Pande said an integrated and tri-services response to meet future security challenges is an "imperative" and that there was a need to get "right joint tri-services structures in place". "It is not fair for me to comment (on Gen Naravane's remarks). But I think in the future, integrated and triservices response to meet future security challenges is an imperative and towards this, I think, we need to get right joint triservices structures in place," Gen Pande said at a press conference. He was asked to comment on the former Army Chief's remarks. "Just to elaborate, we are looking at theatre command as a single entity looking after all security aspects and issues in a geographical area under one general commander. So I leave it here just highlighting the importance of theatrisation but stop short of commenting on what my predecessor's views were," Gen Pande said. The Army Chief said the process of

And that end has to be specified first in the form of a national defence strategy. That defence strategy, in turn, has to flow out of a national security strategy." "Unless there is a national security strategy in place, to just keep talking about theaterisation is actually putting the cart before the horse," he said. Gen Naravane was the Chief of Army Staff from December 31, 2019 to April 30, 2022. According to the theaterisation plan, each of the theatre commands will have units of the Army, the Navy and the Air Force and all of them will work as a single entity looking after security challenges in a specified geographical territory under an operational commander. At present, the Army, Navy and the Air Force have separate commands. Initially, a plan was firmed up for the creation of an Air Defence Command and Maritime Theatre Command. (PTI)

UAE names oil company chief to lead UN climate talks COP28

United Arab Emirates (UAE) on Thursday named a veteran technocrat who both leads Abu Dhabi's staterun oil company and its renewable energy efforts to be the president of the upcoming United Nations climate negotiations in Dubai, highlighting the balancing act ahead for this crudeproducing nation.

Authorities nominated Sultan al-Jaber, a trusted confidant of UAE leader Sheikh Mohammed bin Zayed Al Nahyan, who serves as CEO of the Abu Dhabi National Oil Co. That firm pumps some 4 million barrels of crude a day and hopes to expand to 5 million daily. Those revenues fuel the ambitions of this federation of seven sheikhdoms on the Arabian Peninsula as well as the production of more of the heat-trapping carbon dioxide that the UN negotiations hope to limit. But al-Jaber also once led a

neutral" city on Abu Dhabi's outskirts an effort later pared back after the global financial crisis that struck Emirates beginning in 2008. Even today, he serves as the chairman of Masdar, a clean energy company that grew out of the project.

"Sultan al-Jaber has the credentials and background to lean into trends that are already on going," said Ryan Bohl, a Mideast analyst for a risk-intelligence firm called the RANE Network. "Him being an oilman, I don't think that will be that big of a risk for him." The Emirates' state-run WAM quoted al-Jaber, a climate envoy for years, as saying that it "will be a critical year in a critical decade for climate action." He called for "a pragmatic, realistic and solutions-oriented approach" to limit global warming to just 1.5 degrees Celsius (2.7 degrees Fahrenheit) by 2050. Scientists say that limit can future climate change harms. Al-Jaber's nomination, however, drew immediate criticism. Harjeet Singh, who is the head of Global Political Strategy at Climate Action Network International, said al-Jaber holding the CEO title at the state oil company posed "an unprecedented and alarming conflict of interest." "There can be no place for polluters at a climate conference, least of all presiding over a COP," Singh said. Alice Harrison of Global Witness put it even more bluntly: "You wouldn't invite arms dealers to lead peace talks. So why let oil executives lead climate talks?" Greenpeace said it was "deeply alarmed" by al-Jaber's appointment, adding: "This sets a dangerous precedent, risking the credibility of the UAE and the trust that has been placed in them." UAE to rollover USD 2bn loan, give additional USD 1bn: Pak PM Office

ISLAMABAD, JAN 12 /--/ The United Arab Emirates (UAE) on Thursday agreed to extend an existing loan of USD 2 billion and provide an additional loan of USD 1 billion to help cash-strapped Pakistan tackle its economic woes, including the fast depleting foreign exchange reserves.

Prime Minister Shehbaz Sharif's Office made the announcement after his meeting with UAE President Sheikh Mohammed bin Zayed Al Nahyan in Abu Dhabi. "The President of the UAE agreed to roll over the existing loan of USD 2 billion and provide USD 1 billion additional loan," the statement said. It said the two leaders discussed bilateral relations and explored ways to further strengthen these ties, especially in the fields of trade, investment and energy. They also had an exchange of views on regional and international issues of mutual interest. "Both sides agreed to deepen the investment cooperation, stimulate partnerships and enable investment integration opportunities between the two countries." it said. Russian forces press deadly assault for breakthrough in east

KYIV, JAN 12 /--/ Russia said Thursday that its forces are edging closer to capturing a salt-mining town in eastern Ukraine, which would mark an elusive victory for the Kremlin but come at the cost of heavy Russian casualties and extensive destruction of the territory they claim.

Ukraine's Donetsk Gov Pavlo Kyrylenko said in televised remarks that more than 100 Russian troops have been killed in the battle for Soledar over the past 24 hours. "The Russians have literally marched on the bodies of their own soldiers, burning everything on their way," Kyrylenko said while reporting that Russian forces had shelled a dozen towns and villages in the region in the past day. Russian forces are using mortars and rockets to bombard Soledar in an unrelenting assault, battling for a breakthrough after military setbacks have turned what the Kremlin hoped would be a fast victory into a grinding war of attrition that has dragged on for nearly 11 months with no end in sight. "Civilians are trying to survive amid that bloodbath as the Russians are pressing their attacks," Kyrylenko said. Soledar's fall would be a prize for a Kremlin starved of good battlefield news in recent months, after losing the significant city of Kherson in December, It would also offer Russian troops a springboard to conquer other areas of the eastern Donetsk province that remain under Ukrainian control, Bakhmut. Suspect in Abe assassination to face murder charge, says his lawyer

TOKYO, JAN 12 /--/ Japanese prosecutors are expected to formally charge the suspect in the assassination of former Prime Minister Shinzo Abe with murder on Friday, his lawyer said. Tetsuya Yamagami was arrested immediately after allegedly shooting Abe with a handmade gun as the former leader was making a campaign speech in July outside a train station in Nara in western Japan. Later that month, Yamagami was sent to an Osaka detention centre and given a five-month mental evaluation, which ended on Tuesday. Yamagami is now back in police custody in Nara after reportedly being deemed fit to stand trial. One of his lawyers, Masaaki Furukawa, told The Associated Press on Thursday that he expects prosecutors to charge Yamagami with murder and gun control law violations. Given the complexity of the case, it will take months before his trial begins, he said. Furukawa said he and two other lawyers took turns visiting Yamagami at the detention centre every 10-12 days, in between his examination by psychiatric experts. His visitors were limited to his lawyers and sister, he said. Furukawa said Yamagami was in good health at the detention centre. He said he could not disclose the details of their conversations before seeing what evidence prosecutors submit to the court in their indictment. Police say Yamagami told them that he killed Abe, one of Japan's most influential and divisive politicians, because of Abe's apparent links to a religious group that he hated. In his statements and in social media postings attributed to him, Yamagami said he developed a grudge because his mother had made massive donations to the Unification Church which bankrupted his family and ruined his life.

"It's an extremely serious case, but someone has to defend him," Furukawa said. "Naturally, he will have to take criminal responsibility for the serious consequences he caused by allegedly firing his gun to take away the life of a politician, and we are tasked with doing our best to reduce his punishment," he added. Some Japanese have expressed sympathy for Yamagami, especially those who also suffered as children of followers of the South Korea-based Unification Church, which is known for pressuring adherents into making big donations and is considered a cult in Japan.

Thousands of people have signed a petition requesting leniency for Yamagami, and others have sent care packages to his relatives or the detention centre. The investigation into the case has led to revelations of years of cozy ties between Abe's governing Liberal Democratic Party and the church since Abe's grandfather, former Prime Minister Nobusuke Kishi, helped the church take root in Japan in the 1960s over shared interests in conservative and anticommunist causes. Current Prime Minister Fumio Kishida's popularity has plunged over his handling of the church controversy and for insisting on holding a rare, controversial state funeral for Abe. (AP)

Royals appear for 1st time after publication of Harry's book

LONDON, JAN 12 /--/ Members of the royal family

appeared in public on Thursday for the first time since the publication of Prince Harry's explosive memoir, touring charities and a hospital as they got on with the task of being working royals. King Charles III travelled to Scotland to meet with local groups that help combat rural isolation, while the Prince and Princess of Wales seemed relaxed as they arrived to formally open Royal Liverpool University Hospital in the home city of The Beatles. The book, "Spare", offers myriad revelations and accusations, many of which have been splashed across the global media for days. In the ghostwritten memoir Harry, 38, recounts his grief at the death of his mother, Princess Diana, a fight with brother Prince William and his unease with the role of royal "spare' in the shadow of his elder sibling, who is heir to the British throne. In a series of interviews, Harry repeatedly blamed the media for his troubles, saying that unfair and intrusive coverage contributed to the rift with William. He also accuses members of the royal family of leaking stories to the media to burnish their own reputations. People are snapping the memoir up. Penguin Random House announced Wednesday that first day sales topped 1.4 million copies. By contrast, Michelle Obama's blockbuster, "Becoming" needed a week to reach 1.4 million when it was released in 2018. The sales figures for "Spare" include hardcover, audiobook and e-book editions sold in the US, Canada and the United Kingdom. (AP)

Pak media regulatory body cracks down on cable operators airing Indian content

LAHORE, JAN 12 /--/ Pakistan's electronic media watchdog on Thursday launched a crackdown on cable operators airing Indian content on TV channels in the

The Pakistan Electronic Media Regulatory Authority (PEMRA) field staff conducted raids at four cable operators "for airing illegal Indian channels as well as Indian content," the

watchdog said in a statement. It identified the cable operators M/ s Sharjah Cable Network, M/s Karachi Cable Services, M/s New Satellite Communication and M/ s Star Digital Cable Network in Karachi. During the raid, the regulatory body seized illegal equipment and issued show cause notices to the violators, the statement said. The PEMRA has launched an operation in the

country on reports of deliberate TV networks and any operator violations of the Supreme Court found defying the orders order by the cable operators, it said.

It warned all cable TV operators of the country to "immediately stop" airing Indian channels/content which are otherwise illegal or proscribed by the authority. "No channel other than PEMRA licensee would be allowed for distribution on cable

henceforth would be dealt strictly in accordance with PEMRA laws,"

In 2016, PEMRA imposed a complete ban on airing Indian content on local television and FM radio channels. However, the Lahore High Court lifted the ban in 2017, declaring it null and void as the Pakistan government had

In 2018, Pakistan's Supreme Court reinstated a ban on airing Indian content on TV channels in the country, overturning the Lahore High Court's order. The decision was largely seen as a tit-for-tat move after similar actions were taken by some channels and the entertainment industry in India against Pakistani content and

Rahul seals chase after Kuldeep spins through Sri Lanka

India won the ODI series with a game to spare at Eden Gardens

KOLKATA, JAN 12/--/ KL Rahul showed some glimpses of form with a gutsv halfcentury as he anchored India to a hardearned four-wicket victory over Sri Lanka in the second ODI on Thursday. Rahul scored an unbeaten 64 off 103 balls on a difficult track as India chased down a modest target of 216 in 43.2 overs. The second highest score for India was vicecaptain Hardik Pandya's 36. Earlier, Sri Lanka were all out for 215 in 39.4 overs with debutant Nuwanido Fernando scoring 50. Mohammed Siraj (3/30) and Kuldeep Yadav (3/51) were the most successful bowlers for the hosts.

Team India, led by Rohit Sharma, will be aiming to win the ODI series vs Sri Lanka when they take them on in the 2nd match at Eden Gardens in Kolkata. India won the 1st ODI by 67 runs at the ACA Stadium in Guwahati on Tuesday. Team India will take heart from the fact that their captain Rohit Sharma is back in form. He smashed 83 off 67 balls that included 9 fours and 3 sixes respectively. His opening partner Shubman Gill scored 70 off 60 balls that included 11 fours. But India's highest run-scorer was Virat Kohli, who smashed 113 off 87 deliveries that included 12 fours and 1 six respectively. Thanks to Kohli and Rohit's brilliant knock, India posted 373 for 7 in 50 overs. Sri Lanka had to struggle hard in the big chase and in the end fell short by 67 runs. They came so close only because Sri Lankan captain Dasun Shanaka's unbeaten 108 off 88 balls that included 12 fours an 3 sixes respectively. Pathum Nissanka smashed 72 off 80 balls that included 11 fours. But apart from these two, no one really stepped up and hence, Sri Lanka ended up on the losing side. Sri Lanka will aim to bounce back and draw level in the series to ensure the series is alive. Sri Lanka began solidly, debutant Nuwanidu Fernando fighting his way to a fifty as he and No. 3 Kusal Mendis put on 73 for the second wicket. At 102 for 1 in the 17th over, they were placed nicely. Was 300 on the cards? With the likes of Charith Asalanka and Dasun Shanaka to come, you wouldn't have bet against it. But the collapse was spectacular. Mendis was trapped lbw by Kuldeep Yadav, and that wicket triggered a slide that cost Sri Lanka six wickets for 50 runs. The strange thing about all of this is that the pitch was pretty flat, and India's bowlers were merely disciplined - though the fielding was superb. Only three batters

in Sri Lanka's line-up failed to get to double figures, and one of them was the No. 11. And yet they were all out for 215 in the 40th over. Only Nuwanidu got to a half-century. India's quicks bowled well again - Mohammed Siraj picking up three wickets and Umran Malik two, with some Sri Lanka batters clearly wary of the latter's pace. But it was Kuldeep Yadav who inflicted the most damage through that innings-defining collapse, picking up Asalanka and Shanaka (for 15 and 2) as well as Mendis, returning figures of 3 for 51 from his 10. Axar Patel was the other bowler to pick up a wicket.

The innings' nosedive was forged more of Sri Lanka's incompetence in this format than India's particular excellence. Mendis had batted nicely for his run-a-ball 34, but got hit on the back leg by a Kuldeep googly at the end of the 17th over, having misread the modest turn. Dhananjaya de Silva let an Axar arm ball slide between bat and pad; Asalanka sent a leading edge back to Kuldeep, the bowler; Shanaka got too far inside the line and let Kuldeep spin one into his pads and then leg stump; later, the bowling allrounders (Wanindu Hasaranga, Dunith Wellalage and Chamika Karunaratne) were all caught by Axar at

backward point, two of them off Malik. The lowest third of the innings had at least added some value before departing, however. Hasaranga made 21 off 17, Karunaratne 17 off 25, and Wellalage played perhaps the most responsible innings of the three, despite being the most junior, producing 32 off 34. It was thanks to them that Sri Lanka breached 200.

Through Nuwanidu's fifty, though, Sri Lanka had at least one positive. He was cautious against the new ball, leaving often, defending plenty, though he rarely seemed anxious even when he faced 10 scoreless deliveries to start, then had got to only 6 off the first 20. He was strong behind square, finding most of his runs, and four of his six boundaries, there. This was all the more impressive given he was batting out of position - he usually comes in at No. 4 or lower in domestic cricket.

Last year we had extended a top-up hospitalisation cover for our members and this time around we have gone one step further and provided a full cover of Rs 1.5 lakh each," newlyelected ICA president Aunshuman Gaekwad was quoted as saying in a media release. The premium is being paid in its entirety by the ICA. "Presently we have extended the cover to 109 members who expressed interest in availing the insurance, all of whom have played between 5 and 9 firstclass matches. In time to come, many more such members will be extended this cover," added Gaekwad (PTI)

Australia pulls out from Afghanistan ODI series

MELBOURNE, JAN 12 /--/ Cricket Australia (CA) on Thursday announced it has withdrawn from the upcoming ODI series against Afghanistan, saying it is "unable to proceed" with the fixture amid Taliban's growing restrictions on women and girls. Australia were slated to take on Afghanistan in a three-match ODI series as part of the ICC Super League in UAE in March following their tour of India. However, after "extensive consultation with relevant stakeholders, including the Australian Government", the CA decided to abandon the fixture. 'Cricket Australia has decided that it is unable to proceed at this time with the upcoming ICC Super League threematch Men's ODI series between Australia and Afghanistan scheduled for the UAE in March 2023," CA said in a statement. "This decision follows the recent announcement by the Taliban of further restrictions on women's and girls education and employment opportunities and their ability to access parks and gyms. "CA is committed to supporting growing the game for women and men around the world, including in Afghanistan, and will continue to engage with the Afghanistan Cricket Board in anticipation of improved conditions for women and girls in the country," it added.

Britain's Jack Draper fires warning to Nadal by reaching Adelaide semi-finals

ADELAIDE, JAN 12 /--/ Britain's Jack Draper fired a warning to Rafael Nadal by storming past Karen Khachanov and into the Adelaide International semi-finals on Thursday. The promising 21-year-old faces defending champion Nadal in the first round of the Australian Open next week and showed he was in fine touch with a 6-47-6 (7/ 3) victory over Russia's Khachanov. It was a measure of revenge for Draper after losing to his third-seeded opponent last week. Draper lifted his ranking from 262 to 40 in a breakthrough 2022 and his Adelaide semi is his third in the past six months. "It'll be amazing to play on court with him, he's a great champion," Draper said of 22-time Grand Slam winner Nadal. "I want to play really well and I want to compete hard and do the best I can." Draper added that he believed he could achieve "great things" but there was "a mountain of work to do". (AFP)

India seek first podium finish in 48 years, to play tricky Spain today

ROURKELA, JAN 12 /--/ A historic bronze medal in the Tokyo Olympics bringing them back among the international elite, India will seek their first podium finish in 48 years in the FIH Men's Hockey World Cup as they begin their campaign against Spain in a tricky match

here on Friday. A medal in this showpiece will strengthen the claim that the former giants of the game with eight Olympic gold have turned the corner in world hockey. The country won a bronze in the inaugural tournament in 1971 and clinched a silver in the next edition in 1973. Ajit Pal Singh led the side to title triumph in 1975 but since then they have failed to even reach the semifinals.

From 1978 to 2014, India could not go past the group stage. The Indian team, no doubt, would be one of the medal contenders with the talented bunch led by Harmanpreet Singh emerging as a force to reckon with. The team has earned respect from other top countries in recent

times. Currently ranked sixth in the world, India have come into the tournament after an impressive show against the world number one side Australia in an away five-match series though they lost the rubber 1-4. Graham Reid's side matched the Australians, one of the favourites to win the World Cup, in most departments of the game, notching up their first win in six years against their formidable opponents. In the previous edition, also held in Bhubaneswar, India had exited at the quarterfinal stage after losing to the Netherlands, the eventual runners-up, and they would be looking to reach at least the semifinals this time. India have also done well in the FIH Hockey Pro

League, finishing third in the 2021-22 season. The confidence and the winning mentality is back with the team. Since Reid took over the head coach's position in 2019, India's stature has grown. He has been able to get the best out of the players, injecting a tactical discipline to their trademark skillful, fluid playing style, making



them a team that is respected and feared in equal measure. "We focussed mainly on scenarios in our training, what if we are 0-1 down, what if we are playing with 10 men, what if they take their keeper off. Those types of scenarios which are important that we have

dealt with," Reid said. Captain and FIH Player of the Year Harmanpreet Singh, a fabulous defender and one of the best drag flickers in the game, will be key to India's success while goalkeeper PR Sreejesh, mid-field ace Manpreet Singh and Hardik Singh, and striker Mandeep Singh are all capable of bringing

about game-changing moments. Defender Amit Rohidas, who has captained the team in the past and also takes penalty corners, and forward Akashdeep Singh will be among the other India players to watch out for. Reid said he wants to take some pressure off captain Harmanpreet, who is also a defensive bulwark. India will hope to begin with a win, as that result can help them top Pool D for a direct quarterfinal berth and avoid playing cross-over matches (meant for second and third place teams of each of each of the four pools). Qualifying for the quarterfinals through cross-over

matches could lead to facing stronger teams in the last-eight stage like defending champions Belgium. "It's an old adage that the first game is the most important, so we are just focussing on that and then take it forward. That's how we are approaching," Reid said. (PTI)
