India won 4 medals on day 5 of Commonwealth Games 2022 at Birmingham. After historic gold of Lawn Bowls team in women's fours the men's table tennis team clinched the second gold medal of the day after beating Singapore 3-1 in the final. After that Weightlifter Vikas Thakur won a silver medal in the men's 96kg final and badminton mixed team won a silver medal after losing to Malaysia in the final. power, providing engineering, technical knowledge or other service for promotion of industrial growth, providing medical health or other allied service, setting up or development of tourism related facilities etc.

The quantum of loan is maximum 75% of the total project cost upto Rs. 10 lakh and 66% of the total project cost exceeding Rs. 10 lakh for purchase of machinery, construction of building etc. The promoters contribution is minimum 25% for the project cost upto Rs. 10 lakh and 34% for the project cost exceeding Rs.

The rate of interest for different loan amount is fixed based on SIDBI's prime lending rate, accordingly rate of Interest calculated as per the range of finance is as

Interest rate is subject to change as per changes in the SIDBI Prime Lending Rate (PLR). A rebate of 1% is provided for prompt payment and 2% lower rate is admissible for industrial concerns engaged in tourism, horticulture, fisheries, food-processing and environment friendly projects like recycling of waste etc. A maximum repayment period of 10 years with a moratorium period of 6 months to 2 years depending on the project is provided.

mobilization, aptitude test, and counselling by the Project Implementing Agencies (PIAs). 05 PIAs have been identified for skill development training and placement of 3000 candidates by the year 2023 under DDU-GKY scheme.

The two PIAs have started their first batch of training for 91 candidates out of which 44 candidates have completed training and are placed in different organisations for wage employment.

To support the other PIAs to initiate training programs, the Department of Rural Development has is organizing mobilization camps from July 18th to September 6th, 2022 in all 25 Gram Panchayats of C.D. Block, Ferrargunj and Prothrapur under the South Andaman District. The objective is to provide orientation to the rural youth about the benefits of the scheme and to enroll them into Kaushal Bharat.


