## MoES-funded GSLV-F14/INSAT-3DS successfully launched

Set to boost India's weather and climate prediction and forecasts, timely alerts and early warnings & advisories for public and last mile users such as fisherfolk and farmers

Sriharikota, Feb. 17(PIB) Satellite INSAT-3DS on launch vehicle GSLV-F14, fully funded by the Ministry of Earth Sciences (MoES), was successfully launched by the Indian Space Research Organisation (ISRO) from the Satish Dhawan Space Centre in Sriharikota, Andhra Pradesh today.

INSAT-3DS will augment the country's meteorological (weather, climate, and ocean related) services with the presently operational INSAT-3D and INSAT-3DR in-orbit satellites. The newly launched INSAT-3DS satellite aims to enhance the monitoring of Earth's surface, atmosphere, oceans, and



environment, elevate capabilities in data collection and dissemination and satellite-aided search and rescue services. The initiative will boost India's weather, climate, and ocean-related observations and services, expanding knowledge and better disaster mitigation and



preparedness in the future. The 51.7-meter (m) tall and 4 m wide Geosynchronous Satellite Launch Vehicle (GSLV)-F14 placed the INSAT-3DS satellite into a geosynchronous transfer orbit, then to a geosynchronous stationary orbit in space.

INSAT-3DS is configured around ISRO's well-proven I-2k bus platform with a lift-off mass of 2,275 kilograms. It is equipped with state-of-the-art payloads: (i) an imager payload with a six-channel optical radiometer to generate images of the Earth and its environment; (ii) a

19-channel sounder payload to provide information on the atmosphere; communication payloads, namely (iii) a data relay transponder to receive meteorological, hydrological and oceanographic data from automatic data collection platforms, and (iv) a satellite aided search and rescue transponder that relays a distress signal or alert from beacon transmitters with global coverage. Indian Industries have significantly contributed to the making of the INSAT-3DS.

## e-EPIC- a secure portable document format

CEO, A&N Islands urges citizens to download e-EPIC through Voter Helpline App

e-EPIC is a secure portable document format (PDF) version of the EPIC which can be downloaded on mobile or in a self-printable form on the computer. A voter can thus store the card on his/her mobile, upload it as a PDF on Digi locker or print it and self-laminate it. This is in addition to PVC EPIC being issued currently.

Who is eligible for e-EPIC?

All General Voters who have valid EPIC Number. All new electors registered during Special Summary Revision 2023 & 2024 and who registered their mobile number while applying will get a SMS and may download e-EPIC.

What are the steps to download e-EPIC? One can download e-



EPIC from <https://voters.eci.gov.in/> or Voter Helpline Mobile App using the following steps: > Register/Login on Voter Portal > From menu navigation click on Download e-EPIC > Enter the EPIC number or Form Reference Number > Verify with OTP sent on registered mobile number (if mobile number registered with Electoral roll) > Click on Download e-EPIC

> If Mobile number not registered in Electoral roll, > Click on e-KYC to complete the KYC or submit Form 8 to update mobile number in Electoral Roll. > Update your mobile number to complete KYC > Download e-EPIC.

## South Andaman District Police cracked down on drug peddlers and ganja smokers

Port Blair, Feb. 17

Continuing its endeavor towards drug free society, the Police Stations under South Andaman District viz. PS Aberdeen and PS Pahargaon arrested 2 persons for possession of Methamphetamine and smoking illicit ganja. On Feb.10, 2024, acting on credible information, the PS Pahargaon team swiftly reached Attampahar area and discovered a car in which someone was smoking a substance resembling ganja near a scrapyard. K. Mohit Swaroop, 27

years old, was found with a folded paper containing ganja. Subsequent testing confirmed the substance to be ganja. Mohit Swaroop was promptly arrested and 6 grams of ganja were seized from him.

Similarly, based on precise intelligence a b o u t Methamphetamine possession by Saurav Dhali, 22 years old, a proactive team from Police Station Aberdeen conducted a raid near Govt. Senior Secondary School, School Line. The operation led to the

apprehension of Saurav Dhali, 22 years old, with 16.90 grams of Methamphetamine.

Two FIRs were registered at PS Pahargaon and PS Aberdeen against the accused persons.

The entire operation was conducted under the supervision of Shri Vikas, IPS, Sub Divisional Police Officer, South Andaman under the overall supervision of Ms Niharika Bhatt, IPS, Superintendent of Police, South Andaman District, a press release from SP (SA) said.

## A&N Police issues advisory on cybercriminals blackmailing citizens

Sextortion is a form of blackmail where cybercriminals threaten to share intimate images of the victims online unless they give in to their demands. While sextortion can be perpetrated by individuals, organized crime is often behind it when the blackmailer demands money. The blackmailer may be based in India or outside the country. Both men and women can be victims of this crime.

In this regard, the Andaman and Nicobar Police has issued the following advisory to safeguard the citizens:

➤ Avoid replying to unknown video calls, unknown friend requests, messages from unknown numbers. Similarly avoid sending friend requests to people you do not know.



➤ Avoid sharing your phone number online with anyone unless you know the person well.  
➤ Avoid sharing intimate photos or videos with others on social media or other messaging apps, as these may be used for blackmailing.  
➤ Keep a record of all contacts from the b l a c k m a i l e r s , particularly any demands or threats and

make a note of everything you know about them for reporting purposes.




