Port Blair, Oct 3:



In a letter addressed to the Chief Secretary the Member of Parliament today said that the quantity of fertilizer supplied to them, is grossly insufficient.

He highlighted that farmers are given only a few gunny

bags of fertilizer every year, irrespective of the size of their cultivation land area. A farmer with more cultivation land is given the same amount of fertilizer as it was given to farmers with a small piece of contd. page-5

EDITORIAL



The Supreme Court (SC) has again been scathing in its criticism of protests that block roads. Its most recent observations have come in the context of the farm protests. Last week, one bench observed that the protests were "strangulating" the Capital. Indeed, since last November, many of the arterial roads leading into Delhi have been blocked by protesters, and also by barricades put up by the police to prevent them from reaching the Capital. Entire "protest cities" have come up on the sites, inconveniencing local residents and commuters who now have to take diversions.

Such observations by the court are not new. There have been similar observations in the past, in other cases dealing with other issues, but apart from noting that such protests that block roads aren't on and that it is the responsibility of governments (the Union and the states) to prevent roads from being blocked interminably by protests, the country's apex court has done nothing. While this may be in keeping with the division of responsibilities between the executive and the judiciary, the SC has never let this come in the way of its (sometimes justifiable) interventions in matters of State in the past. An order by it may well be all that is needed to clear the roads.

Irrespective of the merits of the larger issue, it has been evident for some time that the farm protests have reached an impasse. The farmers have not budged from their maximalist position seeking a complete repeal of the three laws passed last September, and their movement has now acquired distinctly political overtones. The government, after having offered to stay the laws for 18 months while the two sides talk, is now content to play a waiting game. And the SC, which in January stayed the implementation of the laws and asked for a report from expert committee (which was submitted in March), has not heard the case since. It's a status quo that appears to suit everyone.

With elections due early next year in two states whose farmers are part of the protests, Punjab and Uttar Pradesh, it is unlikely that a political solution to the crisis will be found before mid-2022, if then. That puts the onus of resolving the issue on the SC which would do well to resume hearing petitions challenging the legality of the farm laws — it is among the important cases, including the challenges to the abrogation of Article 370 and on electoral bonds pending before it — and, for starters, perhaps convert its observations on blocked roads into an order.

With elections due early next year in two states whose farmers are part of the protests, Punjab and Uttar Pradesh, it is unlikely that a political solution to the crisis will be found before mid-2022, if then. Chief Secretary issues order to

ensure compliance to Prompt & Effective Containment Measures for COVID-19 as per MoHFW

Port Blair, Oct. 1

Considering the need to prevent any potential rise in number of cases in view of the upcoming festive season in the country, MoHFW has issued an advisory to all States and Union Territories (UTs), for a continued focus on 'Prompt & Effective Containment Measures' as well as 'Acceleration in the Pace and Coverage of COVID Vaccination'. In exercise of the powers conferred under section 10 (2) (1) of the Disaster Management Act, 2005, the Union Home Secretary and Chairman, National Executive Committee (NEC) directs vide order of Ministry of Home Affairs, dated 28th Sept, 2021 to consider implementation of Prompt & Effective Containment Measures, as conveyed vide MoHFW advisory dated 21st September, 2021 and the National Directives for COVID-19 Management shall continue to be strictly followed and will remain in force up to 31st October, 2021.

Now therefore, in exercise of the powers conferred under section 24 (1) of the Disaster Management Act, 2005, the Chief Secretary, A&N Administration, Shri Jitendra Narain in the capacity as Chairperson, Union Territory Disaster Management Executive Committee,

for the Union Territory of Andaman & Nicobar Islands has ordered to ensure compliance to the Prompt & Effective Containment Measures for COVID-19 in accordance with the advisory issued by the Ministry of Health and Family Welfare (MoHFW) dated 21st September, 2021 shall continue to be strictly followed and shall remain in force up to 31st October, 2021 for the whole of Andaman and Nicobar Islands. The Deputy Commissioners and Departments concerned may issue necessary Standard Operating Procedures to implement the orders

Wagah-style BSF's retreat ceremony launched at Octerio BoP in RS Pura

PTI: India on Saturday launched a Wagah-Attari-style BSF's "retreat ceremony" at the Octerio Border Out Post near Suchetgarh village on the International Border on the occasion of Gandhi Jayanti.

The ceremony, comprising a structured parade by BSF men, was launched with Lt Governor Manoj Sinha terming the event as a "history in making" and the locals fervently hoping that the usual rattling of guns and booming of shells across the IB, prevalent till recently, will be a thing of past.

They also hoped this event would bring much-needed peace to the Suchetgarh sector in Jammu and Kashmir, helping it become a tourist spot round the year like the Attari border and heralding peace and prosperity for the border residents through tourism activities.

The chants of 'Bharat Mata Ki Jai' and 'Vande Matram' by people rent the air as BSF men carried out their parade in crisp uniforms.

"Today it is a history in making. Suchetgarh will now be known not only on the tourism map of J&K but in entire India," Sinha said.

He also complimented the efforts of the BSF and other agencies in launching the step.

"This is a historical step showing the return of muchneeded peace along the IB, which used to be rocked by the rattling of guns and booming of shells across the border," said Shamsher Singh of Suchetgarh village.

"It will also promote tourism in the area. It is a great day for us," he added.

Like Singh, an elderly woman Kanta Devi was so excited that she danced to the beats of drums by the villagers.

"We have been watching our houses being fired at and shelled for years now. But this scene has brought joy and peace to us. This should be a permanent feature," she said, fervently hoping for peace to prevail in and around her village.

Deepika, a student from the R S Pura border area, said she had seen such retreat ceremonies only on TV till then. She said she was happy that it was being held before her eyes in her own area.

The Jammu and Kashmir government had on July 4, 2016,

launched a border tourism initiative at the Octerio BoP. A group of nearly 100 tourists from various parts of the country visited the Octerio Border Out Post along the IB, which has three-tier border fencing.

Former J&K Minister for Culture & Tourism, Priya Sethi, who had launched the border tourism in Jammu in 2016, had then led the first group of 100 tourists, which travelled in a special bus to the Suchetgarh border belt in R S Pura tehsil of Jammu district.

"It is a historic occasion when the retreat ceremony took place here," BSF's (Jammu Frontier) DIG P S Sandhu said.

This was the first initiative after many years to put in place the retreat ceremony as a part of the border tourism on the Indian side on the lines Wagah border

Sent 106 names for judges, nine for CJs, I expect Govt to clear them soon, says CJI N V Ramana



Underlining the importance of filling judicial vacancies to address pendency of cases, Chief Justice of India N V Ramana said Saturday that the Supreme Court Collegium had recommended 106 names for judges and 9 for Chief Justices since May this year and the government had "so far" cleared names of 7 for judges and one for Chief Justice.

Addressing a gathering at the launch of the 'Pan India Legal Awareness and Outreach Campaign' of the National Legal Services Authority (NALSA) – those present at the Vigyan Bhavan event included President Ram Nath Kovind and Union Law Minister Kiren Rijiju — CJI Ramana said: "I expect that the government will clear the rest of the names very soon."

He said Minister Rijiju has "informed the rest of the things are going to come in a short time, within one or two days".

The CJI said "these appointments will take care of pendency to some extent" and "I seek the cooperation and support of the government to enable access to justice and to strengthen democracy".

On May 20, the Collegium, headed by CJI Ramana, recommended the elevation of Justice Sanjay Yadav as Chief Justice of Allahabad High Court. This was approved by the government following which he was administered the oath of office on June 13. Chief Justice Yadav, however, had a short tenure and retired on June 25.

On September 16, the Collegium recommended names for Chief Justices of 8 High Courts – Calcutta, Meghalaya, Karnataka, Madhya Pradesh, Himachal Pradesh, Allahabad, Karnataka and Chhattisgarh — but these are yet to be cleared.

As for judges, the Collegium had recommended names of judicial officers and

advocates for elevation to the High Courts of Madhya Pradesh, <u>Gauhati</u>, Allahabad, Calcutta, Karnataka, Punjab and Haryana, Chhattisgarh, Jammu and Kashmir, Kerala, Madras, Jharkhand, Patna, Gujarat, Orissa and Bombay.

According to the Department of Justice, a total of 420 vacancies in High Courts existed on May 1, 2021. As of October 1, there are 471 vacancies in the HCs.

Launching the awareness and outreach programme, President Kovind said the country has made substantial progress since Independence in realising its Constitutional goals, "but a lot of work remains to be done to reach the destinations identified by our founding fathers".

Referring to Mahatma Gandhi's call to lawyers to provide free legal aid to people, he called upon the legal fraternity and designated senior advocates in the Supreme Court and High Courts to follow this, and earmark a certain part of their time to provide pro bono services to people from the weaker sections.

The President said that "as a country, our aim is to graduate from 'women development'," and called for increasing the number of women in National Legal Services Institutions. This, he said, "is as important as reaching out to the largest possible number of women beneficiaries".

He pointed out that presently there are about 11,000 women lawyers among over 47,000 advocates on the panel of lawyers enrolled with legal aid institutions at the district level and about 17,000 women Para–Legal Volunteers out of a total of nearly 44,000.

Supreme Court judge Justice D Y Chandrachud said the legal profession still continues to be a feudal profession and this needs to change.

"This is something that the Supreme Court Bar Association can persuade, at least some of the seniors, to democratise access to the legal profession, because the mainstream of our profession does democratise access. We still continue to be a purely feudal profession which I believe needs to change," Justice Chandrachud said, touching on how lawyers beginning their careers prefer to join law firms than start legal practice when they do not have connections to gain entry to lawyers' cham-

Justice UU Lalit, Supreme Court judge and NALSA Executive Chairman, and Justice AM Khanwilkar also spoke on the occasion.

Cross-LoC trade: NIA carries out searches at 9 locations in J&K



The National Investigation Agency (NIA) on Sunday conducted searches on the premises of traders along the Line of Control (LoC) at nine places in Poonch district as part of investigations into large-scale transfer of money by Pakistan through crossLoC trade to fund terror activities in Jammu and Kashmir.

During the searches, the agency recovered documents, digital devices and other incriminating materials, said an official statement.

Sources said the

searches were conducted at Poonch, Kunaiyan, Chandhak, Degwar and Chaktro areas. A case had been registered by the agency in this regard on December 9, 2016 under provisions of the Unlawful Activities (Prevention) Act, 1967, they said. The NIA was assisted in the searches by officials of J&K Police, CRPF and ITBP.

LoC trade was started in the year 2008 as part of confidence-building measures between J&K and Pakistanoccupied Kashmir (PoK). The trade was based on a barter system and third-party goods were not allowed, it added.

The current case is

related to transfer of funds from Pakistan to India through the import of California Almonds (badam-giri) and other items via the Cross-LoC Trade Facilitation Centres (TFCs) at Uri's Salamabad area in Baramulla district and Poonch district's Chakkan-Da-Bag area. These funds were purportedly being used to foment terrorism/separatism in Jammu & Kashmir, the statement said.

Investigation revealed that some of the traders having excess imports diverted the surplus profits to terror organisations, while others were suspected to have links with proscribed terrorist organisations.

India, Germany will see closer cooperation on Afghanistan: German envoy



PTI: India and Germany are very much on the same wavelength on issues concerning Afghanistan and the two countries will see closer cooperation in this regard, German Ambassador to India Walter J Lindner said on Sunday.

"India is a very big actor there (Afghanistan)... involved in a lot of developmental projects and Germany has been very active (there) for the last 20 years. So, we both share pretty much the same principles," Lindner said at an event held to mark the 31st anniversary of German reunification.

He unveiled a symbolic painting on a large wall at the iconic Sheila Theatre in Paharganj here depicting the friendship between India and Germany.

Lindner said the two nations supported the previous government in Afghanistan and tried to help it make headway and improve the situation, especially for women, in the country.

"We are all surprised by the fast advancement of the Taliban. Now, we have to deal with this situation. We still have to get people out of Taliban. We still have a humanitarian crisis to prevent in Afghanistan through the United Nations.

"We have some conditions under which we talk to the Taliban — an inclusive government which is not yet there. But we still have to have some kind of dialogue to make advancement on these points. India is very much on the same wavelength. So, we will see closer cooperation between us," he said.

The German envoy said economy, environmental protection, green energy, student exchange, science and technology, and artificial intelligence will be the key areas of the India-Germany partnership ahead.

Lindner said today is an important day for Germany as East and West Germany were reunited 31 years ago on this

"Usually, we'd host a big reception but due to Covid restrictions, we couldn't do it again. Last year, we came up with the Scorpion's iconic song "Wind of Change", which we re-recorded with Indian musicians," he said.

"This year, we thought we'd do something different but also with an artistic twist. Afghanistan by talking to the That's how we got in touch

Weeks ago, we recognised Covishield. I myself have been vaccinated with Covishield. So, those who have been administered Covishield do not need to undergo quarantine (in Germany) or face any other restrictions."

Since Covaxin has not yet been recognised by the World Health Organisation, those who have taken it have to undergo quarantine. Once the WHO approves the Bharat Biotech-manufactured vaccine, Germany will take the next step and see if it can recognise it, the ambassador said.

On the formation of the next government in Germany, Lindner said it is very likely to be a three-party coalition. The parties that might be involved currently holding negotiations. The idea is to get a coalition treaty signed before Christmas.

AFTER A long interruption in operations amid the pandemic, cruise ship operations had begun at the Mormugoa Port Trust (MPT) in Goa on September 26. About a week later, the Narcotics Control Bureau's (NCB) raids on a Goa-bound ship, the industry feels, may be a "short-term setback" for cruise operations.

MPT Deputy Chairman G P Rai said on Sunday there had been no information on any change in cruise ship operations scheduled at the port and they were expected to continue as usual. However, the revenue streams that had dried up amid the pandemic may perhaps take longer to be revived.

The cruise ship open tions, apart from generating revenue for the cruise line operators and the port, also support allied industries like hotels, restaurants, taxi services and a host of small businesses. In a state heavily dependent on tourism, there were concerns over the bearing Sunday's high-profile drug bust off the coast of Mumbai, may have on cruise line tourism in Goa.

Cordelia Cruises had started their first domestic Port with 1,591 passengers on board. Seventy-five passengers had boarded the ship in Goa that day.

Daton Duain Fix of the USA flattened Ravinder Dahiya of India by 10-0 in the men's freestyle 61-kg category quarterfinals of the World Wrestling Championships which began at Nye Jordal Amfi, Oslo in Norway on Saturday.

The Indian, a silver medallist at the Budapest 2019 World U-23 Championship, will have to wait for a repechage chance. After losing the last-eight stage bout by VSU (victory by technical superiority), Ravinder, 25, will have to wait for the semifinal bout between Arsen Harutyunyan of Armenia and Fix.

In the bout of eight,

Ravinder stunned favourite and world champion Beka Lomtadze of Georgia 6-2 by VPO1 (winner with no technical superiority but the loser scores at least 1 point).

In the qualification round, the Haryana grappler defeated Sunggwon Kim of Korea 13 - 2.

Fix began with an 11-0 win over Tokyo Olympian Georgi Vangelov of Bulgaria in the qualification and in the round of eight he scored an emphatic 10-0 win over Arman Norik Eloyan of France.

Sunil Chhetri adds to India's heft at SAFF Championship



The last time India sent a near full-strength squad for the SAFF Championship was in 2015. Sunil Chhetri was still in his 20s and Afghanistan was still a part of the South Asian Football Federation. India won that edition of the biennial tournament after having lost in 2014 to Afghanistan. Chhetri, Jeje Lalpekhlua scored 6 of the 14 goals scored by the national team in six games.

An ageing Chhetri has now crossed 100 caps for India and will once again return to the 2021 edition of the tournament in Maldives. The tournament in Maldives.

nament is essentially being used by the Indian national team for practice before the start of the third round of the Asian Cup qualifiers from February 2022. Admitting that at his age (37), reaching another 100 caps for India was impossible, Chhetri said that a return to the SAFF Cup for him was an opportunity to add to his longevity.

"I am here to play for my country. I don't take any opportunity for granted. I wanted to play 100 games. And now I will take whatever opportunity I get my way," the Bengaluru FC captain stated.

'Whatever opportunity' is the key phrase that has dictated this Indian campaign. The timing of the Cup, falling right as pre-season for most ISL clubs begin to take shape, means that a camp and friendlies before the tournament was not a possibility.

"We couldn't organise a preparation camp for obvious reasons. SAFF and AFC games are outside of the FIFA calendar. We spoke to the FSDL, ISL clubs, some of which are starting their pre-training. It is the busiest time in Indian football," Stimac said during a virtual conference on Saturday. "Everyone has had to give up on something. It is not easy and it is not enough but I am grateful," he added.

For the past couple of editions the SAFF Cup was treated as a tournament where India could send their U-23 players. After having won the title a record 7 times and being miles ahead in Fifa rankings as compared to the other teams

in the competition, experience rather than winning was the mantra.

But this edition of the SAFF Cup has burgeoned in its importance. A severe lack of international games notwithstanding, it is the position of the coach that has essentially called for Chhetri and Gurpreet Singh Sandhu to be a part of this team. With an unclear future and whether a new contract is headed his way, Igor Stimac has a lot riding on the result of this tournament. Poor performances against Nepal, Bangladesh and Afghanistan during the team being under his charge has posed fresh questions on his tenure

The location of the team in Maldives and their short duration in the island nation has ensured that training has been sub-par.

"We came here only four days ago. We have to travel to Male on speed boats. There are artificial turfs here. We are protecting our players so that they do not get injured. We are playing for 15-20 minutes, working on set pieces. Not much we can do over here," said Stimac. He then added, "We are relying on the understanding that the players know each other very well."

The only semblance of an advantage that India carry into the tournament is the presence of ATK Mohun Bagan and Bengaluru FC players. Eight players from these two teams have been playing in the AFC Cup and are match fit.

"After playing in the AFC Cup group stage matches, ATK Mohun Bagan and Bengaluru FC players continued with their pre-season, so it's an advantage for us. Most of the other ISL sides are yet to start their pre-season. We will have to be careful about how many minutes we can give to those players," said Stimac.
