

## Parliament adjourned sine die Nine Bills passed by Lok Sabha and 11 Bills by Rajya Sabha

New Delhi, Dec. 22

Both the Houses of Parliament today adjourned sine die a day ahead of its schedule. The Winter Session of the Parliament had commenced on 29<sup>th</sup> of the last month and it was scheduled to conclude tomorrow. The Lok Sabha has registered 82 percent productivity while Rajya Sabha 47 percent in the Winter Session of the Parliament. Briefing media about the session, Parliamentary Affairs Minister, Shri Pralhad Joshi said, nine Bills



were passed by the Lok Sabha and 11 Bills by the Rajya Sabha.

They include the Farm Laws Repeal Bill, 2021, the Election Laws (Amendment) Bill, 2021, the Appropriation Bill (No. 5), 2021 and the

High Court and Supreme Court Judges (Salaries and Conditions of Service) Amendment Bill, 2021. He said, 13 Bills were introduced during the session. (Source: india.gov.in)

## DRDO conducts maiden launch of indigenously developed new generation surface-to-surface missile 'Pralay'

New Delhi, Dec. 22 (PIB)

Defence Research and Development Organisation (DRDO) successfully conducted maiden flight test of indigenously developed surface-to-surface missile 'Pralay', from Dr A P J Abdul Kalam Island off the coast of Odisha today. The mission has met all its objectives. The new missile followed the desired quasi ballistic trajectory and reached the designated target with high degree



accuracy, validating the control, guidance and mission algorithms. All the sub-systems performed satisfactorily. All the sensors deployed near the impact point across

the eastern coast, including the down range ships, tracked the missile trajectory and captured all the events.

The Missile is powered with solid propellant rocket motor and many new technologies. The missile has a range of 150-500 kilometre and can be launched from a mobile launcher. The missile guidance system includes state-of-the-art navigation system and integrated avionics.
