



The home ministry considers proposals for name change according to the existing guidelines, in consultations with agencies concerned. It gives a 'no-objection' certificate to change the name of any place after taking consent from the ministry of railways, Department of Posts and the Survey of India, another official said.

For changing the name of a village, town or a city, an executive order is needed. Renaming of a state requires an amendment of the Constitution with a simple majority in Parliament, the official added. (PTI)

## Maharashtra Council passes resolution to "legally pursue" inclusion of 865 Marathi-speaking villages in Karnataka

NAGPUR, DEC 27 /--/ The Maharashtra legislature on Tuesday unanimously passed a resolution to "legally pursue" inclusion of 865 Marathi-speaking villages in Karnataka into the western state, amid the raging boundary dispute between the two states.

The resolution moved by chief minister Eknath Shinde in both Houses of the Maharashtra legislature said the Karnataka legislature had passed a resolution on the issue to purposely fuel the border row and condemned the southern state's stand. "The state government stands resolutely with the Marathi-

However, the Karnataka government took a contrary stand by passing a resolution in its state Assembly.

The border issue dates back to 1957 after the reorganisation of states on linguistic lines. The Karnataka Legislative Assembly last Thursday unanimously passed a resolution on border row

to protect the southern state's interests and not to cede an inch of land to its neighbour. The resolution had also condemned the border dispute "created" by Maharashtra.

The Shiv Sena (Uddhav Thackeray faction) on Tuesday demanded in the Maharashtra Assembly that the 865 villages be declared as a Union Territory till the Supreme Court gives its verdict on the issue. However, it did not figure in the resolution. Deputy chief minister Devendra Fadnavis said in the Assembly that the case is pending before the Supreme Court and it also

has to be ensured that there is no contempt of court while putting forth the demand, as the matter is subjudice.

Maharashtra laid claim to Belagavi, which was part of the erstwhile Bombay Presidency, as it has a sizable Marathi-speaking population. It also laid claim to more than 800 Marathi-speaking villages which are currently part of Karnataka.

Karnataka maintains the demarcation done on linguistic lines as per the States Reorganisation Act and the 1967 Mahajan Commission Report as final. (PTI)

### Khurshid likens Rahul to Lord Ram, BJP says Cong puts devotion to family above devotion to God, nation

described him as
"superhuman" and a "yogi
doing tapasya" as he lauded
the former party chief for his
Bharat Jodo Yatra, evoking
sharpcriticism from the BJP.

**Slammingthe Opposition** party leaders for their show of"sycophancy", the BJP said comparing a person out on bail in a corruption case, a reference to the National Herald probe, to a God worshipped by so many people not only hurts the feelings of Hindus but also the entire society. The Congress leader, however, remained unfazed and defended his remarks. "No one can replace God but everyone can try to walk the path shown by him. Why should anyone object if I say someone is following that path," he said on Tuesday. While BJP spokesperson Gauray Bhatia targeted the Congressatapressconference for Khurshid's comparison, another party spokesperson Shehzad Poonawalla, in a swipe at Congress leaders, said they put "parivaar ki bhakti" (devotion to family) above"bhagwaanandrashtra ki bhakti" (devotion to God and nation).

The Congress must apologise for hurting Hindu sentiments, Poonawalla said. Khurshid, a former Cabinet minister, also likened Congress workers to Lord Ram's brother Bharat. Talking to newspersons in Moradabad on Monday, Khurshid, who is the state coordinator of the yatra, said, "Rahul Gandhi is superhuman. While we are freezing in the cold and

"Rahul Gandhi is superhuman. While we are freezing in the cold and wearing jackets, he is going out in T-shirt (for the Bharat Jodo Yatra). He is like a yogi, he has called himself so,

doing his 'tapasya' (penance) with focus."

Drawing a parallel with Lord Ram and his brother Bharat, Khurshidsaid: "Lord Ram's 'khadau' (wooden slipper) goes very far. Sometimes when Ram ji is not able to reach, Bharat takes his 'khadau' and goes to places.

Likethat, we have carried the 'khadau' in Uttar Pradesh. "Now that 'khadau' has reached Uttar Pradesh. Ram ji will also come, this is our belief, "Khurshid said. He was responding to a question about the Gandhi-led yatra not passing through Uttar

Pradesh till now. Asked about BJP's reaction to his remarks, Khurshid told reporters on Tuesday: "If I believe somebody is following the path shown by God, then what will I say if I have to praise him? How do you praise a person if he has attained such a height? Isn't this said that he is like God? Noone can replace God but everyone can try to walk the path shown by him

him.

"Why should anyone object if I say someone is following that path and that people can again see the story they associate with God. If the BJP has never seen a good man, then it's their problem."

BJP spokespersons, however, alleged that the Congress, when in power, had

questioned the existence of Lord Ram and accused its leaders of repeatedly riding roughshod over Hindu sentiments. Khurshid in his attempt to  $clarify \, remains \, defiant \, about \,$ his outrageous analogy between Prabhu Ram & Rahul! Heights of Parivar Bhakti that you even put Bhagwan Bhakti & Desh Bhakti aside. "Will Salman ji ever make similar analogies for other faith? Can he," Poonawalla tweeted.

The yatra will enter Uttar Pradeshon January 3through Loni in Ghaziabad. It will then pass through Baghpat and Shamli to enter Haryana. Khurshid said the yatra will follow the scientific guidelinesonthecoronavirus pandemic. His statement came in the backdrop of Union health minister Mansukh Mandaviya asking Gandhi to consider suspending the yatra if Covid-19 protocols could not be followed.

To a question related to former prime minister Atal Bihari Vajpayee, Khurshid said: "We respect him, that's why our leader Rahul Gandhi went to his samadhi. The actions of other BJP leaders are not worthy of respect."

The Congress leader said the Bharat Jodo Yatra is working to unite those who love the country while the Bharatiya Janata Party (BJP) works to break the country by spreading hatred.

Reacting to Khurshid's statement, BJP spokesman Harishchandra Srivastava said they reflect nothing but sycophancy."Khurshidsaheb needs to think thousands of times before comparing Rahul Gandhi with the 'mahapurush' who is followed by the entire world. He is a barrister but his statement is a symbol of sycophancy," Srivastava said. (PTI)

# BSF jawan murdered after protest against circulation of daughter's objectionable video; 7 arrested

KHEDA, DEC 27 /--/ A 42-year-old Border Security Force (BSF) jawan was murdered allegedly by seven members of a family in Gujarat's Kheda district after he went to their house to protest while holding one of them responsible for circulating an objectionable video of his minor daughter on social media, police said on Tuesday. The incident took place at around 10 pm on Saturday and the seven accused were arrested on Sunday, they said. BSF jawan Melaji Vaghela, his wife and son went to the house of Dinesh Jaday at Chaklasi village in Nadiad taluka of the district to protest against the objectionable video of Vaghela's daughter, which they claimed was circulated on social media by Jadav's son. "After a heated argument over the issue, Jadav and his six other family membersattacked Vaghela and his family members with sticks and sharp weapons," Nadiad's deputy superintendent of police V R Bajpai told newspersons. Vaghela received injuries on his head and other body parts and died on the spot, he said.

The jawan's son Navdeep too suffered severe head injuries and his wife was also injured, the official said. An FIR was registered on Sunday night at Chaklasi police station under various Indian Penal Code Sections including 302 (murder), 307 (attempt to murder), 323 (voluntarily causing hurt), 504 (intentional insult) and 143 (unlawful assembly), he said. All the seven accused were arrested. They were sent to judicial custody on Monday, the official said. An investigation was on into the incident. A forensic team was in the process of collecting evidence, he said. The incident took place when Vaghela was visiting hisfamily on a holiday before histransfer to Barmer in Rajasthan from Ambasan in Mehsana, superintendent of police Rajesh Gadhiya said. (PTI)

## SC to hear on Jan 2 pleas challenging state laws regulating conversions due to inter-faith marriage

NEW DELHI, DEC 27 /--/ The Supreme Court is scheduled to hear on January 2a batch of pleas challenging controversial state laws regulating religious conversions due to interfaith marriage. A bench of Chief Justice DY Chandrachud and Justice PS Narasimha is scheduled to hear the PILs filed by advocate Vishal Thakre and an NGO 'Citizens for Justice and Peace'. The Supreme Court will also hear a plea by Muslim body 'Jamiat Ulama-I-Hind' which it had allowed last year to become a party to the petitions as it claimed a large number of Muslims are being harassed under these laws across the country. As per the office report uploaded on the apex court website, so far no reply has been filed by the Centre or any of the states which have been made parties to the litigation.

On February 17, 2021, the apex court had permitted the NGO to make Himachal Pradesh and Madhya Pradesh the parties to its pending petition by which it had challenged some controversial state laws regulating conversions due to interfaith marriages. The Supreme Court had on January 6, 2021 agreed to examine certain controversial new laws of Uttar Pradesh and Uttarakhand regulating religious conversions due to such marriages. It had, however, refused to stay the controversial provisions of the laws and issued notices to both the state governments (Himachal Pradesh and Madhya Pradesh) on the petitions.

The pleas, filed by Thakre and the NGO, have challenged the Constitutional validity of the Uttar Pradesh Prohibition of Unlawful Religious Conversion Ordinance, 2020 and the Uttarakhand Freedom of Religion Act, 2018 which regulate religious conversion of people in interfaith marriages. The NGO had submitted during the last hearing that both Himachal Pradesh and Madhya Pradesh should be made parties to its plea as they have also framed laws on the lines of Uttar Pradesh and Uttarakhand. The controversial UP ordinance relates to not only interfaith marriages but all religious conversions and lays down elaborate procedures for any person who wishes to convert to another religion.

The Uttarakhand law entails a two-year jail term to any person or persons found guilty of religious conversion through "force or allurement". The allurement can be in cash, employment, or material benefit. Thak re and others have said in their plea they are aggrieved by the ordinance which curtails the fundamental rights of the citizens of India provided under the Constitution. The plea said the laws passed by Uttar Pradesh and Uttarakhand against 'Love Jihad' and punishments thereof may be declared ultra vires and null and void because they disturb the basic structure of the Constitution as laid down by the law. It claimed they are against public policy and society at large. The plea filed by the NGO alleged the legislations violate Articles 21 and 25, as they empower the state to suppress an individual's personal liberty and the freedom to practice religion of one's choice. # WCD ministry focussed on 3 verticals in 2022 to tackle various issues of women, children safety, Guidance System, but have

NEW DELHI, DEC 27 /--/
The women and child development ministry worked through three verticals of Saksham Anganwadi and Poshan 2.0, Mission Shakti and Mission Vatsalya with an aim to ensure better monitoring and efficient implementation of its various schemes this year.

Saksham Anganwadi and Poshan 2.0 looked into nutrition support for children, adolescent girls and pregnant women and lactating mothers; and for early childhood care and education while Mission Shakti aimed at safety, security and empowerment of women and Mission Vatsalya focused on protection and welfare of children. Last year, the ministry classified all its major programmes under these three umbrella schemes for better implementation. Under Mission Saksham Anganwadi and Poshan 2.0,

the ministry issued the

schemeguidelines on August 1 whereby two lakh anganwadi centres were to be strengthened, upgraded and rejuvenated for improved nutrition and educational delivery. So far, anganwadi workers have been provided with 11.22 lakh smart phones.

Besides, to promote regular growth monitoring of children, 12.65 lakh growth monitoring devices, such as infantometer, stadiometer, weighing scale for mother and infant, weighing scale for child, have been procured by states and Union Territories. To promote the nutritional status of women and children in real-time, Poshan tracker application was put smartphones of anganwadi workers. As on October 31, approximately 9.84 crore beneficiaries have been onboarded. Also, beneficiaries on Poshan tracker were Aadhaar seeded to ensure last mile tracking and delivery of

Under Mission Vatsalya, the Juvenile Justice Model Amendment Rules, 2022 and Adoption Regulations, 2022 were notified in September under district which the magistrates were made the nodal authority at district

levels for all matters relating

to child safety, empowerment and safety including issuance of adoption orders. Concerns remained over high pendency of adoption cases in district courts due to new regulations but ministry said that pendency of adoption orders have come down since the rules have come into force.

number High prospective adoptive parents and low availability of children legally free for adoption was another concern that remained this yearamongvariousquarters but under the new adoption regulation waiting period was removed for those parents who desire to adopt a child having special needs and also from the immediate placement category. The immediate placement category includes children who have been referred several times to prospective adoptive parents (PAP's) through Child Adoption Resource Information and

To support children who have lost both parents, single surviving parent, legal guardian or adoptive parents to Covid pandemic, the scheme for PM Cares for Children was launched last vear under which a total of 4,345 children were found eligible under the scheme till this year. The ministry's two commissions - National Commission for Women and National Commission for Protection of Children continued to play a crucial role this year.

The focus of NCW worked on projects of entrepreneurship, digital literacy, legal awareness while the NCPCR focussed on rehabilitation of street children. he martyrdom of the four 'Sahibzaade" (Sons) is an integral part of the Sikh The occasion is commemorated both with great vigour and very acute sadness by the Sikh community annually in December, also known to be the month of "Poh". Dasmesh Pita Guru Gobind Singhji had four sons.

The mughals and kings of hilly regions asked Guruii to leave the Anandpur Fort. In return, they would not be attacked .. Guru Sahib, the four Sahibzaade, Mata Gujari Kaur, Mata Jeeto Ji, his wife, the five Panj Piaras and a few hundred Sikhs left Anandpur Sahib on the chilly night of

was betrayed .On the intervening night of 20 -21 December, the Mughals breached the vows and attacked Guru's entourage at a site on the Sarsa rivulet, some 25 kms from Anandpur Sahib. The Guru's family was separated and broken away. This spot is now known as "Pariwar Vichhora" and the Gurudwara Sahib is also built up there in their honour as "Gurudwara Pariwar Vichhora Sahib". Guru's Mahil left with Bhai Mani Singh towards Delhi.

Guru Gobind Singh Ji with two elder Sahibzaade, 5 Panj Piaras, and 40 Sikhs proceeded towards Chamkaur and reached there on the afternoon of 21 December.In 17th century, the youngest heroes and bravest comrades of Sikhism, 20 December 1704 towards Ropar. But sacrificed their lives for humanity. attaining martyrdom, the sound of

Gobind Singhji, showed utmost valour and stood up against the tyranny of Mughal Empire. However, the servant breached their trust and in greed of money, disclosed their location to the Mughal. The Mughals came to the house and captured them. All three (Thanda Burj), in chilling winters with no mats to sleep on, just strands of straw as their bedding. The sons were brought to Wazir Khan, the governor of that state. Wazir Khan believed in Emperor Aurangzeb's vision. Wazir Khan told the Sahibzaade that he would spare their lives if they converted to Islam. But they replied bravely - "Pahila Maran Kabul, Jivan Ki Shad Aas, Hoh Sabhna Ki Renuka, Tau Aau Hamare Paas" Thus, the younger sons of Guru Gobind Singh, Sahibzaada Zorawar Singh (Age 9) and Sahibzaada Fateh Singh(Age 5) attained martyrdom at Sirhind, Punjab. They were bricked alive . Mata Gujri Ji also left for heavenly abode. Their prudence, wisdom and spiritual knowledge was way beyond their age for an argument with tyrannical monarch, Wazir Khan. Till date, the Sikhs in Anandpur Sahib and Sirhind, commemorate these days by sleeping on the floor,

without any blanket. When Mata Sahib Kaur and Mata Jitiji, unaware of this adversity and tragedy, inquired about the well being of the four sons. Guru Gobind Singh Ji replied- "In Putran Ke Sees Par, Vaar Diye Sut Chaar, Chaar Muye Toh

Kya Hua, Jeevat Kahin Hazaar"

As I remember the Sahibzaade and Mata Gujar Kaur Ji's sacrifices, I hope to be imbued with the same level of sacrifice, courage, and love. By searching for truth and justice for each of us, remembering that we are all children of that same Divine Light, we can move towards a more courageous and humble practice of love and light in the time of darkness.

In of Home Affairs vide letter No.43/26/6a letter sent to the Secretary, Ministry of ANL dated 01.02.1960 had unambiguously Health & Family Welfare, Govt. Of India, Shri S. Surender, General Secretary of the Government Pensioners' Association has also demanded that benefit of CGHS facility may be extended to all the pensioners who retired after serving in Andaman & Nicobar Islands and presently settled in different State/UTs without any discrimination. It has been brought to the notice of the Association by some of the pensioners who after getting retired from various departments of the A & N Administration and settled at a place in mainland where CGHS facilities are available that their request for enrollment in CHGS have been rejected by the authorities citing the Government of India, Ministry of Health & Family Welfare OM No. Z-15025/58/2017/DIR/CGHS/Pt dated the 21st July, 2017. The Association further said that in view of the CGHS Scheme, MHA's clarification, provision of the CCS (Pension) Rules and various judicial pronouncements and more important to the dismissal of the SLP and Review Petition which were filed by the Union of India, the contention of the Ministry of Health & Family Welfare, as contained in the OM dated 21.07.2017, cannot be logically and legally sustainable as the judicial pronouncements are always superior over the executive/administrative

### Year 2022 saw political slugfests in Maharashtra courtrooms, cases against alleged Maoists

Maharashtra spilled over to the courts in 2022 with the arrests of leaders like Sanjay Raut, Nawab Malik and independent MP from Amravati Navneet Rana in different cases and subsequent legal battles over their bail applications. The courts also dealt with litigation related to the Elgar Parishad-Maoist links case of 2017 with some of the accused getting relief. In February, Nationalist Congress Party (NCP) leader and former minister in the then Maha Vikas Aghadi (MVA) government Nawab Malik moved the Bombay High Court, seeking to quash an alleged money laundering case registered against him by the Enforcement Directorate. The ED case is related to a land deal in Mumbai in which associates of fugitive gangster Dawood Ibrahim were involved. Malik's plea is still pending.

In March, the ED arrested Malik in the case and subsequently a special court for the Prevention of Money Laundering Act

MUMBAI, DEC 27 /--/Political turmoil in (PMLA) cases rejected his bail applications. Malik has now moved the High Court for bail. April saw another high-profile case when Mumbai Police arrested Navneet Rana and her husband, MLA Ravi Rana after they announced that they would recite the Hanuman Chalisa outside then Chief Minister Uddhav Thackeray's private residence 'Matoshree' in Mumbai. About ten days later, the couple was granted bail by a court. But arguably, the case that dominated headlines the most was that of Rajya Sabha MP Sanjay Raut. Trials in the 2008 Malegaon blast case and 2012 Sheena Bora murder continued. Some prosecution witnesses turned hostile in the Malegaon case where BJP MP Pragya Thakur is a prime accused. In February 2022, Justice Pushpa Ganediwala, who had faced flak over the interpretation in a few of her judgements of the term sexual assault' under the Protection of Children from Sexual Offences Act (POCSOA), resigned. ### Hasina, the longest serving Awami League boss

Sheikh Hasina has become the longest serving President of Awami League since 1981 when she first assumed this post. Recently, the ruling party re-elected her for the 10th time in a row. It assumes significance at a time when both politics and the economy of the country are facing challenges in 2023. Moreover, Bangladesh is scheduled to go to polls in early 2024. Sheikh Hasina has cautioned the AL leaders and activists about the conspiracies and asked them to focus on the marginalised people to transform Bangladesh into a developed, prosperous and smart country by 2041. Referring to the measures taken by the government for electoral reforms, she spoke about the new law to appoint Chief Election Commissioner (CEC) and Election Commissioners. She has asserted that the next general election will be conducted in a free and fair manner. Accusing Khaleda Zia of preparing a fake voter list of 1.23 crore people during her regime, she said Awami League is the only party which ensured voting rights of the people.

Given her friendly ties with India, bilateral cooperation is expected to gain momentum in 2023 despite some pending issues, especially the sharing of river waters, that Sheikh Hasina has said Dhaka believes could be resolved through negotiations. Bangladesh-India relations are multifaceted in nature and rooted in a shared history, geographical proximity and commonality in their cultures. The emotional bonds stemming from the contribution of India towards the liberation of Bangladesh in 1971 remain a dominant factor in the country's political, social and cultural web. Being India's next-door neighbour, Bangladesh's relations with New Delhi are crucial for its political and economic stability. The two neighbours have remained engaged bilaterally and, unlike some western nations, India usually refrains from commenting on Bangladesh's domestic politics in public. Owing to geographic reality and historic backdrop, "good relations" are likely to be there in place in the interest of both countries. But there is a general perception in Bangladesh that "we give more and get less" -- this concern must go and being the bigger neighbour, India is expected to take the lead role. The two countries have several pending issues with the most crucial being the sharing of waters in common rivers, including the Teesta River, which flows through India. Prime Minister Hasina has repeatedly said that Dhaka believes the outstanding issues with New Delhi could be resolved through discussions. The governance system appears as the crucial factor to sustain political stability and economic durability in the current context as tensions rose with the return of former prime minister Khaleda Zia's Bangladesh Nationalist Party (BNP) to the political scene after years of wilderness and are eying the upcoming elections. Prime Minister Hasina's Awami Leagueled government has decided to tighten further its spending as trade imbalance and inflation eroded Bangladesh's GDP while a sense of panic gripped people due to fallout from money market volatility. Financial analysts said Bangladesh's growth was remarkable but its economy was now at risk. The Asian Development Bank (ADB) in a recent report feared that the GDP, which it predicted to be 6.6 per cent, now was likely to be lower in 2023-24, though the lending agency did not quantify any figure

### Bangladesh-U.S. diplomatic relations worsen over Ambassador's visit

As the year comes to an end, relations between Bangladesh and the USA remain as frosty as ever. Yet another diplomatic spat of sorts occurred a few days ago, over the US Ambassador's intriguing visit to the Dhaka residence of a 'disappeared' opposition leader.

The ruling Awami League (AL) leaders, already under considerable stress over an impending general election by next year-end, expressed their annoyance over the diplomat's action, but noticeably avoided a confrontational posture. In contrast, both the Dhaka-based Embassy as well as the US State Department strongly backed Ambassador Richard Hass's move, much to the delight of the Bangladesh Nationalist Party (BNP). The state department used the social media to announce its stand, reiterating its commitment to uphold human rights. The leader in US focus is Mr Sajedur Islam Sumon, who belonged to the BNP. Mysteriously, he remains untraced since 2013. The role of the Government is strongly suspected. The US Embassy's explanation is, the Ambassador was only probing complaints made by a civil rights group about the matter, along with similar reported instances of other opposition figures who also went missing during the Al's tenure. He was trying to ascertain the facts of the situation from the family members of Mr Sumon but had to curtail his visit.

The reason: a group of people began protesting in the area. They suggested that Haas should instead institute an inquiry into the alleged genocide of intellectuals and secular political leaders that occurred in 1977. General Ziaur Rahman was then in power. He was also the founder of the BNP, incidentally. Nor was there any official explanation from Dhaka as to how the demonstrators reached the area or if anybody had tipped them off about the controversial visit. Bangladesh Foreign Affairs Minister Dr A.K Abdul Momen, to whom Mr Haas later conveyed his concerns about the demonstration, did not feel there was any threat to anyone's security. The incident would not impact US-Bangladesh relations negatively, he said. The main opposition BNP was not convinced. Its leaders accused the AL Government of harassing Mr. Haas.

### REFLEX ACTION

They condemned the AL's allegedly poor record in handling issues related to human rights as well as democratic rights of opposition parties. Hundreds of people had been reported missing or killed in one-sided dubious encounters, especially by personnel of the rapid Action Battalion (RAB), in recent years. The situation continued to deteriorate despite repeated warnings and concerns expressed by the US and EU countries, not to mention major international HR groups, to the Bangladesh Government.

Eventually, last December the Biden-led US administration slapped sanctions on seven senior RAB officials, along with a warning to Dhaka to deal with the opposition in a more transparent and accountable manner. AL leaders in response alleged that the US had been fed much disinformation about the law and order situation by the motivated opposition. There were major allegations of the BNP aligning with the fundamentalist Jamat-e-Islami during its tenure. It carried out systematic repression and attacks against minority Hindus and AL activists. But the US and EU countries in general overlooked such practices of the BNP and its declared bonhomie with Pakistan and Islamic fundamentalist organisations.

Bangladesh government has since appealed several times to the US to withdraw/reconsider its sanctions, but to no avail so far. However, there is a general feeling that over time, the number of clashes between the AL and opposition parties, as well as the dreaded 'encounters', has significantly reduced. Ironically, there has been a marked increase in the level of violence directed against the Government, on part of the fundamentalist Hifazat-e-Islam group, resulting in major loss of official property and innocent lives. Often sporadic anti-government violence/

arson has continued for 48/72 hours, as was noticed during the last visit of Indian Prime Minister, Mr Narendra Modi to Bangladesh, to mark the 50th anniversary of Bangladesh freedom day in 2021. This has led to an angry, sullen reaction against the ruling AL from the large body of secular political leaders and people in Bangladesh, not to mention mounting concern in neighbouring India, resulting in an extremely delicate situation for Prime Minister

AL leaders and Ministers responded to the Embassy stand through a statement, questioning why the Ambassador did not feel it necessary to visit the Martyrs' memorial in built Dhaka, as a mark of respect to the numerous victims of Islamic fundamentalism during the BNP's rule. His controversial visit incidentally had occurred on the anniversary day for the memorial! The Dhaka-based mainstream as well as social media were sharply divided over the incident and its diplomatic fallout. Some analysts maintained that the US had strongly sent yet another strong public signal about their uneasiness with the ruling AL regime and obvious preference for the BNP. Some years ago, Western analysts and activists had even indicated that they felt 'more at home 'with the BNP than with the AL, during an interaction, as reported in Bangladesh media at the time. Kolkata-based analysts point out that perhaps the explanation of the apparent US bias against the ruling AL was rooted in history. Bangladesh was established through a hostile break-up of pro-West US ally Pakistan in South Asia. The US, though it was forced to recognise Bangladesh and acknowledge existing realities, had never forgiven the AL, the party that led the struggle for East Pakistan's freedom, as well as Russia and India, for their open-ended support for the liberation

It had resulted in a major embarrassing defeat for US/ Western policy/diplomacy and much loss of face. Whether the Democrats or Republicans were in power in the US was not important -- the basic pro-Pak thrust in its diplomacy in South Asia had remained the same. (IPA)

### BJP worried about Rahul Yatra impact in Haryana, Kashmir

Having failed in its design to malign and create hurdles in the path of Rahul Gandhi's Bharat Jodo Yatra, Narendra Modi has finally resorted to the strategy of hitting below the belt. As an obedient colleague, the Health Minister Mansukh Mandaviya conveyed the directives of Modi to Gandhi to suspend his Yatra "in the national interest" if he could not be follow the "protocol"

Mandaviya through his letter to Gandhi tried to create an impression that Modi and his minister were really worried of the alleged resurgence of the dreaded covid 19, but this letter and his subsequent jibe at the Gandhi family that the enormous mass support to the Yatra has frightened Modi to the extent that he even preferred to stake his prestige. His letter has ominous intent is evident from his saying; "I cannot neglect my duty of stopping potential Covid spread just because one family perhaps believes it's above the rules... No one is entitled to special treatment."

The lingering shadow of losing the 2024 Lok Sabha election has been so frightening that this minister came out with an oblique threat. It is certainly not tough to comprehend that he wrote the letter to Rahul out of frustration at the success of the rally and deep incubation of his vengeance. Lest there was no need to mention the word one family"

This is the other form of Narendra Modi's jibe of dynastic politics. On December 20, the day Yatra was in Rajasthan, Mandaviya in his letter expressed apprehension that people of Rajasthan would get infected with Covid. But on December 21, when the Yatra entered into Haryana, not a single case of Covid was mentioned by the minister in his

letter. He wrote "several people" have caught the virus after participating in the yatra and cited Himachal Chief Minister Sukhvinder Singh Sukhu as an example. If the Covid had infected large number of people, why then only Sukhu's name was cited. In all fairness, Mandaviva should have mentioned the total number of the infected number of people. It would not be astonishing if after the veracity of his assertion being challenged his department now may come out with detail number.

Besides the Yatra hurting the electoral prospect of Modi at 2024 Lok Sabha, yet another issue that cajoled the government to take to this step is the unconceivable response of the people of the valley who have been living under the shadow of the state power. The government is not sure how the Kashmiris would react to the situation. If the people of the BJP ruled states, Karnataka, Madhya Pradesh and even Haryana come out on the streets in lakhs, this number may multiply many fold. People coming out on streets would expose the claims of having restored peace and order in the valley and its justifying scrapping of 370, which is being heard in the Supreme Court.

In his letter Mandaviya wrote: "I request [Rahul Gandhi] that Covid protocol, including use of masks and sanitisers, be strictly followed during the march and only those who are vaccinated be allowed to

What is most surprising is he has asked the vaccinated vatris, the participants, to carry the certificate, which was even not necessary when the Covid was at its peak. This is indeed a tactics to substantially reduce the number of participants. Obviously a reduced number of participants would not have the desired impact and the BJP and Modi government could get the opportunity to claim that the Yatra was not welcome by the Kashmiri

The game of the Modi government is out in the public domain, even before it could make a significant dent. Even the Bihar Chief Minister Nitish Kumar ridiculed Modi government for raising an alarm over a fresh COVID-19 spike at a time when Rahul Gandhi's Bharat Jodo Yatra was gaining momentum. He said; "It should be known why they (the ruling BJP at the Centre) had become laidback over Covid in the first place, and why they have certainly become vigilant now when the Congress people are taking out a yatra".

Kumar also sought to know; "Why do these people have an objection to that yatra? Why do they themselves keep taking out

Mandaviya acted on the letter written by three BJP members of Parliament from Rajasthan, P PChaudhary Nihal Chand and Devji Patel claiming that Covid-19 is spreading in the state due to the Bharat JodoYatra. Though they alleged that

coronavirus was spreading, they could not site a single example. They alleged that Bharat Jodo Yatra has not been following Covid protocols. These members probably were not aware that curbs have been lifted. The eminent Supreme Court advocate Prashant Bhushan underlines the ignorance of these members. They in their letter to Mandaviva argued that the Vaccinated will not get and spread Covid and will not get sick. Bhushan pointed out "Now all studies are showing that the Vaccinated are more likely to get Covid and get sick." He seeks to know; "Will these people be held accountable for fooling & harming us?

Nevertheless their allegation is akin to the complaints lodged by the saffron vigilantes across the country against the secular, socialist forces and especially against the Muslims. At the complaints of the vigilantes police arrests the alleged offenders and are jailed. These members did not raise the issue of violation of covid protocol even in Parliament, Members of the house are not wearing the masks. The MPs had requested that Covid protocols, including the use of masks and sanitisers, be strictly followed during the march and only those who are vaccinated be allowed to participate. The MPs also requested the Union minister to ensure that participants are isolated before and after taking part in the march.

One development that sprang out of Wednesday's meeting of experts and senior officials, chaired by the minister was observation of the review meeting that there was no overall increase in caseload as of now. Of the three cases of the Omicron subvariant BF.7 two were detected in Gujarat where Modi held rallies and road shows and one from Odisha. (IPA)

### BJP alleges Gandhi family 'most corrupt family' in Indian politics

day dubbed the Gandhi family as "kattar paapi parivaar" and the "most corrupt family in Indian politics" as it cited the Rajasthan High Court's rejection of Robert Vadra's plea to quash a money laundering probe against

BJP spokesperson Gaurav Bhatia said Rahul Gandhi and Sonia Gandhi should break their "silence" on corruption and money-laundering allegations against Vadra, who is married to Rahul's sister and Congress general secretary Priyanka Gandhi, when their party was in power in Haryana and Rajasthan and at the Centre as well. The Congress has often claimed that the corruption charges against Vadra are politically motivated. The Rajasthan High Court had last week rejected a petition seeking the quashing of an Enforcement Directorate (ED) investigation into the purchase of land in Bikaner by a company (Skylight Hospitality), linked to Vadra and his mother, through alleged shady means. "This is a 'kattar paapi parivaar' (extremely immoral family) of India. Its only work has been to do corruption and grabbing land to hand over to Vadra," Bhatia alleged. The BJP spokesperson also rejected the Congress's claim of witch hunt against Vadra, claiming that it amounted to casting aspersions on the judiciary which has refused to quash charges against him. "They are the most corrupt family in Indian

on bail in corruption cases. It is a serious matter of concern for a government with zero tolerance for corruption," he said, in reference to the corruption probe against Sonia Gandhi and Rahul, both former Congress presidents, in the National Herald case. Bhatia cited the details of the case against Vadra in Rajasthan and said the Congress government there during 2008-13 acquired land and allotted it to non-existing people. Huge parcel of land ended up in the ownership of the company in which Vadra and his mother were partners through a maze of transactions involving fictitious entities, he alleged. ### Court acquits man of charge of possessing 2 bottles of non-duty paid liquor

court here has acquitted a man charged under the Delhi Excise Act for possessing two bottles of non-duty paid liquor labelled for sale in Haryana only', noting the FIR number was mentioned on documents which were prepared prior to the registration of the offence.

The court was hearing a case against Dinesh Kumar, who was accused of possessing two 750 ml bottles of "illicit liquor" one whisky and one vodka bottle at a hotel in Kapashera on January 25, 2021. He was accused of possessing the liquor without any permit or licence, knowing the same to have been unlawfully imported, transported or manufactured or knowing the prescribed duty was not paid.

"This court hereby accords the benefit of doubt to the accused and holds the accused not guilty of commission of the said offence. Accused Dinesh Kumar is thus, acquitted of the offence under sections 33 and 38 of the Delhi Excise Act," Metropolitan Magistrate order passed last week. plained, thereby blemishtampering with the case Section 33 of the Delhi Ex- ing the story of prosecu- property, the court said.

Also, no sincere attempts were made by the police to join public witnesses in the present case, the court said. The court noted while Rana spoke about handing over duly sealed and completely filled liquor bottles, when the case property was produced in court, one bottle was unsealed and the other contained "very little liquid." The joint inspections are being conducted all over the country according to the standard operating procedures on the directions of Union Health Minister Mansukh Mandaviya, a health ministry statement said. An action plan for the

manufacturing units which are identified to be at the risk of manufacturing not of standard quality, adulterated or spurious drugs was made prior to the inspections, according to the statement. A committee of two joint drugs controllers has been constituted at the CDSCO headquarters to monitor the process of inspection, reporting and subsequent action so as to ensure compliance with the

nationwide inspection of Drugs and Cosmetics Act, 1940 and Rules, the statement said. This will ensure high standards of quality compliance with respect to drugs manufactured in the country. The objective of drug regulation is to ensure safety, efficacy and quality of the drugs available in the country. The drug control administration is required to ensure that manufacturing units comply with the Drugs & Cosmetics Act and Rules.

The courts also dealt with litigation related to the Elgar Parishad-Maoist links case of 2017 with some of the accused getting relief. In February, Nationalist Congress Party (NCP) leader and former minister in the then Maha Vikas Aghadi (MVA) government Nawab Malik moved the Bombay High Court, seeking to quash an alleged money laundering case registered against him by the Enforcement Directorate. The ED case is related to a land deal in Mumbai in which associates of fugitive gangster Dawood Ibrahim were involved. Malik's plea is still pending.

In March, the ED arrested Malik in the case and subsequently a special court for the Prevention of Money Laundering Act (PMLA) cases rejected his bail applications. Malik has now moved the High Court for bail. April saw another highprofile case when Mumbai Police arrested Navneet Rana and her husband, MLA Ravi Rana after they announced that they would recite the Hanuman Chalisa outside then Chief Minister Uddhav Thackeray's private residence 'Matoshree' in Mumbai. About ten days later, the couple was granted bail by a court. But arguably, the case that dominated headlines the most was that of Rajya Sabha MP Sanjay

Following her problematic judgments delivered in January and February 2021, the Supreme Court collegium had withdrawn its recommendation to appoint her as a permanent HC judge. In April 2022, the High Courtwashearingapleafiled activist Navlakha, arrested in the Elgar Parishad `Maoist links' case, seeking that he be put under house arrest instead of being kept in prison owing to his health issues. The HC was bemused when it learnt that the prison authorities had refused to hand over to him a book by English humour author P Wodehouse, sent

Navlakha's family. The High Court, though, rejected Navlakha's plea for house arrest. The plea was later allowed by the Supreme Court.

In April, Bollywood actor Salman Khan moved the Bombay High Court challenging the summons issued to him by a magistrate's court on a complaint filed by a journalist over a 2019 dispute. The HC stayed the summons. On September 19, the High Court rejected a bail plea filed by former Delhi University professor Hany Babu, an accused in the Elgar Parishad case, noting that on the face of it there was substance in the allegations against him.

In September, the HC directed the Mumbai civic body demolish unauthorised construction at Union minister and BJP leader Narayan Rane's bungalow in Juhu area, noting that it had violated Floor Space Index (FSI) and Coastal Regulation Zone (CRZ) rules. Anil Ambanigot relief from the High Court in the same month when the court directed the Income Tax department not to take any coercive action against the industrialist on a showcause notice seeking to prosecute him under the Black Money Act. On October 14, the Nagpur bench of the HC acquitted ex-Delhi Univeroverturning his conviction in an alleged Maoist links case. The order has been stayed by the Supreme Court on an appeal filed by government agencies.

On November 18, the High Court granted bail to scholar-activist Anand Teltumbde, yet another accused in the Elgar Parishad-Maoistlinks case, noting that prima facie there was no evidence to show that he was an active member of the banned terror outfit CPI (Maoist) or had indulged in any terrorist act. Between July to September, the National Investigation Agency (NIA) arrested 11 people for allegedly killing Amravatibased pharmacist Umesh Kolhe for sharing social media posts backing BJP leader Nupur Sharma's controversial remarks about Prophet Mohammad.

In December, the NIA filed a charge-sheet against the accused, stating that radicalized Islamists of the Tablighi Jamaat were involved in the murder. (PTI)

The incident happened near Kadakola around 1.30 PM when their car, on the way to Bandipur, is said to have hit the road divider. Mysuru superintendent of police Seema Latkar has visited the spot and the hospital, sources said. A doctor at the hospital said: "all were stable with minor injuries when they came, they were immediately attended and are out of danger without any major bleeding. In an action taken report tabled in Parliament last week, the ministry of external affairs said it has noted the parliamentary panel's observations and will work towards addressing them. India's development partnership with Afghanistan includes more than 500 projects spread across each of its 34 provinces and in various sectors. "Several proposals in this regard are already under process. Due to the political and security situation in Afghanistan, projects

#### Ramesh to move SC against BJP MP Pragya Thakur over 'hate speech'

Congress leader Jairam Ramesh on Tuesday said BJP MP Pragya Singh Thakur's remarks at a function in Karnataka's Shivamogga are a clear example of hate speech and he would move the Supreme Court against her.

Ramesh said he would file a case against Thakur in the apex court as the police in Karnataka would not act against the Bharatiya Janata Party (BJP) MP. Karnataka is currently being ruled by the BJP and the Assembly polls are due in the state early next year. "BJP MP Pragya Singh Thakur's remarks made in Karnataka are a clear example of hate speech and I would be moving the Supreme Court against her for making such remarks," the former Union minister told news agency PTI. The former Union minister said Thakur's remarks clearly seek to divide the society, while claiming that the local police would not act against her since the BJP is in power in the southern state. Thakur said Hindus have the

right to respond to those who attack them and their dignity as she spoke about the killing of Hindu activists. She also called on Hindus to at least keep the knives in their homes sharp, as everyone has the right to protect themselves. Speaking at the Hindu Jagarana Vedike's southern region annual convention at Shivamogga on Sunday, the BJP MP from Bhopal in Madhya Pradesh told the gathering to give a befitting reply to anyone who "infiltrates our house". "Keep weapons in your homes. If nothing else, at least keep the knives used to cut vegetables sharp.... Don't know what situation will arise when.... Everyone has the right to self-protection. If someone infiltrates our house and attacks us, giving a befitting reply is our right," she said. "Love jihad. They have a tradition of jihad. If nothing, they do love jihad. Even if they love, they do jihad in that. We (Hindus) too love, love the god, a sanvasi loves his god.' Thakur said. (PTI)

### Mock drills held in hospitals across country to check Covid readiness

hospitals across the country held mock drills on Tuesday to check preparedness of health facilities to deal with any spurt in Covid-19 cases, with Union health minister Mansukh Mandaviya saying it was important to gauge operational readiness of

equipment and human Mandaviya resources. oversaw the drill at the Centre-run Safdarjung Hospital here, while health ministers reviewed the drill in their respective states. The Centre has asked states and Union Territories to conduct drill as part of precautionary measures following an increase in infection in China and other countries. Officials said the mock drill focused on parameters such as the availability of health facilities in all districts, the capacity of isolation beds, oxygen-supported beds, ICU beds and ventilator-supported beds, and optimal availability of doctors, nurses, paramedics, AYUSH doctors, and other frontline workers, including ASHA and Anganwadi workers.

Mandaviya said the drill was necessary to know how prepared our hospitals are. "Covid cases are rising all over the world and India might witness a spike in cases too. Hence it is important that the entire Covid infrastructure in terms of equipment, processes and human resources are in a state of operational readiness", the health minister stated. Clinical readiness at hospitals is crucial, Mandaviya said while noting that government as well as private hospitals are undertaking mock drills. Cautioning against complacency, he urged everyone to  $% \left( 1\right) =\left( 1\right) \left( 1\right$ follow Covid Appropriate Behaviour. He also asked people to refrain from sharing unverified information and ensure high level of preparedness. India recorded a single-day rise of 157 new Covid-19 cases, while the count of active cases of the disease has marginally decreased to 3,421, according to Union health ministry data updated on Tuesday. In the national capital, the drill took place at the LNJP Hospital and other government-run facilities.

Some of the private hospitals are expected to take up the exercise later in the day. Deputy chief minister Manish Sisodia, who also holds the health portfolio, visited the Delhi government-run Lok Nayak Jai Prakash Narayan (LNJP) Hospital around noon to assess the drill. "The Delhi government is prepared for any kind of emergency. At LNJP, there are 2,000 beds and 450 of them are marked for Covid-19. If a need arises.

Covid-19... we can also increase this number by using nearby banquet halls and add an additional 500 beds for Covid-19, so there would be no shortage," Sisodia told reporters at the hospital. The deputy chief minister asked people not to panic, saying

State medical education minister Vishvas Sarang said the Covid-19 situation in Madhya Pradesh was under control and not a single positive case was reported from the state in the recent past. Officials in West Bengal said the mock drill was conducted at Kolkata-based hospitals including MR Bangur Hospital, Infectious Diseases and Beleghata General Hospital, Medical College Hospital Kolkata, RG Kar Medical College and Shambhunath Pandit Hospital besides Dr BC Roy Post Graduate Institute of Paediatric Sciences. All private hospitals in the city and one hospital each in the districts are also taking part in the drill, the official added. "We are ready to face any situation in case there is any surge in Covid-19 cases. It's an exercise to keep a check on our preparedness. At the moment, the Covid-19 contagion is totally under control and there is no reason to panic. The state has enough testing facilities and we are ready to face any situation," Director of Health Services (DHS) Siddhartha Niyogi told news agency PTI.

Karnataka health minister K Sudhakar said Covid response mock drills are in place in all districts and talukas across the state. He said the BF.7 variant of Covid-19 is transmissible with low virulence, but emphasised that senior citizens, children and pregnant women must remain cautious. (PTI)

### Anubrata gets bail in attempt to murder case

DUBRAJPUR, DEC 27 /--/ A court in West Bengal's Birbhum district on Tuesday granted bail to TMC leader Anubrata Mondal in an attempt to murder case. Mondal, arrested by the CBI in August in the cattle smuggling case, was booked by the police under IPC sections 323 (voluntarily causing hurt), 325 (causing grievous hurt) and 307 (attempt to murder) on the complaint of a TMC worker who alleged that he was assaulted. The sub-divisional court in Dubrajpur granted bail to Mondal when he was produced, after the expiry of his seven-day police custody. Public prosecutor Rajendra Prasad Dey said: 'The investigating officer prayed for police custody but the court after examining the case diary and other records granted him bail. On behalf of the state, I opposed the bail petition.

The police complaint was filed by one Shibthakur Mondal, who alleged that the TMC Birbhum district president had attempted to kill him by throttling him about six months back. The police registered a case and moved the court on December 19, securing a production warrant for Mondal, who was in judicial custody in Asansol. The timing of the assault case raised questions as the Enforcement Directorate was preparing to take him to Delhi for questioning in the cattle smuggling case on the order of a court in the national capital. After he was given bail in the assault case, Mondal was taken back to the Asansol correctional home where he will continue to stay in the cattle smuggling case. "Whatever happened, I am okay with that," the TMC leader told newspersons after the bail order. (PTI)

### Dense fog cloaks Delhi, cold wave in parts of city



national capital reeled under a cold wave as dense fog blotted out the sun on Tuesday morning, lowering visibility to just 50 metres and affecting road traffic and train

Fifteen trains to and from Delhi were reported running late while two were rescheduled, a Railways spokesperson said. At 5.6 degrees Celsius, Delhi's minimum temperature was less than that of Dharamsala (6.2 degrees Celsius), Dehradun (7 degrees Celsius), and Nainital (7.2 degrees Celsius). With a high windchill factor -- a measure of the rate of heat loss from skin that is exposed to the air -- in play, cold day conditions prevailed in some parts of the city such as Palam and Jafarpur. A cold day is when the minimum temperature is less than or equal to

maximum temperature is at least 4.5 degrees below normal. A severe cold day is when the maximum is 6.5 degrees or more below normal. The windchill factor is based on wind speed -- the higher the wind speed during cold weather, the colder it feels on the skin if a person is outside. Delhi clocked a top wind speed of 16 kilometres per hour on Tuesday. The national capital shivered under a 'severe' cold day on Monday, with the maximum temperature dropping 10 notches below normal at some places. The Safdarjung observatory, Delhi's primary weather station, recorded a maximum temperature of 15.6 degrees Celsius on Monday, six notches below normal and the lowest day temperature in December since December 17, 2020. On Tuesday, Safdarjung logged a minimum

temperature of 5.6 degrees Celsius -- a notch below normal. The maximum temperature settled at 17.2 degrees Celsius, three notches below normal.

Meteorologists attributed below-normal day temperatures to frigid north westerly winds barrelling through the plains and reduced sunshine due to foggy weather. Mahesh Palawat, vice president (meteorology and climate change), Skymet Weather, said a western disturbance led to a fresh spell of snowfall in the mountains on December 25-26 and cold northwesterly winds are now sweeping through the plains after its retreat. He said the wind chill factor was also high. Palawat said cold wave conditions in northwest India would abate from Wednesday under the influence of a fresh western disturbance. However, the relief is likely to be prevailed in some parts of the National Capital Region (NCR), Haryana, Punjab. west Uttar Pradesh and north Rajasthan on

According to the India Meteorological Department (IMD), 'very dense' fog is when visibility is between 0 and 50 metres, 51 and 200 metres is 'dense', 201 and 500 'moderate', and 501 and 1,000 'shallow'. In the plains, the IMD declares a cold wave if the minimum temperature dips to four degrees Celsius or when the minimum temperature is 10 degrees Celsius or below and is 4.5 notches below normal. A 'severe' cold wave is when the minimum temperature dips to two degrees Celsius or the departure from normal is more than 6.4 degrees Celsius

### PM Sharif pledges to eliminate terrorism from Pak

ISLAMABAD, DEC 27 /--/As Pakistan reels from multiple incidents of terrorism, Prime Minister Shehbaz Sharif has reaffirmed his vow to eradicate the menace amid criticism from ousted premier Imran Khan on the government's "failure" to curb militancy during its eight-month stint.

of the restive Khyber-Pakhtunkhwa province on Monday, Sharif said that the menace of terrorism was on the rise and the state would crush it very soon, the Dawn newspaper quoted him as saying. He said that with the help of provincial governments and security forces, the government would eliminate terrorism in all its forms. Sharif said that a meeting of the National Security Committee (NSC) would be summoned in a few days to take stock of the security situation. Commenting on the attack on a security compound claimed by the outlawed Pakistani Taliban (TTP) terror group in the restive Khyber Pakhtunkhwa's Bannu district last week, Sharif said it was heart-breaking and added that the law enforcement agencies conducted a successful operation, killing all terrorists who had taken over the compound.

Meanwhile, former prime minister Khan, who wants snap polls in the country at all costs and is likely to dissolve Punjab and Khyber Pakhtunkhwa assemblies, lambasted the Pakistan Democratic Movement (PDM) government for its "failure" to rein in terrorism after coming to power in April this year. During a Pakistan Tehreek-e-Insaf meeting at his residence in Lahore, Khan, the chairman of the party, claimed that his government had "controlled terrorism and was proudly leading the country towards making it one of the world's top tourism destinations". He expressed his concern over the situation at the Pakistan-Afghan border as well. He claimed there was a 52 per cent increase in terror incidents since April and chided the government for the resurgence of terrorism. "At least 52 per cent increase has been recorded in terrorism cases across the country that claimed some 270 precious lives and left over 550 people injured," the former premier said.

Separately, PTI party leader Fawad Chaudhry told reporters that terrorism was returning to Pakistan. He said that during its tenure, the PTI government was proudly projecting Pakistan as the world's top tourist destination, and now the nation was being pushed into the "fire of terrorism, and the embassies were issuing advisories to their employees to avoid five-star hotels" in Islamabad. The United States embassy on Sunday warned about a possible terror threat against American citizens at the Marriott Hotel in Islamabad and prohibited American staff from visiting the five-star facility. The Saudi Arabian embassy in Islamabad also issued a security advisory on Monday, instructing its citizens in Pakistan to restrict their

### China to reopen borders, scrap quarantine for international travellers from Jan 8

BEIJING, DEC 27 /--/Days after it faced nationwide antigovernment protests against its stringent zero-Covid policy, China in a major shift of its coronavirus response policies has announced that it will scrap quarantine for international travellers from January 8 as it reopens its borders and comes out of international isolation after

The National Health Commission (NHC) on Monday announced that Covid-19 management will be downgraded from Class A to B from next month, in the same category as less-severe diseases, such as Dengue fever. China will cancel inbound quarantine for international arrivals starting from January 8, 2023, it said. Previously passengers coming from abroad had to mandatorily stay in over two weeks of quarantine in government accommodations, which was gradually reduced to five days with three days' of observation. These announcements come at a time when the country is grappling with a sudden spurt in coronavirus infections fuelled by the Omicron variant after the Xi Jinping regime relaxed its stringent zero-Covid policy earlier this month following a wave of anti-government

Officials argue that the Omicron variant was not as lethal as the Delta strain, which caused massive casualties all over the world. Covid-19 has been managed as a top category 'A' infectious disease since 2020, putting it at par with bubonic plague and cholera, the Hong Kong-based South China Morning Post reported. Under Chinese laws, authorities must impose the toughest restrictions such as quarantine and isolation of the infected and their close contacts, and lockdowns to contain those diseases. At the border, the infected must be isolated and those who might be infected quarantined, depending on the incubation

The NHC also stopped announcing daily Covid cases from Sunday. The novel coronavirus first emerged in the central Chinese city of Wuhan in December 2019 before it turned into a pandemic. (PTI)

### Amid Ukraine conflict, Covid-inflicted crises, India emerges as voice of Global South

UNITED NATIONS, DEC 27 /--/ India emerged as a voice of the Global South during its two-year term in the powerful UN Security Council, which acrimoniously deliberated on Russia's invasion of Ukraine that led to unprecedented levels of global food and fuel insecurity as the world continued to grapple with inequalities amplified by the pandemic. Before relinquishing its non-permanent seat in the 15member Council on December 31, 2022, India presided over the powerful UN body in December with the country's first woman Permanent Representative to the UN Ambassador Ruchira Kamboj sitting in the President's seat at the horse-shoe table. Just about two months into India's second year of its 2021-2022 term on the Council elected non-permanent member, Russian President Vladimir Putin launched a eastern Ukraine on February 24. UN Secretary-General Antonio Guterres made a direct and strong appeal to Putin to "stop your troops from attacking Ukraine" and give peace a chance as the UN chief called the invasion the "saddest moment in my tenure as Secretary-General of the United Nations." As the Russian invasion unfolded, India's then UN envoy Ambassador T S Tirumurti in February underscored New Delhi's call for urgent deescalation of tensions and cautioned that the situation was in danger of spiralling into a major crisis.

In statements in the Council and the General Assembly throughout the year, India consistently called for an immediate cessation of hostilities and an end to violence. New Delhi emphasised that dialogue and

forward and actions that exacerbate the conflict should be avoided. "Our world faced many trials and tests in 2022 some familiar, others we might not have imagined just one year ago," Guterres said, adding that even in the brutal war in Ukraine, the power of determined, discreet diplomacy has helped people and tackle unprecedented levels of global food insecurity. India abstained on most resolutions related to the Russia-Ukraine war in the Security Council, General Assembly and the Human Rights Council, including on a Security Council procedural resolution to convene a rare emergency special session of the General Assembly.

The 193-member General Assembly, the representative body of the United Nations, convened the rare emergency session on February

Ukraine, only the 11th such emergency session of the UNGA since 1950. Kamboj, who took charge of India's Permanent Mission in New York in August, has asserted that in the course of the Ukraine conflict, India has "spoken in one voice that we are for peace. Peace is also a side and we favour diplomacy and dialogue We are among the few countries, dare I say, which are speaking to both sides." As the Ukraine conflict continued unabated through the months of 2022, India highlighted that its impact has not been limited just to Europe. The Global South especially is facing serious economic consequences, with growing concerns about energy and food security exacerbating the hardships unleashed by the Covid-19 pandemic. While India supplied 240 million doses of

countries, it also provided humanitarian assistance to Ukraine and economic support to some of its neighbours in the Global South under economic distress due to the ripple effect of the conflict. "We were there in response to humanitarian crises. All of this and more points to the fact that India is ready to take its place at the global top table as a country that is willing to bring solutions to the table and to contribute positively to the global agenda," Kamboj said. "Over the last two years of our membership of the Council, I can say with confidence that we have been shouldering responsibilities well, and making every effort to bridge the different voices within the Council so as to ensure that the Council itself speaks in one voice as far as possible on a variety of issues," she said. ### Western New York death toll rises to 28 from cold, storm chaos

hovered around space heaters, hunted for cars buried in snow drifts and looked for more victims Monday, after 28 people died in one of the worst weather-related disasters ever to hit western New York.

The rest of the United States also was reeling from the ferocious winter storm, with at least another two dozen deaths reported in other parts of the country. Up to 9 more inches of snow (23 centimeters) could fall in some areas of western New York through Tuesday, the National Weather Service said. "This is not the end vet." said Erie County Executive Mark Poloncarz, calling the blizzard "the worst storm probably in our lifetime," even for an area accustomed to punishing snow. Some people, he noted, were stranded in their cars for more than two days. President Joe Biden said his prayers were with the victims' families, and offered federal assistance Monday to the hard-hit state. Those who lost their lives around Buffalo were found in cars, homes and snowbanks. Some died while shovelling snow, others when emergency crews could not respond in time to medical crises

Melissa Carrick, a doula, said the blizzard forced her to coach a pregnant client through childbirth by telephone. An ambulance crew transported the woman to a hospital about 45 minutes south of Buffalo because none of the closer hospitals were reachable. "In any other normal Buffalo storm? I would just go because that's what you do just drive through the snow," she said. "But you knew this was different." Scientists say the climate change crisis may have contributed to the intensity of the storm. That's because the atmosphere can carry more water vapour, which acts as fuel, said Mark Serreze, director of the National Snow and Ice Data Center at the University of Colorado, Boulder, Victor Gensini, a meteorology professor at Northern Illinois University, likened a single weather event to an "at-bat" and the climate as your "batting average." "It's hard to say," Serreze said. "But are the dice a little bit loaded

now? Absolutely.'

Kathy Hochul toured the aftermath in Buffalo her hometown on Monday, calling the blizzard "one for the ages". Almost every fire truck in the city became stranded Saturday, she said. Hochul noted the storm came a little over a month after the region was inundated with another "historic" snowfall. Between the two storms, snowfall totals are not far off from the 242 centimeters the area normally sees in an entire winter season.

### South Korea's leader calls for stealth drones to monitor North

SEOUL, DEC 27 /--/ South Korea's on North Korean provocations. It was the president on Tuesday called for stronger air defences and high-tech stealth drones while the military apologised for failing to shoot down North Korean drones that crossed the border for the first time in five years.

South Korea's military scrambled warplanes and attack helicopters on Monday, but they failed to bring down any of the North Korean drones that flew back home or disappeared from South Korean

radars. It raised serious questions about South Korea's air defense network at a time when tensions remain high over North Korea's torrid run of missile tests this year. "We have a plan to create a military drone unit tasked with monitoring key military facilities in North Korea. But we'll advance the establishment of the drone unit as soon as possible because of yesterday's incident," President Yoon Suk Yeol

said during a regular Cabinet Council meeting. "We'll also introduce state-of-the art stealth drones and bolster our surveillance capability." He said South Korea's military needs more intensive readiness and exercises to cope with threats posed by North Korean drones. Lt Gen Kang Shin Chul, chief director of operation at the Joint Chiefs of Staff, said in a televised statement the military feels sorry because of its failure to shoot down the North Korean drones and for causing big public concerns.


Kang acknowledged South Korea lacks capacities to detect and strike small surveillance drones with a wingspan of less than 3 metres (9.8 feet) though it has assets to spot and bring down bigger combat drones. Kang said South Korea will establish drone units with various capacities and aggressively deploy military assets to shoot down enemy drones.



MELBOURNE, Dec 27 /--/ Opener David Warner battled through searing heat to hit an epic unbeaten 200 in his 100th Test on Tuesday before retiring in pain as Australia consolidated their advantage against South Africa at the Melbourne Cricket Ground. On a scorching day, the hosts were 386-3 at stumps on day two of the second Test, leading by 197 after the Proteas were dismissed in their first innings for 189. Travis Head was not out 48 with Alex Carey on nine. Steve Smith (85) and Marnus Labuschagne (14) were the only wickets to fall. But worryingly for Australia, Cameron Green, who took 5-27 in South Africa's first innings, also retired hurt after a nasty rap on the finger from Anrich Nortje. Smith and Warner's 239run partnership took the game further after reaching 200 and dropping to his

away from South Africa, whose bowlers toiled in temperatures touching 37 degrees Celsius (98.6 Fahrenheit). Warner, 36, snapped a near-three-year century drought in typically aggressive and gritty fashion, reaching three figures for a 25th time after coming into the game under pressure after a lean run. It was his first Test hundred since January 2020 and as the opposition bowlers tired, he battled the elements and converted it to 200 for only the third time. But it was an exhausting effort, as he passed 8,000 Test runs en route. Chairs had to be brought out for Warner and Smith to rest on in the drinks breaks, with towels draped over their heads and ice-packs around their shoulders. NEW DELHI, DEC 27 /--/ Jaydev Unadkat did get his much-awaited chance with the red ball and he kept his "promise" with a spirited effort in his first Test for India after 12 years. His love for the longer version of the game became apparent more than ever in January when he typed a tweet that went viral. "Dear red ball, please give me one more chance.. I'll make you proud, promise!" the left-arm pacer had posted. "Everyone thought that I was referring to a national comeback. I was just missing red ball cricket in general as Ranji Trophy was postponed for a second time (due to COVID)," Unadkat told PTI in an interview after his arrival from Bangladesh. The 31-year-old, who had played his first and only Test way back in 2010 with the great Sachin Tendulkar and current head coach Rahul Dravid

being his celebrated teammates, featured in his second outing last week in remarkable circumstances. Having not been on selectors' radar despite a recordbreaking performance in the 2020 Ranji Trophy, a national recall came for Unadkat when he expected it the least. He was not even part of the India A side that toured Bangladesh before the Test series, so one could not fault him for keeping his hopes to bare minimum. Eventually, his patience and perseverance prevailed as he was flown to



Bangladesh as a backup pace option, with Mohammad Shami not regaining full fitness for the series. ### Another year, another set of medals; Mirabai continues to rule Indian weightlifting

NEW DELHI, DEC 27 /--/ The legend of Mirabai Chanu continued to grow as she added a second World Championships medal to her muchdecorated trophy cabinet while other Indian lifters too revelled in the glory of a power-packed performance at the Commonwealth Games in 2022. They say winning is a habit and Mirabai has certainly made one. The lifter from Manipuri expectedly bossed the 49kg field at the Commonwealth Games to give India the first gold medal of the Birmingham edition.

It was not a question of if, but the margin of gold medal win as Mirabai was assured of title the moment she entered the not-so-competitive field. Such was her domination that the second-place Mauritian Roilya Ranaivosoa finished 29 kgs behind her. It was Mirabai's third CWG medal and second consecutive gold. The diminutive lifter ended the year with a bang, fetching a silver at the world championships, once again, giving everyone a master class in grit and determination. If she battled painful menstrual cramps to win the Tokyo Olympics silver last year, Mirabai overcame a wrist issue to claim her second world championships medal, adding to her 2017 gold. She lifted a total of 200 kg with 87kg in snatch and 113kg in clean & jerk. The clean and jerk effort also fetched her a silver medal in the section. But as another year passed, the much-anticipated 90kg snatch lift continued to elude her. And that is perhaps the biggest downer for the tenacious Mirabai, who has been trying to pull off that one lift since 2020 as more and more opponents achieve the feat in the run-up to the Paris Olympics. Earlier in July-August, the senior weightlifters set the ball rolling at Birmingham with Mirabai going on a record-smashing spree. Records continued to tumble with Jeremy Lalrinnunga claiming his maiden CWG gold medal, obliterating the Games record in snatch and total weight with an aggregate of 300kg (140kg+160kg). Achinta Sheuli too shattered the Games record in snatch and total lift on his way

to gold with an effort of 313kg(143kg+170kg).



Indian weightlifters bagged a total of 10 medals, including three golds as many silvers, and four bronze. While Mirabai (48kg), Jeremy (73kg) and Achinta (77kg) took home gold medals, Sanket Sagar (55kg), Vikas Thakur (96kg), S Bindyrani (55kg) fetched silver medals, and P Gururaja (61kg), Lovepreet Singh (109kg), Gurdeep Singh +109kg) and Harjinder Kaur (71kg) added a shade of bronze. India topped the medals tally in the sport in the tournament. But the lifters, barring Mirabai, were not able to take forward the CWG momentum. Most of them skipped the Asian and World Championships and for those who didn't, the gulf between them and the other lifters around the world was visible. Apart from Mirabai, the four other Indian lifters were placed in groups C and D, failing to finish even in the top 20 in the worlds earlier this month.. (PTI)

#### Argentina confident Scaloni will stay with World Cup winners

BUENOS AIRES, Dec 27 /--/ Argentina's football federation chief insisted Monday that coach Lionel Scaloni will remain with the World Cup winners. "Scaloni is the coach of the Argentina national team. We are both men of our word, we said yes to each other. I have no doubt that he will continue," Argentine Football Federation (AFA) president Claudio Tapia said. Scaloni, 44, has been in charge of the team since 2018, leading them to the Copa America in 2021 - Argentina's first international trophy since 1993. He then guided Lionel Messi and the squad to a third World Cup with victory over France in the final in Qatar earlier this month.

#### Prannoy regains career-best world no. 8 rankings

NEW DELHI, DEC 27 /--/ Star Indian shuttler HS Prannoy regained his career-best number eight position in the latest BWF world rankings issued on Tuesday. The 30-year-old from Kerala, who has been in good form this year, had achieved the number eight ranking in 2018 for the first time before slipping to 34 in 2019. However, some memorable performances in the season, including the Thomas Cup win, seven quarterfinals, two semifinals and a runner-up finish at the Swiss Open, saw him rise like a phoenix in 2022.

#### Ashleigh Gardner new No. 1 in women's T20I all-rounders' ranking

DUBAI, DEC 27 /--/ Australian all-rounder Ashleigh Gardner has overtaken West Indies skipper Hayley Matthews, India's Deepti Sharma and New Zealand captain Sophie Devine to attain a career-best No.1 spot in the latest ICC Women's T20I player rankings for all-rounders released on Tuesday. Following a closely-fought five-match T20I series, which Australia won 4-1, Gardner, who was named Player of the Match in the last game for her 32-ball unbeaten 66 and bowling figures of 2/20, has topped the allrounders' list for the first time after moving up three spots. Gardner (417 points) holds a big advantage over Devine (389) and Deepti (387) in second and third spots respectively, with Matthews dropping two places (381) to

### More than skin deep: Fans line up for Messi tattoos



BUENOS AIRES, DEC 27 /--/ Fans of the Argentine team that claimed football's ultimate prize in Qatar this month are lining up in Buenos Aires for tattoos of victorious captain Lionel Messi and the World Cup trophy. "For the next two weeks, I have (appointments) exclusively related to the World Cup," tattoo artist Esteban Vucinovich told AFP in the capital. "Some had already made an appointment for tattoos of snakes or skulls, but they are changing it to Messi or the Cup. I have two or three appointments a day," he said. The most requested skin art is of the trophy, said Vucinovich, followed by Messi and then goalkeeper Emiliano Martinez who was crucial in the victory of the Albiceleste in the final against France. Many fans are inspired by the body art of Argentine players such as Angel Di Maria, who has since recently sported a World Cup tattoo on his right leg. "I got a tattoo of

Messi as a gesture of thanks," civil servant Nicolas Rechanik told AFP. "This represents not only what Messi is but also the team that brought us a third World Cup and all the years of effort to reach this goal." Before getting the image of Messi in the team's blue-and-white striped jersey and kissing the trophy indelibly attached to his left leg, Rechanik already sported the likeness of another Argentine football icon: Diego Maradona. "It's a perfect representation of what Argentine football is and what it means to be Argentine," he said. Football fanatic Alma Ocampo, 20, decided to get a tattoo when, to everyone's surprise, Argentina lost its first match of the World Cup to Saudi Arabia. 'When everyone lost confidence, I decided that... if Argentina wins, I will get a tattoo of the Cup. And so I did, with the date December 18, 2022" of the final, she said, adding "it hurt quite a bit." (PTI)
