High Level Committee formed to resolve DBRAIT issues

Students told to approach this Committee with their issues, concerns

PORT BLAIR, SEPT 29/--/ The Chief Secretary and team of senior officers had a detailed discussion with a large delegation of stakeholders comprising of students of DBRAIT, leaders of various Political Parties, PRI members, representatives of important NGOs and Civil Society Organizations regarding various issues raised by students of DBRAIT. Chief Secretary emphasized that the academic future and interests of the students are paramount in the Administration's consideration and reiterated the resolve and commitment of the ANA to take all steps to secure the same.

It was noted that for the past few months, the students of DBRAIT have been protesting on various long-pending issues related to Pondicherry University, which is their affiliating university like nonrecognition of Diploma courses of MSBTE by Pondicherry University, non-extension of affiliation by University, non-conduct of exams for Lateral Entry students for last 2 years by the university etc. However, the ANA has been fully in support of the students' cause and is taking all measures with fullest vigour and force to ensure that

genuine interests of the students' are not affected due to any unilateral actions by any authority, especially PU.

Chief Secretary informed the gathering that many vexatious issues of PU with DBRAIT, which had remained unresolved for the past 3 years, were resolved after the consistent interventions, untiring endeavour and vigorous efforts of the ANA all stakeholders including Pondicherry University, Ministry of Education, GOI and relevant judicial forums. In this context, it was explained that the ANA has successfully resolved the following niggling issues, to the satisfaction of the affected student community at Port

1) Conduct of university examination for all students of DBRAIT.

2) Issuance of Timetable for exams of Lateral entry students (batch 2020-21 and 2021-22, including pending papers since 2

3) Re-issuance of timetable for exams of Lateral Entry students in a staggered manner. (batch 2020-21 and 2021-22 including pending papers since 2 years).

MP bats for workers employed in industrial establishment at DSS Dockyard

PORT BLAIR, SEPT 29/--/ Mr. Kuldeep Rai Sharma, Member of Parliament and President, INTUC (ANI) and Marine Works Employees' Union (MWEU), along with office bearers of MWEU and some contractual workers of Government Dockyard of Directorate of Shipping Services met the Chief on September 2022, to put forth grievances of the workers employed in the industrial establishment of the Government Dockyard of Directorate of Shipping Services.

Administration. major issue discussed was to provide enhanced wages i.e. 1/30th of the basic pay plus Dearness Allowance to the contractual employees of the Directorate of Shipping Services and posting of Assistant Labour Welfare (ALWC) Officer

Government Dockyard. Mr Shri Sharma informed the Chief Secretary that, there are around 150 contractual workers engaged by the Directorate for over 12 to 15 $\,$ years or even more who are entrusted with the nature of similar to that being performed by the regular employees but are paid monthly emolument calculated on the basis of minimum wages with conditions service remaining same as that of

Daily Rated Mazdoors. Inviting reference to the Government of India Office Memorandum no.49014/1/ 2017-Estt. (C) pf dated 04.09.2019, the Member of Parliament said that as the

nature of work entrusted to the casual workers and regular employees is the same, the casual workers need to be paid wages at the rate of 1/30th of the pay at the minimum of the relevant pay scale plus dearness allowance for work of 8 hours a day.

The Chief Secretary was appraised that, the Directorate of Employment Training,



Administration vide it's Office Memorandum 289 dated 22.09.2017 as an welfare measure adopted policy to enhance the wages of all such Daily Rated Mazdoors working in departments, various organisations autonomous bodies of the Andaman and Nicobar Administration as on 01.09.2017 at the rate of 1/30th of the Pay plus Allowance Dearness engaged against an existing vacancy of duly sanctioned post. Even though these contractual workers were engaged much prior to 01.09.2017 against the duly sanctioned posts, they were considered for enhancement of their monthly wages because of the nomenclature of their engagement being 'short

Mr. Kuldeep Rai Sharma further informed the Chief Secretary that in addition to hese long serving 150 odd contractual workers, the Directorate of Shipping Services has engaged around 45 industrial workers such as welders, fitters etc. who are continually being engaged on contract against the vacancy of relevant sanctioned posts and are paid monthly emolument of Rs.18,000/- which is the minimum basic pay of the Mazdoor or monthly wage of Rs.19470/- calculated taking into consideration the minimum daily wage for skilled workers. Since, these industrial workers such welders, fitters, electricians, shipwrights, carpenters, tinsmith, mechanics, etc. who are ITI certificate holders having specialised skills in the relevant trade and are engaged on passing the trade test for the post and are entrusted with the nature of works similar to the regular employees, the Chief Secretary requested to consider paying these industrial workers monthly pay at the minimum of relevant pay scale of post plus Dearness Allowance against which they are engaged.

The Chief Secretary assured the representatives of the Marine Works Employees 'Union that the administration will look the matter sympathetically to cause relief to the contractual employees of Directorate of Shipping Services as permissible under rules.

PFI module had planned attacks on Jews visiting Tamil Nadu hill station, say NIA officials

The Popular Front of India (PFI) has been extensively using social media for recruiting youths for antinational activities and one of the modules of the nowbanned outfit even had prepared attack foreigners, especially Jews visiting Vattakkanal, a hill station in Tamil Nadu, officials said.

According investigation carried out by the National Investigation Agency (NIA), the module comprising about 15 youths and their associates from southern states, mostly PFI members or those attracted to the global terror group ISIS, had also conspired to attack high court judges, senior police officers and Muslims belonging to Ahmediya sect with the intention of committing terror acts within India. The module had allegedly entered into criminal conspiracy to wage a war against the government by collecting explosives and

Union finance minister asks Karnatakato do branding during G-20 meetings BENGALURU. SEPT 29 /-

-/ Union finance minister NirmalaSitharaman on Thursday said most of the G-20 meetings next year will be held at several destinations across the country, including those in Karnataka, and called on the state to do its branding. and to identify its products. which can be showcased.

She also requested the Chambers of Commerce to work together with those industries, particularly small and medium, and those particularly working handicrafts and traditional Karnataka products, so that they are showcased and the benefit of G-20 coming to the state is reaped fully. "Next year, India is going to hold the chair for G-20. The 20 countries and multilateral institutions which are invited to participate will be moving all over the country.



The Prime Minister has said G-20 meetings will happen not just in Delhi, most of them will happen outside of Delhi, and there are several destinations in Karnataka where the meetings will be held,' Sitharaman said. She said, "I hope and earnestly wish, and I will certainly do my bit for Karnataka to do its branding, to identify those products, which can really be branded and showcased during the G-20 meetings. It will immediately attract the attention of the top leadership which will be moving across the country during the course of next

The Finance Minister, who is Member RajyaSabha from Karnataka was addressing the 105th Annual General Meeting of Federation of Karnataka Chambers of Commerce and Industry (FKCCI) here. Noting that next year is the "year of millets" and Karnataka is the lead producer of millets in the country, Sitharaman, while highlighting its processing said millet is the "gold for wellbeing", all over the world there is a market for it. "All over the world there is a market for it. India is the largest producer and third largest exporter of millets, but value addition is what is going to be important. she said, while observing that there is a need for a lot of startups to look at innovative ways of doing it. target important persons and places of public importance, the officials said. The module -- Ansarul-Khilafa Kerala -- was also indulged in a secret campaign of recruiting, motivating and radicalizing Muslim youths to join ISIS/ ISIL, they said, adding the associates used various internet based platforms (both surface and deep web) for propagating ISIS ideology. Active

surveillance mounted by the investigators found five suspects namely Manseed, Swalith Mohammed, Rashid Ali Safvan and Jasim NK, and they were arrested from Kannur district in Kerala on October 2, 2016 while they were holding a conspiracy meeting as part of their preparation to allegedly wage a war against the government.

Later, searches were conducted at the residence of the accused and materials, including digital

interrogation revealed that accused communicated with coconspirator within and outside India over social media platforms like Facebook, Telegram, etc to allegedly wage a war against the government, the officials said. One of the accused. Swalith disclosed Mohammed, about the receipt of funds from his associates in the UAE for funding their activities. The accused had conspired and propagated ISIS ideology directly and through social media and recruiting members for antinational activities. They created various Telegram groups like 'The Gate', 'Bab Al Noor', 'Play Ground', etc, the officials said. Investigation has established that accused had knowingly and intentionally conspired and conducted preparation to foreigners. attack

prominent political leaders at Kozhikode, Kerala, and to attack a programme of Jamaat-e-Islami at Kochi,

the officials said. Vattakkanal is a small scenic hill station in Tamil Nadu's Dindigul district where every year hundreds of Israeli youths arrive for vacation after their compulsory military service in Israel. The NIA investigations have also found that one Shajahan, a Kerala resident, who was working on ISIS terror network in India, had earlier visited Turkey/Syria for allegedly carrying out terror activities and was deported from there. The NIA also found that Shajahan had joined the National Democratic Front, which was the earlier avatar of the PFI, and gradually got indoctrinated leaders. He came in contact with PFI leaders namely Haris, Shabeer, Manaf, Mustafa, Sadik, Shajil and

the discussions were made on atrocities committed on the Muslims by the "nonbelievers" in India and other parts of the world, the officials said, adding that particularly, Shameer, the then divisional president of the PFI's Valapattanam indoctrinated unit, Shajahan with the ISIS ideology. After declaration of Caliphate by Abu BakarBagdadi of the ISIS, Shameer motivated Shajahan to go for 'hijra' as per Hadis and Quran for waging jihad. As directed Shameer who was already in Syria, Shajahan along with his wife and two sons went to Malaysia in October 2016 enroute to his final destination Syria, the officials said. In Malaysia, Shajahan was met by one Rasheed and they moved to Iran from Malaysia. In Iran, Shajil and his family and Midlaj joined this group via Mangalore-Dubai-Iran, then further proceeded to

Abdul Manaf PP in Turkey. In February 2017, when Shajahan and Abdul Manaf PP along with their families attempted to cross over to Syria, law enforcement agencies of apprehended Shajahan and deported to India on February 10, 2017. However, Abdul Manaf

managed to cross the border. After his earlier failed attempt, Shajahan again planned to go to Syria for 'hijra' in March 2017. He acquired Indian passport on forged identity Mohammed Ismail Mohideen with the help of one travel agent Mustafa, the officials said. This time Abdul Khayoom and Abdul Razak also planned to go to Syria with Shajahan for 'hijra'. Shajahan had reached Iran from Bangkok, they said. While Khayoom managed to cross over to Syria, Shajahan Razak apprehended again in Turkev and deported to India on July 1,2017, the officials said. (PTI)

BJP throttling democracy by not conducting assembly polls in J&K: Cong

SRINAGAR, SEPT 29 /--/ JammuandKashmirPradesh Congress Committee (JKPCC) on Thursday accused the BJP of throttling democracy by not conducting the assembly elections in the union territory, saying it was a ploy of the ruling party at the Centre. On PFI ban, the JKPCC president Viqar Rasool said that outfit was not present in J-K and the AICC will respond to that. However, he sought a ban on the RSS as well. "RSS naturally is criminal organisation. They should ban it too and you should see their past record. Today, Mohan Bagwatii sometimes visits mosques, which is a criminal history," he said. Rasool said the last assembly election in J-K took place in 2014 and it has now been almost nine years with the polls for the new assembly. 'The elections are being deferred continuously. Timely elections are the beauty of democracy. If the elections are conducted on time in other states of the country, then why not in J-K?" reporters here. (PTI)

2020 Delhi Riots: Courtdischarges 10 accused from the offence of destroying house by fire

NEW DELHI, SEPT 29 /--/ A court here has discharged 10 accused from the offence of allegedly destroying house by fire in a case related to the 2020 northeast Delhi riots. The court, however, said that they will face charges for rioting. The court was hearing a case where the accused persons allegedly engaged in rioting and torched the complainant's vehicle parked on a road in the Maujpur area on the morning of February 25, 2020. Noting that the charge for the offence of mischief by fire or explosive substance with intent to destroy house was not made out as the complainant's vehicle was allegedly burnt onthepublic road, Additional Sessions Judge Amitabh Rawat transferred back the case only for the offence of rioting to the magisterial court concerned. officers for adultery: SC Thursday said that armed forces must have some kind of mechanism for disciplinary proceedings against their officers for adultery as "this is a conduct that can shake up the life of officers. The top court said adultery creates "pain" in a

family and it should not be treated in a lighter manner. 'In uniformed services, discipline is of paramount importance. This is conduct that can shake up the life of officers. Everybody is ultimately dependent on the family as a unit of society. The integrity of society is based on the faithfulness of one spouse to another. "This (adultery) is going to shake the discipline in the armed forces. Armed forces must have some kind of assurance that they will take action. How can you cite Joseph Shine (judgement) and say it cannot be," said a five-judge Constitution bench headed by Justice K M Joseph. It said the apex court 2018 judgement, which

declared penal provision on adultery as unconstitutional, cannot be referred to halt disciplinary proceedings against guilty. "Adultery creates pain in a family. We have held so many sessions as judges in the high courts and seen so families are torn. We are telling you that do not treat this in a lighter manner. There was one incident where the mother, who committed adultery filed a habeas corpus plea seeking custody of her children. They (children) refused to talk to the mother. That's the kind of hate that happens," the bench observed.

The top court, on a plea filed by NRI Joseph Shine, in 2018 had struck down Section 497 of the Indian Penal Code, dealing with the offence of adultery while holding it unconstitutional. The observations by the bench, also comprising Justices Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy, and CT Ravikumar came after Additional Solicitor General Madhavi Divan, appearing for the Centre, submitted a plea seeking clarification of the 2018 judgement has been

The Ministry of Defence (MoD) had moved the apex court saying that the September 27, 2018 judgement striking down adultery as an offence could come in the way of armed forces personnel being convicted for adulterous acts. She told the bench that disciplinary actions were taken against certain army personnel for adultery, however, the Armed Forces Tribunal (AFT) quashed such proceedings in many cases, citing the Joseph Shine judgement. "We are seeking that striking down of section 497 will not come in the way of armed forces taking action against officers for unbecoming conduct," Divan said.

The ASG informed the apex court that disciplinary actions taken in the Army are gender neutral and even if a female officer is found to be indulging in adulterous activities, she will also face action for misconduct. The top court said there was nothing in the 2018 judgement which precludes the armed forces and it can challenge the individual orders of the AFT. The ASG sought time to go through the 2018 judgement in detail. The top court then posted the matter for hearing on December 6. (PTI)

'Bharat JodoYatra' posters found torn a day before its Karnataka entry

BENGALURU, SEPT 29 /--/Some posters put up to welcome leaders to the Congress' 'Bharat Jodo Yatra' were found to be torn at Gundlupet in Chamarajanagar district on Thursday, a day before it is set to enter

Reacting sharply, the Congress said, "The $40\,\%$ Commission BommaiGovt is already getting the jitters". The BJP's Bharat Todo Team of paid goons has been pressed into service to destruct, destroy and tear up posters, the Congress incharge of Karnataka Affairs, Randeep Singh Surjewala alleged. "They'll never be able to stop the war cry against Price Rise, Unemployment, Disparity& Divisiveness", he

Congress state president DK Shivakumar alleged that a few posters were torn and burnt by the BJP. 'Preparations are afoot to receive the 'Bharat JodoYatra' but the BJP people have torn and burnt some banners. We will not be cowed down. We have faced enough of such things. They (BJP) should know this," Shivakumar told reporters in Chamarajanagar. He demanded that the police initiate action against those who tore the banners. "Let them (police) refuse to take action, then we will speak rest of the things," Shivakumar said.

The Congress lodged a police complaint in this connection in the police station concerned, sources close to the Congress state president said. Chief ministerBasavarajBommai said: "All know who is doing 'BharatJodo' and who's doing 'Thodo". Addressing reporters in the district headquarters town of Haveri, Bommai said let Shivakumar comment on the incident, permission must be obtained for putting up posters.

The BJP need not tear the posters of any political party. Since people knew "everything," there was no need for him to say much about it, the chief minister said. Sources close to Shivakumar said the Congress leaders lodged a complaint at the police station concerned against those who tore and burnt the banners. (PTI)

PFI must be held accountable for hartal violence

Deposit Rs 5.2cr with govt: Kerala HC

KOCHI, SEPT 29 /--/ The Kerala High Court on Thursday directed banned outfit PFI and its ex-state general secretary to deposit Rs 5.2 crores with the Home Departmenttowardsdamages estimated by the KSRTC and the state government in connection with the hartalrelated violence September 23, saying they must be held accountable for

Expressing concern that

the state administration "did virtually nothing to prevent the hartal organisers from going ahead with their illegal demonstrations incidental road blockages" despite a 2019 HC order against it, the court said Abdul Sathar, ex-state general secretary of PFI, be made an accused in all thehartalviolence related cases. A bench of Justices A K JayasankaranNambiar and Mohammed Nias C P also directed that when considering bail pleas in those cases, magisterial and sions courts snould impose a condition which insists upon payment of the amount quantified towards damage/ destruction of property by the accused for grant of any relief to them. "Citizens of the state cannot be made to live in fear solely because they do not have the organized might of the persons or political parties at whose instance such violent acts are perpetrated," the court said. It further said that media reports revealed that the police force played only a passive role in dealing with the situation on September 23till the court intervened on that date. "An effective compliance with our earlier order dated January 7, 2019 would have necessitated the stateadministration to ensure that no public procession, gathering or demonstration took place in the state if the same was in connection with a call for a flash hartal," the bench said. It also said that the Popular Front of India (PFI) and Sathar "cannot feign ignorance" their constitutional obligations. especially when they claim to represent members of a pluralistic society.

It fixed them with the financial liability, saying that their action of inciting their supporters and goading them day "cannot be legally countenanced". "They must be held responsible and made accountable for their illegal actions," the bench said and directed them to deposit the amount within two weeks. On failure to deposit the amount

within the stipulated time, the state government shall take immediate steps under the Revenue Recovery Act to proceed against the assets/ properties of PFI, the personal assets of its office bearers. including Sathar, for realisation of the Rs5.2 crores, the court directed. "Theamountssorealizedshall be purely provisional and shall be duly accounted for and held by the state governmentinaseparateand dedicated account, for disbursal to those claimants who are identified by the Claims Commissioner as entitled to such amounts. "The respondents shall also be liable to such further amounts as are found to be payable to the claimants in the adjudication proceedings the Claims Commissioner," the court said. appointed

Sarangadharan as the Claims Commissioner and directed the state government to ensure his office is fully functional within three weeks. with these directions, the bench listed the matter on October 17 for the state government to report the action taken in compliance of the directions.

The order came on a plea moved by the Kerala State Road Transport Corporation

DeepuThankan seeking compensation of over Rs 5 croresfrom PFI and Satharfor damages to its buses and reduction in services during the hartal on September 23. During the hearing, the state government told the bench that strict and unbiased legal action was initiated in all instances of violations reported during the hartal. It also said that private vehicles and private establishments also suffered a loss to the tune of Rs.12,31,800, due to the wrath of the harthal sympathizers. "Almost all the accused in the incidents that took place on the day of PFI harthal were identified and many of them were already arrested and the remaining will be arrested soon. Till September 26, 417 FIRs were registered in connection with the incidents during the harthal, 1,992 persons were arrested and 687 preventive arrests were made." the state told the bench, KSRTC, in its plea, has contended that the hartal was called without any advance notice which was a violation of the high court's orders and that the violence on that day resulted in smashingofwindscreensand

India is a rich country with poor population facing issues like starvation, unemployment: Gadkari

NAGPUR, SEPT 29 /--/ Unionminister Nitin Gadkari on Thursday said even as India has emerged as the world's fifth largest economy and although the country is rich, its population is poor, facing issues like starvation, unemployment, casteism, untouchability and inflation. The gap between the rich and the poor has widened in the country, which needs to be bridged, he said. He was addressing a programme

Bharat organised by VikasParishad, RashtriyaSwayamsevakSangh (RSS)-inspired organisation. 'We are the fastest-growing $economy\,in\,the\,world\,and\,are$ the fifth largest economy. We are a rich nation with a poor population. Our country is rich, but the population is poor facing starvation, unemployment, poverty, casteism, inflation, untouchability and other factors that are not good for

the progress of the society," he said. "There is a need to social economic equality in the society. The gap between these two sections of the society has widened. Economic disparity has also increased like social disparity," the Minister for Road Transport Highways noted.

Gadkari emphasised the need to work in the fields of education, health and

services to bridge the richpoorgap. "The purpose of the Bharat Vikas Parishad is very clear, but the biggest challenge before us is how to work in various sectors with social responsibility and social consciousness to bring about a change in the society. However, we are still very far from our objective and need to speed up our efforts to achieve it," he said. The minister called for working in a united way to develop 124 aspirational districts in the country. "These aspirational districts in the country are lagging behind socially and in terms of education and health. The urban regions have witnessed a lot of development, but a hugepopulationhasmigrated to cities due to lack of facilities and opportunities," he said while appealing to the Bharat Vikas Parishad to work on empowering rural areas. "Swami Vivekananda said

that the 21st century belongs to India, and therefore everyone should contribute in their own way towards the progress of the nation," he

Gadkari gave an example of his own initiatives being carried out in the tribal regions since the last 23 years, under which EkalVidyalays are being run in the Vidarbha, where 18,000 students are education. (PTI)

PMGKAY extension, a political move?

The government's decision to extend by three months its programme to provide free rations to the poor at a cost of Rs 44,762 crore could have been influenced by political considerations. The decision to ease pain from high inflation was taken at a meeting of the Union Cabinet chaired by Prime Minister NarendraModi. But, a fact that cannot be overlooked is that it comes ahead of the crucial assembly elections in Gujarat and Himachal Pradesh. The opposition has already started wondering whether such "selfish announcements of freebies" will prevent the country from becoming self-reliant, increase the burden on honest tax payers and prevent investment in new technologies. For the record, the sixth extension of the pro-poor scheme comes comes at a time when food inflation is ruling at a high level. Consumer price index (CPI) based inflation in the food basket rose to 7.62 per cent in August 2022 against 6.69 per cent in the preceding month, as per the National Statistical Office (NSO) data. The retail inflation in the food segmentwas 3.11 per cent in August last year.

The Pradhan Mantri Garib Kalyan Anna Yojana to provide 5 kg of wheat and rice free of cost to 80 crore poor every month will now run through December 31, 2022. The free quota is over and above the normal allocation under the National Food Security Act (NFSA), which is 5 kg per personpermonthatahighlysubsidisedrateofRs 2-3 per kg. The PMGKAY was started in April 2020 to help the poor whose livelihoods were shuttered byanationwidelockdownaimedatcontainingthe spread of the Coronavirus. The scheme has been extended multiple times and was to end this Friday. Under this scheme, 5 kg of foodgrain per person per month is provided free of cost for all the beneficiaries covered under the NFSA. The government has so far spent Rs 3.45 lakh crore on the PMGKAY scheme since its launch in April 2020. With the additional expenditure of about Rs 44,762 crore for the latest extension, the overall expenditure of the PMGKAY will be about Rs 3.91 lakh crore for all the phases. 122 lakh tonne (12.2 million tonne) of foodgrains will be given out free of cost in the three months from October 1.

The scheme has been extended a mid concerns in some quarters about the government's buffer stocks of foodgrains, as erratic monsoon rains have led to fear of lower production of rice. Rice production is estimated to fall by 6 per cent to 104.99 million tonnes in the Kharif season this year. Wheat output had also dropped to 106.84 million tonnes in the 2021-22 crop year ended June from the record 109.59 million tonnes in the previous year due to heat waves early this year. The procurement of wheat fell by more than 50 per cent to 19 million tonnes in the 2022-23 marketingyear(April-March), forcing the Centre to ban wheat exports. Earlier this month, the exports of broken rice were also banned and a 20 percent export duty was slapped on non-basmati rice and non-par boiledrice.

Nepal President's refusal to sign passed bill leads to political crisis

With less than two months left before the national elections in Nepal, the refusal of the President of Nepal, Vidya Devi Bhandari, to approve the Citizenship Amendment Bill even after the passage of the proposed enactment by both houses of the parliament has thrown the Himalayan state into a vortex of political crisis. It will make children whose parents' whereabouts were not known eligible to citizenship. Under the amendments, children born to a Nepali mother but whose father is unknown could get citizenship document after the mother makes a declaration.

The amendment to Citizenship Act 2007 makes foreigners married to Nepalis entitled to citizenship. Nepalis who are citizens of foreign nations to do business and conduct economic activities in the country will be entitled to citizenship documents. If the amendment is inked, more than 500,000 people will be eligible to citizenship certificates and voting rights thereof. This seems to unnerve the top brass of Communist Party of Nepal (United Marxist Leninist), whose chairman is Khadga Prasad Sharma Oli. President Bhandari too was elected to the National Assembly, the lower house of the parliament as a candidate of the CPN(UML). President is refusing to authenticate the amendment bill.

According to Article 113 (3) of the Constitution of Nepal 2015, the President has the authority to send the Bills other than those related to finances within 15 days for reconsideration, but it does not allow the President to return the bill or not certify it for the second time. Article 113 (4) specifies that it shall be verified within 15 days after the passage of the bill by the federal parliament with amendments or in the same form. The President disregards all this and has thus triggered a constitutional crisis, However, President Bhandari, who was dissatisfied with the Citizenship Bill, appears to have neglected the

provisions of the Constitution. The President is not allowed to stop the certification of any Bill passed by both the houses of federal parliament for the second time. Five top leaders of the political parties comprising the ruling centre-left alliance accused the President of trying to deprive many Nepalis of their right to citizenship by refusing to approve the bill. "The unconstitutional move of the president has seriously insulted and devalued the federal parliament elected by the people," they said in a joint statement. Balaram K. C., a retired judge of the Supreme Court described the refusal of the President to sign the amendment as a serious and grave violation of the constitution by a ceremonial head of state.

Taking a pot shot at CPN(UML) supremo, CPN (Maoist Center) Chairman Pushpa Kamal Dahal a k a Prachanda at Bharatpur Airport said that the controversy around the Citizenship Bill is motivated. "When KP Oli was the Prime Minister, the Citizenship Bill was introduced as an ordinance. Now when this bill is presented to the parliament, they are calling it anti-national. Nothing can be more dishonest and immoral than this," he quipped.

However, the credibility of once media-hyped underground Maoist leader of Nepal has been on the decline among the people of Nepal. The CPN (Maoist Center) boss visited India a few months back and called on the Bharatiya Janata Party president Jagat Prasad Nadda. And the two leaders in a joint communiqué stated that his party and the BJP had different ideologies but a common objective to uplift the poor section of society. He praised India for buying power from Nepal and extending support to his country during the earthquake and the Covid pandemic. Several legal experts are of the opinion that the President should either resign as president or somebody should file a case against her in the Supreme Court The President has pushed her into the crossfire of controversy by addressing the Global Security Initiative conference organised by the Communist Party of China. Nepal's ministry of foreign affairs took an exception to this reminding that the President Bhandari went beyond her jurisdiction by addressing the GSI conference against Nepal's foreign policyThis is a violation of the nonaligned foreign policy that Nepal has been following, the MoFA observed in a statement. When President Bhandari was requested to participate in the conference, the government advised her not to attend the event as it was linked to the Chinese security umbrella and would be detrimental to Nepal's foreign policy. But she ignored the advice.

MsBhandari erred on two counts. First is her lack of adherence to protocol which is mandatory for the head of state by refusing to sign the amendment bill as a custodian of the Constitution of Nepal. Second, she seems ill-advised to keep Chinese communist bureaucrats in good humour, maybe to remain in the good book of Oli. The CPN(UML) is opposed to India, especially due to its ideological opposition to the BJPin-power 'a Fascist threat' to neighbouring states like Nepal, stated by a top leader of the party at a meeting

The latest deadlock over President's behaviour is going to have its impact on the national elections by yearend. The two communist parties refighting each other and that is giving a bad name to the communists in general. The left supports in Nepal are worried at the continuous disunity in the communist movement in the country. (IPA)

Iran has a history of women struggle for progressive reforms

The custodial death of MahsaAmini, a young woman who was arrested by the morality police in Tehran, has sparked wide protests in Iran. Under the scanner are police who patrol public places to enforce the headscarf law and other Islamic laws. Conversations are also taking place on the situation of women in Islamic Republic.

Since the Islamic revolution in 1979, women have been required by law to wearaveilcoveringtheirheadandneck and conceal their hair. Over the past two decades, however, more and more women in Tehran and other cities of Iran have been letting strands of their hairs outside their veil as a form of protest. More recently, some women have been sharing photos that show them taking off headscarves in opposition to hijab rules.

The struggle against compulsory headscarves made headlines in December 2017 when a young woman, Vida Movahed, waved her hijab on a stick at Tehran's Revolution Street. Then, on July 12, this year, -- the hijab and chastity day on the Islamic Rebulic's calendar--- another group of women took part in a national civil disobedience campaign against mandatory headgear. More and more women, many of whom have not experienced the 1979 revolution, have language of radical reform in 1979,

sentences for violating the hijab rules.

The Iranian Revolution, which ended with the victory of Islamists and the creation of the Islamic Republic, was marked by a noticeable presence of women. Thousands of young women joined Islamist and leftist politics groups. In his interviews with foreign journalists before returning to Iran Ayatollah Khomeini praised women for

their involvement in the revolution. Earlier, however, Khomeini had taken a firm stand against the Shah's "White Revolution" --- one of the axes of which was women's access to the Iranian public space. Since the beginning of the 20th century, especially during the Constitutional Revolution of 1906—1911, progressive Iranian women demanded access to schooling and the right to expression. Before the end of Mohammed Reza Shah Pahlavi's reign in 1978, thirty per cent of students in Iranian universities were women. Though many Iranian students were attracted by the revolutionary

> In March 1979, after the new Islamic law on veiling at workplaces came into force, massive demonstrations took place in the Capital and major cities of Iran. Thousands of men took to the streets shouting slogans such as: "We did not make the revolution to go backwards." The demonstrators were attacked and injured by Islamist stormtroopers. They were not supported by the secular opposition groups who advised them to remain calm, so as Along with the introduction of compulsory veiling, the Islamic Republic abolished the modernizing reforms in the field of civil liberties for women and families law introduced during the Pahlavi regime. The Shahera laws restricting the exercise of polygamy and raising the legal age of marriage to 18 were abolished.

After the death of Khomeini in 1989 and the end of the eight-year war with new future for their country. (IPA)

Iraq, new ideological currents emerged among women who demanded reforms while supporting the Islamic regime. Reformist women stood firm against some of the ideological framework of the Islamic regime in the 1990s, but they were gradually overtaken in the first decade of the twenty-first century by a younger generation, the carriers of new

demands. The most significant action of this new generation of activists was the "One million signatures for the repeal of all discriminatory laws against women in Iran" campaign in 2006. From the Green Movement women against electoral frauds in 2009 to protest against acid attack on women's resistance movement in streets of Esfahan in 2014, women's resistance movement have caused social and political tremors in Iran.

In one of its recent reports on the country, Amnesty International noted that the Iranian authorities have not taken any initiatives to combat violence against woman and girls in private spheres or public sphere. Recent history shows us that Iranian women have been present at all major points in the country's destiny. They contributed to the evolution of the Iranian public sphere while building a







MUMBAI, SEPT 29 /--/ As Hrithik Roshan awaits the release of his two-hero film Vikram Vedha superstar says working in a multi-starrer elevates his performance

Before Vikram Vedha, in which Hrithik features alongside superstar Saif Ali Khan, he had shared screen space with other actors in films such as Mission Kashmir, "Kabhi Khushi Kabhie Gham...", Dhoom 2, Zindagi Na Milegi Dobara and War. Apex court expands scope of MTP Act, brings unmarried women in ambit

landmark verdict, the Supreme Court on Thursday expanded the scope of the Medical Termination of Pregnancy (MTP) Act and the corresponding rules to include unmarried women for abortion between 20-24 weeks of pregnancy, saying limiting the provision to cover only married women will render it discriminatory and violative of Article 14.

The apex court held the meaning of the words "sexual assault" or "rape" under the rules of MTP Act, includes a husband's act of sexual assault or rape committed on his wife. "The meaning of rape must therefore be understood as including marital rape, solely for the purposes of the MTP Act and any rules and regulations framed thereunder," it said. The Supreme Court said the rights of reproductive autonomy, dignity, and privacy under Article 21 give an unmarried woman the right of choice on whether or not to bear a child, on a footing similar to a married woman. A bench of Justices DY Chandrachud, AS Bopanna and JB Pardiwala said the ambit of reproductive rights is not restricted to the right of women to have or not have children and also includes the constellation of freedoms and entitlements that enable a woman to decide freely on all matters relating to her sexual and reproductive health.

The apex court's verdict came on an appeal by a woman from the North-East challenging the Delhi High Court order denying her permission to abort her pregnancy from a consensual relationship after her partner refused to marry and left her. It said the object of Section 3(2)(b) of the MTP Act read with Rule 3B is to provide for abortions between 20 and 24 weeks of pregnancy rendered unwanted due to a change in the material circumstances of women. "In view of the object, there is no rationale for excluding unmarried or single

women (who face a change in their material circumstances) from the ambit of Rule 3B. A narrow interpretation of Rule 3B. limited only to married women, would render the provision discriminatory towards unmarried

violative Article 14 of the Constitution", the bench said. It added that

Article 14 requires the state to refrain from denying to equality before law

or equal protection of laws, and prohibiting unmarried or single women (whose pregnancies are between 20 and 24 weeks) from accessing abortion while allowing married women to access them during the same period will fall foul of the spirit guiding Article 14. "The law should not decide the beneficiaries of a statute based on narrow patriarchal

principles about what constitutes "permissible sex", which create invidious classifications and excludes groups based on their personal circumstances. The rights of reproductive autonomy, dignity, and privacy under Article 21 give an unmarried woman the right of choice on whether or not to bear a child, on a similar footing of a

married woman", the bench said. Chandrachud, in a lengthy verdict of 75 pages, said the ordinary meaning intercourse with a

person, without their consent or against their will, regardless forced intercourse in the occurs context matrimony.

court added that married women may also form part of the class of

sexual assault or rape and a woman may become pregnant as a result of non-consensual sexual intercourse performed upon her by her husband. "We would be remiss in not recognising that intimate partner violence is a reality and can take the form of rape. The misconception that strangers are exclusively or almost exclusively responsible for sex- and genderbased violence is a deeply regrettable one. Sex- and genderbased violence (in all its forms) within the context of the family has long formed a part of the lived experiences of scores of women", it said. The apex court said it is not inconceivable that married women become pregnant as a result of their husbands having "raped" them and the nature of sexual violence and the contours of consent do not undergo a transformation when one decides to marry.

"The institution of marriage does not influence the answer to the question of whether a woman has consented to sexual relations. If the woman is in an abusive relationship, she may face great difficulty in accessing medical resources or consulting doctors," it said. The bench said it is only by a legal fiction that Exception 2 to Section 375 of the IPC removes marital rape from the ambit of rape, as defined in Section 375. "Notwithstanding Exception 2 to Section 375 of the IPC, the meaning of the words "sexual assault" or "rape" in Rule 3B(a) includes a husband's act of sexual assault or rape committed on his wife. The meaning of rape must therefore be understood as including marital rape, solely for the purposes of the MTP Act and any rules and regulations framed thereunder...", it added

The bench said since the challenge to Exception 2 to Section 375 (marital rape) of the IPC is pending consideration before a different Bench of this Court, it would leave the constitutional validity to be decided in that or any other appropriate proceeding. (PTI)

Sanskrit Nrisingha Prasad Bhaduri, linguist Pabitra Sarkar, and Kaliprasanna Bhattacharya, a priest who has conducted Durga Puja rituals for at least 60 years, came together for the initiative as part of a campaign to promote Bengali. "The devotion lies in the heart and not in the language in which the shlokas are chanted. It is always better to offer the prayers in a language, which we know and understand, rather than saying it in Sanskrit with half of the meaning not understood by us," Bhaduri

Maha Ashtami -- the second day of the four-day festival, including Pushpanjali and Sandhi Puja, are considered to be the most significant ones and are conducted in Sanskrit, also called 'Dev Bhasha' or the divine language. Even though Pushpanjali, or offering of flowers, is held on multiple days during the Durga Puja, the one on Maha Ashtami is revered thousands of people queuing up at pandals to take part in the ritual. The Bengali shlokas have been compiled in a book, which has been distributed among the puja committees of Kolkata. The Sanskrit verses are also there in the book if someone wants to check the accuracy of the translation, said Srimanta Choudhury who is the head of the campaign, initiated by a group of Bengali techies living abroad. The Bengali verses can be downloaded chantbangla.org in PDF or in an audio format, chanted by noted elocutionist Satinath Mukherjee, he

Around 250 Durga Puja committees in West Bengal will be conducting the rituals in Bengali this year, he added. Not only the community Pujas, but also the Pujas at several 'Bonedi traditional Bari' or households will be conducted with these verses. Some residential complexes will also be using the Bengali sholkas, Mukherjee said. developments on Sunday MLAs supporting him defied the central observers and thwarted their move to hold a meeting of party legislators. Instead, they held a parallel

meet to pitch for Gehlot's continuation or the guarantee that his bete noire Sachin Pilot does not replace him. Gehlot, a three-time state chief minister, described himself as a disciplined soldier of the party and expressed his sadness over the turn of events in the state. Asked if he will continue as chief minister, Gehlot said Gandhi will decide

"In the last 50 years, I have worked as a loyal Congress soldier from the time of Indira Gandhi, Rajiv Gandhi, Narasimha Rao and Sonia ji, be it becoming a central minister or state unit chief, general secretary or CM for the third time, I cannot forget that. The events that happened (on Sunday) has shaken all of us. Only I know how hurt I am because a message went that I want to remain CM," Gehlot said. "I have apologised to Sonia ji because a simple resolution, which is our tradition and which we always pass a situation emerged that it could not be passed. I, as a CLP leader, whatever the reasons, could not get the resolution passed," he said. He also said that in the aftermath of the events, he has decided that he will not fight the party president polls. Congress general secretary KC Venugopal later said the party president will decide on the Rajasthan chief minister's post within a day or two. Venugopal made the statement outside Gandhi's 10, Janpath residence here after a series of meetings to resolve the Rajasthan crisis. He also said it will be clear by tomorrow, the last day of filing nominations for the top post, who all will contest. Meanwhile, senior Congress leader Digvijaya Singh, who is likely to file his nomination for the Congress president's post on Friday, met Shashi Tharoor, who said they agreed that theirs is "not a battle between rivals but a friendly contest" among colleagues. Singh met the party MP from Thiruvananthapuram on Thursday after collecting nomination papers for the polls.

"Received a visit from Digvijaya Singh this afternoon. I welcome his candidacy for the Presidency of our Party,' Tharoor said in a tweet. "We both agreed that ours is not a battle between rivals but a friendly contest among colleagues. All we both want is that whoever prevails, @incIndia will win!" he said. (PTI)

Fall in country's foreign exchange reserves not worrying: Experts

foreign exchange reserves of the country due to the depreciation of the rupee is not a worrying factor, and there is coverage for nine months of imports, experts said here

The country's forex kitty continued its southward journey, with the overall reserves declining by USD 5.219 billion to USD 545.652 billion for the week ended September 16, the Reserve Bank of India had said. The reserves, which have been dipping as the central bank deploys the kitty to defend the rupee amid pressure caused majorly by global developments, had declined by USD 2.23 billion to USD 550.87 billion in the previous week. State Bank of India Group chief economic adviser Soumva Kanti Ghosh said: "India's foreign exchange reserves have gone down from USD 630 billion to USD 550 billion. But is not a cause for concern as there is coverage for nine months of imports.'

However, Ghosh said the rupee should find some value. HDFC Bank chairman Atanu Chakrabarty said India is not decoupled as it imports a large amount of energy. He said the foreign exchange reserves are down by USD 80 billion due to the depreciation of the rupee vis-a-vis the policy decision scheduled to come out on September 30, the rupee, however, consolidated in a narrow range and settled 13 paise higher at 81.80 against the US dollar on Thursday. The rupee on Wednesday plunged below the 82-mark for the first time in intraday trade before settling 40 paise down at 81.93 against the dollar. Chakrabarty, however, said the banking sector is in the pink with low NPAs and the capital expenditure cycle starting to pick up. The Indian economy at present is more formalised due to the implementation of the Goods and Services Tax and digitalisation, he said, adding that there has been a push towards infrastructure development. He also mentioned that presence of a big middle class in India will drive consumption but cautioned on the high inflation which is higher than the RBIdesignated band of four to six per cent. "So cut in interest rates may not be there in tomorrow's monetary policy committee (MPC) meet," he said. New Development Bank of BRIC countries former chief K V Kamath viewed that since the present high inflation is mainly on account of food, a cut in rates may not have the desired impact.

Kremlin: 4 regions of Ukraine to be folded in Russia Friday

KYIV, SEPT 29 /--/ Russia confirmed on Thursday it will formally annex parts of Ukraine where occupied areas held Kremlin-orchestrated referendums on living under Moscow's rule that the Ukrainian government and the West denounced as illegal and rigged.Russian President Vladimir Putin will attend a ceremony on Friday in the Kremlin when four regions of Ukraine will be officially folded into Russia, spokesman Dmitry Peskov told reporters. Peskov said the pro-Moscow administrators of the regions will sign treaties to join Russia during the ceremony at the Kremlin's St. George's Hall. The official annexation was widely expected following the votes that wrapped up on Tuesday in the areas under Russian occupation in Ukraine and after Moscow claimed residents overwhelming supported for their areas to formally become part of Russia.

The United States and its Western allies have sharply condemned the votes as sham and vowed never to recognise their results. German Foreign Minister AnnalenaBaerbock on Thursday joined other Western officials in denouncing the votes. Under threats and sometimes even (at) gunpoint people are being taken out of their homes or workplaces to vote in glass ballot boxes, she said at a conference in Berlin. This is the opposite of free and fair elections, Baerbock said. And this is the opposite of peace. It's dictated peace. As long as this Russian diktat prevails in the occupied territories of Ukraine, no citizen is safe. No citizen is free. Armed troops had gone door-todoor with election officials to collect ballots in five days of voting. The suspiciously high margins in favor were characterized as a land grab by an increasingly cornered Russian leadership after embarrassing military losses in Ukraine.Moscow-installed administrations in the four regions of southern and eastern Ukraine claimed Tuesday night that 93% of the ballots cast in the Zaporizhzhia region supported annexation, as did 87% in the Kherson region, 98% in the Luhansk region and 99% in Donetsk.

Ukraine too has dismissed the referendums as illegitimate, saying it has every right to retake the territories, a position that has won support from Washington. The Kremlin has been unmoved by the criticism. After a counteroffensive by Ukraine this month dealt Moscow's forces heavy battlefield setbacks, Russia said it would call up 300,000 reservists to join the fight. It also warned it could resort to nuclear weapons. Also on Thursday, Ukrainian authorities said Russian shelling has killed has killed at least eight civilians, including a child, and wounded scores of others. A 12-year-old girl has been pulled out of rubble after an attack on Dnipro, officials said.

The rescuers have taken her from under the rubble, she was asleep when the Russian missile hit, said local administrator ValentynReznichenko.Reports of new shelling came as Russia appeared to continue to lose ground around a key northeastern city of Lyman while it struggles to press on with chaotic mobilization of troops and prevent the fighting-age men from leaving the country, according to a Washington-based think-tank and the British intelligence reports. The Institute for the Study of War, citing Russian reports, said Ukrainian forces have taken more villages around Lyman, a city some 160 kilometers (100 miles) southeast of Kharkiv, Ukraine's second-largest city. The report said Ukrainian forces may soon encircle Lyman entirely, in what would be a major blow to Moscow's war effort. The collapse of the Lyman pocket will likely be highly consequential to the Russian grouping in northern Donetsk and western Luhansk oblasts and may allow Ukrainian troops to threaten Russian positions along the western Luhansk region, the institute said. The British military intelligence report claimed the number of Russian military-age men fleeing the country likely exceeds the number of forces Moscow used to initially invade Ukraine in February. (AP)

Pakistan's former PM Nawaz Sharif's daughter Maryam acquitted in corruption case

ruling Pakistan Muslim League-Nawaz (PML-N) party, its vice president Maryam Nawaz was on Thursday acquitted by a high court in a corruption case. The Islamabad High Court (IHC) accepted her appeal and that of her husband Muhammad Safdar who had challenged their convictions by an anti-corruption court in the Avenfield property case in July 2018. A two-judge bench comprising Justice Aamer Farooq and Justice Mohsin Akhtar Kayani hearing their appeals said the opinion of the investigating officer could not be considered as evidence. The joint investigation team did not present any facts, it just collected information, Justice Kayani observed. At the conclusion of the case, the bench held that the National Accountability Bureau (NAB). the prosecutor in the case, failed to establish the charges of corruption. The Thursday's verdict has paved way for Maryam to be eligible to contest elections. Lawyer Mirza MoizBaig said: A person who has been convicted of a crime involving corruption or moral turpitude is disqualified from contesting elections unless a period of five years has lapsed since their release."While the Supreme Court has, in the case of Samiullah Baloch, held that a disqualification under Article 62(1)(f) continues for life, a disqualification under Article 63(1)(g) isn't incurable, he explained.

Maryam Nawaz, unlike her father, was never declared to fall short of the requirements enshrined under Article 62(1)(f). To the contrary, the only bar to her contesting elections was her conviction in the Avenfield -- properties in London -- reference. With the conviction being overturned by the Islamabad High Court, Maryam Nawaz's candidature for an election to the Parliament will no longer trigger Article 63(1)(g)," he added.

Maryam in a brief chat with the media outside the court said they had been vindicated. As she talked to the media, she also spoke to her father Nawaz Sharif in London and also received another call from her uncle Prime Minister Shehbaz Sharif, who congratulated her on her acquittal.

The Prime Minister later in his reaction to the verdict said the edifice of lies, slander and character assassination had come crumbling down. Maryam's acquittal in the Avenfield reference is a slap in the face of the so-called accountability system that was employed to target the Sharif family. My congratulations to Maryam beti (daughter) and Safdar, he tweeted.

While Maryam and her husband were convicted along with PML-N supremo Nawaz Sharif, the elder Sharif was handed down 10 years in jail, Maryam sentenced to seven years in prison, and her husband was sentenced to one year in prison. They had filed appeals against their conviction before the IHC in the second week of August 2018 and the court had on September 18 the same year suspended their sentences and released them on bail. The elder Sharif's appeal is still pending as has been living in London and failed to appear before the court despite being given several opportunities. Overturning the conviction of his daughter, however, opens a window for him to come back and get his bail processed with the hope to get relief. (PTI)

Sri Lanka Parliamentary panel headed by PM Gunawardena sets up subcommittee to tackle economic crisis

Suu Kyi convicted again, Australian economist gets 3 years

military-ruled Myanmar convicted former leader Aung San Suu Kyi in another criminal case Thursday and sentenced Australian economist Sean Turnell to three years in prison for violating Myanmar's official secrets act, a legal official said.Suu Kyi received a three-year sentence after being convicted with Turnell under the secrets law, said the official, who spoke on condition of anonymity because he is not authorised to release information about the case. Three members of her Cabinet were also found guilty, each receiving sentences of three years. Turnell was also convicted of violating immigration law, for which he was given a three-year sentence to be served concurrently with the term for violating the secrets law. The 20 months he has already spent in detention will be deducted from his sentence, leaving him less than a year and a half to serve. Turnell, 58, an associate professor in economics at Sydney's Macquarie University, had served as an adviser to Suu Kyi, who was detained in the capital Naypyitaw when her elected government was ousted by the army on Feb. 1, 2021. Family and friends expressed hope he will soon be freed and deported, as has occurred with other foreigners in Myanmar convicted of political offenses, though less serious ones. It's heartbreaking for me, our daughter, Sean's 85-year-old father, and the rest of our family to hear that my husband, Professor Sean Turnell, was convicted and sentenced to 3 years' imprisonment," his wife Ha Vu, also an economist, said on her Facebook page.

"Sean has been one of Myanmar's worked tirelessly to strengthen Myanmar's economy." My husband has already been in a Myanmar prison for almost 2/3 of his sentence, she added. "Please consider the contributions that he has made to Myanmar, and deport him now!" Australian Foreign Minister Penny Wong's office rejected the court's ruling and called for Turnell's immediate release. Decrying that he had been unjustly detained, her office said Australian diplomats were denied access to the court hearing for the verdict. We will continue to take every opportunity to advocate strongly for Professor Turnell until he has returned to his family in Australia, it said in a statement. Tim Harcourt, a longtime friend, said Turnell is "a great economist, nice bloke and a great human being. His main cause in life is to reduce poverty around the world and he'd developed particular expertise in Myanmar. "Hopefully common sense and justice can prevail and Sean can return to his wife and family in Australia soon, said Harcourt, a professor at the University of Technology Sydney.

Turnell was arrested five days after the military takeover by security forces at a hotel in Yangon, the country's biggest city. He had arrived back in Myanmar from Australia less than a month before that to take up a new position as a special consultant to Suu Kyi. As director of the Myanmar Development Institute, he had already lived in Naypyitaw for several years. The day after the military's takeover, he posted on Twitter: Safe for now but heartbroken for what all this means for the people of Myanmar. The bravest, kindest people I know. They deserve

The five co-defendants were charged on the basis of documents seized from Turnell. The exact details of their offense have not been made public, though state television said last year that Turnell had access to secret state financial information and had tried to flee the country. Turnell and Suu Kyi denied the allegations when they testified in their defense at the trial in August. Myanmar's colonial-era official secrets act criminalizes the possession, collection, recording, publishing, or sharing of state information that is directly or indirectly, useful to an enemy. The charge carries a maximum penalty of 14 years in prison. The trial, like the others involving Suu Kyi, was held in a purpose-built prison courtroom and was closed to the media and the public. Defense lawyers were barred by a gag order from revealing details of the proceedings. The multiple criminal cases brought against the 77-year-old Suu Kyi are widely seen as an effort to discredit her and to prevent her return to politics. She had already been sentenced to 20 years' imprisonment after greatest supporters for over 20 years and has being convicted of illegally importing and possessing walkie-talkies, violating coronavirus restrictions, sedition, election fraud and five corruption charges. Suu Kyi is still being tried on seven counts under the country's anti-corruption law, with each count punishable by up to 15 years in prison and a fine

Defense lawyers are expected to file appeals in the secrets case in the coming days for Turnell, Suu Kyi and three former ministers: Soe Win and Kyaw Win, both former ministers for planning and finance, and Set Aung, a former deputy minister in the same ministry, the legal official said. Australia has repeatedly demanded Turnell's release. Last year, it suspended its defense cooperation with Myanmar and began redirecting humanitarian aid because of the military takeover and Turnell's ongoing detention. Cambodian Prime Minister Hun Sen, when he visited Myanmar in January this year, asked for Turnell's release in a meeting with the leader of ruling military council. Senior Gen. Min Aung Hlaing replied that he would consider it positively. (AP)

Bumrah ruled out of T20 World Cup due to back stress fracture

spearhead Jasprit Bumrah was on Thursday ruled out of the T20 World Cup due to a back stress fracture, dealing a massive blow to team's chances at the ICC flagship event starting next month in Australia. A BCCI official told PTI that Bumrah will be forced out of action for six months due to the back injury.

"Bumrah is not going to play the T20 World Cup for sure. He has a serious back condition. It's a stress fracture and he could be out for a period of six months," a senior BCCI official told PTI on conditions of anonymity. Stress fracture is a tiny crack in the bone, caused by overuse and is common in sports persons. When stress reaction (bone bruise) goes undetected for a considerable time, it develops into stress fracture. Almost 50 per cent of sports injuries are caused by stress fractures. Back stress fractures do not require surgery but a lot of time to heal. Rest is best solution to treat stress fractures. It is understood that either Deepak Chahar or Mohammed Shami could replace Bumrah in the main squad. Both were named as stand-by players for the prestigious tournament by the BCCI. Bumrah, who played the second and third T20 against Australia, had travelled with the team to Thiruvananthapuram for the seriesopener against South Africa but left for Bengaluru to be at National Cricket Academy (NCA) for rehabilitation. The 28-year-old fast bowler is the second senior star player to be ruled out after Ravindra Jadeja, who is recovering from a knee surgery. The Indian team is already looking unsettled at the moment and Bumrah's injury has only compounded the woes for skipper Rohit Sharma and coach Rahul Dravid.

"Losing Bumrah and Jadeja will be huge for India. We didn't expect that things will pan out as they have. He was rested for the Asia Cup precisely to manage his workload management. Now it remains a question if he was even fit enough to play the Australia



series," the senior official said. Many senior players have been given adequate rest, keeping in mind their workload. What is more interesting is the fact that Bumrah has played only five Tests, five ODIs and as many T20Is in 2022 apart

from IPL games for Mumbai Indians. That's not a lot of cricket, considering that he was rested for Asia Cup, West Indies tour and also some of the bilateral cricket played in India. That's a lot of rest.

'As of now he is at the NCA and the rehab will be a long and arduous one. Yes, World T20 is important but he is still young and India's biggest bowling asset. You can't take risk with him," the official said.

Bumrah, who has a slinging action, puts a lot of pressure on his back during loading. Former West Indies pace bowling great Michael Holding had assessed that Bumrah was always a candidate for back injuries. (PTI)

Former FIFA referee Sumanta Ghosh dies

KOLKATA, SEPT 29 /--/ Kolkata-based former FIFA referee Sumanta Ghosh, who officiated in pre-World Cup and pre-Olympic tournaments, died of prolonged illness at his residence here on Thursday. He was 70 and is survived by his wife and two sons.

"He was not keeping well for the past few days, and he breathed his last around 3 am this morning," a Bengal referee said. Born on April 10, 1952, Ghosh became a FIFA referee in 1990 and retired in 1997. He officiated in pre-World Cup and pre-Olympics tournaments, AFC Club Championships, SAFF Cup and the Jawaharlal Nehru Cup among others. After retirement, Ghosh continued to be associated with refereeing by becoming referees' instructor and AIFF Match Commissioner. It is really sad to hear that Sumanta-da is no more. He was a doyen of Indian refereeing and his invaluable contribution to the game will always remain with us. Touching 'SKY-line': Suryakumar is now India's highest run-scorer in T20Is in single calendar year

Suryakumar Yadav's status as India's best T20I batter in recent times has been reaffirmed as he became the highest scorer in a single calender year with 732 runs, surpassingShikharDhawan's 689 back in 2018.

Suryakumar, who scored one of his finest T20I halfcenturies against South Africa on a seaming track in Thiruvananthapuram on Wednesday, is only 24 runs shortofcompleting 1000 runs in the format. His strike-rate in 2022 is a whopping 180.29, while his career strike-rate is a staggering 173.35 across 32

He has already hit 57 sixes and 88 boundaries in his career so far. Comingon to bat at No.4 position in the firstT20IagainstSouthAfrica with India being reduced to 17/2 in the seventh over, Suryakumar hit two sixes off his first three balls to give the innings a change in momentum after a slow start. He remained unbeaten on 50 off 33 balls as India scaled the target with more than three overs to spare and eight wickets in hand. With the two sixes early in the innings, Suryakumar also went past Pakistan's Mohammad Rizwan to record the most sixes in any calendar year in

Rizwan held the record for his 42 sixes in 2021 with Martin Guptillalso smashing 41 sixes in the same year. Suryakumar has taken his tally of sixes to 45 in 2022 already, a record in all T20Is, with three more months to widen the gap with Rizwan. While Rizwan took 26 innings to hit 42 sixes, Suryakumar has broken the record batting five times

Suryakumar is up to second position in the latest MRF Tyres ICC Men's T20I Player Rankings with 801 rating points after his halfcentury in the third and final T20I against Australia in Hyderabad. (PTI)

Serie A's first woman referee to make debut this weekend

MILAN, SEPT 29 /--/ Italy's Serie A is set to have its first match officiated by a woman after the country's referee association AIA confirmed on Wednesday that Maria Sole Ferrieri Caputi would take charge of a game this weekend. In July, Ferrieri Caputi was promoted to the top rung of Italian football's match officials and on Wednesday the football federation assigned her Sassuolo's home clash with Salernitana on Sunday afternoon.

"This isn't any old day, I'm pretty emotional," said AIA president Alfredo Trentalange at a press conference in

"Maria Sole will make her Serie A debut on the basis of her merit... We don't hand out privileges, Maria Sole has earned this, and it's a success for the whole refereeing sector." Ferrieri Caputi refereed in the third-tier Serie Clast season but she has already taken charge of a match featuring a Serie A side, when Cagliari played Cittadella in the Italian Cup in December. The 31-year-old also officiated the latter team's Serie B match with SPAL two months before. Women referees are becoming increasingly common in the men's game, with three selected for the upcoming men's World Cup in Qatar. Among that trio is Stephanie Frappart, the highest profile women's referee who has taken charge of men's matches in the Champions League, French Ligue 1 and World Cup qualifiers. (AP)
